Motion by Rev. Claude Hampleman. seconded by Rev. Leon McBride, to accept Rev. W. T. Turnbough's resignation as a member of the General Board of the National Association. Motion carried.

Business Committee appointed by the moderator was Elber Avery. Earl Adcock, Barbara Cook.

Motion by Rev. Claude Childers, seconded by Rev. Claude Hampleman to adjourn. Motion carried.

No further action on this motion.

Bro. Wallace Malone made a motion to table this matter until 2:00 p.m., seconded by Virgil McAlpin. Motion carried.

Motion by Rev. Claude Childers, second by Rev. Leon McBride to adjourn until 1:30 p.m. Motion carried.

Board appointed by the moderator being Rev. Claude Hampleman, Rev. Gene Norris, Rev. George Ritter.

Motion by Rev. Dwight Dame, seconded by Rev. Cecil Walker to strike the motion by Rev. Claude Hampleman, seconded by Bro. Leon McBride on the item of business from the record. Motion carried.

Motion made by Rev. Claude Childers, seconded by Ray Stern that we recommend that each church send the tithe money of their offerings to the state treasurer with 30 per cent being held in the state and 70 per cent being sent to the national association to be allocated to the various phases of our denominational work. The 30 per cent being held in the state to be allocated by our state board to the various state associational work. Motion carried.

Motion by Rev. Claude Childers, seconded by Rev. O. C. McClerren, that the yearly conference begin on Friday morning and continue through Saturday evening, and that an amendment be made to Article Six (6) in our yearly conference constitution. Motion carried by two-thirds of the voters present.

Motion by Rev. Dwight Dame, seconded by Arthur Jones, to give heired money to the Sunday School Alliance. Motion lost.

Motion by Rev. Wallace Malone, seconded by Rev. Dwight Dame, that one thousand dollars (\$1,000) be placed in the State Home Mission. Motion carried.

Motion by Rev. Leon McBride, seconded by Hosea V. Smith, to give five thousand dollars (\$5,000) toward an administration building on the camp ground with the name of the late Elmer P. Warren on it. Motion carried.

Motion by Bro. Earl Adcock, seconded by Rev. Dewey Merritt, to table business on balance of money until the next yearly conference. Motion lost.

Motion by Rev. Dwight Dame, seconded by Rev. Claude Hampleman, to give balance of money to state home mission. Motion carried.

Report by the auditing committee was given and a motion by Rev. Dwight Dame, seconded by Rev. Cloy Myers, to accept the report with a balance of \$72.06 on hand. Motion carried.

Motion by Rev. Dwight Dame, seconded by Rev. Cecil Walker to empower the chairman to appoint five (5) delegates to the national association. These delegates are Mrs. Betty Hampleman, Mrs. Claude Childers, Mrs. Carrie McBride, Mrs. Barbara Cook and Carrol Cook.

Rev. Claude Childers was nominated for moderator and Rev. Dwight Dame made a motion to close nomination and was seconded by Rev. Claude Hampleman. Rev. Childers was duly elected.

Rev. Claude Hampleman was nominated for assistant moderator. Motion made by Bro. Earl Adcock, seconded by Bro. Wayne Warren, to close nomination. Rev. Hampleman thus was duly elected.

Motion by Rev. Claude Childers, seconded by Rev. Cecil Walker to re-elect Zola McClerren as treasurer. Motion carried.

Sis. Betty Hampleman was nominated for clerk and duly elected.

Motion by Rev. Gene Norris, second by Rev. Wallace Malone, that the yearly trustees be empowered to see about the construction of an administration building. Motion carried.

Report of the business committee was given and a motion was made by Rev. Dwight Dame and seconded by Rev. Cloy Meyers to accept the report. Motion carried.

Item (1) We, the business committee, recommend that churches of this conference when calling a pastor he should first be interviewed by the deacons of the church to determine if he has a card in good standing and that he belives and preaches the Bible as interpreted by the Free Will Baptist Treatise.

Motion by Rev. Claude Childers, second by Rev. Dwight Dame, to accept this item. Motion carried.

Item (2) We, the business committee, recommend that the quarterlies of this conference appoint no minister on the examining board or business committee who does not preach the Bible as interpreted by the Free Will Baptist Treatise.

Motion made by Rev. Wallace Malone, seconded by Rev. Jasper Armstrong, to accept Item 2. Motion carried.

Item (3) We, the business committee, ask this conference to instruct the program committee to send program to those who will be on it next year.

Motion by Dev. Dwight Dame, second by Rev. Cevil Walker, to accept Item 3. Motion carried.

Item (4) We, the business committee, recommend that both men and women who are qualified to come before the ordaining council that hands be laid on them during the ordination

prayer. Our treatise states that ministers are ordained by prayer and the laying on of hands. Signed: Committee.

Motion by Rev. Claude Childers, second by Rev. Wayne Warren. to accept Item 4. Motion carried.

Item (5) We, the business committee, find Bro. Byford Campbell, Bro. Dorsey Braden, Bro. Bertrum Smith are not qualified for their cards by failure to attend quarterly meetings as prescribed by the by-laws and constitution. Signed: Committee.

Motion by Rev. Claude Childers, second by Rev. Hosea V. Smith, to accept Item 5. Motion carried.

Rev. Jack Ketteman was nominated for trustee and duly elected.

Bro. Leon McBride was duly elected to fill the vacancy of Bro. Les Elliott as State Missionary Director of Foreign Missions.

A vote of thanks was given the churches for the delicious meals they served.

The chairman was empowered to appoint a program committee. The following were named: Bro. Wendell Kelley, Bro. Everett Lewis, and Rev. George Ritter.

Motion by Bro. Jasper Armstrong, second by Rev. Cloy Myers, to adjourn. Motion carried.

ILLINOIS WOMAN'S AUXILIARY PLAN OF WORK FOR 1960

W. N. A. C. Watchword: "Calvary's Call".

Theme: "They (the women) remember His words". Luke 24:8.

Hymn: "Jesus Saves".

1. Stewardship-Prayer

- A. Establish intercessory prayer bands that the prayer power of the woman unable to attend auxiliary meetings may be enlisted in the missionary cause.
- B. That we re-emphasize our slogan, "Every Freewill Baptist Woman A Tither" by taking as our goal in 1960 the 100% tithers with special attention given to our young people in the field of tithing.
- C. That we strive in 1960 for a 10% increase in our missions offerings to be given during the special seasons of prayer.
- D. That all Auxiliaries observe the World Day of Prayer.

2. Enlistment

- A. To make as our goal, a 10% gain in Woman's Auxiliary organizations. The ultimate aim is to reach every church.
- B. Recognition to be given to the churches that visit every woman in the church inviting them to join the organization.

3. Personal Service

- A. This year Illinois Woman's Auxiliary plans to emphasize three methods for doing mission work in the local community. Namely:
- (1) Visiting—this is one of the most important phases as so many different people can be reached by visitation.

- (2) Distribution—distributing love, cheer and material aids to those who need it, with always the purpose of making the name of Christ known to those near you. Distribution of the Gospels in printed form as well as evangelistic tracts pay a rich dividend.
- (3) Holding Meetings—Either group meetings or services held in places that are our responsibility. These can be in homes of the unsaved, institutions or in our regular meetings, praying one for another that we might be led into a great service.

4. Mission Study

- A. That as soon as possible every local Auxiliary study the Manual, and then adopt and apply the manual suggestions to meet their own problems and needs.
- B. That each Auxiliary conduct at least two mission study classes—one-third of the membership of the Auxiliary completing the study of a book; two-thirds of the members reading one missionary book during the year.
- C. That the Study Course chairman keep an accurate record of each woman completing each study class held, and also the number of members reading a missionary book and reporting same to her convention chairman.
- D. That each study course chairman feel the definite responsibility for promoting study classes.
- E. That the book list printed in our Year Book as well as information given in "Contact" or "Freewill Baptist" on missions be used by the study course chairman.

5. Youth Auxiliary Work

- A. That each auxiliary sponsor at least one youth auxiliary.
 - B. That the local auxiliary be urged to provide the literature for the youth auxiliary organization in the church.
 - C. That young people of every church be encouraged to attend the Freewill Baptist Youth Camp.

- D. That every auxiliary be urged to cooperate in the annual Stewardship Contest conducted for youth organizations. A speaker or an essay, or both, is urged from each auxiliary to the district convention, where a winner is selected for the National Association.
- E. That the District Youth Chairman be responsible for promoting interest and gifts for the Youth Camp.

6. Reports

- A. Our only records of gifts and statistics are from reports. Recognizing, therefore, the importance of reporting accurately, and regularly, is requested by the convention.
- B. We urge that all the Recording Secretaries and Treasurers be faithful in making reports to the district.
