#### SPECIAL SESSION - AUGUST 20, 1960

A special session was called in connection with the meeting for reorganization. Rev. Claude Childers was moderator and a quorum was declared after checking the delegations from the churches which had not joined new quarterly meetings. There were three churches left in the Franklin County Quarterly, twelve in the Freedom and two in the Northern. Mrs. Maxine Powless was appointed clerk.

The newly-formed South Central Illinois Quarterly Meeting presented a letter asking admission into the body. Delegates were Rev. Clyde Gulley, Vard Roberts, Mrs. Betty Hampleman, Robert Laur, Howard Adams, Buford McClerron and Rev. Sherman Sullivan. Motion by Rev. Taylor Coursey and seconded by Mrs. Geraldine Lewis, that the new quarterly be received into membership. Motion carried. Motion was passed to change Article VI of the Constitution to read: "The Yearly Conference shall convene on the third Friday night of June when it shall be the duty of all ordained authority and delegates to be present". This is a change from the "fourth Friday morning." The 1961 session will be June 16, 17.

The chair was then empowered to appoint delegates to help organize a State Association. Those appointed were Rev. Claude Hampleman, Rev. George Ritter, Rev. Curt Rogers, Rev. Cecil I. Hall, Rev. Charles Osborn, Rev. Albert Bays and Rev. Dwight Dame. A letter was authorized to this effect. Conference was then adjourned.

The State Association was formed by the Southern Illinois Yearly Conference, which is now made up of four quarterlies— Franklin County, Freedom, Northern, South Central and the Canaan District Association which is made up of two quarterlies, the East Central and the West Central. The State Association will be at the Alliance Tabernacle June 23-24, 1961, beginning Friday at 9:00 a. m.

Rev. Wallace Malone nominated Rev. Leon McBride for moderator. Motion by Rev. Dwight Dame to close nominations and to elect by acclamation.

Rev. Leon McBride nominated Rev. Wallace Malone as assistant moderator. Motion by Rev. George Ritter to close nominations and proceed to elect. Jesse Boswell was duly elected as clerk.

Motion to give \$50 per year to treasurer. Motion sustained.

Sister Betty Hampleman was nominated as treasurer and duly elected.

Elver Bunnell was nominated as trustee and duly elected.

(1) That the clerk read the names of those who passed away the past year, and that we stand together in silent prayer in the memory of those who have passed on.

#### CHURCH COVENANT

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises the support of Missions, the success of Sunday schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
