

- 1. We the Business Committee, make the following recommendations:

- Item I. That Ministers Cards of good standing passed from the State Association be granted on reports channeled through subordinate bodies beginning with recommendations from the local church of which he is a member and endorsed by the Quarterly and District, or Yearly, of which his church is a member.
- Item II. That requirements for Minister's Cards of good standing be as follows:
 - Section 1. Minister must make an annual report of past year's activities.
 - Section 2. Must preach a minimum of twelve sermons during the past twelve months unless physically handicapped or over sixty-five years of age.
 - Section 3. Must not take part in practices repugnant to the Free Will Baptist Doctrine, such as:
 - A. Sanctification as a definite second work of Grace.
 - B. Oneness rather than the Trinity.
 - C. Unknown tongues as commonly recognized.

D. Positional Eternal Security of the believer rather than provisional security as taught by the scriptures and recognized in our Treatise.

Item III. We recommend that all of our churches be encouraged to support our State Co-operative Plan.

Item IV. Concerning Co-operative Plan:

Section 1. That the Co-operative Plan receipts be divided with sixty per cent going to our national work and forty per cent being retained for work in Illinois to be allocated as follows:

State Association General Fund to receive	50%
Sunday School Alliance to receive	40%
Bible College Fund to receive	10%

These allocations to be in effect until the State Home Mission Board places a man on the field at which time the following allocation is recommended to become effective:

State Association General Fund to receive	#30%	١
State Home Mission Board to receive	40%	·
Sunday School Alliance to recieve	25%	
Bible College Fund to receive		

Item V. At the request of the Canaan District and the Southern Illinois Yearly Conference, we recommend that this State Association give authority to the Executive Board and the State Home Mission Board to employ the services of a minister to organize and establish new work in Illinois.

Item VI. At the request of the Southern Illinois Yearly Meeting, we recommend that this Association accept the lease of the new Administration Building site from the Sunday School Alliance thereby assuming ownership and responsibility of the building.

Item VII. That this Association pay our clerk an annual salary of \$50.00 and our treasurer an annual salary of \$100.00. We also recommend that this Association purchase an adding machine for use by our treasurer.
