Finance Committee reports



The Board recommended that Bro. Leo Pergson be licensed to preach and that Bro. Norman Colecleasurer's license be extended for one year.


They also recommended that Bro. Ford, Bro. Mottley and Bro. Ben Fortune be ordained as deacons.
