The Executive Board was called together with a letter from the Santa Maria Church asking for assistance with a member who was walking disorderly.

Meeting called to order by singing and prayer---Rev. Lambert gave Rev. Boyles charge of the service.

- Motion No. 1. Motion was made and seconded to have Rev. Boyles to act as moderator for this conference.
The motion carried unanimously.

Everyone present was a member of the church and had power to vote.

Minutes of the last church conference read. A letter of notification was read, the date being 12/4/59.--Bro. Lambert was sure the letter was received by the accused because it was a registered. Personal witnesses made statements that they knew the accused had received the letter from hearing of accounts of his statement made. Fred Laurance himself made the public statement that he would not appear at the trial. This statement was made at the church on 12/17/59 during the evening service.

Moderator ask for the treatise to be read, The secretary of the executive board read Sec. VI, Sub, 4a and 4b.

After every effort was made by the Executive Board to find and talk to Fred and not being able to find him, the trial proceeded. The accused was not present.

- Motion No. 2. Motion was made and seconded to have the reason for the meeting and trial to be discussed.
The motion carried unanimously.

Personal witness of Alfred Llanders, age 19 years old. Alfred was the one who went to Okla. with Fred. These are the actions the he says Fred committed. Drinking--Drunk while pastoring at Santa Maria--and in Okla.--Dancing--Adultery--Misusing church finances and desert-church and family.

- Motion No. 3. Motion was made and seconded to drop Fred Laurance from the church, and denomination and after 30 days void his Ordination papers. [His Ordination papers were turned to Bro. Boyles preceding the trial by Fred himself.]

Motion carried unanimously.

- # 3. Brother Riley Haworth has been examined and found worthy to be ordained as a deacon and it is recommended that he be ordained at the pleasure of his church. Carried.

The Minutes of the executive Board meetings held between the two quarterly meeting were read and approved as read. The meetings were: Sept 1, 1960, Delano Church was organized. Rev. Don Farris was elected Pastor.

October 26, 1960. Taft Church. Brother Norman Colecleasure was examined and ordained as a minister, since he was moving to Colorado and the ordination would allow him to start a new work in that state.

Sunday School Representative Report: By Bro. Fred Session, Bakersfield church. He stated that we were down 30 in attendance since last quarter. The Bakersfield Church recieved the banner for this quarter. South Union and Shafter were the only churches that gained in attendance. Bro. 
