

Minutes of the No. 2 Quarterly Meeting of the Southern Association

FRIDAY?, Feb. 11, 1966

The executive board oral report was given stating they had elected Bro. Hames as chairman and Don Farris as Secretary.

A motion carried that the volunteers at today's meeting be chosen as delegates to the State Association meeting. (These members were listed on the letter to the State Meeting).


The South Union Ave. Church requested the Associational meeting in February ~~1966~~. A motion carried to have the meeting there.

Bro. Gene Rogers and Bro. Scudders, from C.B.I., were visiting the quarterly meeting and Bro. Rogers, spoke on the status of the school, and encouraged support for the school.


