

Minutes of the No. 2 Quarterly Meeting of Free Will Baptists
Meeting Held at the Arvin Free Will Baptist Church, Feb. 9 and

REPORT OF SPECIAL COMMITTEE ON BACKSLIDING:

We recommend that we, the Oklahoma State Association of Free Will Baptists, go on record that we believe a person who has been regenerated or born again and is living in unconfessed, unforgiven sin, is rebellious to the principles of the Kingdom of God and His righteousness, and therefore is a backslider in a lost condition who must repent and be restored to the right relationship with God or be eternally lost.

We recognize, according to Hebrews 6:3-6, that it is possible for a person to get in the condition that he could never return to Christ. This, we believe, is apostasy. However, we also recognize that a regenerate person can fall into sin, be in a lost condition and still not be an apostate. This person, through repentance, can be reconciled to God.

The executive board report No. 2 was read recommending that Bro. Tom Hunt be licensed to preach the gospel for one year. A motion carried that he be licensed as recommended.


