A motion carried that this quarterly meeting recommend to the Southern Association that all ministers' phone numbers be listed in their minutes.





OF FREE WILL BAPTISTS meeting at the South Union Avenue Free Will
Baptist Church, August 13 and 14, 1971.

Friday Evening August 13, 1971

Congregational singing was led by Bro. Wilburn Holiday, "Glad Reunion Day" and Press Along to Glory Land".

The meeting was called to order by the moderator Rev. Arville Nelson followed by prayer by Rev. J. C. Armstrong.




Resolution committee # 2 was accepted recommending that we stand to show our appreciation for the Shafter churches hospitality for hosting this meeting.
