RESOLUTION COMMITTEE REPORT: Recommended that we give the host church a standing vote of thanks for their hospitality.

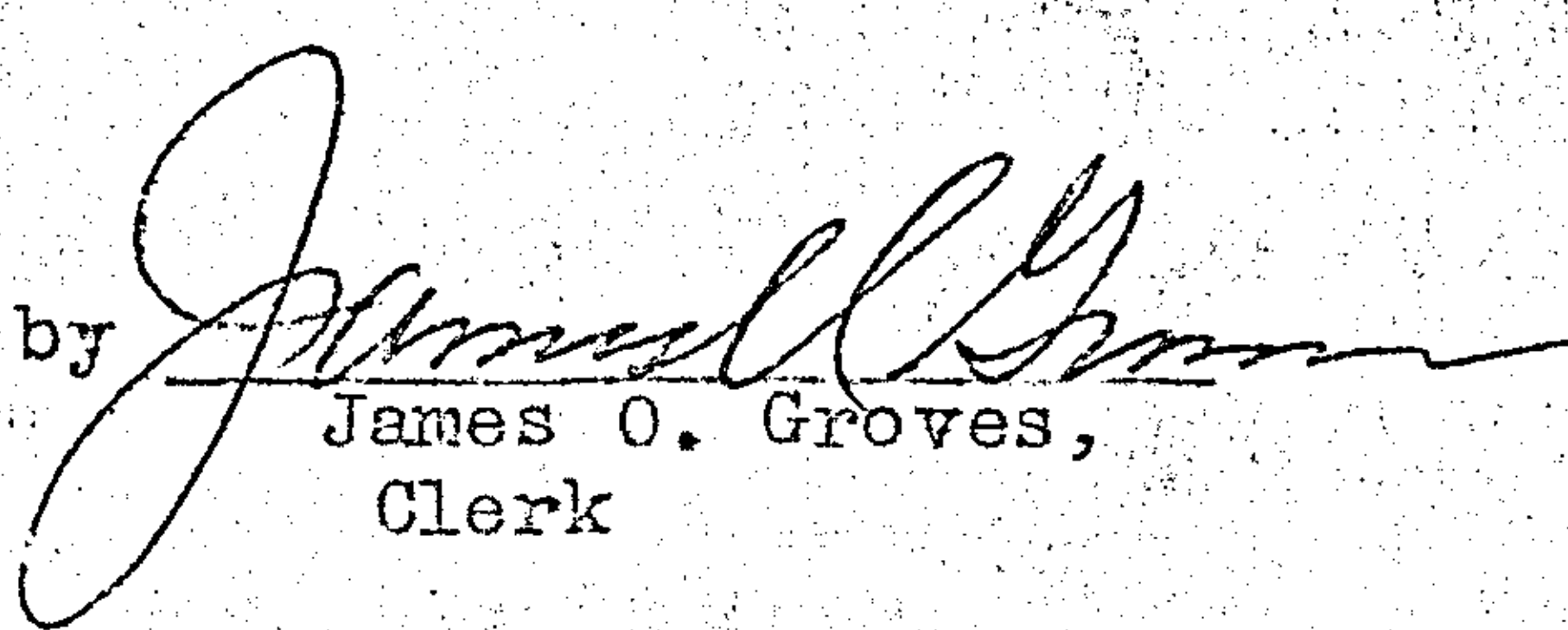

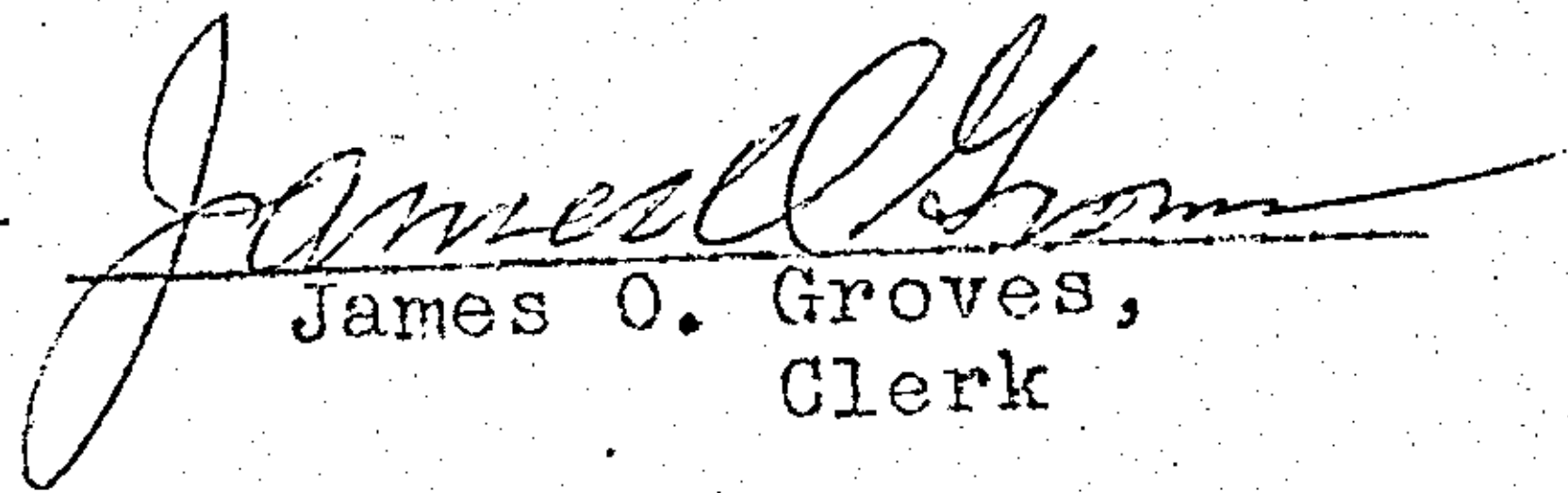

their own testimony and burden of their heart.

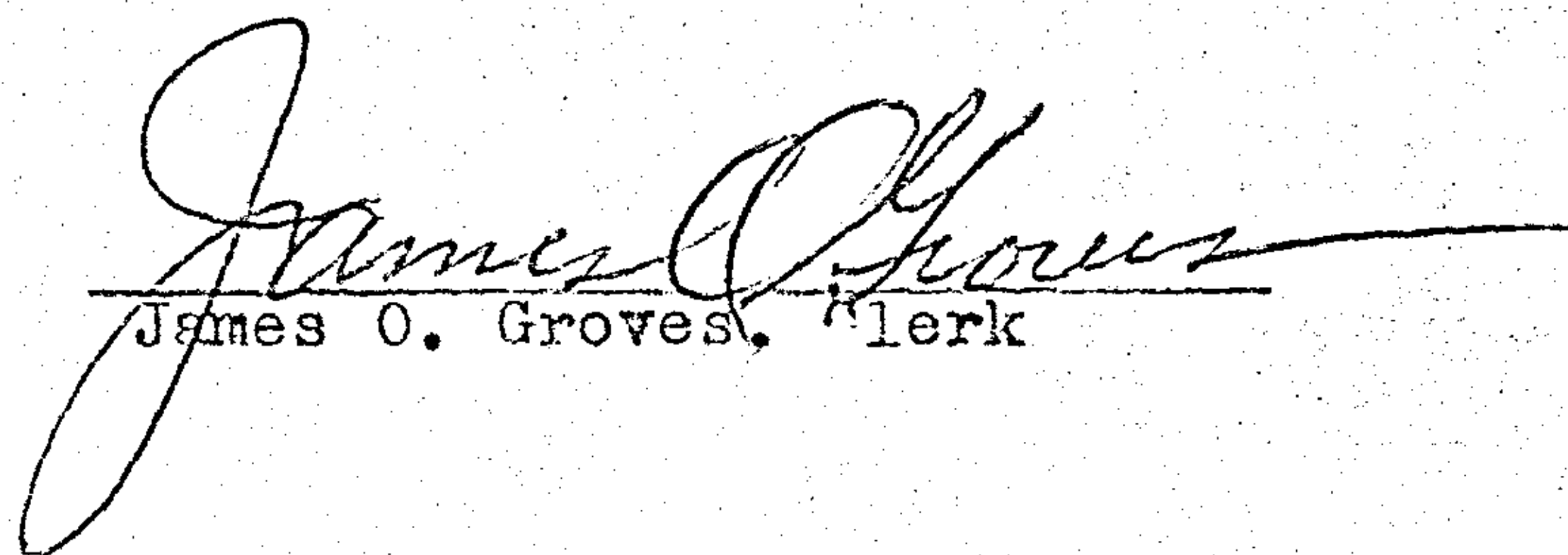

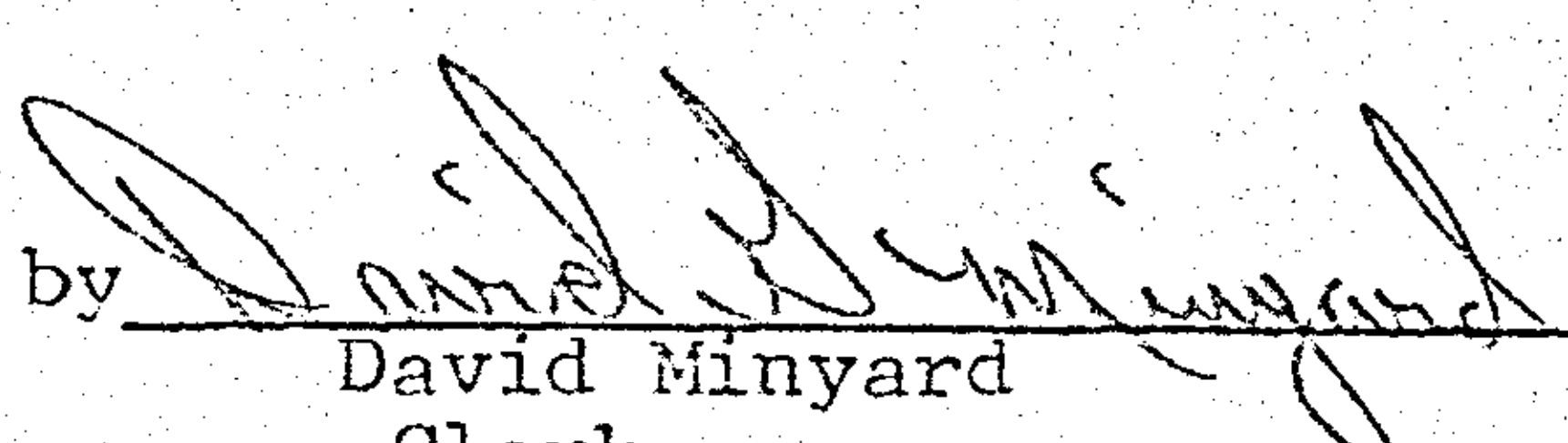
