

# PROCEEDINGS OF THE ANNUAL MEETING

# Morning Session

The Sixty-Fourth session of the Southern Union Association of Free Will Baptists met on September 22, 1990 at Camp Nebo, in Holt, Florida.

At 9:00 a.m. Bro. Ralph Bass, moderator, opened the session with a word of welcome and an invitation to the visiting brethren to be seated in the fellowship of the association. The congregation was then led by Bro. Darrell Holley in singing "We're Marching to Zion" and "All Hail the Power." Following the singing, the opening prayer was offered by Rev. L.V. Pinson. The congregation then retired to the front yard for the customary welcoming handshake.

Upon returning to the building, the reading clerk, Sis. Linda Pinson, read the church letters. (The vital statistics from those letters are contained in a chart at the end of this publication). The findings of those letters were accepted by majority vote.

The minutes of the preceding quarterly meeting were read by the interim clerk, Rev. Greg Hollifield. After the minutes were approved by the body, Bro. James Turner and Bro. Ed Bass were elected as associational deacons.

At 9:50 a.m. the meeting was dismissed for a ten minute recess so that the moderator, clerk, and treasurer might prepare nominations for the various committees. At 10:00 a.m. the body reconvened with the singing of an hymn followed by the reading of committee nominees. Nominations were accepted by majority vote and the committees were given time to convene until 10:45 a.m.

From 10:45 until 11:00 a.m. the reports from the following committees were presented: Temperance, Sunday School, Ladies Auxiliary, Resolutions, and Obituaries. Following the reading of the report from the Obituaries Committee, a moment of silence was observed.

The reading of committee reports was suspended at 11:00 a.m. for a time of worship. Bro. John Pinson led the congregation in singing "No, Not One," then Rev. Greg Hollifield presented an expository sermon from Galations 1:1-9 entitled "God's Prescription for the Soul's Disease." The body was then dismissed for lunch.

### Afternoon Session

The congregation reconvened at 1:00 p.m. with singing led by Bro. Darrell Holley. Following prayer offered by Bro. Ed Bass, the reports of the Treasurer and Suggestions Committee were given. (The contents of each report are presented in the next section).

Rev. W. A. Wilkinson presented the afternoon devotion entitled "A Definition of Faith" from Hebrews 11:1-6. At the conclusion of the devotion, an host of business matters were addressed:

The Executive Committee moved to replace Rev. Steve Hasty, who has recently moved, with Rev. Greg Hollifield.

The Ordaining Council was made complete by having Bro. James Turner replace Rev. V.C. Whittaker. Bro. John Pinson, whose term on the council expired in 1990, was reappointed by the body to continue his work there until 1995.

The Campsite Committee nominees were presented and approved. (For a listing of those on the committee, please consult the appropriate section of the Associational Directory.) Matthew Pinson was approved to be the youth camp coordinator for 1991.

Patti Hollifield and Linda Pinson were approved by the body to be delegates from our association at the state meeting to be held in Birmingham, AL.

Rev. W. A. Wilkinson reported that the balance in the camp fund as of September 22, 1990 was \$1185.16.

Nominations for association officers were then taken and voted on. The officers approved for 1991 are listed in the front of this publication.

Rev. W. A. Wilkinson gave a report on the Children's Home, and an offering of \$83.13 was collected for the Home.

Rev. L. V. Pinson presented a letter from the National Association's President of the Master's Men, James Vallance, concerning a financial need for his trip to Cuba. An offering of \$49.00 was collected for this need.

Following these matters of business, Bro. John Pinson, the chairman of the ordaining council, presented Bro. James Carden to the body for the purpose of ordination. Following the laying on of hands upon Bro. Carden, Rev. L. V. Pinson presented to Bro. Carden and his wife a charge to faithfulness in the ministry. As Bro. Darrell Holley led in singing "Faith of Our Fathers," the congregation presented the right hand of fellowship to Rev. and Sis. Carden. Rev. Carden was then appointed by the body to bring the morning message at the next annual meeting.

The Sixty-Fourth Session of the Southern Union Association of Free Will Baptists concluded in the front yard with the customary parting handshake.

- The suggestion that the Sunday School Rally be held at Camp Nebo on June 8, 1991 beginning at 10:00 a.m.

### REJECTED

- The suggestion that the number of associational meetings be reduced from four to two per year.

FIRST QUARTERLY MEETING

January 13, 1990

First Free Will Baptist Church of Pensacola

The first quarterly meeting of the decade was called to order by Rev. L.V. Pinson. Brother Darrell Holley was then called upon by Rev. Pinson to lead the congregation in singing "All Hail the Power of Jesus' Name", "O, For a Thousand Tongues to Sing", and "This is My Father's World."

Following the official word of greeting extended by the host pastor, the moderator, Ralph Bass, addressed the need of arriving on time for the meetings. (This announcement was necessitated by a recent change in the starting time for the quarterly meetings.) Then, Mr. and Mrs. Greg Hollifield were welcomed to the association.

Prior to the morning message, the congregation was led by Brother John Pinson in singing "He Lives" and "Alas and

Did My Savior Bleed." Two special musical selections were presented as well. The second was a duet by John and Matthew Pinson Singing "Now I Belong to Him." Burdened by the lack of interest in the associational meetings, Rev. L.V. Pinson presented a challenge to the body by reading a note from the 1889 minutes of the Liberty #1 Association of Free Will Baptists. To highlight the history of the Southern Union Association, Rev. W.A. Wilkinson presented a brief testimony on his role in the association. Brother Greg Hollifield was then asked to deliver the morning message. From Luke 12:13-21, Brother Hollifield presented an expository sermon entitled "The Parable of the Rich Fool/The Lonely Whine of the Top Dog." Following the message, the body was dismissed for lunch.

In the afternoon session, the body assembled by singing "Did You Think to Pray?" The moderator, after presenting an exhortation to faithfulness, asked Rev. John Whitfield to open in prayer. Brother Darrell Holley then presented a brief devotion from Paul's correspondence to the Thessalonians.

The business meeting was then conducted by Brother Ralph Bass. A letter was presented to the association from the First Free Will Baptist Church of Mobile requesting that their new pastor, Mr. Greg Hollifield, be screened for

ordination. Following an unanimous acceptance of the request, Rev. W.A. Wilkinson gave his report on the financial status of the camp.

In other matters of business: Rev. L.V. Pinson reported on the plans for the Mid-South Pastor's and Worker's Conference; the body voted to continue starting its quarterly meetings at 10:00 a.m.; and Rev. W.A. Wilkinson reminded everyone of the date for the Easter Fellowship.

While the congregation fellowshipped and sang, the ordaining council screened Brother Greg Hollifield and approved of him for ordination. In the presence of God's people, Rev. L.V. Pinson presented the charge to Brother Hollifield and exhorted his wife Patti to faithfully support her husband in the ministry to which God had called him.

After collecting an offering of \$30.00 for the Children's Home, the meeting was dismissed in prayer led by Brother John Pinson.

# SECOND QUARTERLY MEETING April 7, 1990 First Free Will Baptist Church of Mobile

In the morning session of the second quarterly meeting, Brother Ralph Bass opened by welcoming those in attendance. Rev. Steve Hasty, the minister of music in the Mobile church, then led the body in singing six hymns. Following the first two hymns, Rev. W.A. Wilkinson was asked to lead the congregation in prayer. After the fourth hymn, Brother Matthew Pinson presented a special selection in song. With the completion of the sixth hymn, Rev. Steve Hasty delivered the morning message using Matthew 20:1-16 as his text. His message, entitled "Why stand we here idle?", presented an historical overview of the Free Will Baptist movement. After the message, the host pastor dismissed the congregation for lunch.

In the afternoon session, the assembly reconvened as Rev. Steve Hasty led those present in singing two opening hymns. Between those hymns, Rev. L.V. Pinson led the congregation in prayer. Following the second hymn, Rev. W.A. Wilkinson presented the afternoon devotion from Judges 6:34-40.

To open the business session, Rev. Tony Downey led the body in prayer seeking God's direction for all that would be done. Rev. W.A. Wilkinson then reported on the financial status of Camp Nebo. Rev. L.V. Pinson followed with an update on the foreign missions outreach of Free Will Baptists.

With the presentation and acceptance of Rev. V.C. Whittaker's resignation from the office of association clerk, the assembly selected Rev. Greg Hollifield to fulfill Rev. Whittaker's term. It was at this point that the new clerk assumed his responsibility of keeping the minutes for the meeting.

Following the appointment of an interim clerk, discussion was made concerning who would take Rev. E.B. Ledlow's place as the speaker at the annual meeting. With nothing resolved concerning this matter, it was announced that the next quarterly meeting would be held at the Canaan Free Will Baptist Church, and Rev. W.A. Wilkinson reminded the body that the Easter Egg Hunt would be held at Camp Nebo on Saturday, April 14.

In other business, Rev. Greg Hollifield announced that he would be filing Form 4361 this year with the Internal Revenue Service. (Although Rev. Hollifield mistakenly referred to this form as Form 4136, he wants to go on public

record here to make the correction in case of being audited). After this announcement, an offering of \$18.50 was collected for Camp Nebo.

Thanks were then extended to the ladies of the Mobile church for their hospitality. Prayer requests were shared and Rev. Steve Hasty led the body in taking these requests to the Lord in prayer. Rev. Greg Hollifield then presented a brief report on the status of Southeastern Free Will Baptist College. Following that report, Rev. L.V. Pinson led the body in praying the dismissal prayer.

# THIRD QUARTERLY MEETING July 7, 1990 Canaan Free Will Baptist Church

Sixteen people attended the third quarterly meeting of 1990. They were called to worship by Brother Jesse Odom who led the assembly in singing "Victory in Jesus" and "More About Jesus." Between the two hymns, Brother Odom also led the body in prayer.

Brother Darrell Holley then assumed the responsibility of leading the congregation by leading in the hymns "Faith of Our Fathers", "There Is a Fountain", "Praise Him!", "Shall We Gather at the River?", and "He Hideth My Soul." After Patti Hollifield sang "My Jesus I Love Thee," the host pastor extended his official welcome. Prayer requests were then received by Rev. Downey and public prayer was led by Rev. W.A. Wilkinson.

Rev. L.V. Pinson then delivered the morning message. Using Psalm 26:1-12 as his text, Rev. Pinson presented a sermon entitled "Our Love for the Church" in which he gave five reasons one should love the church.

Following the message, Rev. Downey gave a brief testimony, and Rev. Wilkinson announced that Brother Ralph Bass would be absent for the day due to certain funerals within his community. Due to the moderator's absence, Rev. Wilkinson, as chairman of the executive committee, assumed the responsibility of directing the meeting. Brother Darrell Holley was then asked to dismiss the body in prayer prior to lunch.

After lunch, Brother Odom led the congregation in singing "The Glory-Land Way." Following prayer, led by Rev. Downey, the afternoon devotion was presented by Brother Odom from John 14:1-9.

As the business session was opened, Rev. Wilkinson announced that the next meeting would be held at Camp Nebo on Saturday, September 22. In new business, Rev. Downey proposed that the pastors and deacons from the association meet at a future date to discuss current social and associational issues. It was emphasized that such a meeting wasn't to be a formal meeting but more of an informal fellowship. It was decided in majority vote that this meeting be held on Saturday, September 8 at 10:00 a.m. at Canaan Free Will Baptist Church.

Rev. W.A. Wilkinson then presented a financial statement on the operation of Camp Nebo. With twenty-one campers in June 1990, \$380.00 was collected in camper fees. The total expense for the camp was \$442.52 leaving \$1,199.46 in the camp treasury.

Rev. Pinson then announced the current needs of Rev. R.C. Wiggins placing a great emphasis on his financial needs due to an imminent heart surgery. Afterward, an offering of \$40.67 was collected for the children's home. The meeting was then dismissed in prayer by Rev. Greg Hollifield.

# PASTORS AND DEACONS FELLOWSHIP September 8, 1990 Canaan Free Will Baptist Church

Presiding over the fellowship was Rev. Tony Downey. After a word of welcome, Brother John Pinson was asked to lead the body in singing four hymns. Following the fourth hymn, Rev. Downey opened the floor for discussion of modern issues of concern. Issues discussed included: America's involvement in the Persian Gulf crisis; making the Gospel relevant in the twentieth century; and the present apathy of the local church.

After presenting these issues to the Lord in prayer, Brother John Pinson sang "I Would Love to Tell You What I Think of Jesus." Then, Brother John was joined by his son Matthew in singing "Where Could I Go but to the Lord?" Following the singing of three more hymns led by Brother Pinson, the assembly listened to Rev. Downey deliver the morning message from I Chronicles 12. The sermon was an exhortation to consistently apply the Scriptures to twentieth century issues. The body was then dismissed for lunch. No meeting followed the lunch break.

"Verily, verily, I say unto you, the servant is not greater than his Lord." John 13:16. "If you know these things happy are ye if ye do them." John 13:17. "Because Christ also suffered for us, leaving us an example." I Peter 2:21.

### AS TO THE RULES - ARTICLE 1

- Section 1 When a sufficient number of members are ready for organization, the articles of faith and the covenant shall be read, and if adopted, the right hand of fellowship shall be extended. After prayer, they shall proceed to the election of officers, after which they shall be declared organized and ready for business.
- Section 2 No church shall be organized with less than three male members nor within six miles of another church of the same faith, unless in towns or cities.
- Section 3 The officers of a church shall be a pastor, one or more deacons, a clerk and treasurer, and not less than three trustees.
- Section 4 The church shall call their pastor at the next conference preceding the last regular conference in the associational year, unless in case of vacancy, in such a case they may call a conference for that purpose.

- Section 5 Any church, in case of necessity, may call a conference and elect one of their members or a visiting minister as moderator.
- Section 6 The church may hold a conference as often as it deems necessary.
- Section 7 It is suggested that the church commune and wash the members' feet as often as convenient, and it shall not be postponed on account of disobedient members.
- Section 8 The church shall not try a member without a hearing unless said member refuses to attend the conference when notified to do so.
- Section 9 The church is to recommend the questioning of any member for licensing, the same as for ordination.
- Section 10 A presbytery of 5 ordained men shall be appointed by the moderator to hold office for 5 years to conduct ordination of ministers or deacons for this association or any church connected with this association.
- Section 11 Deacons shall not be ordained until they are tried.
- Section 12 Each minister shall be a member of some live church and in good standing with the church.
- Section 13 It shall be the duty of every member, male or female, to attend each conference meeting if possible. On that day, the pastor is expected to instruct the church in a spiritual manner by giving plain and pointed lessons on doctrine, discipline, the rule of holy living, and the church member's duties.
- Section 14 As the Scriptures teach against worldliness in any form, be it resolved that each member seek the divine guidance of the Holy Spirit in things that pertain to holy and righteous living.

### ARTICLE 2

- Section 1 The pastor shall attend his church unless providentially hindered and shall sit as moderator to see that justice is carried out. In case of his absence, he is to appoint some suitable brother to assume his repsonsiblity when he thinks the situation warrants such action. He shall also hold a protracted meeting with his church once a year.
- Section 2 The deacons shall be elected by the church and shall hold office at the discretion of the church. They shall watch the flock, advise the unruly members, and report such to the church in conference when necessary. They may administer the ordinance of baptism, shall make all necessary arrangements for the communion, monitor the needs of the church and the support of the pastor. They shall take notice of such members who refuse or neglect to partake of the Lord's Supper and wash each other's feet, and endeavor to ascertain the cause that the same may be laid before the church in conference.
- Section 3. The clerk shall be elected by the church and shall hold office at the discretion of same. He shall keep a record of the members and minutes of the business transactions of the church and shall read the same in conference as often as the church may demand. He shall turn all books and papers over to his successor in office.
- Section 4 The treasurer shall be elected by the church, shall hold office at the will of the church, shall hold monies paid into the church for general expenses, and shall turn over all money and papers to his successor.
- Section 5 The trustees shall be elected by the church, and shall hold office for two years until their successors are elected, unless removed for cause. They shall look after the repairs of the church, but they cannot sell or otherwise dispose of the church property without an order from the church in conference.
- Section 6 No one shall be received in the church unless Scripturally baptised by immersion by an ordained baptizer.

- Section 7 Members must pay their debts contracted by themselves or make satisfactory arrangements with their creditors, and they shall help pay their pastors.
- Section 8 We recommend that each church elect a Home Missions Treasurer and all money collected for Home Missions be retained in the church and paid out only by order of the church.
- Section 9 No preacher has a right to organize and bring a church into our Association without the arm of a church in our Association to help organize and presbytery same.
- Section 10 We recommend that each ordained minister in our Association obtain credentials showing the denomination that ordained him, the name of the church, the country, and the state. If possible, the presbytery that ordained him should also be named.
- Section 11 It is required of each church to do everything possible to promote religious work by encouraging young members to speak in public in behalf of our Saviour.
- Section 12 Each church shall encourage its members to attend every conference possible, to study the minutes, follow the rules and the articles of faith which are to be read in the church at least once a year.
- Section 13 No member shall leave the house without sufficient cause nor engage in conversation without being subject to being called to order by the moderator.
- Section 14 All discussion in conference must be conducted with calmness and good feelings. Those who speak must rise to their feet, address the moderator and stay with the point in debate.
- Section 15 No member shall speak more than twice on the same subject without permission from the moderator, nor shall the remarks of any member be unreasonably long.
- Section 16 When the moderator speaks in debate, he shall nominate some other moderator in his stead.
- Section 17 No one shall be interrupted while speaking unless it is necessary to call him to order.

Section 18 The Executive Committee is the governing body of the Association to act on things pertaining to the Association when the Association is not in session.

## PERMANENT REGULATIONS

- 1. The officers shall be elected every 2 years.
- Each church may appoint up to 4 delegates to the Association each year.
- All deacons from the different churches are to be counted as standing delegates to the Association.
- Minutes will be kept by Clerk of the Quarterly Meetings and recorded in the Annual Minutes.
- 5. The clerk is to write the Resolution of Thanks.
- Each church is to record and report their Children's Home offering separte from other offerings.
- A letter of explanation from each church is to be sent in absence of representation at the Quarterly Meetings.
- No minister shall be held responsible for marrying anyone unknowingly who has previously been married, having a living husband or living wife.
- No minister is to be called as pastor or used as an evangelist in any church in this Association without being subject to questioning by the ordaining council.
- 10. No minister is to be used an an evangelist in this Association expect one of Free Will Baptist Faith.
- Each church recommend someone from their membership to be placed on the executive committee every two years.

### GUIDELINES FOR ORDINATION

- This Association ordains no man that has more than one living wife; nor a man whose wife has more than one living husband.
- Every minister carries a license until he is either called to a church or enters full time evangelistic work. The license of ministers licensed by this

Association are to be reissued each year if the church of which they are member makes this request.

- This Association ordains no one that doesn't fully believe the faith and practices of the Free Will Baptist Treatise.
- This Association ordains no one that doesn't believe and practice tithing.
- 5. This Association ordains no one that doesn't believe in the verbal inspiration of the Word of God.
- This Association will not ordain women to preach the Gospel.
- This Association will not ordain anyone that is affiliated with the World Council of Churches.
- 8. This Association will not ordain anyone with a bad testimony with them that are without.
- This Association will not ordain anyone that doesn't believe and practice the ordinances of the church.
- 10. This Association will not ordain anyone that doesn't believe a person can apostatize and be lost.

# CHURCH COVENANT

Having given ourselves to God, by faith in Jesus Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We Promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unhloy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of men.

We agree faithfully to discharge our obligations in reference to study of the Scriptures, secret prayer, family devotions, and social worship, and by self-denial, faith and good works endeavor to grow in the grace and in knowledge of our Lord and Saviour Jesus Christ.

We will not forsake the assembling of oursleves together for church conferences, public worship, and the observance of the ordinances of the gospel, nor fail to pay according to our ability for the support of the chruch, of its poor, and all its benovolent work.

We agree to acept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "Keep the unity of the Spirit" in the bonds of peace to be careful to one another's happiness and reputation, seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and the gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on Earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools and evangelistic efforts for the salvation of the world.

And may the God of Peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
