The Moderator read II Timothy 4:1-8 and gave a very interesting talk.

MC that a new Church be started in Dothan.

MC that Rev. John M. Rich had the work of the new Church under the direction of the Home Mission Board.

MC to present this matter to each Church; asking them to pledge their support in this new work.

MC to hold a two week revival conducted by Rev. Rich.

MC to ask for volunteer Sunday School teachers to work in the mission.

MC to hold this meeting the last two weeks in May.

MC to give Rev. John Edwards and Junior Ward a lot on which the tent could be placed.

MC for the adjournment of the Home Mission Board.

MC for the Executive Board to accept the movement of the Home Mission Board.

The Board members expressed their appreciation for the movement.

MC that \$25.00 of the Associational money be designated for use by the Home Mission Board in their new project.

MC for Rev. John Edwards to be in charge of publicity.

ORDAINING COUNSEL MEETING

Saturday night before second Sunday in April—First Free Will Baptist Church, Dothan

The Counsel met at the First Church in Dothan and ordained George Stephens as minister of the gospel.

August, 1959-Corinth Free Will Baptist Church

The Counsel met with Corinth and ordained Ralph Baxley as deacon of the Church.

PROCEEDINGS OF THE FIRST QUARTERLY SESSION HELD WITH HOWARD GROVE CHURCH, JANUARY 10, 1959.

The moderator called the meeting to order, and Dorman Deal led the congregation in singing. Lendon Hamrick led the opening prayer. A. C. Womack gave the morning devotional. He read from St. Luke 6:12. In his devotional remarks, he pointed out the effectiveness of prayer and its role in making the quarterly sessions successful.

Rev. S. T. Shutes gave the welcome to which Shelly Fowler gave the response. The congregation sang "What a Friend" led by Gordon Odom. Prayer was offered by Rev. John Edwards.

The moderator appointed a finance committee consisting of Lendon Hamrick, Gordon Odom, Stanley Outlaw. David Rabon and Buddie Bell were appointed reading clerks.

Ministers were recognized and a count revealed that six were present. Eight Deacons were recognized.

The Delegates were seated.

The finance committee reported \$42.50 received and report was adopted.

Congregational singing was led by Gordon Odom after which the congregation recessed for a short period.

WORSHIP HOUR

Congregational singing was led by Gordon Odom. The Moderator presented Rev. Clyde Owen, pastor of the Springhill Church, who brought a very illuminating message on prayer. The real effectiveness of prayer, He indicated, is difficult to determine. An altar prayer was led by the moderator. "Amazing Grace" was sung after which the benediction for the lunch hour was pronounced by Shelly Fowler.

AFTERNOON SESSION

After congregational singing, the afternoon devotional was brought by Rev. Stanley Outlaw, who spoke on the backward, upward, and onward look. He read from Titus 2:13.

The value of Prayer Services, a very informative talk, was given by Dorman Deal. He related the greatness of prayer through the story of Hannah and Samuel.

Young People's Auxiliaries, their purpose, organization, and functions, were then discussed by Dannie Sue Jones, who encouraged the organization of YPA's in every church in the Association.

Minutes of the Executive Board meeting were adopted.

Rev. John Edwards reported on the State Association. The report indicated the existence of a spirit of cooperation at the State Association.

Dorman Deal, newly appointed trustee for the Children's Home, reported on the Children's Home, and in so doing, stated that the Home was presently in better condition, financially, than previous reports had reflected.

MC* that the State Line Association support the dollar club of the State Association. This is voluntary contributions of individuals of 1.00 (or more) to any newly organized or organizing church in the state.

MC that the treasurer's report be adopted as read.

MC that the report of the committee on revision of the constitution be adopted. The following changes were approved. In Article 1 and Article 7,

the word annually shall be replaced with quarterly. Article 9 shall be added and shall read as follows: The quarterly sessions shall convene on Saturday before the second Sunday in January, April and July. The annual session shall convene on Thursday and Friday before the second Sunday in October.

MC that the clerk be authorized to superintend the printing of the handbook.

MC that money of old quarterly meeting be transferred to treasurer of Association.

MC that reading of quarterly and annual letters be omited and that statistical table be mimeographed and included in program. These statistics are to be compiled by the clerk and the letters to be examined by a credentials committee.

Volunteer to be Midway quarterly session was Rev. Madison Taylor.

A rising vote of thanks was given to host church.

The Association adjourned.

PROCEEDINGS OF THE SECOND QUARTERLY SESSION HELD WITH SPRINGFIELD CHURCH, APRIL 11, 1959

Congregational singing began the morning fellowship period. Rev. Paul Long, pastor of the Piney Grove Church, led the opening prayer.

Moderator appointed Dorman Deal, Madison Taylor, and Thurman Drink-water as credentials committee to examine church letters.

Moderator recognized the visiting ministers, who were Rev. Paul Long, Rev. John Rich, Rev. Rufus Hyman, and Dr. Homer Willis. Six Local ministers were recognized.

The devotional for the morning was brought by Rev. Horace Herndon, pastor of the host church, who read from Phillipians 3: 13-14, and was emphatic on the importance of unity in the local church and the Association. Unity, He said, begins in the heart of the individual.

Welcome was given by Lendon Hamrick.

Response was given by Dorman Deal.

The credentials committee reported and the report was accepted.

Finance committee appointed was Norman Smothers, Stanley Outlaw, and Gordon Odom.

Digest committee appointed was Mrs. Lewis Mallory, Mrs. Eunice Jones, and Mrs. Dorman Deal.

The delegates were seated in proper order.

A progress report, indicating several steps or growth by the individual churches, was given.

Congregational Singing preceeding the worship hour was led by Gordon Odom. Charles Mathis gave the invocation. The congregation sang "Blessed Assurance" after which Lendon Hamrick led the congregation in prayer.

The moderator presented Rev. John Edwards, member of Home Mission Board of the Association, who introduced Dr. Homer Willis, general director of Home Missions of the National Association. Dr. Willis gave information on home missionaries of the Denomination and mission work in the United States and U. S. possessions. Dr. Willis read from Acts 29:30 and spoke on carrying the message of the son of God; on the effects of preaching the gospel; and that salvation is free to all.

MC that an offering be received designating it for the Home Mission Board of the National Association.

Benediction was pronounced by Rev. Rufus Hyman.

After congregational singing, Rev. Madison Taylor brought the afternoon devotional. He read from 11 Timothy 4:1 and 11 Chronicles 7:14. He emphasized that love and unity are to be used interchangeably.

The moderator used Prov. 19:18 in speaking briefly on striving to provide for the material and spiritual things of life. He emphasized the need for expanding the work of Free Will Baptists in this Area and the need for a vision lest we perish.

Finance committee reported and report was adopted. Committee reported receipts of 45.00 for associational dues and a home mission offering of 27.45.

Digest committee reported that 10 ministers, 8 deacons, 28 delegates, and 23 visitors had registered during the day. Report of the committee was adopted.

The need for an ordaining counsel was discussed.

MC that constitution be amended so that an ordaining counsel will be maintained by the association, the counsel to have authority to establish policy regarding questioning, etc. of ministers. Amendment :MC that the counsel have power to ordain deacons, also.

MC to give the chair the authority to appoint a committee to serve in the capacity to ordain until the regular-election of officers at which time a counsel would be elected.

The chair appointed Rev. Horace Herndon, chm., Rev. John Edwards, and Rev. Madison Taylor to serve on this committee.

MC that each minister in the Association be required to make an annual (written) report; form to be used for the report to be determined by Executive Board. These reports are to be examined and approved or rejected at the descretion of the Ordaining Counsel. Ministers, whose reports are approved, are to be issued a card certifying their good standing and are to become members of the State Line Association Presbytery.

MC that treasurer's report be adopted as read.

MC that Articles of Faith as are set forth in Treatise of the Faith and Practices of Free Will Baptists be adopted for State Line Association.

A rising vote of thanks was given the host church. Benediction was pronounced by Rev. Madison Taylor. Adjournment.

PROCEEDINGS OF THE THIRD QUARTERLY SESSION HELD WITH GRANGERBURG CHURCH JULY 11, 1959.

The Association was called to order by the moderator and congregational singing was led by Norman Smothers. Rev. Rufus Hyman led the opening prayer.

Psalms 100 and 101 were read by Rev. John Edwards, who brought the morning devotional. He spoke on the creator and the individuals responsibility to recognize this supreme diety as the source of all blessings.

The moderator appointed Bryon Mallory, Billy Rabon, and Mrs. John Edwards to serve as the credentials committee.

Grangerburg extended a cordial welcome to the quarterly session of the

Association to which Dorman Deal responded for the Association.

The credentials committee reported and the delegates were properly seated.

A. C. Womack, Lendon Hamrick, and Norman Smothers were appointed to serve as a finance committee.

The Association informally discussed the progress of the quarterly session and the Association's need to launch all out for the work of the Lord. Several representatives from the various churches reported great steps of progress in their local church.

The woship hour was opened with congregational singing. Dannie Sue Jones sang "Can he depend on You".

The moderator presented Rev. Stanley Outlaw, pastor of New Hope Church. Rev. Outlaw spoke on "The laymen's role in the church". In his message he pointed out that it is essential for the laymen to cooperate, to be open-minded, to be willing, and to be submissive. He read from St. Matthew, 25: 1-13.

The benedicition for the lunch hour was pronounced by Rev. Madison Taylor.

AFTERNOON SESSION

Rev. Horace Herndon led the opening prayer.

Dorman Deal brought the afternoon devotional, which showed certain truths applicable to the Association.

A. C. Womack, Vice-Moderator of the Association, spoke on "The Layman and his Church". He listed the standards to be exemplified by the responsible Layman.

Executive Board reported and the report was adopted. (See Board reports)

Home Mission Board reported. The report traced the action of the committee, including the difficulties encountered, regarding the plans for a revival in the city of Dothan. MC that report be adopted and that offering be taken designating it for use by the Home Missions Board projects.

Offertory Prayer was offered by B. W. West.

Finance committee reported an offering of 23.90 and Associational dues of 44.50. Finance committee report was adopted.

Treasurer's report was read and adopted.

Digest committee reported 8 ministers, 31 delegates, and 20 visitors registering. The moderator called for miscellaneous business.

Clerk reported plans for printing the handbook.

Minutes of previous session were read and adopted.

A rising vote of thanks was given to Grangerburg.

Benediction was pronounced by Rev. John Edwards.

Adjournment.

PROCEEDINGS OF THE SEVENTY-FOURTH ANNUAL SESSION HELD WITH SPRINGHILL CHURCH AND UNION SPRINGS CHURCH, THURSDAY AND FRIDAY, OCTOBER 8 AND 9, 1959.

THURSDAY MORNING

Congregational singing was led by Junior Ward, and Rev. Leo Curtis prayed the opening prayer.

Welcome was given by the Pastor of Springhill Church, Rev. Clyde Owen. Rev. Horace Herndon gave the response.

Shelly Fowler, Rev. Horace Herndon, and Rev. John Edwards were appointed to serve in the capacity of credentials committee.

Rev. Lee Mixon brought the morning devotional. He read from Psalms 1 and spoke on the qualities of a strong Christian and the prerequistes of a strong Association.

Credentials Committee reported. Report was accepted and delegates were seated. Roll call indicated that 58 delegates were present.

The progress report showed an increase in membership, auxiliary enrollments, and giving as well many other steps of progress.

Call for petitionary letters was issued. None were received.

Correspondents from sister Associations were recognized. Rev. Will Hutto represented the Southeastern Association, Rev. and Mrs. Coy Watson and Rev. Barnes represented the Midway Association, and the Liberty Association was represented by Rev. Bill George.

Fourteen ministers were present. Ministers and visitors were recognized. The moderator appointed the committees. (See Committee Reports for personnel of committees.)

Finance Committee received an offering for the Children's Home.

Congregational Singing and a season of prayer preceded the morning message, which was brought by Rev. Bill George of Bonifay. He read from 11 Chronicles 20:3-4 and spoke on "Our eyes are upon Thee". He stressed that our eyes should turn from the secular things to the lasting, the eternal, the spiritual.

The congregation was dismissed for the lunch hour.

Rev. Coy Watson prayed the opening prayer for the afternoon session.

Rev. Horace Herndon read from 11 Samuel 10:1-26 in bringing the afternoon devotional. His devotional was very applicable to the Association. He was emphatic was the slowness that the Association has moved. Conservatism and tradition should be exchanged for liberality and newness of ideas. He stated that it was imperative for the Association to abandon the horse and buggy and be more progressive.

MC to accept Executive Board report. (See Board Reports)

The moderator, by way of orientating the Home Mission's Board's report, spoke on the trend of rural churches in our denomination and the need for new churches in the city and the efforts of the Board.

MC that Home Mission Board report be adopted.

MC that the five members Home Mission Board be elected with one term expiring 1960, 61, 62, 63, and 64 respectively; the chairman to be the first elected or the five year member. Thereafter, the chairman shall be the member serving his fifth year.
