

EXECUTIVE BOARD MEETINGS

October 27, 1959-First Church, Dothan

The Moderator opened the board meeting with Titus 2. Dorman Deal led the opening prayer.

The Moderator spoke on the responsibility of board members and the seriousness and Christ-likeness with which they should execute the business of the Association.

The board entered into the business period and chose the following themes for the year:

Ist Quarter-The Year of Advance . . . through Home Missions

2nd Quarter-The Year of Advance . . . through Foreign Missions

3rd Quarter-The Year of Advance . . . through the Woman's Auxiliary 4th Quarter-The Year of Advance . . . through MISSIONS

The Board then considered the business referred to it by the Association. A MSC* that the board recommend to the Association that the associational year end August 31 for the benefit of pastors who wish to move before the school year begins and to allow more time for reports to be prepared between the end of the quarter and the associational meeting. With this change the associational quarters would be: September through November; December through February; March through May; June through August, the associational year being from September 1 through August 31.

A MSC to recommend the following amendment to the Constitution: "The standing delegates shall consist of all ordained ministers and deacons belonging to the State Line Association. In addition each church shall be . . . (see Article 11 of the constitution)

By mutual consent the board agreed to cut the number of minutes printed from 500 to 400.

MSC that the clerk be authorized to purchase a filing cabinet for the Association.

The board then made an extensive study of the association and established several goals for the advance of the association.

MSC to hold regular quarterly board meetings.

MSC that the moderator be instructed to include in his opening address, remarks informing the body procedure for introducing business.

MSC that the nominations committee be instructed to select only the home for the sessions; that the responsibility of selecting speakers be discontinued and delegated to the board.

MSC to have a meeting of associational clerk and church clerks to discuss annual letter.

MSC to see that emphasis is placed on at least one denominational enterprise each year and that national figures be selected to speak, conforming with the department on which the emphasis is placed.

MSC to submit to the Home Missions Board list of recomended goals. The Home Mission Board is to be instructed to study this list article by article and to plan for the execution of such goals as it shall deem of validity. The Home Mission Board is to report to the Executive Board of its plans.

April 26, 1960-First Church, Dothan

August 16, 1960–First Church, Dothan

The Moderator called the meeting to order and brought the devotion.

The Executive Board meeting with the pastors, clerks and treasurers of associational churches entered into the business session.

The new annual letters were discussed.

MSC to pay for the reproduction of old minute books from the general fund.

The moderator announced the resignation of the treasurer, Junior Ward. MSC to appoint a treasurer to complete the unexpired term of the treasurer. David Rabon was appointed by the board to complete the unexpired term of the treasurer.

The moderator invited comments and suggestions regarding any associational project or activity.

A. C. Womack pronounced the benediction.

MSC that the board take the proposed amendments under consideration and make a report at a later date.

MSC for the board to send special letters to the former clerks of the association, inviting them to this seventy-fifth annual session.

MSC for the board to hold a special meeting at Howard Grove at 9:00 on Thursday, October 5.

September 27, 1960–Corinth Church

Rev. John Edwards, vice-chairman of the board, read I Thessalonians 1 after which Shelley Fowler lead the opening prayer.

The moderator referred the board to the unfinished business, that of considering proposed changes to the constitution. The board informally discussed the proposed change. After much consideration the board MSC to recommend to the association that the proposed decorum changes be rejected. MSC to recommend to the association that the proposed constitution changes

be rejected. MSC to recommend to the association that a committee be appointed by the chair to study the constitution, decorum and church decorum taking under consideration Rev. George Stephens' proposal, the outdated rules and regulations now a part of the constitution and decorum, and to consider rules and regulations which will more closely correlate the work of the State Line Association with the National Association. We recommend that this committee be composed of five members; that they make a report in writing at the third quarterly session so that the association may have ample time to study the proposed constitution, decorum and church decorum changes, and that this be considered for adoption at the seventy-sixth annual session.

MSC to pay Dr. Homer Willis for the National Home Mission Board not less than \$75.00 for his work in the annual session.

October 5, 1960-Howard Grove

The Executive board made the following report regarding a minister's and deacon's conference.

We recommend that we, the State Line Association, have a minister's and deacon's Conference, whereby the ministers and deacons may get together and exchange ideas. We feel that each church would benefit from such a meeting.

HOME MISSION BOARD MEETINGS

January, 1960

The Home Mission Board met and made the following plans:

MSC to recommend that each church of the State Line Association send 12.00 to the State Association designating it for the Montgomery project.

MSC to recommend that each church send an offering to each quarterly session and the annual session for the Home Mission Board.

ORDAINING COUNCIL MEETINGS

March 6, 1960-Howard Grove

The Ordaining Council met at Howard Grove Church to ordain Harold Womack as a Deacon. Rev. L. R. Curtis was appointed to fill Rev. John Edwards place and Rev. George Nobles was appointed to fill Rev. Horace Herndon's place.

Rev. Madison Taylor, Chm.

The Ordaining report referred body to constitution which gave the Council authority to set up by-laws and regulations. The Council read its adopted by-lays and stated that it had ordained Charles Mathis as a deacon at the First Church of Dothan.

PROCEEDINGS OF THE FIRST QUARTERLY SESSION HELD WITH COWARTS CREEK CHURCH, JANUARY 8, 1960

The first quarterly session opened with Dorman Deal leading the congregational singing with Norman Smothers at the piano. The Rev. John Edwards led the invocation. The morning devotional was brought by Reverend Stanley Outlaw. He spoke on Revelation 22:14. He emphasized that missions at home were just as essential as those on foreign fields.

The moderator officially opened the session. In the moderator's opening address, he commended both individuals and churches for their cooperative response to the efforts of the Association to advance. He pointed out the many increases in enrollment and memberships in the various auxiliaries of the Association. He encouraged the Home Mission Board to make efforts to organize new churches. He then appointed the Executive Board as the credentials committee.

The welcome was given by Shelley Fowler of Cowarts Creek. Billy D. Ammons of New Hope gave the response.

Gordon Odom led the congregation in singing "Showers of Blessings' after which Charles Mathis led in prayer.

The credentials committee reported and the report was accepted and delegates seated.

Sue Jordan, Billy Ammons, and Neel Rose Parramore were appointed to serve as finance committee. Eunice Jones was appointed as chairman of the digest committee for the remainder of the year and given authority to select helpers.

Congregational singing for the worship hour was led by Dorman Deal. The congregation sang "Amazing Grace" honoring the senior members of the Association. Reverend George Stephens led the opening prayer for the worship hour. The moderator then presented the speaker, Reverend L. R. Curtis,

pastor of Howard Grove. He used as his text Mark 5:19. His message reflected the necessity of cooperation and unity to make a home mission program effective.

The benediction for the lunch hour was pronounced by Junior Ward.

Congregational singing for the afternoon session was led by Dorman Deal. The afternoon devotional was brought by Reverend George Stephens, pastor of Magnolia Church. He read Acts 1:7, 8 and Matt. 28:19,20. He said we must be world-minded and at the same time recognize the importance of home missions.

Reverend John Edwards, chairman of the Home Mission Board, spoke on "The Necessity of Home Missions". He encouraged strong missions programs. Foreign missions, he said, evolve out of home missions. We, as a denomination, he indicated, are obligated to be missionaries in one way or another.

The first item of business in the business session was the report of the Executive Board. The business referred to the Board by the Association was considered first. MSC to adopt the Board's recommendation of changing the associational year from October 1 through September 30 to September 1 through August 31. The Board recommended the following amendment to the Association: Article 11 "The standing delegates shall consist of all ordained ministers and deacons belonging to the State Line Association. In addition each church shall be . . . MSC to amend the constitution by inserting in Article 11 the following: "The standing delegates shall consist of all Officers, Executive Board Members, ordained ministers and deacons. In addition each church shall be . . . (see Article II of the constitution).

The Home Mission Board made its report and MSC that the report be adopted. (See reports of boards). The Ordaining Council made its report and MSC that the report be adopted (See reports of Boards).

The finance committee reports ten churches contributing \$48.00. MSC to adopt report. Digest committee reported and MSC to adopt report.

The treasurer's report was given and MSC to accept the report. MSC to take a special offering for the Home Mission Fund. An offering of \$16.12 was received.

The annual church letter form was discussed and a MSC to adopt the form recommended by associational clerk and church clerks.

A rising vote of thanks was given Cowarts Creek Church for the wonderful hospitality shown.

Adjournment.

Benediction was pronounced by Shelley Fowler.

PROCEEDINGS OF THE SECOND QUARTERLY SESSION HELD WITH NEW HOPE CHURCH, APRIL 9, 1960

The program opened with the congregation singing "Bring them In" led by Dorman Deal. The invocation was offered by Reverend Horace Herndon.

Dorman Deal, in bringing the morning devotion, read Romans 10:14 and John 14:6 and emphasized that we should "awake unto righteousness" and put Christ first and foremost.

The session was officially opened and the moderator, in his opening remarks, reviewed the work of the Association. His report reflected certain gestures of progress made by the Association.

The Executive Board was appointed to serve as credentials committee.

A cordial welcome was given by New Hope Church. Reverend Madison Taylor gave the response. Eight ministers were recognized.

The congregation sang "Where he Leads".

The credentials committee reported the letters in order, and MSC to adopt the report of the committee. MSC to seat the delegates.

The following were appointed to serve as finance committee: T. A. Payne, L. R. Curtis, and Mrs. Mary Franklin.

The morning worship opened with inspirational singing. Reverend Clyde Owens led the invocation for the worship hour. Reverend John Edwards was presented by the moderator. He read from St. Matthew 28:16-20. He related the command "Go Ye" and brought a very challenging message on foreign missions.

The benediction for the lunch hour was pronounced by Reverend Stanley Outlaw.

Inspirational singing opened the afternoon session. M. F. Jones led the opening prayer.

Reverend Clyde Owens brought the afternoon devotion. Acts I was the scriptural scource of his informative devotion. He pointed out that one must bear a cross and be mission minded in order to wear a crown.

Reverend George Stephens spoke on the subject "The King's Marching Orders". His instructional thoughts reflected that the Christ is alive—was vindicated from the grave—is to be shared with the millions and is to be taught to the world.

In the business session, the Executive Board reported that it had not met during the quarter.

The Home Mission Board reported and MSC to adopt report.

The Ordaining Council reported and MSC to adopt report.

The finance committee suggested a mission offering, after which it reported. MSC to adopt report.

Digest committee reported and MSC to adopt the report.

Treasurer's report was given and a MSC to adopt the report.

MSC to elect associational clerk as historian of the Association.

A Minister's and Deacon's Conference was discussed and the need for one in the State Line Association was stressed. MSC for the Executive Board, and ministers who wish, to attend Minister's and Deacon's Conference of the Salem Association with the Board reporting at the next quarterly session.

Report of the Children's Home was given by Dorman Deal, a trustee of the Home.

A rising vote of thanks was given the host church.

Adjournment.

PROCEEDINGS OF THE THIRD QUARTERLY SESSION HELD WITH THE FIRST CHURCH, DOTHAN, JULY 9, 1960

Inspirational singing opened the third quarterly session of the associational year 1959-60. Lewis Mallory led the singing with Norman Smothers at the piano. Reverend Horace Herndon offered the invocation.

A cordial welcome was given by Reverend John Edwards, pastor of the host church. Norman Smothers gave the response.

The moderator officially opened the session. Orientation of new procedures of the Association followed. Byron Mallory, David Rabon, and Sheeley Fowler were appointed to serve as credentials committee.

The congregation sang "Where he leads".

Reverend Coy Watson, pastor of Shiloh Church, brought the morning devotion. He read from St. John 10:14. His devotion reflected that Jesus, as a good shepherd, endeavored to bring all the sheep together in one fold as good sheep. He pointed out the security available in the Lord.

In the progress report, it was noted that another church, Springfield, had changed from half to full time.

The credentials committee reported the letters in order. The committee, however, reported that out of the fifteen churches, reports were not received from five, whom, it suggested, that the Home Mission Board contact. MSC to adopt the report of the committee. MSC to seat the delegates.

Cecil Parramore, Mrs. Walter Houston, and Mrs. A. W. Sims were ap pointed to serve as a finance committee.

Inspirational singing preceded the morning message, which was brought by Reverend Horace Herndon. Reverend Herndon spoke from Genesis 4:9 and 10 using as his theme "Am I My Brother's Keeper". Reading also from II Cor. 3:15 and 16, he pointed out that we must first be a consecrated Christian before we can qualify as our brother's keeper. His message indicated that we, in many instances, as an association, have failed as our brother's keeper.

The benediction for the lunch hour was pronounced by Rev. George Stephens.

Inspirational singing was led by Junior Ward. Reverend Rufus Hyman, of the Union Hill Association, led the opening prayer.

Reverend Madison Taylor brought the afternoon devotion. In reading from John 17:, he spoke about the Woman's Auxiliary as a helper-a helper from which the church can greatly benefit.

Mrs. Mary Edna Cook spoke on the Woman's Auxiliary. After reading from John 4:39, Acts 16:14, she referred her audience to the role women have played in promoting the work of the Lord. The purpose of the auxiliary, she pointed out, is two-fold-to promote a missionary spirit in the church and to help people to give systematically.

Mrs. Peggy West spoke on "What a Woman's Auxiliary can mean to a Church". The Woman's Auxiliary, Mrs. West stated, strives to labor together to promote Christ's kingdom, and will make sacrifices to advance the Lord Jesus. She urged the support of the Woman's Auxiliary.

The association entered its business session. The finance committee reported a total of \$47.00 received and MSC to adopt report.

Minutes of the last Executive Board meeting were read and MSC that the minutes be adopted and the work of the Board approved.

The Home Mission Board reported. MSC to adopt the report and for an offering to be taken for the benefit of the radio program. The finance committee reported an offering of \$24.41.

The treasurer's report was given and MSC to adopt report. Adjournment.

Benediction was pronounced by Reverend Stanley Outlaw.

PROCEEDINGS OF THE SEVENTY-FIFTH ANNUAL SESSION HELD WITH HOWARD GROVE AND CORINTH CHURCHES, OCTOBER 6 AND 7, 1960

The congregation singing, "Revive us again" opened this historical session. The invocation was offered by Reverend Freeman Edwards. The welcome was given by Edna Killingsworth of Howard Grove. The response was given by Reverend Bobby G. Register, pastor of Springhill church.

The moderator officially opened the session. He read Psalms 17:15 and commended the Association for its splendid work of progress during the past year.

The moderator appointed the Executive Board as the credentials committee.

The moderator issued a call for petitionary letters with the following churches responding: Antioch, Christian Home, Panther Creek, Slocomb and Union Hill. These churches came with the following petitionary statement:

"We the following churches: Union Hill, Panther Creek, Antioch, Christian Home, and Slocomb of the Union Hill Free Will Baptist Association have disbanded as an Association and we petition the State Line Association for membership. This done by order of Association in annual session, August 26, 27, 1960."

The moderator then appointed Reverend L. R. Curtis to assist the committee.

The devotion was given by Reverend Horace Herndon, pastor of Springfield Church. He read Psalms 133 and spoke on unity and the importance of working together.

After congregational singing, Reverend T. B. Mellete led in prayer. The moderator issued a call for correspondents from Sister Associations. Reverend T. B. Mellette was recognized from the Midway Association.

The following ministers were recognized: Dr. Homer Willis, T. B. Mellette, Roy Thomas, H. Harrison, Freeman Edwards, C. R. Houston, George Stephens, Madison Taylor, John Edwards, Bobby Register, Horace Herndon, Walter Eldridge, Clyde Owens, I. O. Cook, Bill George, Ralph Bell, Trim Finch, L. R. Curtis, and Rufus Hyman.

The moderator appointed the following committees: Auxiliary, Education, Finance, Suggestions, Temperance, Character of Ministers and State of Churches (see report of committees for personnel of committees).

Former clerks of the Association were recognized. Mary Edna Cook, clerk of the Association for seven years, was presented with a plaque for her services. C. B. Green, clerk of the Association for twenty-three years, was awarded a plaque for his services.

An offering was taken for the Children's Home. Inspirational singing opened the worship hour.

The Moderator introduced Dr. Homer Willis, promotional secretary of the National Home Mission Board. He read St. Luke 10:33. Love, he said is not the most important thing in the world, but love in action is the most important. Compassion, he pointed out, is imperative for our fellow-man. His message presented a challenge to the Association.

The afternoon session began with congregational singing after which Reverend Houston led the invocation. Reverend Roy Thomas brought the devotion. Using a map, he illustrated the need for more Free Will Baptist Churches in the United States, particularly in the Northwestern United States.

He read Matt. 14-13. Our attitude, he pointed out, should be to follow Jesus and to be prolific in spreading the gospel.

Visitors from other denominations were recognized.

The credentials committee reported thirteen churches reported from the State Line Association with their letters in order and a petitionary letter from the Union Hill Association; the letter representing five of the six churches that were a member of that Association. This Association, it was pointed out had a mission established at Samson, Alabama, with an indebtedness of \$1500.00.

MSC to seat the delegates.

MSC to accept the churches of the Union Hill Association who came by petitionary letter and to accept the mission at Samson. Amended: MSC that the Trustees of the Mission be asked to waive their authority.

Minutes of the Executive Board were read MSC to adopt the report of the Board. The moderator announced that the constitution committee, authorized by the adoption of the Board's report, would be appointed at the second day of the session.

The Home Mission Board made an oral report. It reported that the response to the Home Mission project had been much greater during the last quarter than previously. MSC to accept the report.

The report of the Ordaining Council was given. MSC to accept report of the Council.

MSC to accept partial report of the digest committee.

MSC to give the right hand of Christian fellowship to the new Churches received.

The following officers were elected:
