## CONSTITUTION

1. The Association shall be known as the State Line Free Will Baptist Association of Alabama and Mississippi.

2. The Association shall be composed of ministers, deacons, and delegates of different churches forming the same.

3. All ministers and churches wishing to become members of this body must willingly submit to the Articles of Faith, Constitution and Rules of the same.

4. Each church in this Association shall be entitled to three delegates for the first hundred members or fraction thereof and one delegate for every additional fifty members.

5. This Association shall have a standing Credentials Committee composed of three members, which shall be composed of deacons. The oldest member shall be dropped each year and a new one appointed by the Moderator. Their duty shall be to examine all church letters and applications for membership, both churches and ministers and make report of same to the body.

6. Officers of this Association shall be a Moderator, Assistant Moderator, Clerk and Treasurer, Assistant Clerk and Treasurer who shall be elected by ballot at each regular session.

7. This Association shall meet on Friday and Saturday before the second Sunday in October of each year and shall not adjourn until all business is transacted.

8. The Association shall vote on where the next Association shall be held until one church gets the majority vote.

9. The Constitution, By-Laws, may be altered or amended at any regular session of this Association by a majority vote of the members present.

10. No minister, deacon or delegate shall be seated in this body unless they agree to stay throughout the session unless they are providentially hindered.

11. All ministers pastoring the Churches in the Alabama-Mississippi Association shall abide by rules of the same.

#### **DECEMBER 3, 1984**

The ministers and deacons of the Alabama-Mississippi State Line Association meet at Pleasant Ridge Free Will Baptist Church for the purpose of discussing business concerning the status of Splunge Church and ordained ministers no longer in good standing of this said body.

After much discussion and with total agreement of action to be taken, the ordaining council and credential committee was sent to talk with Conrad Whitson, Doyle Chandler and Mike Lindley, with the recommendation of asking for each one's certificate of ordination and card of good standing with a follow-up report to be given at the meeting to be held at Barnesville Free Will Baptist Church on December 17, 1984, to this same said body. Meeting was adjourned with prayer.

## **RULES OF DECORUM**

1. This Association shall be opened and closed with singing and prayer.

2. The officers elected at the previous session shall begin their administration at the opening of each regular session.

3. Only one person shall speak at a time. He shall arise and address the Moderator and when recognized he shall proceed.

4. No person shall be interrupted while speaking by anyone except by the Moderator and not by the Moderator unless he breaks the rules of order.

5. The person speaking must adhere to the subject in question and shall not use words of personal reflection.

6. No person shall speak more than twice on the same subject without leave of the association and not more than five minutes each time.

7. No member shall laugh or whisper in time of public speaking.

8. No person shall address another except by the appellation of brother or sister.

9. No member shall absent himself without leave of the Moderator.

10. The names of all ministers, deacons, and delegates shallbe enrolled by the clerk and called as often as deemed necessary by the Moderator. 11. Every member of this body shall vote for or against every move that comes before it. Those failing to do so shall be reprimanded by the Moderator.

12. Any person who shall knowingly break any of these rules shall be reproved by the Moderator according to directions of the Association.

### **RULES FOR THE PREACHERS**

1. All ministers wishing to become a member of the Association will be required to go before the Ordaining Council with a recommendation from the church of which they are a member also be called upon to present their credentials for examination and answer satisfactorily such questions as they may ask of them.

2. All preachers shall attend all business meetings unless providentially hindered.

3. Any minister who behaves himself unbecomingly to his high and exalted calling shall be reported by the Ordaining Council to the Association, who shall deal with him.

4. All ministers will be required to strictly adhere to the teaching of the Free Will Baptist, according to the Articles of Faith.

5. All ministers shall be required to support and stand by boards and committees appointed by this association and do their utmost to make them a success.

6. No minister shall speak slanderously or cast personal reflections upon another minister that will hurt his influence or ministerial standing. 7. Any minister who draws his letter from the church to which he belongs automatically cancels his credentials until he joins some other church of the same faith and order and he is not allowed to minister any rights that is allowed the minister of the gospel to perform.

#### **CHURCH RULES**

1. We agree as members of the State Line Association of the Free Will Baptist to cooperate in every move for the betterment of our denomination and the extension of God's Kindgom throughout the world.

2. We agree to meet in conference as often as necessary to transact the business of the church.

3. The Moderator shall be chosen by the sufferage of the church in the absence of the Pastor. The moderator shall observe good order and explain all questions before he takes the voice of the church on them and shall have the liberty of speech as any other, but not vote unless there is a tie, when he shall give the deciding vote.

4. It shall be the duty of all members to fill their seats in conference and bear their part of the expense.

5. No member shall leave their seat during conference without permission from the Moderator.

6. No member shall arraign another before the Church for any grievance without taking gospel steps. Matt. 18:15-17.

7. All business brought before the church by motion and second and in gospel-like order shall be attended to by the church, unless withdrawn by mover.

 Any person wishing to speak shall arise and address the Moderator and if two arise at the same time the Moderator shall decide who shall speak first and no member while speaking shall cast any reflection on any person, but shall adhere strictly to the subject under consideration.
 No member shall speak twice on the same subject without permission from the church and not more than five minutes at the time.

10. It shall be the duty of all churches' members to be present at all church meetings, to vote on all questions that come before the church when called on by the Moderator or any member of the church who desires the mind of the whole church.

11. If any member shall remain silent during the transaction of any business of the church and afterward complain of what was done, the same shall be deemed disorderly and the member so offending shall be dealt with accordingly.

12. The members of the church shall not talk about one another slanderously, nor shall give report of circulation that may arise again at any church meeting, but shall make it known to the one the report is against and to no one else and any member doing otherwise shall be dealt with accordingly.

13. We agree to do all business by a majority of the members present at any regular or called conference, providing a quorum is present, said quorum being seven (7) members or more.

14. Any member or minister of the church who talks about his brother or sister slanderously shall be dealt with according as the church sees fit.15. We recommend that each church in this Association have as many as two Sunday services each month.

16. These rules shall be read at the opening of each conference and strictly enforced by the Moderator.

## **ARTICLES OF FAITH**

1. *The Bible.* The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.

2. *God.* There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe; and in the Scriptures as Father, Son, and Holy Ghost; yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.

3. *Christ.* Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Saviour and Lord.

4. *The Holy Spirit*. The Scriptures assign to the Holy Spirit all the attributes of God.

5. *The Government of God.* God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for, as the highest welfare of men requires.

6. *The Sinfulness of Man*. Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

7. *The Work of Christ.* The Son of God by His incarnation, life, sufferings, death, and resurrection effected for all a redemption from sin that is full and free, and is the ground of salvation by faith.

8. *The Terms of Salvation*. The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith, the soul is renewed by the Holy Spirit, freed from the dominion of sin, and becomes a child of God. 3. Continuance in faith and obedience unto death.

9. Election. God determined from the beginning to save all who should

comply with the conditions of salvation. Hence by faith in Christ men become His elect.

**10**. *Freedom of the Will*. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.

11. *Salvation Free.* God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.

12. *Perseverance*. All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

13. *Gospel Ordinances*. BAPTISM, or the immersion of believers in water, and the LORD'S SUPPER, are ordinances to be perpetuated under the Gospel. FEET WASHING, an ordinance teaching humility, is of universal obligation, and is to be ministered to all true believers.

14. *Tithing*. God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel (Matt. 23:23), and the apostle Paul said, "Upon the first day of the week let every one of you lay by him in store, as God hath prospered him" (I Cor. 16:2a).

15. *The Christian Sabbath.* The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.

16. *Resurrection, Judgment, and Final Retribution.* The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."

## **CHURCH COVENANT**

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise, by His grace to love and obey him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and self-denial, faith and good works endeavor to "grow in grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel; nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "Keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it out chief business in life to extend the influence of Christ in society, constantly praying and toiling that the kingdom of God may come and his will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the World. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
