#### CONSTITUTION

- 1. The Association shall be known as the State Line Free Will Baptist Association of Alabama and Mississippi.
- 2. The Association shall be composed of ministers, deacons, and delegates of different churches forming the same.
- 3. All ministers and churches wishing to become members of this body must willingly submit to the Articles of Faith, Constitution and Rules of the same.
- 4. Each church in this Association shall be entitled to three delegates for the first hundred members or fraction thereof and one delegate for every additional fifty members.
- 5. This Association shall have a standing Credentials Committee composed of three members, which shall be composed of deacons. The oldest member shall be dropped each year and a new one appointed by the Moderator. Their duty shall be to examine all church letters and applications for membership, both churches and ministers and make report of same to the body.
- 6. Officers of this Association shall be a Moderator, Assistant Moderator, Clerk and Treasurer, Assistant Clerk and Treasurer who shall be elected by ballot at each regular session.
- 7. This association shall meet on the second Saturday in April and the second Saturday and Saturday night in October of each year and shall not adjourn until all business is transacted.
- 8. The Association shall vote on where the next Association shall be held until one church gets the majority vote.
- 9. The Constitution, By-Laws, may be altered or amended at any regular session of this Association by a majority vote of the members present.
- 10. No minister, deacon or delegate shall be seated in this body unless they agree to stay throughout the session unless they are providentially hindered.
- 11. All ministers pastoring the Churches in the Alabama-Mississippi Association shall abide by rules of the same.

#### RULES OF DECORUM

- 1. This Association shall be opened and closed with singing and prayer.
- 2. The officers elected at the previous session shall begin their administration at the opening of each regular session.
- 3. Only one person shall speak at a time. He shall arise and address the Moderator and when recognized he shall proceed.
- 4. No person shall be interrupted while speaking by anyone except by the Moderator and not by the Moderator unless he breaks the rules of order.
- 5. The person speaking must adhere to the subject in question and shall not use words of personal reflection.
- 6. No person shall speak more than twice on the same subject without leave of the association and not more than five minutes each time.
- 7. No member shall laugh or whisper in time of public speaking.
- 8. No person shall address another except by the appellation of brother or sister.
- 9. No member shall absent himself without leave of the Moderator.
- 10. The names of all ministers, deacons, and delegates shall be enrolled by the clerk and called as often as deemed necessary by the Moderator.
- 11. Every member of this body shall vote for or against every move that comes before it. Those failing to do so shall be reprimanded by the Moderator.
- 12. Any person who shall knowingly break any of these rules shall be reproved by the Moderator according to directions of the Association.

#### **RULES FOR THE PREACHERS**

(1) All ministers wishing to become a member of the Association will be required to go before the Ordaining Council with a recommendation from the church of which they are a member, also be called upon to present their credentials for examination and answer satisfactorily such questions as they

may ask of them.

- (2) All preachers shall attend all business meetings unless providentially hindered.
- (3) Any minister who behaves himself unbecomingly to his high and exalted calling shall be reported by the Ordaining Council to the Association, who shall deal with him.
- (4) All ministers will be required to strictly adhere to the teaching of the Free Will Baptist, according to the Articles of Faith.
- (5) All ministers shall be required to support and stand by boards and committees appointed by this association and do their utmost to make them a success.
- (6) No minister shall speak slanderously or cast personal reflections upon another minister that will hurt his influence or ministerial standing.
- (7) Any minister who draws his letter from the church to which he belongs automatically cancels his credentials until he joins some other church of the same faith and order and he is not allowed to minister any rights that is allowed the minister of the gospel to perform.

# **CHURCH RULES**

- (1) We agree as members of the State Line Association of the Free Will Baptist to cooperate in every move for the betterment of our denomination and the extension of God's Kingdom throughout the world.
- (2) We agree to meet in conference as often as necessary to transact the business of the church.
- (3) The Moderator shall be chosen by the sufferage of the church in the absence of the Pastor. The moderator shall observe good order and explain all questions before he takes the voice of the church on them and shall have the liberty of speech as any other, but not vote unless there is a tie, when he shall give the deciding vote.
- (4) It shall be the duty of all members to fill their seats in conference and bear their part of the expense.
- (5) No member shall leave their seat during conference without permission from the Moderator.
- (6) No member shall arraign another before the Church for any grievance without taking gospel steps. Matt. 18:15-17.
- (7) All business brought before the church by motion and second and in gospel-like order shall be attended to by the church, unless withdrawn by mover.
- (8) Any person wishing to speak shall arise and address the Moderator and if two arise at the same time the Moderator shall decide who shall speak first and no member while speaking shall cast any reflection on any peson, but shall adhere strictly to the subject under consideration.
- (9) No member shall speak twice on the same subject without permission from the church and not more than five minutes at the time.

- (10) It shall be the duty of all churches' members to be present at all church meetings, to vote on all questions that come before the church when called on by the Moderator or any member of the church who desires the mind of the whole church.
- (11). If any member shall remain silent during the transaction of any business of the church and afterward complain of what was done, the same shall be deemed disorderly and the member so offending shall be dealt with accordingly.
- (12). The members of the church shall not talk about one another slanderously, nor shall give report of circulation that may arise again at any church meeting, but shall make it known to the one the report is against and to no one else and any member doing otherwise shall be dealt with accordingly.
- (13). We agree to do all business by a majority of the members present at any regular or called conference, providing a quorum is present, said quorum being seven (7) members or more.
- (14). Any member or minister of the church who talks about his brother or sister slanderously shall be dealt with accordingly as the church sees fit.
- (15). We recommend that each church in this Association have as many as two Sunday services each month.
- (16). These rules shall be read at the opening of each conference and strictly enforced by the Moderator.

#### ARTICLES OF FAITH

- 1. The Bible. The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.
- 2. God. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe; and in the scriptures as Father, Son, and Holy Ghost; yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.
- 3. Christ. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Saviour and Lord.
- 4. The Holy Spirit. The Scriptures assign to the Holy Spirit all the attributes of God.
- 5. The Government of God. God exercises a wise and benevolent providence over all beings and all things maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for, as the highest welfare of men requires.
- 6. The Sinfulness of Man. Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

- 7. The Work of Christ. The Son of God by His incarnation, life, sufferings, death, and ressurection effected for all a redemption from sin that is full and free, and is the ground of salvation by faith.
- 8. The Terms of Salvation. The conditions of salvation are: (1) Repen tance or sincere sorrow for sin and hearty renunciation of it. (2) Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith, the soul is renewed by the Holy Spirit, freed from the dominion of sin, and becomes a child of God. (3) Continuance in faith and obedience unto death
- 9. *Election*. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect.
- 10. Freedom of the Will. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.
- 11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.
- 12. Perseverance. All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.
- 13. Gospel Ordinances. BAPTISM, or the immersion of believers in water, and the LORD'S SUPPER, are ordinances to be perpetuated under the Gospel. FEET WASHING, an ordinance teaching humility, is of universal obligation, and is to be ministered to all true believers.
- 14. *Tithing*. God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel (Matt. 23:23), and the apostle Paul said, "Upon the first day of the week let every one of you lay by him in store, as God hath prospered him" (I Cor. 16:2a).
- 15. *The Christian Sabbath*. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.
- 16. Resurrection, Judgment, and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."

#### DOCUMENTS AND ORDER OF BUSINESS

**ITEM 1:** We recommend that the Clerk be paid \$35.00 plus expenses for printing of the minutes and postage for association mailing; the Moderator \$15.00; Assistant Moderator \$10.00; the Treasurer \$5.00; Assistant Clerk \$30.00 for their services. The Clerk to superintend the printing of the minutes and distribute them.

**ITEM 2:** We recommend that the moderator preach the introductory sermon, the Assistant Moderator preach the Saturday night sermon and Holy Communion service with feetwashing in October.

**ITEM 3:** We recommend that the body decide where the next association shall convene.

**ITEM 4:** We recommend that our Saturday sessions begin at 9:00 a.m. and Saturday night session at 7:00 p.m.

**ITEM 5:** We recommend that no money be paid out of any fund except by order of the Association.

**ITEM 6:** We recommend that all pastors explain the value of tithing to various churches.

**ITEM 7:** We recommend we go on record opposing all drugs and liquor traffic and legalizing of intoxicating beverages, the ERA, Abortion on Demand and homosexuality.

ITEM 8: We recommend that our pastors preach one doctrinal sermon a year in each church.

**ITEM 9:** We recommend that the Association grant each ordained minister a card of good standing each year.

**ITEM 10:** We recommend that we do not ordain any minister with two living wives nor his wife with two living husbands.

**ITEM 11:** We recommend that any minister for two years failing to represent himself in person or by letter to the association, his name be dropped from the roll of ministers in the minutes and he not receive a card of standing.

**ITEM 12:** We recommend that each church letter to the association remain the same as was adopted in church conference.

**ITEM 13:** We recommend that our Saturday session in April convene at one church of our association and the Saturday and Saturday night session in October convene at another church of our association.

ITEM 14: We recommend we abide by the National Treaties.

**ITEM 15:** We recommend we adopt the Roberts' Rules of Order as parliamentary procedure of this association.

**ITEM 16:** We recommend that any new business coming before this body must come through the Business Committee. All requests to be submitted in writing and signed.

**ITEM 17:** We recommend we have a standing Ordaining Council to be appointed by the Moderator at the close of each session.

**ITEM 18:** We recommend we close our church year the 1st Sunday in September and that all church letters be received by the association at least 15 days before the association convenes.

**ITEM 19:** Any minister whose name has been dropped from the roll of ministers, if he wishes to be reinstated, to make his request to the Ordaining Council.

**ITEM 20:** We recommend that each church send \$1.00 per member for Association and Minute Fund, not to exceed \$125.00.

**ITEM 21:** We recommend that the Articles of Faith read verbatum to the National Treaties Articles of Faith.

**ITEM 22:** We recommend that the Business Committee be retained throughout the entire year for the purpose of preparing any business to come before the association.

**ITEM 23:** We recommend that all churches call no minister for a pastor that is not in full fellowship with some Free Will Baptist Associational body.

**ITEM 24:** We recommend that each church send a list of delegates to the clerk 10 days prior to each session.

**ITEM 25:** We recommend that the reading of the church letters before the associational body be omitted and a roll call of delegates by the clerk be made at each session.

**ITEM 26:** We recommend that all ministers provide the clerk with current addresses and phone numbers at each session.

**ITEM 27:** We recommend that the Credentials Committee, Committee on Committees and Business Committee meet with the Associational Moderator, Assistant Moderator and Clerk, at the designated place on Thursday night prior to each session.

**ITEM 28:** We recommend that this association have a standing ordaining council of three members composed of ministers of this body, with the oldest member to be dropped each year at the fall session and a new member to be appointed by the moderator.

**ITEM 29:** We recommend that all business matters to be presented before the associational body be submitted in writing, signed, to the clerk to go before the business committee 10 days prior to each session.

**ITEM 30:** We recommend that the association meet semi-annually with the first session to meet on the second (2nd) Saturday in April and the second session to meet on the second (2nd) Saturday and Saturday night of October, with the morning session to begin at 9:00 a.m. and the evening service to begin at 7:00 p.m. to include communion and feet-washing service.

#### CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise, by His grace to love and obey him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and self-denial, faith and good works endeavor to "grow in grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel; nor fail to pay according to our ability for the support of the church of its poor, and all it's benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "Keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonsih the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the kingdom of God may come and his will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the World. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
