PROCEEDINGS OF THE FIRST QUARTERLY SESSION
First FWB Church, Samson, AL
January 13, 1996

The session opened with the congregation singing, *Count Your Blessings, When We All Get to Heaven, and He Keeps Me Singing*. Bro. Van Clements led the congregational singing and Bro. Ira Cox accompanied on the piano. Bro. Lewis Mallory gave the Invocation.

The Welcome was given by the host pastor, Rev. Donald Gainey; the Response was given by Bro. Lewis Mallory.

The Clerk officially opened the Session.

In his initial remarks, the Moderator said it was good to be back at First FWB Church in Samson; it had been a long time since we had met there. He said he had had a long fellowship with the former pastor, Rev. Aubrey Brannon, who had passed away several years ago. Bro. Edwards recognized Mrs. Aubrey Brannon, his widow.

The Credentials Committee was appointed: Bro. Byron Mallory, Rev. Mike Beckon, and Bro. Braxton Click. The Finance Committee was appointed: Sis. Ann Kennedy, Sis. Maude Fowler, and Sis. Irene Ward. There were no petitionary letters or correspondence from sister associations.

Ministers and Deacons present were recognized.

Bro. Robert Paul, from the host church, read Psalm 103, commenting on certain verses, and then led in prayer.

MSC to accept the Credentials Committee Report showing all 20 churches reporting; 19 with delegates, and the recommendation to seat these delegates; The Moderator called out the church name, and the delegates stood and gave their names; the clerk checked them off by the delegates list sent in by the churches.

MSC to accept the report of the Home Missions Board: they are still supporting Rev. Dave Franks, Jr., Rev. Lynn Miley, a board member, also stated that his son, Jonathan, was is route to the Ivory Coast as a missionary for seven months. Jonathan still needs \$200.00 per month in support; his plans are to attend the University of Alabama Medical Program and become a missionary doctor.

MSC to accept the Christian Board of Education Report given by Bro. Greg Ammons.

MSC to accept the Minister's Retirement Report given by Bro. Junior Ward. MSC to accept the new guidelines prepared after a Board Meeting. Following these reports, Bro. Ward recognized the retirees or widows of retired ministers who were present: Dr. John Edwards, Mrs. Aubrey Brannon, and Rev. Madison Taylor. Two Widows are in the nursing home: Mrs. Ruby Nobles and Mrs. Addie Hyman. Mrs. Earl Stevens lives in the Corinth FWB Church community. Rev. Ralph Bell lives at home and is in very bad health.

MSC to accept the Ordaining Council's Report.

MSC to accept the Youth Camp Board's Report.

MSC to accept the Children's Home Report

MSC to accept the Treasurer's Report and the Finance Committee's Report.

MSC to accept the Registration Committee Report showing 16 ministers, 11 deacons, 42 delegates, and eight visitors for a total of 77.

The first item of miscellaneous business was adoption of the amendment to Article VIII, SECTION V of the Constitution of State Line Association. MSC to take the amendment off the table and proceed to vote. Following a motion and second for or against the motion-it was adopted.

After a 15 minute recess, Bro. Van led the congregation in singing, *Joy Unspeakable, Redeemed, and Have Faith In God*. Rev. Mike Beckon led in prayer. As a member of the Pastor's and Worker's Conference, Bro. Mike encouraged all that could to attend Feb. 5 & 6 in Florence, AL. He said more information would be coming soon.

Ushers were Bro. Lewis and Bro. Byron Mallory; Bro. Byron prayed. The offering was designated for Jonathan Miley. Rev. & Mrs. Raymond Rivers sang, *Amazing Grace* for the special music.

Bro. Dennis Woodham preached during the Morning Worship Hour, entitling his message, "The Good News." He said that Luke 11:23 could be called the overlooked beatitude; many of people are offended, but the cure to being offended is to follow Christ's command to us to 'love one another.' Home Missions and Ordaining Council had no reports.

MSC to accept the Finance Committee and Treasurer's Reports given by Sis. Ann Kennedy.

MSC to accept the Registration Committee report.

Miscellaneous Business:

Sis. Jackie Peters, President of the District WNAC, gave a report of the work; this report was received as information.

Dr. Richard Cordell gave a brief report on the Russian Project: Dr. Leroy & Faye Forlines are presently in Russia teaching; others are expected to go for tract canvassing, and then for follow-up to this; several of these ministers and laymen are from Alabama, particularly, the Madison FWB Church, Huntsville.

Rev. Jim McNeil stated that the First Church would be having some special events within the next few weeks and into the next year. He urged everyone to attend and support these Free Will Baptist endeavors.

Rev. Bobby Ned Peters gave a report on the Missions Walk-A-Thon scheduled for April 27.

Rev. Thomas Coxwell said Dave and Becky Franks, Jr., and the children would be coming early for furlough, because Becky is expecting their third child in November.

The session was recessed at 10:15 until 10:45.

Following recess, Bro. Van led the congregation in singing, *No Tears in Heaven*, and *I Want to Know More About My Lord*. Rev. Frank Fagan, pastor of New Hope, sang, *The Greatest Love Story*. The congregation then sang, *I Shall Not Be Moved* and *Come Unto Me*.

The Session began with singing directed by Bro. Van Clements; Sis. Sandra Skiles was the pianist, in the absence of Bro. Ira Cox, and Sis. Wendy Shuemake was the organist. We sang *I Would Not Be Denied*, *Faith is the Victory*, *Victory in Jesus*, *Just Over In The Glory Land*, and *What A Day That Will Be*. Rev. Ronnie Dobbs opened the Session in prayer; Rev. Mike Beckon, pastor of the host church, gave the Welcome, and Rev. Raymond Rivers gave the Response. The Clerk, Sis. Rhetta Butler, officially opened the Session.

Dr. John Edwards, Moderator, said that several years ago the Union Hill Association was organized at Union Hill. He stated that he was glad to be at Union Hill for this Session and to be able to again fellowship with those attending the Session, which is the best part of the quarterly meetings. We actually do not carry on any business; we hear the reports of the committees that have already met and conducted the business of their committee, he said.

MSC to accept the oral report given by Bro. Braxton Click, Children's Home Trustee: there are 39 children at the home; the first new building is finished and occupied; the second new building will soon get underway. It will house the kitchen, recreational room, etc.

MSC to accept the finance committee report and give the church a rising vote of thanks.

During miscellaneous business, Rev. Lonnie Skiles, Alabama Home Missions Board, reported that Rev. Dennis Haygood was on the field in East Huntsville. Bro. Lonnie asked prayer for him since he was having surgery on his throat. He also reported that the Prattville Mission was looking for another place to meet. He asked prayer for both of these items.

Rev. Bobby Ned Peters reported the LA Youth Conference would be held at Harvest July 29-31; Rev. Mike Beckon, evangelist.

Many were mentioned with physical illnesses and in need of prayer themselves as well as their families: Grace Edwards, Jan Baxley, Ruby Houston, Ralph Bell, Pauline Hasty, Starla Franklin, Lourie McNeil; and for Van Clements who has moved his business to his home.

Rev. Raymond Rivers invited all the ministers to Corinth the first Wednesday of each month for the Minister's Fellowship. Bro. Raymond also led in prayer for all the requests made.

Following recess, Bro. Van led the congregation in singing *Living By Faith, Where Could I Go?, Farther Along, The Eastern Gate, Sweet Hour of Prayer, and I Must Tell Jesus*. We had several specials: Bro. Van sang, *Beulah Land*; Rev. and Mrs. Raymond Rivers sang accapella, *What a Homecoming*; and Rev. Frank Fagan sang, *Look For Me*.

The Ushers were: Rev. Jim Osborn, Bro. Bobby Kennedy, Rev. Madison Taylor, and Rev. Jim McNeil; Bro. Osborn prayed the offertory prayer. Sis. Wendy and Sis. **PROCEEDINGS OF THE
ONE HUNDRED ELEVENTH ANNUAL SESSION
Howard Grove Free Will Baptist Church
October 12, 1996**

The Annual Session was opened with the congregation singing: *We'll Work 'Til Jesus Come, Joy Unspeakable, I Feel Like Traveling On*, and *Oh, I Want To See Him*; Bro. Van Clements led the singing, and Sis. Sandra Skiles played the piano. The Invocation was given by Bro. Lewis Mallory.

The Welcome was given by Rev. James Osborn, pastor of the host church; the Response was given by Rev. Dave Franks, Jr., Foreign Missionary to Uruguay. Bro. Dave and his family are home on furlough; Sis. Becky, his wife, is expecting their third child in November.

The Clerk officially opened the Annual Session for any business properly brought before the body. In his initial remarks, the Moderator, Dr. John Edwards, said that today was graduation day for him and Sis. Rhett. He said he had been affiliated with State Line Association for 28 years; he has never missed any of the four sessions each year, neither has he ever been late for one. He has served as Moderator for 21 years; and also served on the Mission Board, Ordaining Council, and as Assistant Moderator. When he first came to this Association, some churches did not have air conditioning; now no church is without it.

He said, "We've seen a lot of changes;...we've come a long way in that aspect, but there's a long way to go spiritually; all of us need to grow in the Lord...It's been a real privilege for me to serve in the Association. Victory Fellowship FWB Church, newly organized, petitioned for membership in our association. Pastor, Rev. Steve Sanders, presented the petition; Victory Fellowship was represented with one deacon and fees. MSC to accept them into our fellowship pending three months under the watchcare of our association. Letter of petition follow these minutes. There was no correspondence from sister associations.

The Moderator recognized 15 ministers, 12 deacons, and one visitor, Rev. Fred Jones, Missionary to Prattville, AL, our speaker for the day. Others came in later and were recorded on the registration report.

Bro. Harold Womack, deacon from the host church, brought our scripture reading and prayer; his text was Luke 10: 25-37 and Bro. Womack focused on our acts of love and kindness to our fellowmen.

GUIDELINES FOR THE STATE LINE MINISTER'S RETIREMENT

I. NAME: State Line Association Minister's Retirement

II. WHO QUALIFIES FOR BENEFITS?

- A. Any minister who has attained sixty-five (65) years of age and has pastored or is pastoring a church in the State Line Association for a minimum of five (5) years.
- B. The minister who has promoted the retirement plan for at least five (5) years and has enrolled in the program prior to April 13, 1996. Any minister who enrolls after April 13, 1996 must pastor five (5) years from the date of enrollment in a church that supports the retirement program in order to qualify.
- C. The church has contributed to the Board of Minister's Retirement regularly; either through the Association's Co-Operative Plan or directly to the Board of Retirement for at least five (5) years.
- D. The minister does not have to cease pastoring in order to be eligible for benefits.
- E. When a minister has pastored five (5) years or more in the State Line Association and has met all the qualifications for retirement, at his death, his widow would be eligible to begin drawing his retirement providing she does not remarry and her membership remains in good standing in a church which is affiliated with the Free Will Baptist Denomination.
- F. Any minister who has not reached the age of retirement and becomes physically disabled to perform his pastoral duties may apply for retirement benefits if he has fulfilled all other requirements.

III. THE MINISTER'S MEMBERSHIP

- A. The minister who has reached the age of retirement must maintain membership in a local Free Will Baptist Church which is affiliated with the local, state, and National Association of Free Will Baptists.
- B. If the minister's membership is in a Free Will Baptist Church outside the State Line Association, that church of FWB Association in which he is affiliated must submit a **letter of good standing** to the State Line Association **each year** stating that fact.

IV. RETIREMENT BENEFITS:

- A:** The retiring or disabled minister must have his church submit an application to the State Line Association for approval **before** he receives any benefits.
- B:** Benefits shall be paid according to the following scale:

| 5-10 years pastoring | \$25.00 per month |
| 10-15 years pastoring | \$50.00 per month |
| 15-20 years pastoring | \$75.00 per month |
| Over 20 years pastoring | \$100.00 per month |
- C:** If funds are not available, all retirees benefits shall be prorated.
- D:** Birthday and Christmas bonuses will be determined by the Board of Retirement as funds are available.
- E:** Pastoring outside the State Line Association will not be used in calculating benefits.
- F:** Pastoring a church in the State Line Association after **April 13, 1996** that does **not** support the Minister's Retirement Plan will not be used in calculating benefits.
- G:** The retired ministers shall be governed by the State Line Association Presbytery's rules.
- H:** The retirees are urged to attend all Associational Meetings.
- I:** These guidelines will not effect those who are already receiving retirement benefits.

Please note: Changes have been made to Section II B, & E; Section III A, & B; Section IV A, F, G, H, & I.

Second Quarterly Session:

On March 12, 1996, a reminder, along with an application and guidelines for the Minister's Retirement Program was sent to pastors and/or church clerks who, at that time, had still not enrolled in the program.

As the new adopted policy states, if the church or pastor does not enroll by April 13, 1996, the pastor cannot be grandfathered into the program. His retirement period will begin from the date of application. As of April 2nd, the following have not responded:

We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end, we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

STATE LINE ASSOCIATION CONSTITUTION ADOPTED APRIL 7, 1962

Article I - Name

This organization shall be known as the State Line Association of Free Will Baptists.

Article II - Composition

This Association shall be composed of such regularly organized and well-disciplined Free Will Baptist Churches, conveniently located as may embody themselves under this Constitution.

Article III - Representation

SECTION I: (Standing Delegates) All elected officers, Board members, licensed ministers, ordained ministers, and ordained deacons who are members of a member church shall be standing delegates.

SECTION II: (Elected Delegates) Each church shall be entitled one (1) delegate for every twenty-five (25) members and one (1) delegate for the fractional part of twenty-five (25) members, it shall be entitled to two (2) delegates.

SECTION III: (Certification) No one will be seated as an elected delegate unless they are certified as such on their church letter.

Article IV - Admission

SECTION I: (Churches) Newly constituted or other churches maintaining gospel order, and preaching, agreeing with the denomination in doctrine and practices, as are contained in the NATIONAL TREATISE OF FAITH AND PRACTICE OF THE ORIGINAL FREE WILL BAPTIST, in favor of benevolent enterprises such as Sunday School, C. T. S., missions, and education, desiring admission into this union shall petition with delegates and letter at any session, and if, upon examination, are found to be orthodox and orderly, after not less than three (3) months under the watch-care of the Association, shall be received into the Association, and such reception shall be manifested by the right hand of Christian fellowship given by the chair.

SECTION II: (Ministers) Admission of ministers shall be subject to a recommendation of the Ordaining Council and approval of the Association.

Article V - Discipline

SECTION I: (Duties) Any church who shall fail to attend three successive sessions and whosoever shall be generally remiss, and whosoever shall fail to conform to the practices and adopt the doctrine of the Free Will Baptist Denomination, and whosoever shall fail to comply with the rules, regulations, and decisions of this Association shall be subject to discipline and exclusion.

SECTION II: (Duties of Moderator) The Moderator shall preside over all sessions and shall serve as chairman of the General Board and Executive Committee.

SECTION III: (Power) This Association shall have no authority and/or power in the internal affairs of any church in this Association, nor shall they have any power over the property of any church.

Article VI - General Officers

SECTION I: (Officers) The officers of this Association shall be a Moderator, Assistant Moderator, Clerk, Assistant Clerk, and Treasurer, who shall be elected annually, and who shall be a member of a member church.

SECTION II: (Duties of Moderator) The Moderator shall preside over all sessions and shall serve as chairman of the General Board and Executive Committee.

SECTION III: (Duties of the Assistant Moderator) The Assistant Moderator shall assist the Moderator and act as Moderator in the Moderator's absence.

SECTION IV: (Duties of the Clerk) The clerk shall record and preserve the proceedings of the body when in session and shall record and preserve the proceedings of the General Board. He shall compile and have published the minutes of the Association. All records shall be delivered to his successor in office.

SECTION V: (Duties of the Treasurer) The treasurer shall receive all funds and shall be responsible to give a correct account of all funds received and disbursed by him.

Article VII - Boards

SECTION I: (Standing Boards) Standing Boards of the Association shall include the General Board, Executive Committee, Home Mission Board, Board of Minister's Retirement, Ordaining Council, Board of Christian Education and the Youth Camp Board.

SECTION II: (Personnel) Standing Boards, exclusive of the General Board and Executive Board, shall be elected as follows: the first named for a term of one year, the second for a term of two years, and the third for a term of three years, and so forth. Succession to the office thereafter shall be as order requires.

SECTION III: (General Board) The General Board shall be composed of the Moderator, the Assistant Moderator, the Clerk, and the Treasurer, and one representative from each church. The names of the representatives shall be submitted by each church at the annual session and shall be elected by the body.

SECTION IV: (Duties of the General Board) The General Board shall have power to act in behalf of, and for the Association from one regular session to another, to carry out the plans and undertakings of the Association, to fill any irregular vacancies that may occur in any department between sessions of the Association, to plan a program of work for the Association, and to handle all matters coming within the scope of the work of the Association. It shall be the duty of this Board to make written reports of all its work to each of the Associational sessions for final approval.

SECTION V: (Executive Committee) The Executive Committee shall be composed of the Moderator, Clerk and five (5) members of the General Board. The General Board will elect these five members. It shall be the duty of the Executive Committee to transact emergency business when the Association is not in session. The Executive Committee shall give a written report of business transacted at each session of the Association.

SECTION VI: (Duties of Boards) It shall be the duty of the various standing Boards to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their work as may become necessary and create such by-laws as may be deemed essential for thier government, consistent with the constitution. It shall be the duty of such Board to make a written report at each session of the Association for final approval.

Article VIII - Finance

SECTION I: (Policy) The financial policy of the Association shall be the giving of tithes and offerings. It is suggested that each church pay 10 per cent of its income to the association.

SECTION II: (Offerings) A free will offering shall be received at each session.

SECTION III: (Disbursements) All disbursements shall be made by check and all checks shall be signed by the moderator and the treasurer.

SECTION IV: (Budget) Each standing Board shall prepare a budget of its proposed financial expenditures at the beginning of each Associational year and present same for approval of the Association before any expenditures are made for the year.

SECTION V: (Unified Treasury) funds of all departments shall be handled by the treasurer of the Association. Designated and Co-Operative funds cannot be transferred from one account to another.

Article IX - Meeting

SECTION I: The Association shall convene quarterly. The first and second quarterly sessions shall convene on Saturday before the second Sunday in January and April. The third quarterly session shall convene on the last Saturday in June. The fourth meeting shall be the annual session and shall convene for one day, which shall be on Saturday before the second Sunday in October.

Article X - Alteration

This constitution may be amended or altered at any regular session by a two-thirds vote of members present provided proposed amendment or alteration has been presented in writing at the previous session.

BY-LAWS OF THE STATE LINE ASSOCIATION ADOPTED APRIL 7, 1962

1. Each meeting shall be opened by reading a portion of the Bible and with prayer and shall be closed with prayer.
2. Questions of fellowship, expulsion, and all other items of business of the Association shall be settled according to the NATIONAL TREATISE OF FAITH AND PRACTICES OF THE ORIGINAL FREE WILL BAPTISTS.
3. All business of the Association shall be brought before the body by move and second and shall be disposed of according to Robert's Rules of Order.
4. The associational year shall begin September 1 and end August 31.
5. Churches and their pastors shall serve as committees and shall be named by the chair at least three months before the annual session.
6. Each church shall send a letter to each session certifying the election of their delegates and containing general, financial, and statistical information about their church and any other information that the Association may request.

7. No church shall be recognized in this body who does not commune and wash feet at least once a year.

8. By a two-thirds vote of all members present a ruling of the Moderator can be over-ruled.

9. It shall be the duty of the moderation to seat all delegates in a designated section of the assembly room at the beginning of each business session.

10. No member shall absent himself while the Association is in session without first obtaining permission from the moderator.

11. No person shall be allowed to speak more than ten minutes nor twice on the same subject without special permission from the moderator.

12. No person shall be allowed to nominate more than one member provided the person nominated is elected.

13. Ministers pastoring in the State Line Association of Free Will Baptists must be in good standing with a local Association of Free Will Baptists which is affiliated with a State Association of Free Will Baptists which is affiliated with the National Association of Free Will Baptists. A minister pastoring in the State Line Association and his wife if married must not have two living wives or husbands. Any church in the State Line Association that calls a pastor not meeting the above qualifications will automatically be out of fellowship with the State Line Association. (Anyone who has been divorced and remarried is considered as having two living wives or husbands.)

14. These by-laws may be amended or altered at any regular session by two-thirds vote of members present, provided proposed amendment or alteration is presented in writing.

STATE LINE ASSOCIATION By-Laws of the Presbytery

MINISTERS

1. Admission and Standing

(A) Candidates for licensing and Ordination

1. An individual shall first unite with a church that is a member of the Association.

2. This church shall petition the Association through the Ordaining Council of the Association for licensing and ordination of its candidate.

(B) Ordained and licensed ministers coming from other Associations.

1. He must unite with a church in the State Line Association.

2. His church must petition for his membership in the Associa-

tion through the Ordaining Council of the Association. This must be done by the next Associational meeting after calling the pastor.

3. Any church who calls a pastor who does not wish to unite with the Association must be examined by the Ordaining Council. This must be done by the next Associational meeting after calling the pastor.

(C) Ministers coming from other denominations.

1. He must first unite with a church in the State Line Association.

2. This church must petition for his membership in the Association through the Ordaining Council of the Association.

II. Qualifications.

(A) Licensed

1. The individual must satisfactorily answer questions prepared by the Ordaining Council.

2. Candidates that are married must not have more than one living wife or candidates wife must not have more than one living husband.

3. He must be of sound character.

4. He must abstain from the use of any alcohol beverages and, or the use of tobacco.

(B) Ordination

1. The individual must satisfactorily answer questions prepared by the Ordaining Council.

2. Candidates that are married must not have more than one living wife or candidates wife must not have more than one living husband.

3. He must be of sound character.

4. He must abstain from the use of any alcohol beverages and, or the use of tobacco.

5. He must hold license for not less than one year before applying for ordination.

6. He must be called to a Christian work or presently enrolled in Free Will Baptist Bible College and completed at least one year before applying for ordination.

(C) Ministers Making Application From Other Association:

1. Must present license or ordination certificate to Ordaining Council for ratification by Council.

2. He must present a letter of recommendation from Association from which he comes or from his licensing body which is affiliated with a State Association of Free Will Baptists which is affiliated with the National Association of Free Will Baptist, provided he was licensed or ordained by this licensing body.

(D) Ministers Making Applications From Other Denominations:

(a) Licensed

1. Must surrender license from denomination of which he was previously a member.
2. Must hold FWB license for one year before ordination.
3. He must answer questions prepared by Ordaining Council.

(b) Ordained

1. Must have ordination papers ratified by Ordaining Council.
2. Must answer questions prepared by Ordaining Council for ordination.
3. He will not be re-ordained, but upon approval of the Ordaining, he will be granted a FWB Ordination Certificate.

DEACONS

MSC that the local church be allowed to examine and ordain its deacons if it so chooses or send them to the Association if they desire.

I. Deacons Sent to Association for Ordination:

1. He must be a member of a church in the State Line Association.
2. He must have been elected by his church to the office of deacon.
3. The church shall petition the Association through the Ordaining Council of the Association for ordination of its candidate.

II. Qualifications

1. He must be of sound character.
2. He must be the husband of one wife and candidates wife must be the wife of one husband.
3. He must believe and practice FWB doctrine.
