

James Osborn about the pay of our guest speakers. The answer was their expenses are paid. They receive an honorarium and the offering. Board was reminded we usually use local pastors for the quarterly sessions.

MSC to elect the following Executive Board to handle emergency business that may arise in the Association in between sessions: Bro. Tommy Taylor, Rev. Dennis Woodham, Bro. Lewis Mallory, Bro. Levy Parramore, Rev. James Osborn, The Moderator, Assistant Moderator, Clerk, Treasurer. The Moderator will serve as Chairman. Move was made to accept by Bro. Lewis Mallory; second by Bro. Earl Culpepper.

MISCELLANEOUS BUSINESS: Rev. Jim McNeil discussed the Acts 148 plan for support of our foreign missionaries. The plan has been adopted and

implemented by the State Association. The plan is not mandatory for our churches to support but strongly encouraged. Alabama's program is a modification of the Arkansas plan. Most of the other states have already adopted a plan for each state to support their own. If we don't support our own, they will be basically without support. Guidelines for determining percent of support are in place. Alabama is phasing into supporting our own missionaries assuming 70% in 1998; 80% in 1999; 90% in 2000; 100% by 2001. Program begins January 1, 1998. The budget is \$192,000. Shares will be broken down into 1000 shares. Three percent will go for administrative costs. The "Share Plan" is method for churches to support the program. Shares will be adopted by our churches or individuals to be paid by the month. We will "pool" our resources to finance our missionaries. This is a program whereby our missionaries home on leave will not have to spend all their time traveling all over the U.S. raising support. Rev. McNeil asked for some time at January session to address the new program.

MSC to recommend adoption of the program to the association at the January session. Move by Bro. Lewis Mallory; second by Bro. Earl Culpepper.

Rev. John Edwards announced November is Home Missions month. Offerings received in this month are used to finance the National Home Missions Office.

Dave Franks, Jr. and Family are scheduled to leave for Uruguay November 24th announced by Rev. Edwards. Dave Franks, Jr. Sunday will be observed at Eastside on November 16th.

The Moderator said he would like to have a meeting of the General Board and Chairpersons of all the other boards before our January Quarterly Session. Each board is requested to present a "Plan of Work" for this association year. This would let us all work together in a coordinated manner. The meeting is schedule for January 5th at First Church. Clerk is to send out letters to General Board members and Board Chairpersons.

Rev. McNeil said he would like to see the Association support the State Promotional Office.

Move to adjourn. Dismissed with prayer.

#### GENERAL BOARD MEETING JANUARY 5, 1998 - FIRST CHURCH, DOTHAN

The meeting was called to order by the Moderator, Rev. Bobby Peters. He welcomed Board members and visitors. Moderator read Hebrews 4:12-13. He said he was glad to be a part of the association. "It makes me able to reach more; it helps me fulfill my part of the Great Commission," he said. The Moderator asked for us to pray for Rev. Dennis Woodham and Rev. James Osborn, who have been sick. Rev. Osborn had surgery in December. Bro. David Miller led in prayer.

Sis. Ann Kennedy was unable to be present but had sent a copy of the financial report for associational year 96-97. The Moderator mentioned the idea of each church paying their share of the Association's dues to the State Association which is \$50.00 per church in the association. The State Association sends \$35.00 of this to the National Association for dues. The Moderator said we cut down on the number of copies of the Associational Minutes and shopped around and got the best price we could find to cut down on expenses from the General Fund. We got 200 copies for \$1060.00 (including tax) which was a savings of \$674.00 from last year's cost. The Moderator requested each church be conservative in the number of copies they pick up to assure all churches get what they need. It was the consensus of General Board Members present that very few copies are used in each church. Rev. McNeil suggested we might find ways to cut down even further on cost of minutes for the next year.

Sis. Wendy Shumake, Chairperson of the Christian Board of Education, said the Christian Board has discussed some ideas on a lock-in and youth rally but things were kind of up in the air right now until the proposed amendment to merge the Christian Board and Youth Camp Boards was voted on at the January Quarterly Session.

Rev. Mike Beckon represented the Youth Camp Board. The proposed date for 1998 camp is June 22-26, 1998, at the Vineyard. Cost will remain at \$99.00. He reported the 1998 Youth Retreat held January 2, 3 was successful. Rev. Danny Smith was speaker. Sixty young people attended. Another retreat is being planned for January 1999. Some ideas they have thought about if the amendment is approved are Couples Retreat; Alternative for Halloween; College Day; Pastor's and Men's Retreat; Prom Alternative; Women's Retreat; a music group for the young people.

Bro. Earl Culpepper represented the Home Mission Board. He submitted the following report from the Home Mission Board: They recommend the Board buy four shares of The Acts 1:8 Plan (Mission Support Plan). Give the balance of their share of the budget to the Jeff Turnbough (Spain) Account. Their requested budget is \$1500.00. The Moderator commented on a proposed mission conference scheduled for January 29 - February 1. Churches from this area were placed on the end of the North Alabama Mission Conference. There will be further comments below.

The Moderator went on record as favoring passage of the amendment to merge Christian Board and Youth Camp Board.

The question was asked of the Board members how many of the churches would be in favor of paying their share of the dues to the State Association. He asked for a show of hands. Most were in favor.

Rev. Wayne Parker asked the question, "Should we talk about the 'What if's' should the amendment be approved?" The Moderator said we should and come up with a good recommendation to present to the Associational Body.

Question from Bro. Harvey Windham, New Hope Board Member. "If the Christian Board recommendations were not supported in the past, why do we expect our churches to support the combined board?"

The All Boards Members recommend to the Association Body: That the amendment to combine the Christian Education Board and the Youth Camp Board into one Board be approved and the newly combined Youth and Education Board consist of the eight members which now make up these two boards. Two members would be rotated off each year as already established for the next three years and only one member each year be elected to the Youth and Education Board. At the end of three years, the new board would be down to a five member board. The combined board would be responsible for electing a chairman as provided by our constitution. Move was made by Bro. Lewis Mallory; second by Bro. Junior Ward. Move was carried. Plan of support would be to receive combined per cent of the Associational Plan of Support which is 24%. Move by Bro. David Miller; second by Bro. Lewis Mallory. Move was carried.

Rev. Jim McNeil discussed the Acts 1:8 Mission Support Plan. Two churches have pulled out of the Missions Conference scheduled for January 29 - February 1. It was the consensus of the Board to re-schedule the conference for a later date and get better organized. He said North Alabama had been having a very successful conference for 25 years. Bro. Earl Culpepper asked why the Turnboughs support was dropped from the list to be supported by Alabama. Rev. McNeil said they get their support from Tennessee and Missouri. He explained that just pastoring a few years in a state did not qualify one for support. He said the State appointed Board had assistance from the National Mission Board in establishing the guidelines.

Rev. Rick Cash is new State Promotional Director.

Question was asked by Bro. Junior Ward, "Did you mention removal of the word "Home" from the Home Mission Board?" The Moderator said yes, this would allow for broader coverage of all missions.

Bro. Levy Parramore said our pastors need to really push support of the Association from the pulpit. The Board was in agreement.

It was consensus of the Board to take a further look into the matter of each church paying their dues.

MSC to adjourn. Dismissed by Rev. Bobby Peters.

#### PROCEEDINGS OF THE FIRST QUARTERLY SESSION EASTSIDE FWB CHURCH, DOTHAN, AL January 10, 1998

The session opened with the congregation singing "Joy Unspeakable," "Dwelling In Beulah Land," "It Is No Secret," "Just Over In The Glory Land," The Moderator, Rev. Bobby Peters, requested special prayer for Rev. Dennis Woodham and Rev. James Osborn who have been sick for sometime. Rev. Osborn has been in the hospital since mid December. Rev. Woodham is undergoing treatment. Prayer was led by Rev. Jim McNeil. Singing was led by Bro. Van Clements; pianist was Sis. Saundra Skiles. Bro. Junior Ward gave the invocation. Welcome was by Rev. John Edwards, Host Church and Response was by Rev. Joe Beckon, First Church, Dothan.

The session was opened by the clerk, Sis. Loretta Culpepper. Initial remarks by the Moderator were brief. He appointed the Credentials Committee consisting of: Rev. Jim McNeil, Bro. David Miller, Rev. Joe Beckon. Finance Committee appointed was: Sis. Ann Kennedy, Sis. Sue Sanders, Sis. Martha Clements.

Call for Petitionary Letters was responded to by the clerk reading a letter from New Harmony FWB Church, Rev. Larry Dykes, Pastor. Rev. Irvin Hyman, Albany, GA, who is interim pastor at Pine Hill FWB Church, responded to correspondence from sister associations.

There were 16 ministers and 10 deacons recognized.

Scripture reading and prayer was by Host Church pastor, Rev. John Edwards. He read from John 14.

MSC to accept the Credentials Committee report and seat the delegates. Roll called by clerk.

MSC to remove from the table Constitutional Amendment to Article VII, Section I, "Boards." It reads:

ARTICLE VII - BOARDS SECTION I: (Standing Boards) Standing Boards of the Association shall include the General Board, Executive Committee, Home Mission Board, Board of Minister's Retirement, Ordaining Council, Board of Christian Education and the Youth Camp Board.

Recommended change reads:

ARTICLE VII - BOARDS SECTION I: (Standing Boards) Standing Boards of the Association shall include the General Board, Executive Committee, Missions Board, Board of Minister's Retirement, Ordaining Council, and the Youth and Education Board.

Amendment was removed from the table and read by the Moderator. He asked for any questions. He asked all in favor to stand. Majority present approved the amendment. No votes against.

General Board proceedings presented by clerk for November 9, 1997 and January 5, 1998 meetings. (See General Board Minutes for proceedings.) The following recommendations were presented to the body for consideration. (1) "The General Board recommends adoption of the Acts 1:8

Missionary Support Plan adopted by the Alabama State Association at the 1997 Annual Meeting." The Acts 1:8 Plan was explained by Rev. Jim McNeil, State Moderator, Alabama patterned this program after Arkansas' plan. Their plan has been very successful. This is a plan designed to underwrite the support of foreign missionaries from Alabama by putting the responsibility of raising support on the local churches rather than the missionary. Under this plan we will be getting missionaries to the field more guickly, more economically and more refreshed and will promote strong personal ties between our missionaries and our Alabama churches. Each missionary with strong residency ties to the state will be eligible for support. The plan for Alabama is to assume 70% of support in 1998; 80% in 1999; 90% in 2000; full support in 2001. This first year will cost \$192,000. This has been broken down into 1000 shares which will cost \$192.00 per year or \$16.00 per month. Churches, Sunday Schools, individuals are all encouraged to purchase shares. Each missionary eligible will receive a per cent of his/her support based on how strong the residency ties are. The State Association overwhelmingly endorsed this plan. Rev. McNeil reported the program is moving well in North Alabama. A move to accept by Rev. Thomas Coxwell, second by Bro. Lewis Mallory, Bro. Byron Mallory guestioned about why Missionaries Jeff and Susan Turnbough were not on the support list. He feels they should not have been removed. Rev. McNeil's response was that the state committee appointed to administer the program researched where missionaries were born, where most of their life was spent in determining their residency. He said the Turnboughs are being taken care of by Tennessee and Missouri. Move was adopted by standing vote, no votes opposing. The motion carried. Designate your money going to Acts 1:8 Mission Support Plan and send to Alabama State Association of FWB, ATTN: Rick Cash, POB 9, Guin, AL 35563. Pamphlets explaining the program were passed out and pastors and delegates encouraged to take this information back to their churches.

(2) Recommendation from General Board and the Chair Persons of the Other Standing Boards that were present at the January 5 Board Meeting recommends adoption of the following:

"That the amendment to combine the Christian Education Board and the Youth Camp Board into one Board be approved and the newly combined Youth and Education Board consists of the eight members which now make up these two boards. Two members would be rotated off each year as already established for the next three years and only one member be elected to the Youth and Education Board each year. At the end of three years, the new board would be down to a five member board. The combined board would be responsible for electing a chairman as provided by our constitution. Plan of support would be to receive combined per cent of the Associational Plan of Support which is 24%."

Move to accept General Board's recommendation by Rev. Jim McNeil, second Bro. Lewis Mallory. Question by Rev. Ronnie Dobbs - "Why bring members down to five?" Moderator's answer, "Five is sufficient number." Motion approved by a standing vote majority. No opposing votes. Motion carried.

Mission Board Report was given by Bro. Byron Mallory. He made a move to accept. (See Mission Board Report for 1-10-98 for report.) Rev. Jim McNeil raised a question, "Can we designate money since we have accepted the Acts 1:8 Program?" Rev. John Edwards said, "I would like a legality check." Rev. Jim McNeil questioned whether to recommend outflow of funds when they, the Board, might need money down the line for some other program like a missions conference. Moderator inserted that there might be a missions rally on January 31 at the end of the North Alabama Missions Conference that would come under the scope of the Missions Board and some of the churches would be having the Missionaries on Sunday after. Bro. Earl Culpepper, member of the Mission Board, said they had not heard anything about a conference until the General Board meeting on January 5. The Moderator said all he could do was apologize that the Mission Board had not been told. At this point, Bro. Byron Mallory said he was handing in his letter of resignation from the Mission Board. The Moderator said he would like for him to stay on the Board but if that was what he wanted that he would accept his letter. The letter is attached as Attachment 1 to these minutes. Mr. Mallory's resignation was accepted. Rev. Ronnie Dobbs asked the question from the floor if the vacancy created by the resignation would be filled today. The Moderator said yes and asked for a volunteer. No one volunteered. He asked for a nomination from the floor. No nomination. He started to move on with other business but Bro. Tommy Taylor said he would volunteer. The Body approved Bro. Tommy Taylor to fill the term which expires in 1999.

Since the Christian Education Board and Youth Camp Board merged, the Christian Board of Education was not asked for a report. MSC to accept reports from Minister's Retirement, Ordaining Council, Youth and Education, Children's Home, Finance and Registration. Treasurer's Report was given by Sis. Ann Kennedy. MSC to accept Treasurer's report.

Miscellaneous Business. Rev. Fred Hersey, former missionary to Japan, said he is now residing in Dothan. He will be with the Missions Board through February. Then he will be unemployed. It was announced that Sis. Ann Kennedy's mother is in the hospital.

Announcements: The Associational Minutes are available at front of church.

Pastors' and Workers' Conference will be at Northport, February 16-18.

First Church Dothan needs to swap times to host association in April. Bro. Levy Parramore said he had discussed with his pastor and Magnolia would exchange times. The April session will be held at Magnolia, the June session will be held at First Church Dothan.

Jackie Peters said WNAC would have a lunch time meeting today in the Primary Sunday School Room.

First Church will host Rick Amato on Sunday night, January 18 at 6 P.M. The young people from all the churches are invited to attend.

A Memorial Singing for Rev. Madison Taylor will be held at Pine Hill on February 21 at 7 P.M. Everyone is invited.

Adjourned for recess.

Worship service began with congregational singing. Bro. Van organized a choir to help him. Songs were "Til The Storm Passes By," "Jesus Hold My Hand," "I Want To Know More About My Lord," "He's Been So Good To Me," Rev. Thomas Coxwell led in prayer. The choir sang a special song, "Come Unto Me."

Rev. Thomas Coxwell, Bro. Chris Mitchell, Rev. Ronnie Dobbs, Bro. Lewis Mallory were ushers, Bro. Lewis led in offertory prayer. MSC to give offering to the General Fund.

Morning Message was brought by Rev. Mike Beckon. Rev. Frank Fagan could not be here. Rev. Beckon's scripture was Rev. 3:14-22. John on the Isle of Patmos wrote about the seven churches. His writings are as current as the morning paper. The church needs the fire of the Almighty God. In the story of Elijah on Mt. Carmel, the refreshing rain did not come down until the fire of God fell to consume the sacrifice, the altar and all the water round about the altar.

Rev. John Edwards gave instructions for lunch. Rev. E.R. Mayo asked the blessing on the food. Meeting adjourned.

He said it broke his heart when he saw the attendance on Roll Call Sunday, March 29th. ### CHURCH COVENANT

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel; nor fail to pay according to our ability for the support of the church, or its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace. To be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel. We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end, we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

# STATE LINE ASSOCIATION CONSTITUTION ADOPTED APRIL 7, 1962

Article I - Name

This organization shall be known as the State Line Association of Free Will Baptists.

Article II - Composition

This Association shall be composed of such regularly organized and well-disciplined Free Will Baptist Churches, coveniently located as may embody themselves under this Constitution.

Article III - Representation

SECTION 1: (Standing Delegates) All elected officers, Board members, licensed ministers, ordained ministers, and ordained deacons who are members of a member church shall be standing delegates.

SECTION II: (Elected Delegates) Each church shall be entitled one (1) delegate for every twenty-five (25) members and one (1) delegate for the fractional part of twenty-five (25) members,

it shall be entitled to two (2) delegates.

SECTION III: (Certification) No one will be seated as an elected delegate unless they are certified as such on their church letter.

# Article IV - Admission

SECTION 1: (Churches) Newly constituted or other churches maintaining gospel order, and preaching, agreeing with the denomination in doctrine and practices, as are contained in the NATIONAL TREATISE OF FAITH AND PRACTICE OF THE ORIGINAL FREE WILL BAPTIST, in favor of benevolent enterprises such as Sunday School, C. T. S., missions, and education, desiring admission into this union shall petition with delegates and letter at any session, and if, upon examination, are found to be orthodox and orderly, after not less than three (3) months under the watch-care of the Association, shall be received into the Association, and such reception shall be manifested by the right hand of Christian fellowship given by the chair.

SECTION II: (Ministers) Admission of ministers shall be subject to a recommendation of the Ordaining Council and approval

of the Association.

Article V - Discipline

SECTION I: (Duties) Any church who shall fail to attend three successive sessions and whosoever shall be generally remiss, and whosoever shall fail to conform to the practices and adopt the doctrine of the Free Will Baptist Denomination, and whosoever shall fail to comply with the rules, regulations, and decisions of this Association shall be subject to discipline and exclusion.

SECTION II: (Duties of Moderator) The Moderator shall preside over all sessions and shall serve as chairman of the General

Board and Executive Committee.

SECTION III: (Power) This Association shall have no authority and/or power in the internal affairs of any church in this Association, nor shall they have any power over the property of any church.

Article VI - General Officers

SECTION I: (Officers) The officers of this Association shall be a Moderator, Assistant Moderator, Clerk, Assistant Clerk, and Treasurer, who shall be elected annually, and who shall be a member of a member church.

SECTION II: (Duties of Moderator) The Moderator shall preside over all sessions and shall serve as chairman of the General Board and Executive Committee.

SECTION III: (Duties of the Assistant Moderator) The Assistant Moderator shall assist the Moderator and act as Moderator in the Moderator's absence.

SECTION IV: (Duties of the Clerk) The clerk shall record and preserve the proceedings of the body when in session and shall record and preserve the proceedings of the General Board. He shall compile and have published the minutes of the Association. All records shall be delivered to his successor in office.

SECTION V: (Duties of the Treasurer) The treasurer shall receive all funds and shall be responsible to give a correct account of all funds received and disbursed by him.

### Article VII - Boards

SECTION I: (Standing Boards) Standing Boards of the Association shall include the General Board, Executive Committee, Missions Board, Board of Minister's Retirement, Ordaining Council, Youth and Education Board.

SECTION II: (Personnel) Standing Boards, exclusive of the General Board and Executive Board, shall be elected as follows: the first named for a term of one year, the second for a term of two years, and the third for a term of three years, and so forth. Succession to the office thereafter shall be as order requires.

SECTION III: (General Board) The General Board shall be composed of the Moderator, the Assistant Moderator, the Clerk, and the Treasurer, and one representative from each church. The names of the representatives shall be submitted by each church at the annual session and shall be elected by the body.

SECTION IV: (Duties of the General Board) The General Board shall have power to act in behalf of, and for the Association from one regular session to another, to carry out the plans and undertakings of the Association, to fill any irregular vacancies that may occur in any department between sessions of the Association, to plan a program of work for the Association, and to handle all matters coming within the scope of the work of the Association. It shall be the duty of this Board to make written reports of all its work to each of the Associational sessions for final approval.

SECTION V: (Executive Committee) The Executive Committee shall be composed of the Moderator, Assistant Moderator, Clerk, Treasurer, and five (5) members of the General Board. The General Board will elect these five members. It shall be the duty of the Executive Committee to transact emergency business when the Association is not in session. The Executive Committee shall give a written report of business transacted at each session of the Association.

SECTION VI: (Duties of Boards) It shall be the duty of the various standing Boards to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their work as may become necessary and create such by-laws as may be deemed essential for thier government, consistent with the constitution. It shall be the duty of such Board to make a written report at each session of the Association for final approval.

### Article VIII - Finance

SECTION I: (Policy) The financial policy of the Association shall be the giving of tithes and offerings. It is suggested that each church pay 10 per cent of its income to the association.

SECTION II: (Offerings) A free will offering shall be received at each session.

SECTION III: (Disbursements) All disbursements shall be made by check and all checks shall be signed by the moderator and the treasurer.

SECTION IV: (Budget) Each standing Board shall prepare a budget of its proposed financial expenditures at the beginning of each Associational year and present same for approval of the Association before any expenditures are made for the year.

SECTION V: (Unified Treasury) funds of all departments shall be handled by the treasurer of the Association. Designated and Co-Operative funds cannot be transferred from one account to another.

Article IX - Meeting

SECTION I: The Association shall convene quarterly. The first and second quarterly sessions shall convene on Saturday before the second Sunday in January and April. The third quarterly session shall convene on the last Saturday in June. The fourth meeting shall be the annual session and shall convene for one day, which shall be on Saturday before the second Sunday in October.

Article X - Alteration

This constitution may be amended or altered at any regular session by a two-thirds vote of members present provided proposed amendment or alteration has been presented in writing at the previous session.

### BY-LAWS OF THE STATE LINE ASSOCIATION ADOPTED APRIL 7, 1962

- 1. Each meeting shall be opened by reading a portion of the Bible and with prayer and shall be closed with prayer.
- 2. Questions of fellowship, expulsion, and all other items of business of the Association shall be settled according to the NATIONAL TREATISE OF FAITH AND PRACTICES OF THE ORIGINAL FREE WILL BAPTISTS.
- 3. All business of the Association shall be brought before the body by move and second and shall be disposed of according to Robert's Rules of Order.
- 4. The associational year shall begin September 1 and end August 31.
- 5. Churches and their pastors shall serve as committees and shall be named by the chair at least three months before the annual session.
- 6. Each church shall send a letter to each session certifying the election of their delegates and containing general, financial, and statistical information about their church and any other information that the Association may request.

7. No church shall be recognized in this body who does not commune and wash feet at least once a year.

8. By a two-thirds vote of all members present a ruling of the

Moderator can be over-ruled.

- 9. It shall be the duty of the moderation to seat all delegates in a designated section of the assembly room at the beginning of each business session.
- 10. No member shall absent himself while the Association is in session without first obtaining permission from the moderator.
- 11. No person shall be allowed to speak more than ten minutes nor twice on the same subject without special permission from the moderator.

12. No person shall be allowed to nominate more than one member provided the person nominated is elected.

- 13. Ministers pastoring in the State Line Association of Free Will Baptists must be in good standing with a local Association of Free Will Baptists which is affiliated with a State Association of Free Will Baptists which is affiliated with the National Association of Free Will Baptists. A minister pastoring in the State Line Association and his wife if married must not have two living wives or husbands. Any church in the State Line Association that calls a pastor not meeting the above qualifications will automatically be out of fellowship with the State Line Association. (Anyone who has been divorced and remarried is considered as having two living wives or husbands.)
- 14. These by-laws may be amended or altered at any regular session by two-thirds vote of members present, provided proposed amendment or alteration is presented in writing.

### STATE LINE ASSOCIATION By-Laws of the Presbytery

#### MINISTERS

1. Admission and Standing

(A) Candidates for licensing and Ordination

1. An individual shall first unite with a church that is a member of the Association.

- 2. This church shall petition the Association through the Ordaining Council of the Association for licensing and ordination of its candidate.
- (B) Ordained and licensed ministers coming from other Associations.
- 1. He must unite with a church in the State Line Association.
- 2. His church must petition for his membership in the Associa-

tion through the Ordaining Council of the Association. This must be done by the next Associational meeting after calling the pastor.

3. Any church who calls a pastor who does not wish to unite with the Association must be examined by the Ordaining Council. This must be done by the next Associational meeting after calling the pastor.

(C) Ministers coming from other denominations.

- 1. He must first unite with a church in the State Line Associa-
- 2. This church must petition for his membership in the Association through the Ordaining Council of the Association.

### II. Qualifications.

(A) Licensed

1. The individual must satisfactorily answer questions pre-

pared by the Ordaining Council.

2. Candidates that are married must not have more than one living wife or candidates wife must not have more than one living husband.

3. He must be of sound character.

4. He must abstain from the use of any alcohol beverages and, or the use of tobacco.

(B) Ordination

1. The individual must satisfactorily answer questions prepared by the Ordaining Council.

2. Candidates that are married must not have more than one living wife or candidates wife must not have more than one living husband.

3. He must be of sound character.

- 4. He must abstain from the use of any alcohol beverages and, or the use of tobacco.
- 5. He must hold license for not less than one year before applying for ordination.
- 6. He must be called to a Christian work or presently enrolled in Free Will Baptist Bible College and completed at least one year before applying for ordination.
- (C) Ministers Making Application From Other Association:
- 1. Must present license or ordination certificate to Ordaining Council for ratification by Council.
- 2. He must present a letter of recommendation from Association from which he comes or from his licensing body which is affiliated with a State Association of Free Will Baptists which is affiliated with the National Association of Free Will Baptist, provided he was licensed or ordained by this licensing body.

- (D) Ministers Making Applications From Other Denominations:
- (a) Licensed
- 1. Must surrender license from denomination of which he was previously a member.
- 2. Must hold FWB license for one year before ordination.
- 3. He must answer questions prepared by Ordaining Council.
- (b) Ordained
- 1. Must have ordination papers ratified by Ordaining Council.
- 2. Must answer questions prepared by Ordaining Council for ordination.
- 3. He will not be re-ordained, but upon approval of the Ordaining, he will be granted a FWB Ordination Certificate.

  DEACONS

MSC that the local church be allowed to examine and ordain its deacons if it so chooses or send them to the Association if they desire.

- I. Deacons Sent to Association for Ordination:
  - 1. He must be a member of a church in the State Line Association.
  - 2. He must have been elected by his church to the office of deacon.
  - 3. The church shall petition the Association through the Ordaining Council of the Association for ordination of its candidate.
- II. Qualifications
  - 1. He must be of sound character.
  - 2. He must be the husband of one wife and candidates wife must be the wife of one husband.
  - 3. He must believe and practice FWB doctrine.

### **GUIDELINES FOR THE STATE LINE MINISTER'S RETIREMENT**

I. NAME: State Line Association Minister's Retirement

### II. WHO QUALIFIES FOR BENEFITS?

- A. Any minister who has attained sixty-five (65) years of age and has pastored or is pastoring a church in the State Line Association for a minimum of five (5) years.
- B. The minister who has promoted the retirement plan for at least five (5) years and has enrolled in the program prior to April 13, 1996. Any minister who enrolls after April 13, 1996 must pastor five (5) years from the date of enrollment in a church that supports the retirement program in order to qualify.
- C. The church has contributed to the Board of Minister's Retirement regularly; either through the Association's Co-Operative Plan or directly to the Board of Retirement for at least five (5) years.
- D. The minister does not have to cease pastoring in order to be eligible for benefits.
- E. When a minister has pastored five (5) years or more in the State Line Association and has met all the qualifications for retirement, at his death, his widow would be eligible to begin drawing his retirement providing she does not remarry and her membership remains in good standing in a church which is affiliated with the Free Will Baptist Denomination.
- F. Any minister who has not reached the age of retirement and becomes physically disabled to perform his pastoral duties may apply for retirement benefits if he has fulfilled all other requirements.

### III. THE MINISTER'S MEMBERSHIP

- A. The minister who has reached the age of retirement must maintain membership in a local Free Will Baptist Church which is affiliated with the local, state, and National Association of Free Will Baptists.
- B. If the minister's membership is in a Free Will Baptist Church outside the State Line Association, that church of FWB Association in which he is affiliated must submit a letter of good standing to the State Line Association each year stating that fact.

### IV. RETIREMENT BENEFITS:

- A: The retiring or disabled minister must have his church submit an application to the State Line Association for approval before he receives any benefits.
- B. Benefits shall be paid according to the following scale:

5-10 years pastoring \$25.00 per month 10-15 years pastoring \$50.00 per month 15-20 years pastoring \$75.00 per month Over 20 years pastoring \$100.00 per month

- C. If funds are not available, all retirees benefits shall be prorated.
- D. Birthday and Christmas bonuses will be determined by the Board of Retirement as funds are available.
- E. Pastoring outside the State Line Association will not be used in calculating benefits.
- F. Pastoring a church in the State Line Association after April 13, 1996 that does not support the Minister's Retirement Plan will not be used in calculating benefits.
- G. The retired ministers shall be governed by the State Line Association Presbytery's rules.
- H. The retirees are urged to attend all Associational Meetings.
- These guidelines will not effect those who are already receiving retirement benefits.
