## DECLARATION OF RIGHTS

Section 1. That all power of the church government is inherent in the people and the preachers; that is, that they may have a right through their representatives, to establish, alter or amend their form of church government, two-thirds agreeing thereto.

Section 2. That a Christian church is a society of believers in Christ, and is a divine institution, Jesus Christ being the head of the Church and the Bible the only rule of our faith and practice.

Section 3. That no rule of faith and doctrine shall ever be established in the Freewill Baptist Church contrary to the Bible.

Section 4. No person who loves the Lord Jesus Christ and obeys the Gospel should ever be deprived of church membership.

Section 5. Every member has inalienable right to private judgment in matters of religion and may speak freely of the same in a way that will not violate the law of God, or the law of their country, or the rights of their fellowman.

Section 6. Church trials should be conducted on Gospel principles only, and no minister or member should be excommunicated except for immorality, the propagation of un-Christian doctrine, neglect of duty enjoined by the word of God, or the rules of the Church.

Section 7. The Church has a right to form and enforce such rules and regulations only as are in accordance with the Holy Scriptures, and may be necessary to carry into effect the great system of practical Christianity.

Section 8. There may be three grades of association established in the Freewill Baptist Church. First the Monthly Association, second, the Annual Association, third the General Association.

Section 9. That the church has a right to select their leaders and delegates to the annual association.

Section 10. It shall be the duty of each church to select two deacons and one clerk.

Section 11. It shall be the duty of the different church clerks to keep a correct minute of all their church meetings in a book provided for that purpose.

Section 12. Each church represented in the annual association shall be entitled to two delegate voters, whose membership does not exceed 50 and one additional for every 25 over 50.

Section 13. That for the purpose of ordaining elders, there shall convene a Presby. Said Presby shall consist of five ordained elders. It shall be the duty of said Presbytery to examine all applicants that may come before them for license and ordination, and if found competent, shall ordain them or set apart for the work by prayer and laying on of hands. Said Presbytery shall have full power to try ministers and deacons, composing this association, for immorality, propagation of un-Christian doctrine, neglect of duty enjoined by the word of God or the rules of the church, on proper testimony: their word to be final. Any member of the Presby being absent at a meeting the moderator has the right to select another ordained elder to take his place in that session of business.

Section 14. No minister shall be ordained to the office of elder unless they meet the requirements as stated in I Tim. 3:1-7, and pass a satisfactory examination upon the subject of repentance, faith, justification, the door of the church, water baptism, the Lord's Supper, washing the saint's feet, and transaction of church business in general.

Section 15. Any one who desires the office of elder shall take the following steps before presenting himself for ordination. He must come to the Presbytery recommended by church letter for license; He must be a member of the church that recommends him, and if found competent they shall issue license; after he has had his license one year, he shall go before the Presbytery with church letter recommending him for ordination, and if found worthy on second examination, they shall ordain him.

Section 16. That for the purpose of receiving licentiates or ordained ministers from other denominations who come to us well recommended we receive them and ratify their license or credentials.

Section 17. It shall be the duty of the Presbytery to give a letter of dismissal and recommendation to any ordained minister, if in good standing, wishing to leave our association.

Section 18. It shall be the duty of any minister coming before the Presbytery for license or ordination, or to have their credentials ratified, that they must belong to a Freewill Baptist Church in Stone Association, and bring a letter of recommendation from same.

Section 19. That any minister being called from another Association to pastor a church in Stone Association of Central Indiana, must come before presbytery for examination.

Section 20. Forbidding any one hereafter having more than one wife, to be ordained for either a minister or a deacon. Also that if and when any of the present ministers or deacons become the husband of more than one wife, or marry a woman with a living husband, his ordination would automatically be annulled.

Section 21. No woman will be licensed or ordained to the office of elder.

Section 22. Be it resolved that all members be in subjection unto their elders and unto those who would have rule over them in the Lord.

Section 23. Be it resolved that no minister be allowed to aid or abet either directly or indirectly in the manufacture of intoxicating drinks or to indulge in the sale of them.

Section 24. It shall be the duty of any member wishing to leave the Freewill Baptist Church to call for a letter before leaving.

## **RULES OF DECORUM**

Section 1. No complaint shall be brought in the church against transgressing members until the aggrieved party complies with the directions given by our Lord in St. Matthew 18: 13, 17.



Section 2. It shall be the duty of the deacon of the church to go to any transgressing member, talk to them and they shall have until the second church meeting to make reconciliation. It may be the duty of the church to choose a committee to settle questions of aggrieved causes. It shall also be the duty of the deacons to look after the widows in their daily ministrations. Rom. 16: 17; II Cor. 12: 21; II Cor. 13: 1.

Section 3. It shall be the duty of the Stewards to advise the church to promote means to sustain the church and preachers. I Cor. 16: 1, 2; II Cor. 9: 7; Luke 10: 7; I Cor. 9: 14.

Section 4. It shall be the duty of each minister on receiving members in the church, to ask the applicant the following questions: First—"Do you feel that you love God with all your heart, soul, mind, and strength?" Second—"Are you a believer with all your heart that Jesus Christ is the son of God?" Third—"Are you willing to walk in all His precepts?" We take members into the Freewill Baptist Church by Conversion, Letter and Recommendation. Matt. 22:37; Acts 8: 37; John 13: 1, 17; I Cor. 11: 20, 22; Luke 22: 18, 20; Matt. 26: 26, 29.

## ARTICLES OF FAITH

Article 1. We believe in one eternal God, the Creator and Up-holder of all things and in Jesus Christ, His Son, and in the Holy Ghost, and that these three are one. St. John 1:1; I Cor. 8: 6; St. John 10: 30.

Article 2. We believe the Holy Scriptures of the Old and New Testaments to be the Word of God, and the only rule of Faith and Practice: II Pet. 1: 19-20; II Tim. 3: 14-17; Dan. 10: 21; Acts 1: 16-17; Matt. 21: 42.

Article 3. We believe that man is unable to recover himself from the fallen state that he is in, by reason of sin, only by the grace of God through the exercise of faith Gen. 1:27; Gen. 2:16-17; Psalms 51:5; Rom. 5: 12-19; John 3: 5-7; Eph. 2: 3.

Article 4. We believe that baptism and the Lord's Supper and the washing of the saint's feet are ordinances of Jesus Christ and that immersion is the only mode of baptism; not the putting away of the filth of the flesh, but the answer of a good conscience toward God by the resurrection of Jesus Christ. Matt. 3: 14-16; Matt. 3: 5-6; I Pet. 3: 21; John 3: 21; Acts 10: 47; Matt. 28: 19; Luke 22: 18-20; I Cor. 11: 20-29; John 13: 1-17; Matt. 26: 26-29.

Article 5. We believe that no minister has the right to administer these ordinances except such as are regularly ordained. I Tim. 4: 14; Acts 8: 17-19; II Tim. 1: Heb. 6: 2.

Article 6. We believe in the resurrection of the dead, a general judgment, the punishment of the wicked, and the joys of the righteous are eternal. Matt. 28: 6; John 5: 28-29; I Cor. 15: 51-58; John 11: 25; II Thess. 1: 4-9; Rev. 14: 9-13; Luke 16: 23; Rom. 2: 4-5; II Cor. 5: 10; Matt. 12: 36; Rev. 20: 11-15; Matt. 25: 41; Acts 17: 13; Isa. 33: 14.

Article 7. We believe according to the Scriptures; Paul's letter to the Hebrews 6:1-7; that after man has been made partaker of the Holy Ghost if he shall fall from Grace, it is impossible to renew him again unto repentance, or restore him unto the favor of God. Heb. 6: 1-7; I John 5: 16.

Article 8. We believe that a man can make shipwreck of his faith. Rom. 8: 38-39; I Cor. 10: 9; Job 17: 9; Matt. 16: 18; John 10: 27-28; Phil. 1: 6; II Chron. 15: II Pet. 1: 10; Ezek. 33: 18; John 15: 16; I Cor. 10: 12; Heb. 12: 15; I Chron. 28: 9; Rev. 2: 4-5; Acts 1: 25; Matt. 24: 13; Rev. 22: 19; Phil. 3: 11-14.

Article 9. We believe that sanctification is the work of God's Grace, by which the soul is cleansed from all sin and wholly consecrated to Christ. It takes place in the Spiritual Birth, constantly growing in the Grace and the Knowledge of our Lord Jesus Christ and becomes final at the end. Heb. 12: 14; Phil. 3: 21; I Cor. 6: 11; II Thess. 2: 13; II Thess. 5: 19-23; John 17: 17-19; II Tim. 2: 20-21.

Article 10. We believe that all Christians have a right to the sacramental table upon the principles of their acceptance with him, for St. Paul says: "But let a man examine himself, and let him eat of that bread and drink of that cup." I Corinthians 11: 28."

## OFFICERS AND THEIR DUTIES

Pastor. It is the pastor's duty faithfully to preach the word, to have the general superintendence of the church. To be himself an example of the flock, to visit the members, especially the sick, as he has the opportunity, and to do all within his power to promote the religious interest of the church which he serves, and to advance the cause of Christ among men.

Deacon. The deacons are elected for life or during of good behavior. They should be men distinguished among their brethren for piety and benevolence. Before entering upon the duties of their office they are ordained by the Presby. Ordination consisting of charges, laying on of hands and prayer. It is their duty to serve at the Lord's table. To distribute of the bounty of the church among its needy members, to visit the sick, to assist the pastor in promoting order in attendance upon the church, and to conduct religious meetings in the absence of the pastor.

Clerk. It is the duty of the clerk to keep a church book and in it record the church covenant, and the names of the members, all the proceedings of the church, and the exercise of its doctrine and management of its temporal affairs. They also sign all the letters and other communications made by authority of the church.

Treasurer. The treasurer shall be entrusted with the funds of the church, and it shall be their duty to keep a regular account of all the money received, and make a report of the same annually to the church or as often as the church requires. Funds shall be drawn on the treasury only by the order of the church.

## RULES OF CONFERENCE AND ASSOCIATION

1. The Association and Conference when met shall be opened and closed by singing and prayer.

2. Only one person shall speak at any time and he shall rise and address the moderator.

3. No person shall be interrupted by anyone except the moderator until he is through speaking, nor shall the moderator, unless he breaks the order.

4. The person speaking shall adhere to the subject in question and shall not cast any personal reflection on him who has spoken before.

5. No person shall speak more than two times on any one subject without leave of the Association.

6. No member shall address each other except by the appellation of brother or brothers.

7. No member shall laugh or whisper in the time of public speech.

8. No member shall absent himself from the Association without leave.

9. The names of the members of this Association shall be enrolled and called over as often as the Association may think it necessary.

10. No person shall speak more than five minutes at any time without leave of the association or conference.

11. Any person who shall knowingly break any of the association or conference rules shall be reprovved by the moderator.

12. Every member of this body shall vote for or against every move that comes before it by standing vote. When they fail to do this they shall be reprimanded by the moderator.

13. When two or more members rise at the same time the moderator shall decide who is entitled to speak.

14. All committees shall be appointed by the moderator.

15. The devotional committee shall consist of the pastor and deacons of the church where the association or conference is convened.

16. Visiting ministers have the right to speak only with leave of the conference or association.

17. The member first named on a committee shall be the chairman.

18. The moderator in case of a tie may cast the deciding vote.

19. No minister shall have a right to vote in the conference or association unless he is in good standing with his church and association.

20. No one has the right to vote except ordained authority and delegates of this association.

21. For the purpose of doing conference and association business the ordained authority and delegates will be placed in separate sections of building during business session.
