

# PRESBYTERY REPORT FOR YEAR 1972-1973

October 21, 1972

Presby met at Mt. Carmel Church of Indianapolis. Bro. Cecil Carpenter came before Presby to have his credentials ratified for Deacon for Florida Station Church was passed by Presby.

October 31, 1972

Presby met with Rev. Larry Baker about his standing in the Conference. He was put on a year probation. Bro. Chuck Reagen turned his Deacon credentials into the Presby.

January 19, 1973 Bro. John Miller came before the Presby to be examined for license to preach the Gospel after examined he was passed.

April 13, 1973

Bro. James Lee came before the Presby for license to preach the Gospel after examination he was passed.

July 13, 1973

Bro. Tommy Walker came before the Presby to be examined for office of Deacon, after examined, was passed.

Bro. Maurice Jones came before Presby to be examined for Deaconafter examination, was passed.

October 25, 1973

Presby recommended to Association that Bruce Jackson, Larry Bakercredentials be made void. To be notified to surrender credentials.

Bro. John Estepp came before Presby to be Ordained as Deacon for Burlington Drive Church after examination, was passed.

#### EVANGELIST REPORT

Motion carried that our next Association go to the Mt. Hope Church of Anderson. Bro. Bobby Greene Preach the opening message Friday, at 7 p.m. October 25, 1974.

#### DECLARATION OF RIGHTS

- Section 1. That all power of the church government is inherent in the people and the preachers; that is, that they may have a right through their representatives, to establish, alter or amend their form of church government, two-thirds agreeing thereto.
- Section 2. That a Christian church is a society of believers in Christ, and is a divine institution. Jesus Christ being the head of the Church and the Bible the only rule of our faith and practice.
- Section 3. That no rule of faith and doctrine shall ever be established in the Free Will Baptist Church contrary to the Bible.
- Section 4. No person who loves the Lord Jesus Christ and obeys the Gospel should ever be deprived of church membership.
- Section 5. Every member has inalienable right to private judgment in matters of religion and may speak freely of the same in a way that will not violate the law of God, or the law of their country, or the rights of their fellowman.
- Section 6. Church trials should be conducted on Gospel principles only, and no minister or member should be excommunicated except for immorality, the propagation of un-Christian doctrine, neglect of duty enjoined by the word of God, or the rules of the Church.
- Section 7. The Church has a right to form and enforce such rules and regulations only as are in accordance with the Holy Scriptures, and may be necessary to carry into effect the great system of practical Christianity.
- Section 8. There may be three grades of association established in the Free Will Baptist Church. First the Monthly Association, second, the Annual Association, third the General Association.

Section 9. That the church has the right to select their leaders and delegates to the annual association.

Section 10. It shall be the duty of each church to select two deacons and one clerk.

Section 11. It shall be the duty of the different church clerks to keep a correct minute of all their church meetings in a book provided for that purpose.

Section 12. Each church represented in the annual association shall be entitled to two delegate voters, whose membership does not exceed 50 and one additional for every 25 over 50.

Section 13 That for the purpose of ordaining elders, there shall convene a Presby. Said Presby shall consist of five ordained ministers. It shall be the duty of said Presbytery to examine all applicants that may come before them for license and ordaination, and if found competent, shall ordain them or set apart for the work by prayer and laying on of hands. Said Presbytery shall have full power to try ministers and deacons, composing the association, for immorality, propagation of un-Christian doctrine, neglect of duty enjoined by the word of God or the rules of the church, on proper testimony: their word to be final. Any member of the Presby being absent at a meeting the chairman has the right to select another ordained elder to take his place in that session of business. Also that the Clerk of the Presby have the right to appoint a chairman for the session of Business. In absence of regular Presby member the chairman may not appoint more than two to serve in that session of business.

Section 14. No minister shall be ordained to the office of elder unless they meet the requirements as stated in I Tim. 3:1-7, and pass a satisfactory examination upon the subject of repentance, faith, justification, the door of the church, water baptism, the Lord's Supper, washing the saint's feet, and transaction of church business in general.

Section 15. Any one who desires the office of elder shall take the following steps before presenting himself for ordination. He must come to the Presbytery recommended by church letter for license; He must be a member of the church that recommends him, and if found competent they shall issue license; after he has had his license one year, he shall go before the Presbytery with church letter recommending him for ordination, and if found worthy on second examination, they shall ordain him.

Section 16. That for the purpose of receiving licentiates or ordained ministers from other denominations who came to us well recommended by their Conference or Association we receive them and ratify their license or credentials.

Section 17. It shall be the duty of the Conference or Association to give a letter of dismissal and recommendation to any ordained minister, if in good standing, wishing to leave our association. The letter must state, good only for a period of ninety (90) days.

Section 18. It shall be the duty of any minister coming before the Presbytery for license or ordination, or to have their credentials ratified, that they must belong to a Free Will Baptist Church in Stone Association, and bring a letter of recommendation from same.

Section 19. That any minister being called from another Association to paster a church in Stone Association of Central Indiana, must come before presbytery for examination.

Section 20. Forbidding any one hereafter having more than one wife, to be ordained for either a minister or a deacon. Also that if and when any of the present ministers or deacons become the husband of more than one wife or marry a woman with a living husband, his ordination would auto matically be annulled.

Section 21. No woman will be licensed or ordained to the office of elder.

Section 22. Be it resolved that all members be in subjection unto their elders and unto those who would have rule over them in the Lord.

Section 23. Be it resolved that no minister be allowed to aid or abet either directly or indirectly in the manufacture of intoxicating drinks or to indulge in the sale of them. Be it further resolved that no minister or member of the Free Will Baptist Church be allowed to drink. Be it further resolved, that no member of this church shall tolerate the sale or manufacture or use of intoxicating drinks, such as liquors, wines or beers in their homes or on their premises.

Section 24. It shall be the duty of any member wishing to leave the Free Will Baptist Church to call for a letter before leaving.

Section 25. Licensed or ordained ministers coming from another Free Will Baptist Conference or Association must bring a letter of recommendation from the same.

Section 26. Only an ordained minister of this body may serve as a member of the Presbytery.

#### RULES OF DECORUM

Section 1. No complaint shall be brought in the church against transgressing members until the aggrieved party complies with the directions given by our Lord in St. Matthew 18: 13, 17

Section 2. It shall be the duty of the deacons of the church to go to any transgressing member, talk to them and they shall have until the second church meeting to make reconciliation. It may be the duty of the church to choose a committee to settle questions of aggrieved causes. It shall also be the duty of the deacons to look after the widows in their daily ministrations. Rom. 16: 17: II Cor. 12: 21; II Cor. 13: 1.

Section 3. It shall be the duty of the stewards to advise the church to promote means to sustain the church and preachers. I Cor. 16: 1, 2; II Cor. 9: 7; Luke 10: 7; I Cor. 9: 4.

Section 4. It shall be the duty of the minister on receiving members in the church, to ask the applicant the following questions: First—"Do you feel that you love God with all your heart, soul, mind, and strength?" Second—"Are you a believer with all your heart that Jesus Christ is the son of God?" Third—"Are you willing to walk in all His precepts?" We take members into the Free Will Baptist Church by Conversion, Letter or Recommendation. Matt. 22: 37; Acts 8: 37; John 13: 1, 17; I Cor. 11: 20. 22; Luke 22: 18, 20; Matt. 26: 26, 29

#### ARTICLES OF FAITH

- Article 1. We believe in one eternal God, the Creator and Upholder of all things and in Jesus Christ, His Son, and in the Holy Ghost, and that these three are one. St. John 1: 1; I Cor. 8: 6; St. John 10: 30.
- Article 2. We believe the Holy Scriptures of the Old and New Testaments to be the Word of God, and the only rule of Faith and Practice: II Pet. 1: 19-20; II Tim. 3: 14-17; Dan. 10: 21; Acts. 1: 16-17; Matt. 21: 42.
- Article 3. We believe that man is unable to recover himself from the fallen state that he is in, by reason of sin, only by the grace of God through the exercise of faith. Gen. 1:27; Gen. 2:16-17; Psalms 51:5; Rom. 5:12-19; John 3:5-7; Eph. 2:3.
- Article 4. We believe that baptism and the Lord's Supper and the washing of the saint's feet are ordinances of Jesus Christ and that immersion is the only mode of baptism, not the putting away of the filth of the flesh, but the answer of a good conscience toward God by the resurrection of Jesus Christ. Matt. 3:14-16; Matt. 3:5-6; I Pet. 3:21; John 3:21; Acts 10:47; Matt. 28:19; Luke 22:18-20; I Cor. 11; 20-29; John 13:1-7; Matt. 26:26-29.
- Article 5. We believe that no minister has the right to administer these ordinances except such as are regularly ordained. I Tim. 4:14: Acts 8:17-19; II Tim. 1; Heb. 6:2.
- Article 6. We believe in the resurrection of the dead, a general judgment, the punishment of the wicked, and the joys of the righteous are eternal. Matt. 28:6; John 5:28-29; I Cor. 15:51-58; John 11:25; II The.s. 1:4-9; Rev. 14:9-13; Luke 16:23; Rom. 2:4-5; II Cor. 5:10; Matt. 12:36; Rev. 20:11-15; Matt. 25:41; Acts 17:13; Isa. 33:14.
- Article 7. We believe according to the Scriptures; Paul's letter to the Hebrews 6:1-7; that after man has been made partaker of the Holy Ghost if he shall fall from Grace, it is impossible to renew him again unto repentance, or restore him unto the favor of God. Heb. 6:1-7; I John 5:16
- Article 8. We believe that a man can make shipwreck of his faturand be lost. Rom. 8:38-39; I Cor. 10:9; Job 17:9; Matt. 16:18; John 10:27 28; Phil. 1:6; II Chron. 15: II Pet. 1:10; Ezek. 33:18; John 15:16; I Cor. 10:12; Heb. 12:15; I Chron. 28:9; Rev. 2.45; Acts 1:25: Matt. 24:13; Rev. 22:19; Phil. 3:11-14
- Article 9. We believe that sanctification is the work of G.d's Grace, by which the soul is cleansed from all sin and wholly consecrated to Christ. It takes place in the Spiritual Birth, constantly growing in the Grace and the Knowledge of our Lord Jesus Christ and becomes final at the end. Hep. 12:14; Phil. 3:21; I Car. 6:11; II Thess. 2:13; I Thess. 5:19-23; John 17. 17-19; II Tim. 2:20-21.
- Article 10. We believe that all Christians have a right to the sac ramental table upon the principles of their acceptance with Him, for St Paul says: "But let a man examine himself, and let him eat of that breac and drink of that cup." I Corinthians 11:28.
- Article 11. We believe that no person is a member of the Free Will Baptist Church except those that have the witness within themself.

#### OFFICERS AND THEIR DUTIES

Pastor. It is the pastor's duty faithfully to preach the word, to have the general superintendence of the church. To be himself an example of the flock, to visit the members, especially the sick, as he has the opportunity, and to do all within his power to promote the religious interest of the church which he serves, and to advance the cause of Christ among men.

Deacon. The deacons are elected for life or during good behavior. They should be men distinguished among their brethren for piety and benevolence. Before entering upon the duties of their office they are ordained by the Presby. Ordination consisting of charges, laying on of hands and prayer. It is their duty to serve at the Lord's table. To distribute of the bounty of the church among its needy members, to visit the sick, to assist the pastor in promoting order in attendance upon the church, and to conduct religious meetings in the absence of the pastor.

Clerk. It is the duty of the clerk to keep a church book and in it record the church covenant, and the names of the members, all the proceedings of the church, and the exercise of its doctrine and management of its temporal affairs. They also sign all the letters and other communications made by authority of the church.

Treasurer. The treasurer shall be entrusted with the funds of the church, and it shall be their duty to keep a regular account of all the money received and make a report of the same annually to the church or as often as the church requires. Funds shall be drawn on the treasury only by the order of the church.

#### RULES OF CONFERENCE AND ASSOCIATION

- 1. The Association and Conference when met shall be opened and closed by singing and prayer.
- 2 Only one person shall speak at any time and he shall rise and address the moderator.
- 3. No person shall be interrupted by anyone except the moderator until he is through speaking, nor shall the moderator, unless he breaks the order
- 4. The person speaking shall adhere to the subject in question and shall not cast any personal reflection on him who has spoken before.
- 5. No person shall speak more than two times on any one subject without leave of the Association.
- 6. No member shall address each other except by the appellation of prother or brothers.
  - 7. No member shall laugh or whisper in the time of public speech.
- 8. No members shall absent himself from the Association without leave.
- 9. The names of the members of this Association shall be enrolled and called over as often as the Association may think it necessary.

- 10. No person shall speak more than five minutes at any time without leave of the association or conference.
- 11. Any person who shall knowingly break any of the association or conference rules shall be reproved by the moderator.
- 12. Every member of this body shall vote for or against every move that comes before it by standing vote. When they fail to do this they shall be reprimanded by the moderator.
- 13. When two or more members rise at the same time the moderator shall decide who is entitled to speak.
- 14. All committees shall be appointed by the Moderator, he shall also appoint three (3) members of the Presby, the first appointed being the Chairman. The Chairman will then appoint the other two members.
- 15. The devotional committee shall consist of the pastor and deacons of the church where the association or conference is convened.
- 16. Visiting ministers have the right to speak only with leave of the conference or association.
  - 17. The member first named on a committee shall be the chairman.
  - 18. The moderator in case of a tie may cast the deciding vote.
- 19. No minister shall have a right to vote in the conference or association unless he is in good standing with his church and association.
- 20. No one has the right to vote except ordained authority and delegates of this association.
- 21. For the purpose of doing conference and association business the ordained authority and delegates will be placed in separate sections of the building during business session.
- 22. To rotate conference and association from church to church and not to visit any church twice until all have been visited.
- 23. All ministers are required to fill out a ministers report form, if they fail to do so their name will be placed in the Minutes as ministers who made no report.
- 24. If any minister fails to appear for two consecutive sessions of our quarterly meetings that the Presby go see them.
- 25. All delegates must register at the beginning of the conference and association, if they fail to do this they lose the right to vote in this conference or association.
- 26. Anyone coming to the Presby must present themselves to the Presby on Thursday night in the association and on Friday night in the conference.
- 27. All delegates must be present throughout each conference and association in order to have privilege to vote in the business session.
- 28. All ministers and deacons who fail to attend the ministers and deacons meeting each quarter shall be admonished by his pastor, and should he be absent two cut of three meetings he shall be admonished by Presby
