PROCEEDINGS Of The Union Hill Association

FRIDAY MORNING, 10:00 A. M., October 23, 1959

The Thirty-Ninth annual session of the Union Hill Association, which convened with Slocomb and Union Hill Churches, October 23, 24, 1959.

Theme for session: "Where There Is No Vision, the People Perish," Prov. 29:18. "There shall be showers of blessings." Prayer by Rev. John Edwards of Dothan, Ala. Song, "Draw Me Nearer."

Rev. Leo Curtiss conducted a very inspiring devotional using for scripture Psalms 23, subject: "Leadership." "We need the leadership of the Lord rather than man," brother Curtiss said. "There is God to believe in and God who provides for His people," the speaker stated.

The Vice-Moderator, Rev. Thim Finch, called body to order and letters from the churches were presented and read. Churches and delegates as follows:

At 10:50 the Association recessed for business session until 1:30 p.m. The 11:00 hour began with congregation singing, "Amazing Grace, How Sweet the Sound." The song service was led by Rev. A. L. Anderson. Bro. Anderson led us again in singing "When We All Get To Heaven."

Rev. John Edwards, pastor of the First Church of Dothan, was asked to bring the message in the absence of Rev. John M. Rich, who was scheduled to bring the Introductory Message.

The Rev. John Edwards used for scripture Proverbs 13:15 as a subject "Sin". "It is necessary to preach on sin. All it has to offer is pleasure for only a season."

Rev. W. T. Hutto, pastor of Union Hill gave the benediction. 12:00—Noon Hour.

1:30 P. M. SESSION

The Rev. Trim Finch, vice-moderator, called the body together, singing, "Victory In Jesus." Prayer by Rev. Trim Finch. The beautiful song, "Hand in Hand With Jesus" was then sung.

There was a motion and second we follow the printed program as much as possible. Motion carried.

Business recessed until Saturday morning.

FRIDAY NIGHT SESSION-7:00 O'Clock

The Rev. A. L. Anderson, pastor of Panther Creek Church, had charge of song service. The meeting began with singing "Try Jesus," then "When the Morning Comes We Will Understand." Prayer by Rev. Trim Finch.

Again Bro. Anderson led us in singing "It Won't Be Very Long Till He Shall Appear." Prayer by Rev. Rufus Hyman.

Another beautiful song was sung "Belonging to God Is Perfectly Right." A good testimony meeting was had and then Rev. John Edwards was given charge of preaching service. Then Rev. A. L. Anderson and Bro. Edsel Smith sang "How Great Thou Art" with Mrs. Rufus Hyman at the piano.

The speaker used for a subject: "The Greatness of God," taken from Psalms 104:1: "Thou Art Very Great." Also Matt. 28:18, and 1 Cor. 1:25 was used in connection. This was a very good message.

SATURDAY-10:25

Opening song, "Waiting Till He Shall Come". Prayer by Rev. Trim Finch.

The moderator, Rev. Bobby G. Register, read John 4:35, "The White Harvest Fields." God said "Go take the message of Salvation to those who are lost. We need a vision of Christian service, a world wide ministry."

Renewed call for church letters and Panther Creek and Antioch delegates were seated.

By motion and second Nominations report be taken off of the table and motion and second the report was referred back to the committee for further study.

Next was the reading of report of ministers.

There was a period of recess from business for five minutes.

After recess we were led in good spiritual singing.

THE ORDAINING COUNCIL '

DECORUM OF THE UNION FREE WILL BAPTIST ASSOCIATION

Article 1. The name of this body shall be The Union Hill Free Will Baptist Association .

Article 2. Time of annual meeting: Friday and Saturday before fourth Sunday in August.

Article 3 Officers. The officers of this body shall be a Moderator, Vice Moderator, Clerk, Asst. Clerk, Treasurer, Executive Committee, Ordaining Council, Mission Board, and any other officers as the needs may Election of Officers: The election of officers shall be annually on the last day of the Association, and the Association shall elect officers anyway deamed best. Duties of officers: The Moderator. The Moderator shall preside over all business sessions of the Association and help make plans for the welfare of the Asociation. Vice Moderator. The Vice-Moderator shall assist the Moderator and preside when the Moderator is obsent from the church. Clerk. The clerk shall keep a record of all business of the Association, prepare manuscript for minutes, and do all correspondence for the Association. Asst. Clerk. The Assistant Clerk shall assist the clerk in his absence from the chair. The Treasurer. The Treasurer shall receive and hold all funds of the Association, pay all bills, and present statement when called upon. The Executive Committee. The Executive Committee shall have authority to do all acts for and in the name of the Association when the Association is not in session. Ordaining Council. The Ordaining Council shall examine all applicants for ordination to the Ministry, to ordain and issue all credentials, revoke, said ordination whenever a Minister becomes disorderly or refuses to repent and become in order with this body. The Mission Board. The Mission Board shall work to create interest in missions, to open mission points, and to establish new churches in the bounds of this body. Trustees. Trustees shall hold title to associational property, shall have right to buy and sell.

Article 4. Representatives shall be 2 delegates for first 25 members or fraction thereof and 1 additional delegate for each 25 members or fraction thereof.

Article 5. That no delegate or minister shall be allowed to absent himself from the body during any session without permission from the Moderator.

Article 6. That each minister shall make a report of how many churches he is serving, if any, and what each church had paid him for his services.

Article 7. That no church be considered in this body that retains minister or deacon that has more than one living wife or drinks intoxicating beverages, or fail to pay their just and honest debts, or fail to make satisfaction.

Article 9. All business shall be disposed of according to good usage. But no move shall be submitted to the body where there is a move before the house unless the first one be withdrawn by the person who made such a move and no person shall be allowed to speak more than ten (10) minutes each time without move and second carried by the body.

Article 10. No person shall be disturbed while speaking so long as he keeps to the point in debate, then only by the Moderator and only to call him in order. Only one person shall be allowed to speak at a time and he must rise, to his feet and address the Moderator and he must not use abusive language or personal reflection upon anyone.

Article 11. This Association shall have a treasurer and executive committee to be elected annually. And no church shall be considered in this body who shall have retained a minister that has stepped aside from his obligations in any form (as in 1st Timothy, chapter 3) unless said minister has shown by his actions that he has repented of the former evil.

Article 12. That any minister who will voluntarily step aside must immediately turn his credentials over to the Executive Committee and said Executive Committee shall visit the various churches to see if they are in good standing or not and help them retain good order.

Article 13. That no church shall retain a minister or deacon who does not rule his own house.

Article 14. That no church be recorded in this body who does not commune and wash feet at least one time a year and each church shall state in its associational letter as to whether this ordinance has been kept or not. And state how much it has paid and all ministers serving churches shall preach one sermon a year on doctrine and rules of Holy living.

Article 15. Any preacher belonging to this body who sends an appointment of serving churches who fails to meet at the appointed hour shall be due acknowledgement to the congregation or church.

CHURCH DECORUM

- 1. The church may choose a pastor annually at the last conference in Association year, or if they prefer, it may choose a pastor for an indefinite length of time to continue from year to year, as long as they may deem it proper to keep up the connection.
- 2. When it becomes necessary, a Pastor may be chosen at any given time, but if the choice be modeat aspcial conference the time must be oppointed at a monthly meeting of the church.
- 3. The pastor shall be moderator of the church, but when the moderator is absent or does not sit, a suitable brother shall be appointed in his place.
- 4. There shall be two or more deacons in the church whose duty it shall be to superintend the collection and distribution of all contributions made by the church for the pastor, etc. and to distribute the bread and wine in administration of the Lord's Supper.
- 5. The deacons shall take notice of such members as refuse or neglect to partake of the Lord's Supper and endeavor to ascertain the cause that the same may be laid before the church in conference if necessary.
- 6. Some suitable member shall be appointed clerk and it shall be his duty to do all the recording and writing pertaining to the business of the church and to preserve a file of the minutes of Association.
- 7. When a clerk is appointed, all the books, minutes, etc., belonging to the clerk, shall be immediately delivered to him by his predecessor.
- 8. When it becomes necessary, a committee of not less than three male members, well acquainted with business, shall be appointed whose duty it shall be to give advice to brethren who apply to them relative to cases of dealing, etc., with the church.
- 9. The church holds a two days' meeting embracing Saturday and the Lord's Day following, the first of which shall be the regular time of the conference.
- 10. It shall be the duty of every church member, male or female, to attend each conference meeting, if they can, for on that day the pastor is expected to instruct the church in a certain manner by giving plain and pointed lessons on doctrine, discipline, and the rules of Holy living.
- 11. Any male member who shall fail to attend three successive conferences and any member who may be generally remiss in attending meetings of the church according to covenant (Article 10), shall be cited to appear in conference and answer for his conduct, but may exempt members from this is necessary.
- 12. Conferences shall be opened and conducted as follows: (1) Prayer, unless divine service has just been conducted, and generally then. (2) Invite visiting brethren to seats. (3) Open the door for reception of members. (4) Call absentees. (5) For acknowledgements. (6) For reference of deferred business. (7) For matters of dealing which are

in order to come before the church. (8) For miscellaneous business.

- 13. Visiting brethren called in as help from sister churches shall be allowed to vote.
- 14. Any ordinary member of the Baptist Church who does not hold this church in fellowship may be received into the church without a letter when it is made apparent that his Christian character is above reproach and that he has applied for letter and could not obtain it because he desires to poin this or some sister church. All other persons must join by letter or baptism.
- 15. We receive members by experience of baptism; or confession of faith, by letter or restoration.
- 16. When the moderator calls for absentees the clerk shall inform the church what members have been absent from three successive conferences and the moderator shall appoint some brother or brethren to cite each of them to the next conference.
- 17. No member shall be expelled unless he has been cited verbally or in writing ta attend this trial provided his residence be known to the church.
- 18. When a witness, not a member of the church, is introduced he shall not be examined until the question has been put to the church; "Will you hear the testimony of the witness?"
- 19. The evidence in every case of dealing and acknowledgement shall be recorded in the church book.
- 20. Mmbers dismissed from the church by letter who become disorderly or continue to hold their letters without good reason shall be cited to conference to answer their conduct.
- 21. Expelled members shall be restored to membership on their petition if their walk since expulsion has convinced the church that they have seriously repented for their former evil.
- 22. A vote shall not be taken upon the question without a move and a second and on all important questions the vote shall be taken by rising to the feet.
- 23. No motion shall be made while a move and second is before the conference.
- 24. It shall be considered disorderly for any member to absent himself from conference when an important question is to be decided, but a member, upon request, may be exempted by the chairman from voting on either side in peculiar cases.
- 26. All discussions in conference must be conducted with calmness and good feeling. Those who speak must rise to their feet, and keep to the point in debate.
- 27. No one shall speak more than three times on the same question without permission from the moderator, nor shall the remarks of anyone be unreasonably long.

- 28. When the moderator speaks he must designate some brother to act in his stead.
- 29. No one shall be interrupted while speaking unless it is to call the speaker to order.
- 30. We believe it to be the duty of the church to commune, wash saints' feet as often as the church sees fit, the expense to be paid by the church.
- 31. Members not in good standing should not commune, but the administration should not be deferred on account of any ordinary matter of dealing.
- 32. Public fasting, humilitation and prayers shall be observed on proper occasion.

ARTICLES OF FAITH UNION HILL FREE WILL BAPTIST ASSOCIATION

- 1. We believe there is just one living and true God whose name is Jehovah, the Maker and Ruler of the Universe.
- 2. We believe there is one Lord Jesus Christ, by whom all things and by whom salvation is made secure.
- 3. We believe in the beginning God made man, upright and placed him in a state of holiness under the laws of His Maker, but by voluntary transgression of his own he fell from that holy and happy state.
 - 4. We believe that no man shall suffer in hell for lack of Christ.
- 5. We believe that the Holy Scriptures are the Word of God and that they are the only rule of faith and practice.
- 6. We believe that sinners are drawn to God the Father by the Holy Ghost through Jesus Christ His Son.
- 7. We believe that good works are the fruit of faith and faith without works is dead.
- 8. We believe that the blessings of salvation are made free and may be obtained by all mankind.
- 9. We believe that commemoration and feet washing are ordinances of Christ and immersion only is baptism.
- 10. We believe that all Christians should unite in performing the sacred ordinances.
- 11. That the end of the world is approaching when Christ will descend from Heaven and raise the dead from the graves for final retribution, that a solemn separation will take place, the righteous being adjudged to everlasting happiness and the wicked to endless punishment and that judgment will fix forever the final state of a man in Heaven or Hell on principles of righteousness.
- 12. We believe it is possible for a Christian to make shipwreck of his faith after being saved become lost again. This is possible but not probable; therefore, we should watch and pray to make our calling and election sure.
