Sis. Susan Parker gave the WNAC report, stating that the District meeting will be the last Saturday in March at Clinton.

Bro. Earnest Harrison, Executive Secretary of the State Office gave a report as follows:

- (a) The Arms of Compassion program (formerly Oklahoma Children's & Family Ministries), is being led by Bro. John Hewitt and is doing well.
- (b) The State meeting will be in October at Hillsdale FWB College.
- (c) The Coop fund had its highest month ever. He urged all churches to continue giving and to sign up their Pastor for the Retirement Fund.
