PROCEEDINGS

The Thirty-Seventh Annual Session of the Vernon Free Will Baptist Association was held with Mount Pleasant church, October 20, 21, and 22, 1917. The introductory sermon was preached by Rev. T. J. Adair. Text: Mark 10:40. There was then an intermission of one hour for refreshments.

EVENING SESSION.

At 2 o'clock P. M., the association reassembled by singing. Prayer by Bro. A. J. Saunders. The former moderator being absent, Rev. T. J. Adair was made moderator pro tem. Rev. T. J. Adair took his seat as moderator and proceeded to permanent organization as follows:

The roll of churches was called. Letters were handed in and read. The names of delegates were enrolled as per statistical table.

Moved in order that the delegates from each church supply their amount of delegates, whereupon the following delegates were enrolled:

Moved and seconded that we go into an election for moderator and clerk. Rev. T. J. Adair was elected moderator and S. G. Johnson, clerk.

After a few appropriate remarks by the moderator, the association proceeled to business in the following order:

1. Open the door for the reception of new churches into the body. Received none. Called for corresponding delegates from sister associations. None.

Committee on Arrangements report as follows: Singing Sunday morning at 9 o'clock. Preaching at 11 o'cock by Rev. T. J. Adair. Sing-

ing in the afternoon. The Association adjourned to meet at 8 o'clock Monday morning.

SUNDAY SERVICES.

Sunday morning at 9 o'clock the congregation met and had prayer and song service till 11 o'clock. At 11 o'clock there had gathered a large congregation. Rev. T. J. Adair occupied the stand and preached to a large and attentive audience. Text: Genesis 3rd Chapter and later clause of the 9th verse. After which the Lord's Snpper was administered to a host of partakers. At the conclusion of the service, the congregation was aismissed for recreation and refreshments. After which, the evening was spent in song service.

MONDAY MORNING.

The Association met at 8 o'clock according to adjournment. After singing, prayer was offered by the moderator.

The minutes of Saturday were read and the roll of delegates called. The moderator stated that a quorum was present. The Association proceeded to business in the following manner:

- 3. We recommend that the next session of this association be held with Friendship church, about three miles west of Melborne, Ala., beginning Friday before the 3rd Sunday in October, 1918. Rev. D. G. W. Hollis preach the introductory sermon and that Rev. G. B. Taylor be his alternate.
- 4 We recommend that we have one Union Meeting and that it be held with Vernon church, beginning on Saturday before the 4th Sunday in July, 1918. That Rev. Woods Springfield preach the introductory sermon and that Rev. T. J. Adair be his alternate.
- 5. We recommend that we elect an Executive Committee or five to take an oversight of the churches and ministers and that act as a Finance Committee to assist in raising funds necessary to meet the needs of the

CONSTITUTION.

Section 1. This Association shall be known as the Vernon Free Will Baptist Association of Alabama, and being composed of delegates from the different churches forming the same, each church being entitled to five delegates.

- 2. This body shall be considered an advisory council, but having no authority over the affairs of the churches, unless they depart from the Articles of Faith of this Association. In case any church departs from the Articles of Faith and supports doctrines of heresy, or allow any minister of her body to teach doctrines not in keeping with our Articles of Faith, the same shall be dealt with by this Association as it may see proper, according to the teachings of the Bible.
- 3. Each church in the Association shall be considered an advisory body and shall control its own internal affairs in matters of discipline, etc., though the Association shall rule in matters of doctrine ad general interest, though the church may in extreme cases call in aid from sister churches.
- 4. All questions of doctrine and matters of general interest shall be settled by a two-thirds vote of the Association, and the decision shall be final.
- 5. The officers of this Association shall be a Moderator, Clerk and Treasurer, who shall be chosen at each session by a majority vote.
- 6. This Association shall meet annually at such time and place as may be agreed upon by a previous annual session, and shall not adjourn until all business is transacted.
- 7. Churches wishing to become members of this Association must adopt its Articles of Faith and conform to its usages.
- 8. We agree as churches of this Association to use our best influence to promote the interest of all moral and benevolent institutions; such as Temperance Cause, Sabbath Schools, Missionary Wonk, etc.
- 9. No member of this Association shall be eligible to the office of the Moderator more than two successive sessions, unles no other member is competent to act in that capacity.

RULES OF DECORUM.

Article 1. This Association shall be called to order by the Moderator who presided at the last session. Former Clerk shall also officiate until the body is fully organized.

Artice 2. The Association shall be opened and closed with singing and prayer.

Article 3. The Moderator and Clerk shal be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.

Article 4. The names of the delegates from the different churches shall be enrolled and called as often as necessary during the session.

Article 5. A majority of the delegates present shall rule in all cases, except in the reception of churches into our body, then it must be unanimous.

Article 6. The Moderator shall not be allowed to vote, except in case of a tie; and then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, providing he appoints some one to the chair while he is speaking.

Article 7. Only one person shall speak at the same time, who shall rise and address the Moderator.

Article 8. No brother shall be interrupted while speaking, unless he departs from the subject under discussion, or use words of personal reflection.

Article 9. No person shall be entitled to speak more than twice on the same subject, Without leave from the Association, nor more than fifteen minutes at a time.

Article 10. No member shall laugh or talk during the time the debate is going on.

Article 11. No member shall absent himself from the Association without leave from the Moderator.

Article 1. We believe there is one true and living God, who is the supreme ruler of heaven and earth, self-existent Creator of all things; and revealed under the personal direction of Father, Son and Holy Ghost, equal in every divine perfection, and existing in distinct but harmonious offices in the great work of redemption.

Article 2. We believe the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly instruction; that it has God for its author, Truth for its matter, and Salvation for its end; that is, reveals the principles by which God will judge us, and therefore is and shall remain to the end of this world the center of Christian union, the supreme standard by which all human conduct, creeds and opinions will be tried.

Article 3. We believe that man was created holy, under the law of his Maker, but from voluntary transgression fell from the happy state, in consequence of which, all manking are now deprayed, and wholly unable of their own free will and ability to recover themselves from the fallen state in which they are by nature.

Article 4. We believe that God has not fixed the future state of mankind by an absolute and unconditional decree, but salvation is offered in the Gospel free to all, and if sinners are lost forever it will be their own fault. Article 5. We believe that Christ by His death and sufferings made an atonement for the sins of all mankind in general, and every individual in particular; however, that none but those who believe in Him can be partakers of the givine benefits.

Article 6. We believe that true faith cannot proceed from the exercise of our natural faculties and powers, or from the force and operations of free will, since man, in consequence of his natural corruption, is incapable either of thinking or doing anything spiritually good.

Article 7. We believe in the general application of the Grace of God to fallen man sufficiently to enable him, morally and actually, to obey the requirements of the law of liberty. Jas. 1:15, this is to act saving faith. John 1:9, however, none but those who believe, or acquiesce in Christ will be saved thereby. Acts 17:32; Romans 2:19; John 3:19.

Article 8. We believe in the free moral agency of man, by the grace of God, before and after conversion, that he is laid under no invincible necessity, by his Creator, to act in any given way; that if he lives after the flesh he shall die, but if he through the Spirit do mortify the deeds of the body he shall live, and, therefore man is always a proper subject of admonition and exhortation. Heb. 11.12-13; Rom. 12:14; Mark 13:12; Eze. 18:24; Rev. 2 and 3 chapters; Eze. 33:13 and 28; 1st Tim. 4:1; Heb. 3:5; 1st Cor. 1:12-22; 1st Peter 1:10.

Article 9. We believe that a visible church of Christ is a congregation of believers, associated by covenant in the faith of fellowship of the Gospel, observing the ordinances of Christ, governed by His laws, and exercising the gifts, rights and privileges invested in them by His word, that its only proper officers are bishops or pastors, and deacons, whose qualifications and duties are defined in the Epistle of Timothy and Titus.

Article 10. We believe that Christians baptism is immersion in water, in the name of the Father, Son and Holy Ghose; and that believers are the proper subjects.

Article 11. We believe the Lord's Supper is of perpetual obligation, by which the members of the church, in the case of bread and wine, are to commemorate together the dying love of Christ, preceded always by solemn self examination.

Article 12. We believe in open and free communion, and the churches of our body are authorized, through their pastors, to invite Christians of all orthodox churches who are in good standing in their respective churches to commune with us at the Lord's table.

Article 13. We believe in the resurrection of the dead and the general judgment; that the joys of the righteous and the punishment of the wicked will be eternal; upon the principles of grace and justice.
