Proceedings

The Thirty-Eighth Annual Session of the Vernon Free Will Baptist Association was held with Friendship Church October 18, 19, and 20, 1918.

Former moderator and clerk being absent, Bro. R. N. Yerby was elected moderator pro tem, and R. H. Yerby was elected clerk pro tem.

On motion the moderator called the roll of churches and the delegates were enrolled as shown in the statistical table.

Bros. A. A. Burgin and F. E. Burns were appointed reading clerks.

Opened the door for the reception of new churches into the body, Damascus Church came forward with letter and delegates and was received in full fellowship.

On motion Bro. J. G. Sanders from Mt. Pleasant Church and Bro. F. E. Burns from Friendship Church were seated as delegates.

On motion the Association went into an election for moderator and clerk. Bro. R. N. Yerby was elected moderator and R. H. Yerby clerk.

Called for corresponding delegates from sister associations. None present. Invited visiting brethren to seats with us.

On motion the moderator was empowered to appoint all committees. The following were appointed:

Saturday Morning.

The roll of delegates was called and the moderator announced a quorum present.

On motion the reading of the minutes of Friday was omitted.

The moderator then called for reports of committees.

Report of Committee on Arrangements.

We, your committee on Arrangements, beg leave to report as follows:

We recommend that Rev. D. G. W. Hollis preach at 3 o'clock in the afternoon.

We recommend that we take up the regular work of the association until that hour.

Repoit of Committee on Documents and Order of Business.

We, your committee on Documents and Order of Business, beg leave to make the following report:

- 1. We recommend the former order of business.
- 2. We recommend that the next session of this Association be held with Damascus Church, 15 miles west of De Kalb Miss. Begiuning on Friday before the third Sunday in October 1919, and that Rev. T. J. Adair preach the introductory sermon and Rev. G. B. Taylor be his alternate.
- 3. We suggest that the Sunday Schools of this Association organize a Sunday School Convention for the purpose of building up more Sunday School interest.
- 4. We recommend that we have one Union Meeting, and that it be held with Springfield Church beginning on Saturday before the fourth Sunday in July 1919.
- 5. We recommend that the clerk superintend the printing of the minutes. That we have 250 copies printed and that he have them printed where he can get it done best and cheapest, and that he be allowed \$5.00 for his services.

Rev. D. G. W. Hollis preached an interesting sermon from the seventh Chapter of St. Matthew.

The Association then adjourned until Sunday morning

The Thirty-Eighth Annual Session of the Union Meeting of the Vernon Free will Baptist Association met with Vernon Church July 27, 1918 The introductory sermon was preached by Rev. woods Springfield. Subject: The four things belonging to Christ Texts: Phil 1:27, 2:30, 3:18, 4:13

Afternoon Session.

The house was called to order by the former moderator Rev. T J. Adair Prayer by the moderator The moderator then called the roll of churches and the following delegates responded:

3rd. What can best be done for the advancement of the Free Will Baptist Cause? Rev. T. J. Adair, Rev. Woods Springfield.

4th. Did Christ intend for his followers to wash each others feet? If so, why do the churches not practice it now? Rev. Woods Springfield, Rev. M. D. Clearman.

The moderator called for report of committee on devotional exercises.

Sunday Salvices.

Sunday morning the congregation met pursuant to adjournment.

The house was called to order by the moderator.

Song and prayer services conducted by Rev. T. J. Adair. At 11 o'clock am Rev. Woods Springfield preached to a large congregation. Subject, Sins against the Holy Spirit. Text, Acts 7:55.

Constitution.

Section 1. This association shall be known as the Vernon Free Will Baptist Association of Alabama, being composed of delegates from the different churches forming the same, each church being entitled to five delegates

- 2. This body shall be considered an advisory council, but having no authority over the affairs of the churches, unless they depart from the articles of Faith of this Association. In case any church departs from the articles of Faith and supports doctrines of heresay, or allows any minister of her body to teach doctrines not in keeping with our Articles of Faith, the same shall be dealt with by this Assocsation as it may see proper, according to the teachings of the Bible.
- 3. Each church in this Association shall be considered an advisory body and shall have control of its own internal affairs in matters of discipline etc., though the Association shall rule in matters of doctrine and general interest. The church may in extreme cases call in the aid of sister churches.
- 4 All questions of doctrine and general interest shall be settled by a two-thirds vote of the Association, and the decision shall be final.
- 5 The officers of this Association shall be a moderator, clerk and treasurer, who shall be chosen at each session by a majority vote.
 - 6. This Association shall meet annually at such time

and place as may be agreed upon by a previous annual session, and shall not adjourn until all business has been transacted.

- 7. Churches wishing to become members of this Association must adopt its Articles of Faith and conform to its usages.
- 8. We agree, as churches of this Association, to use our best influence to promote the interest of all moral and benevolent institutions; such as temperance cause, Sabbath Schools, missionary work etc.
- 9. No member of this Association shall be eligible to the office of moderator more than two successive terms, unless no other member is competent to act in that capacity.

Rules of Decorum.

- Article 1. This Association shall be called to order by the moderator who presided at the last session. Former clerk shall also officiate until the body is fully organized.
- 2. The Association shall be opened and closed with singing and prayer.
- 3. The moderator and clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.
- 4. The names of the delegates from the different churches shall be enrolled and called as often as necessary during the session.
- 5. A majority of the delegates present shall rule in all cases, except in the reception of churches into our body then it must be unanimous.
- 6. The moderator shall not be allowed to vote, except in case of a tie, then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, providing he appoints some one to the chair while he is speaking.
 - 7. Only one person shall speak at a time, who shall

rise and address the moderator.

- 8. No brother shall be interrupted while speaking, unless he departs from the subject under discussion, or use words of personal inflection.
- twice on the same subject, without leave from the Association, nor more than fifteen minutes at a time.
- 10. No member shall laugh or talk during the time the debate is going on.
- 11. No member shall absent himself from the Association without leave from the moderator.

Articles of Faith.

- Article 1. We believe there is one true and living God who is the supreme ruler of heaven and earth, self-existent Creator of all things; and revealed under the personal direction of Father, Son and Holy Ghost, equal in every divine perfection, and existing in distinct but harmonious offices in the great work of redemption.
- 2. We believe the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly instructions; that it has God for its author. Truth for its matter and Salvation for its end; that it reveals the principals by which God will judge us, and therefore is and shall remain to the end of this world the center of Christain Union, the supreme standard by which all human conduct, creeds and opinions will be tried.
- 3. We believe that man was created holy, under the law of his maker, but from voluntary transgression fell from that happy state, in consequence of which, all mankind are now depraved, and wholly unable of their own free will and ability to recover themselves from the fallen state in which they are by nature.
- 4. We believe that God has not fixed the future state of mankind by an absolute and unconditional decree, but salvation is offered in the Gospel free to all, and if sinners

are lost forever it will be their own fault.

- 5. We believe that Christ, by his death and sufferings made an atonement for the sins of all mankind in general and every individual in particular; however, none but those who believe in him can be partakers of the divine benefits.
- 6. We believe that true faith cannot proceed from the exercise of our natural faculties and powers, or from the force and operations of free will, since man, in consequence of his natural corruption is incapable either of thinking or doing anything spiritually good.
- 7. We believe in the general application of the grace of God to fallen man sufficiently to enable him, morally and actually, to obey the requirements of the law of liberty. Jas. 1:15, this is to act saving faith. John 1:9 however none but those who believe, or acquiesce in Christ will be saved thereby, Acts 17:32; Rómans 2:19; John 3:19.
- 8. We believe in the free moral agency of man, by the grace of God, before and after conversion, that he is laid under no invincible necessity by his Creator, to act in any given way; that if he lives after the flesh he shall die, but if he through the spirit do mortify the deeds of the body he shall live, and, therefore man is always a proper subject of admonition and exhortation. Heb. 11:12-13; Rom. 12:14; Mark 13:12; Eze. 18:24; Rev. 2 and 3 chapters Eze. 33:13 and 28; 1st Tim. 4:1; Heb. 3:5 1st Cor. 1:12-22; 1st Peter 1:10.
- 9. We believe that a visible church of Christ is a congregation of believers, associated by covenant in the faith of fellowship of the Gospel, observing the ordinances of Christ, governed by his laws, and exercising the gifts, rights and privileges invested in them by his word, that its only proper officers are bishops or pastors, and deacons, whose qualifications and duties are defined in the Epistles of Timothy and Titus
 - 10. We believe that Christians baptism is immersion

in water, in the name of the Father, Son and Holy Ghost; and that believers are the proper subject.

- __obligation, by which the members of the cuurch, in case of bread and wine, are to commemorate together, the dying love of Christ, preceded always by solemn self—examination.
 - We believe in open and free communion, and the churches of our body are authorized, through their pastors, to invite Christians of all orthodox churches who are in good standing in their respective churches to commune with us at the Lord's Table
 - 13. We believe in the resurrection of the dead and the general judgement; that the joys of the righteous and the punishment of the wicked will be eternal; upon the principals of grace and justice.
