#### MINUTES.

The Forty Second Annual Session of the Vernon Freewill Baptist Association was held with Union Chapel Church, October 23-24-25, 1922.

The Introductory sermon was preached by Rev. M. L. Hollis, text, Neh. 4-6. After preaching one hour was taken for refreshments.

The ministers and delegates assembled in the church house.

The former Moderator and Clerk being present proceeded to business as follows:

A song was sung and prayer by Moderator, who announced the Association ready for business.

- 1. By motion the Moderator appointed Bros. Grant Johnson and J. E. Chaffin as reading Clerks.
- 2. The letters from the various churches were called for, handed in and contents noted as per Statistical Table.
- 3. On motion it was agreed to permanently organize, which was done by electing Rev. M. L. Hollis Moderator and J. W. Chaffin, Clerk.

The Moderator and Clerk took their seats and after appropriate remarks by the Moderator for the honor he promised to discharge his duty to the best of his ability.

- 4. Called for corresponding messengers from sister Associations. Came forward Rev. J. D. Byars, T. A. Guin, J. T. Williams from Mt. Mirah, and J. B. Smith from Jasper. The Moderator and Clerk extended to them the right hand of welcome.
  - 5. Give invitation for new Churches, was none.

On motion the Association adjourned to meet Monday morning at 8 o'clock.

A song was sung and prayer was offered by M. D. Clearman. Benediction by the Moderator.

#### Sunday Service

Sunday morning at 9:00 o'clock the congregation was called together with a song which was followed by an interesting sermon delivered by Rev. S. F. Lee, Text Matt. 25:29.

At 11:00 o'clock Rev. J. D. Byars preached to a very large congregation, Text, St. John 3:18.

Sacrament was served to a large congregation. Intermission one hour.

The Choir arranged and rendered a fine song service and at 2 p. m., Rev. S. T. Coleman occupied the stand and preached, using for his Text, Gal. 5:17.

#### Monday Session

The Association met persuant to adjournment, opened by singing, Amazing Grace.

The Moderator reading the 25th Chapter Proverbs, followed by prayer, song after prayer, Amazing Grace.

The Association was called to order by the Moderator.

The Clerk called the roll. The Delegates answered to their names, and the Moderator announced a quorum present and the Association ready for business.

On motion the reading of the minutes of Saturday Session was omitted.

#### Called for Report on Various Committees

#### RULES OF DECORUM

Article 1. The Association shall be called to order by the Moderator who presided at the last session. Former Clerk also officiating until the body is fully organized.

Art. 2. The Association shall be opened and closed

with singing and prayer.

Art. 3. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.

Art. 4. The names of delegates from the different churches shall be enrolled and called as often as neces-

sary during the session.

- Art. 5. A majority of delegates shall rule in all cases, except in the reception of churches, then it shall be unanimous.
- Art. 6. The Moderator shall not be entitled to vote except in the case of a tie, and then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, provided he appoint some one to the chair while he is speaking.

Art. 7. Only one person shall speak at the same time, and he shall rise and address the Moderator, and

after recognition by the Moderator, proceed.

Art 8. No brother shall be interrupted while speaking, unless he depart from the subject under discussion, or use words of personal reflection.

Art. 9. No person shall be allowed to speak more than twice on the same subject without leave of the Association, nor more than fifteen minutes at a time.

Art. 10. No member shall laugh or talk during the

time the debates are going on.

Art. 11. No member shall absent himself from the Association without leave from the Moderator.

#### CONSTITUTION

Article 1. This Association shall be known as the Vernon Freewill Baptist Association of Alabama, and being composed of ministers and delegates from the different churches forming the same, each church being entitled to three delegates.

ing entitled to three delegates.

Art. 2. This body shall be considered an advisory council, but having no authority over the affairs of the churches, unless they depart from the articles of faith of this Association. In case any church depart from the articles of faith and supports doctrines of heresy, or allows any minister of her body to teach doctrine not in keeping with our articles of faith, the same

shall be dealt with by the Association as it may see

proper according to the teachings of the Bible.

Art. 3. Each church of this Association shall be considered an advisory body and shall control its own-internal affairs in matters of discipline, etc. Though the Association shall rule in matters of doctrine and general interests, though the church may in extreme cases call in aid from sister churches.

Art. 4. All questions of doctrine and matters of general interest shall be settled by a two-thirds vote of

the Association, and the decision shall be final.

Art. 5. The officers of this Association shall be a Moderator, Clerk and Treasurer, who shall be chosen at each session by a majority of votes.

Art. 6. This Association shall meet annually at such time and place as may be agreed upon by previous annual session, and shall not adjourn finally, until all

the business is transacted.

Art. 7. Churches wishing to become members of this Association must adopt our Articles of Faith and conform to its usages.

Art. 8. We agree as churches of this Association to use our best influence to promote the interest of all moral and benevolent institutions, such as Temperance Cause, Sabbath Schools, Missionary Work, etc.

Art. 9. No member of this Association shall be eligible to the office of Moderator more than two successive sessions, unless no other member be competent to act in that capacity.

#### Articles of Faith, and Church Covenant

1. The Bible. The Scriptures of the Old and New Testaments were given by inspiration of God, and are

our infallible rule of faith and practice.

2. God. There is one living and true God, revealed in nature as the Creator Preserver, and Righteous Governor of the universe, and in the Scriptures as Father, Son, and Holy Spirit, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.

3. Christ. Christ is God manifest in the flesh; in ris divine nature truly God, in his human nature truly man. The mediator between God and man, once cruci-

fied, he is now risen and glorified and is our ever present Saviour and Lord.

- 4. The Holy Spirit. The Scriptures assign to the Holy Spirit all attributes of God. He is the reprover, comforter, guide and sanctifier of men.
- 5. The Government of God. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.
- 6. The Sinfulness of Man. Man was created innocent but by disobedience fell into a state of sin and
  condemnation. His posterity therefore inherit a fallen nature of such tendencies that all who come to
  years of accountability sin, and become guilty before
  God.
- 7. The Work of Christ. The Son of God Ly his incarnation, life, sufferings, death and resurrection effacted for all a redemption from sin that is full and free and is the ground of salvation by faith.
- 3. The Terms of Salvation. The condition of salvation are 1. Repentence or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey him in all things In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obeidence until death.
- 9 Election. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become his elect.
- 10. Freedom of the Will The human will is free and self-controlled, having power to yield to the influence of the truth and the spirit, or to resist them and perish.
- 11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take the water of life freely.
  - 12. Perseverance. All believers in Christ, who

through grace persevere in holiness to the end of life have promise of eternal salvation.

- 13. Gospel Ordinances. Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel: Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.
- 14. The Christian Sabbath. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works and activities, and for personal communion with God.
- 15. Resurrection, Judgment and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done ill unto the resurrection of judgment; then the wicked will "go away into eternal punishment but the righteous into eternal life."
