PROCEEDINGS of 1924

The Forty Fourth Annual session of the VERNON FREE WILL BAPTIST ASSOCIATION convened with Mt. Willing Church, on Friday, Baturday and Sanday, October the 17th, 18th and 19th, 1924. At eleven o'clock a.m. the congrigation was called to-gather by a song after which Rev. M. L. Hollis occupied the stand and preached a very able introductory sermon, subject. "Go forward." Exodus 14:15. After which one hour was taken for refreshments. In due time the body was called back into the house by the Moderator, Rev. C. A. Chaffin.

The house was called togeather by the moderator, after a song, devotional service was conducted by Rev. J. L. Conner, reading for his lesson the 5 chapter of Gal. Prayer by Rev. T. G. Harrison.

Rall call of delegates, there being a quorum present the moderator announced the assciation ready for buisness. Motion offered and carried to omit the reading of Saturday minutes. Called for reports of committees as follows:

ON DOCUMENTS and ORDER of BUISNESS

We, your committee on documents and order of buisness, beg to submit the following roport:

1st. We recomend the former order of buisness.

2nd. We recomend that the next session of of this association be held with Mt. Harmony church, the same to convene on Saturday before the third Sunday in October, 1925.

- 3rd. We recomend that we have 500 copies of minutes printed, and that we let our home press do the printing, also that the clerk superentend this work, and that he be allowed \$8.00 for his service.
- 4th. We recomend that we adopt the Articles of Faith of the Origonal Free Will Baptist of the United states
- 5th. We recomend that the moderator preach the Introductory sermon at the next association, or appoint someone to preach it in his stead.
- 6th. We recomend that we hold fifth Sundays meetings instead of a Union meeting, and that no pastor accept any work on fifth Sundays, as he should attend these stated meetings, and that they begin on raturdays before the fifth Sundays.
- 7th. We recomend that the 6th article of the Constitution be amended to read as follows: "This Association shall meet Annually on Saturdays before the third Sundays in October, and the place of meeting shall be set by the previous session, and shall not adjourn finally until all the buisness is transacted."
- 8th. We recomend that this association adept the resolution as adopted by the second Union meeting, held at Liberty church, which were as follows: "That each church in the association take up a volentary collection at each monthly service, the same to be turned over to the church Treasurer, to be used as the church may direct for the advancement of church work.
- 9th. We recomend that the first meeting day after the association be designated as Educational day, and that all collections taken on that day be contributed to the Free Will Baptist College at Ayden, N. U.

Mt. Pleasant church also turned into the Association \$3.61, on "old worn out ministers fund." Making a total of \$19.61, which was given to Rev. G. B. Taylor by the Association.

After some short talks by the Moderator and others, the Association having finished all the business came to a close to meet with Pearces Chapel church, four miles north of Smithville, Miss., on Saturday before the third Sabbath in October, 1926.

The parting hand was taken while the choir sang "God be with you till we meet again."

CONSTITUTION

Article 1. This Association shall be known as the Vernon Freewill Baptist Association of Alabama, and shall be composed of delegates from the different churches forming the same, each

church being entitled to three delegates.

Article 2. This body shall be considered an advisory council, but having no authority over the affairs of other churches, unless they depart from the articles of faith of this Association. In case any church departs from the articles of faith and support doctrines of heresy, or allows any ministers of her body to teach doctrines not in keeping with our articles of faith, the same shall be dealt with by this Association as it may deem proper and right, according to the teachings of the Bible.

Article 3. Each church in this Association shall be considered an advisory board and shall control its own internal affairs in matters of discipline, etc., though the church may in extreme cases claim aid from sister churches, but the Association shall

rule in all matters of doctrine and general interest.

Article 4. All questions of doctrine and matters of general interest shall be settled by two-third vote of the Association and

the decision shall be final.

Article 5. The officers of the Association shall be Moderator, Clerk and Treasurer, who shall be chosen at each session by a majority of votes.

Article 6. The Association shall meet annually at such time and place as may be agreed upon by the previous annual session, and shall not adjourn finally until all business is transacted.

Article 7. Churches wishing to become members of this Association must adopt its articles of faith and conform to its usages.

Article 8. We agree, as churches of this Association, to use

our best influence to promote the interest of all moral and benevolent institutions, such as the temperance cause, Sabbath Schools, Missionary work, etc.

RULES OF DECORUM

Rule 1. The Association shall be called to order by the Moderator, who presided at last session. The former Clerk also officiating until the body is fully organized.

Rule 2. The Association shall be opened and closed with

singing and prayer.

Rule 3. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.

Rule 4. The name of delegates from the different churches shall be enrolled and called as often as necessary during the

session.

Rule 5. A majority of delegates present shall rule in all cases, except in the reception of new churches, then it shall be unanimous.

Rule 6. The Moderator shall not be entitled to vote except in case of a tie, and then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, provided he shall appoint some one to the chair while he is speaking.

Rule 7. Only one person shall speak at the same time, who

shall arise and address the Moderator.

Rule 8. No brother shall be interrupted while speaking unless he depart from the subject under discussion, or use words of personal reflection.

Rule 9. No person shall be allowed to speak more than twice on the same subject, without leave of the Association, nor more

than fifteen minutes at a time.

Rule 10. No member shall talk or laugh during the time the

debate is going on.

Rule 11. No member shall absent himself from the Association without leave of the Moderator.

Rule 12. The Moderator shall have power to call the Association together at any time upon a petition of two-thirds of the churches composing the Association over which he presides.

Rule 13. That the appointment of all committees by the Moderator be confined to ministers and delegates composing the Association.

ARTICLES OF FAITH

14,1

Article 1. We believe there is one true and living God, who is the Supreme Ruler of Heaven and Earth, self-existent Creator of all things, and revealed under the personal distinction of Father, Son and Holy Ghost, equal in every divine perfection, and exisiting in distinct but harmonious offices in the great work of redemption.

Article 2. We believe the Holy Bible was written by men divinely inspired and is a perfect treasure of heavenly instruction; that it has God for its author, truth for its matter and salvation for its end; and it reveals the principles by which God

will judge us, and therefore is and shall remain to the end of the world, the center of Christian union, the supreme standard by which all human conduct, creeds and opinion will be tried.

Article 3. We believe that man was created holy under the laws of his Maker, but from voluntary transgression fell from that holy state, in consequence of which all mankind are depraved and wholly unable of their own will and ability to recover from the fallen state in which they are by nature.

Article 4. We believe that God has not fixed the future state of mankind by an absolute and unalterable decree; but salvation is offered in the Gospel free to all, and if sinners are lost forever it will be their own fault.

Article 5. We believe that Christ, by his death and suffering made an atonement for the sins of all mankind in general, and every individual in particular; however, that none but those who believe in Him can be partakers of the divine benefits.

Article 6. We believe that true faith cannot proceed from the exercise of our natural faculties and powers or from the force and operation of the free will, since man in consequence of his natural corruption is incapable either of thinking or doing anything spiritually good.

Article 7. We believe in the general application of the grace of God for fallen men sufficient to enable him morally and actually to obey the requirments of the law of liberty-James 1:25, this is to act saving faith. John 1:9 however, none but these who believe or acquiesce in Christ will be saved thereby; Acts 17:32; Romans, 2:9; John 3:19.

Article 8. We believe in the moral agency of man by the grace of God, before and after conversion; that he is laid under no invincible necessity, but his Creator, to act in a given way, that if he lives after the flesh he shall die, but if he through the spirit, do mortify the deeds of the body he shall live, and therefore, man is always a proper subject for admonition and exhortation. Hebrews 11:12-13; Romans 12:14; Mark 14:12; Ezekiel 18:24; Rev. 2:3; Ezekiel 33:13 and 28; 1st Tim. 4:1; Hebrews 3:5; 1st Cor. 10:12 and 22; 1st Peter 1:10.

Article 9. We believe that visible church of Christ is a congregation of believers, associated by covenant in faith and fellowship of the Gospel, observing the ordinances of Christ, governed by His laws and exercising the gifts, rights and privileges invested in them by His word; that its only proper officers are bishops, pastors and deacons, whose qualifications, claims and duties are defined in the Epistles of Timothy and Titus.

Article 10. We believe that Christian Baptism is immersion in water in the name of the Father, Son and Holy Ghost, and the believers are proper subjects.

Article 11. We believe the Lord's Supper is a perpetual obligation, by which the members of the church in the use of the bread and wine, are to commemorate together the dying love of Christ preceded always by solemn self-examination.

Article 12. We believe in the resurrection of the dead and the general judgment; and joys of the righteous and the punish-

ment of the wicked will be eternal upon principles of grace and justice.

Article 13. We beieve in open and mixed communion and the churches of our body are authorized, their pastors, to invite Christians of all orthodox churches, who are in good standing in their respective churches, to commune with us at the Lord's Table.
