## PROCEEDINGS OF THE Fourty Seventh Annal Session OF THE Vernon Association OF

#### **Free will Baptist**

The Fourty Seventh Annual Session of the Vernon Association, of Free Will Baptist, while convenced with Liberty Church eight miles East of Vernon, Alaba ma, on Thursday night, before the third S nday in Octbor 1927. Eld. C. A Chaffing who was appointed to preach the introductory surmon, being absent, the committee on arangements recommended that Eld. M. L. Hollis preach the opening sermon. using as his subject "Looking Forward' Text, Heb. 12: 2 A large crowd was present and all seemed to have enjoyed the opening service extensively. After the Delegates were assigned to homes, the body adjourned to meet back Friday at 8 a, m. Congreation dismissed with pray by Eld, T. C. Harrison.

#### Morning Session.

Met by singing. The former Moderator being absent, the former Clerk, Eld. M L. Hollis read a Scrip ture lesson from Romans 12th. chapter and offerd prayer, after which Eld. J. W. A move and second was made that Moderator be empowerd to appoint all committees. Move was made to adjourn until 1 p. m. for refreshments. The people of Liberty commutive spread a luxurious dinner which seemed to be enjoyed by all present.

#### **Afternoon Session**

At the appointed time the congregation met after enjoying a few real Spiritual songs led by W. N. Crossley, prayer by Eld E. B. Springfield the Moderator announced the body ready for business. The following committee were appointed.

Tate the committee returned a favorable report; and Eld. M. L. Hollis was appointed by the Association to deliver the charge and take the lead in the ordination services, which was done very effecentaly,

The committee on Preaching made the following

report that Eld. E. B. Springfield preached at 230 p. m. Friday. And Eld. Gib Carmack preached 730. p. m. Saturday Eld. W. C Austin preached at 11 a. m. Eld. Frank Lee preached at 730. p. m. Sunday Eld. G. H. Taylor preach at 930 a. m. Eld. J. W. Porter preached at 11. a m. Eld. W. C. Austin, at 3 p. m.

The congregation was recessed for ten minutes after which they were called back into the house for preaching service; after song and prayer Eld. E. B Springfield enter the pulpit and delivered a good mes sage using as a text John 5; 6. "Wilt thou be made whole;" At the close of the service a general hand shake was taken, during which time many rejoyiced and paised God. A moved and second made to adjourn until Saturday at 8 a. m. carried.

#### **Friday Night Session**

At 7 p. m. a large crowd had gethered back at the church for the evening service. After having a number of good songs and prayers, Eld. Gib Carmack preached a sermon that was enjoyed by a host of people, using as his text St. John 3:7; "Ye must be borned again."

At this point a number of good talks were make on the Sunday School, and the need of a Sunday School in every church.

Called for the report on Quarys and Resolutions. See report.

Called for report on Deceased members. See report. Called for report on Preaching.

Motion was made to adjourn 10 minutes befor preach ing. At 11 a. m. the congregation reassembled in the house for preaching, after singing a few good songs Elder W. C. Austin filled the pulpit and preached a noble sermon, using as a text Isa. 28:16-20. This was a real in-

spiring message and every one present seemed to enjoy it. One hour was taken for refreshment.

#### **After-Noon Session**

At the appointed time the house was called to order by song and prayer. The Moderator announced the body ready for business.

First a move and second to seat with us Elders W. D. Martin and Bob Franks, from the Jasper Association. The Moderator and Clerk extended to them the right hand of fellow ship.

Called for report on Literature and Education. See report. Elder W. C. Austin made a lengthy talk on the need of a better Educated Ministery and a more whole some literature.

Called for report on Finance. See Report.

At this time the Moderator made a very appropate talk on the need of our old preachers. A collection for this purpose was taken which amounted to \$20.05 which was given to Elders G. B. Taylor and S. M. Perkins, two of our Oldest Ministers. Both the aboved named ministers offered words of apprecation to the Association for their thoughtfulness of them in their old age.

Motion to indorse Eld, W. C. Austin as a representative of the Free Will Baptist Church, a man that we are proud of for his loylty in defending our doctrine, which we truly believe to be the true doctrine of the Bible.

At this time Eld. W C. Austin made a very strong appeal in behalf of his Bible School which is to be taught in Townley, Alabama beginning on November 21, 1927.

#### ARTICLES OF FAITH

Article 1. We believe there is one true and living God who is the Supreme Ruler of Heaven and Earth, self-exist ent Creator of all things, and revealed under the personal distinction of Father, Son and Holy Ghost, equal in every divine perfection, and existing in distinct but harmonious offices in the great work of redemption.

Article 2. We believe the Holy Bible was written by men divinely inspired and is a perfect treasure of Heavenly instruction, that it has God for its author, truth for its matter and salvation for the end; and it reveals the principles by which God will judge [us, and therefore is and shall remain to the end of the world, the center of Christ-

ian union, the supreme standard by which all human conduct, creeds, and opinion may be tried.

Article 3 We believe that man was created holy under the laws of his Maker, but from voluntary transgression fell from that holy state; in consequence of which all mankind are depraved and wholly unable of their own will and ability to recover from the fallen state in which they are by nature.

Article 4. We believe that God has not fixed the future state of mankind by an absolute and unalterable decree; but salvation is offered in the Gospel free to all, and if sinners are lost forever it will be their own fault.

Article 5. We believe that Christ. by his death and suffering made an atonement for the sins of all mankind in general and every individual in particular, however that none but those who believe in Him can be partakers of the divine benefits.

6. We believe the true faith cannot proceed from the exercise of our natural faculties and powers or from the force and operation of the free will, since man in consequence of his natural corruption is incapable either of thinking or doing anything spiritually good. Article 7. We believe in the general application of the grace of God for fallen man sufficient to enable him morally and actually to obey the requirements of the law of liberty-James 1:25,this is to act saving faith. John 1:9 however none but those who believe or acquiesce in Christ will be saved thereby; Act 17:32; Romans, 2:9. John 3:19.

Article 8. We believe in the moral agency of man by the grace of God, before and after conversion; that he is laid under no invisible necessity, but his Creator, to act

in a given way, that if he through the Spirit, do mortify the deeds of the body he shall live, and therefore, man is always a proper subject for admonition and exhortation Hebrews 11:12-13. Romans12 :14. Mark 14:12. Ezekiel 18:24 Rev 2:3; Ezekiel 33:13 and 28; 1st Tim. 4:1, Hebrews 3:5; 1st Cor. 10:12 and 22; 1st Peter 1:10.

Article 9. We believe that the visible church of Christ is a congregation of believers, associated by covenant in faith and fellowship of the Gospel, observing the ordinances of Christ; governed by his laws and exercising the gifts, rights and privileges invested in them by His word; that its only proper officers are bishops, pastors and deacons, whose duties are defined in the Epistles of Timothy and Titus.

Article 10. We believe that Christian Baptism is immersion in water in the name of the Father, Son and Holy Ghost, and the believers are proper subjects.

Article 11. We believe the Lords Supper is a perpetual obligation, by which members of the church in the use of bread and wine are to commemorate together the dying love of Christ preceded always by solemn self examination.

Article 12. We believe in the Resurection of the dead and the general judgment; and the joys of the righteous and the punishment of the wicked will be eternal upon principles of grace and justice.

Article 13. We believe in open and mixed communion and the Churches of our body are authorized their pastors to invite Christians of all orthodox churches, who are in good standing in their lrespective churches, to commune with us at the Lords Table.

#### CONSTUTION

Article 1. This Association be known as the Vernon Free Will Baptist Association of Alabama and shall be composed of delegates, from the different churches forming the same; each church, being title to three delegates.

Article 2. This body shall be considered an advisory council, but having no authority over the affairs of the churches; unless they depart from the faith of this Association. If any church, depart from the articles of faith, and support doctrines of heresy or allows any minister to teach doctrines not in  $\kappa$  eeping with our articles of faith, the same shall be delt by this Association as it may deem proper and right, according to the Bible.

Article 3 Each church in this Association, shall be considered an advisory board, and shall control its own internal affairs in matter of discipline, etc. though the church in extreme cases clain. aid from sister churches; but the Association shall rule in all matters of doctrine and general interest.

Article 4. All questions of doctrine and matters of general interest shall be settled by two third vote of the Association, and the decision shall be final.

Article 5 The officers of the Association, shall be a Moderator Clerk, and Treasurer, who shall be chosen at each session by a majority of votes.

Article 6. The Association shall meet annualy at such time and place as may be agreed upon by the previous annual session, and shall not adjourn finally until all business is transacted.

Article 7. Churches wishing to become mem-

bers of this Association must adopt its Articles of Faith and conform to its useage

A ticle 8. We agree, as churches of this Association, to use our best influence to promote the interest of all moral and benevolent institutions, such as the temperance cause, Sabbath School, Missionary work etc.

#### **Rules of Decourm**

Article 1 The Association shall be called to order by the Moderator who presided at last session; former Clerk also officiating untill the body is fully organized.

2 The Association shall be opened and closed with singing and prayer.

3 The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.

4 The names of delegates from the different churches shall be enrolled and called as often as necessary during the session.

5 A majority of delegates present shall rule in all cases except the reception of members, then it shall be unanimous.

6 The Moderator shall not be entitled to vote, except in cases of a

tie and then he shall give the deciding vote. He shall also speak on any question after others has spoken, providing he appoints some one to the chair while he is speaking.

7 Only one person shall speak at the same time and he shall arise and address the Moderator and after recognition by Moderator proceed.

8. No brother shall be interrupted while speaking, unless he departs from the subject under discussion, or use words of personal reflection.

9 No person shall be allowed to speak more than twice on the same subject without leave of Association, nor more than fifteen minutes at a time.

10 No person shall laugh or talk during the time the debate is going on.

11 No person shall absent himself from the Association without leave of the Moderator.

12. The Moderator shall have the power. to: call: the Association together at any time upon a petition of two-thirds of the churches composin; the Association over which he resides.

That the appointment of all the committees by the Moderator 13 be confined to ministers and delegates composing the Association.
