The next session of this Association will be held with Mt. Willing Church, Saturday before the third Sunday in October, 1943. Rev. M. E. Carpenter to preach the Introductory Sermon. Rev. S. F. Lee, alternate.

PROCEEDINGS SATURDAY A. M.

The 62nd annual session of the Vernon Free Will Baptist Association met with Belk Free Will Baptist Church on October 17, 18 and 19, 1942.

Services began with singing and prayers. Bro. Bill Mc-Donald being in charge of the singing.

After some singing and prayers Rev. J. S. Fredrick read the 23rd Psalm and was in charge of a short devotional, after which Rev. E. W. Graves preached the introductory sermon, using for a text Numbers 11:4-6.

After the message the body was dismissed for dinner by Rev. A. L. Warren from the Jasper Association.

SATURDAY P. M.

1. After lunch the congregation was called together by Rev. E. W. Graves, present Moderator.

After song and prayer a move was made and carried to enter into the business of the Asociation.

The present Moderator E. W. Graves read the program for holding the Association, after which he appointed reading clerks to read the letters from the various churches, which were as follows: Bro. Fletcher Collins and Rev. J. S. Fredrick.

Letters of the various churches were called for and read as noted in statistical table.

A move was made and carried to seat the delegates from the various churches.

Delegates being seated a call for petitionary letters was made, none recieved.

Delegates being present from Depriest church, called for a letter of recommendation to the North East Miss., Associtaion.

Called for the election of officers, which were done by ballot; and Bro. J. M. Stokes, and Rev. J. L. Lavender from the Mt. Marriah Association were appointed to count the votes. Officers elected were as follows: Moderator, J. S. Fredrick; Assistant Moderator, S. F. Lee; Clerk, D. G. Jordan.

The newly elected Moderator made some remarks of the honors bestowed upon him, then called for corresponding delegates from the different Associations, which were as follows: Jasper—Rev. A. L. A move was made and carried to adjourn business till 9:00 A. M. Monday.

SATURDAY NIGHT

At 8:15 A. L. Warren preached to a very attentive aduience from St. John 6:66-68.

SUNDAY MORNING

A large crowd gathered Sunday morning for song and prayer service, after which Rev. M. E. Carpenter gave an interesting lecture on the Sunday School lesson (Growth in Christ). after which the Kelly children sang a song and Sister Kate Williams prayed a special prayer for our boys in U. S. service.

At 11:00 o'clock Rev. L. Q. Larwood preached a great message from Ezekiel 34 and Proverbs 29.

SUNDAY EVENING

After a good song and prayer service Rev. J. L. Lavender preached from St. John 14th chapter, subject (The Way).

SUNDAY NIGHT

- 7. We recommend that this delegate body act upon Article 11 in 1941 minute. Article 11 of 1941 repealed.
- 8. We recommend that the committee on Credentials have the same authority to investigate Deacons as Ministers.

FINANCE REPORT

We, your committee on Finance submit the following report: We have collected as minute funds \$45.58.

A move was made and carried to grant a letter of dismissal to Depriest Church.

It was moved and carried to represent in the Alabama State Association with delegates and to send \$50.00 as minute funds, and that the Association pay part of the delegates expense, upon which the following were appointed as delegates to the State Association, Harvey Clearman, V. C. May, W. M. Fields.

The Moderator appointed the following as corresponding delegates to the Sister Association: To Jasper Association S. F. Lee, M. E. Carpenter; North East Miss., V. C. May, D. G. Jordan; Progressive, E. W. Graves, Bill Glasgow; Mt. Marriah, Harvey Yerby D. C. Hall, W. W. Barnes; State Line, J. S. Fredrick, S. F. Lee.

The Moderator appointed M. E. Carpenter, Jim Chaffin, and J. G. Taylor to decide where the next union meeting should be held. The committee sent it to Union Chapel. A public donation was taken for superanuation which amounted to \$15.00.

It was suggested that there be a memorial service in honor of our deceased. Rev. S. F. Lee preached a great memorial message.

A move was made and carried to drop Beaverton church from list.

Three being no other business there was a song and the parting hand shake had.

The Association was dismissed to meet with Mt. Willing Church, on Saturday before the 3rd Sunday in October, 1943.

PROGRAM FOR HOLDING ASSOCIATION

- 1. The Asociation shall be called to order and presided over by the officers elected at the close of the last session.
- 2. The Association shall be opened and closed with singing and prayer.
- 3. The Moderator and Clerk shall be chosen by ballot just prior to the close of each session of the Association, by a majority vote of the delegates present.
- 4. The names of delegates from different churches shall be enrolled and called as often as necessary during the session.

- 5. A majority of the delegates shall rule in all cases, except in the reception of churches, then it should be unanimous.
- 6. The Moderator shall not be entitled to vote, except in case of a tie and then he shall cast the deciding vote. He shall be en titled to speak on any question, after others have spoken, provided he appoint someone to the chair while he is speaking.
- 7. Only one person shall speak at a time and he shall rise and address the Moderator and after recognition by the Moderator shall proceed.
- 8. No brother shall be interrupted while speaking, unless he depart from the sbject under discussion or use words of personal reflection.
- 9. No person shall be allowed to speak more than twice on the same subject without the authroity of the Association more than fifteen minutes.
 - 10. No person shall laugh or talk during discussions.
- 11. No person shall absent himself from the Association with-out permission of the Moderator.

CONSTITUTION

- 1. The Association shall be known as the Vernon Free Will Baptist Association of Alabama, being composed of ministers, deacons and delegates from different churches forming the same. All having full power to vote on all questions which come before the Association. Each church being entitled to three delegates in addition to ministers and deacons.
- 2. This Body shall be considered an advisory council, having no authority over the internal affairs of the churches unless the j depart from the Articles of Faith of this Association. This Association shall have authority over all ministers in the matter of doctrine, character, and etc. In case any minister in this Association depart from and teach doctrine not in keeping wit hthe Articles of Faith of this Association, the same shall be dealt with by the Association as it may seem proper, according to the teachings of the Bible.
- 3. Each church of this Association shall be considered an advisory body and shall control its own internal affairs in matters of discipline, and etc. If any Brother feels impressed to preach the Gospel, the Church shall or may recommend such a Brother to the Association and upon examination of the Brother's qualifications, if in judgement of the Body, the Brother would be useful, they shall confer ordination, same being done at the Association by a legal Presbytery.
- 4. All questions of doctrine and general interest shall be settled by a majority vote of the Association, and the decision shall be final.
- 5. The officers of the Association shall be a Moderator, Clerk and Treasurer, who shall be chosen at each session by a majority vote.
 - 6. The Association shall meet annually at such time and place

as may be agreed upon at the previous session and shall not adjourn finally until all business matters are transacted.

- 7. Churches wishing to become members of this Association must adopt its Articles of Faith and conform ito its usage.
- 8. We agree as church of this Association to use our best influence to promote the interest of all moral and benevolent institutions, such as temperance caus, Sabbath Schools, Missionary work, etc.
- 9. No member of this Association shal be eligible to serve as Moderator for more than two consectutive sessions unless no other member be competent to act in that capacity.
- 10. Any member of this Association who shall be guilty of circulating reports of any nature or aiding in the circulation of any report that is untrue on a brother minister that is caculated to injure his moral reputation and religious influence, the same shall be dealt with by the Association. Any minister of this Association who is known to be guilty of using intoxicating spirits by drinking as a beverage, which is caculated to destroy his influence and usefulness, the same shall be dealt with by this Association as it may deem, proper, according to the teachings of the Bible.
- 11. The Association shall in all cases in the transaction of all business brought before it, be governed by a majority of all delegates present, and any church or delegates failing or refusing to do so is and shall be considered by the Association as being out of order. Each member is to be a party to the enforcement of same.

ARTICLES OF FAITH

- 1. We believe there is one true and living God who is the ruler of Heaven and earth, self-existent Creator of all things, revealed under personal distinction of Father, Son and Holy Ghost, equal in every divine perfection and existing in distinct but harmonious offices in the great work of redemption.
- 2. We believe the Holy Bible was written by men divinely inspired and is a treasure of Heavenly instructions; that it has God for its author, truth for its matter and savation for its end; that it reveas principles upon which God will judge us and therefore is and shall remain to the end of the world the center of Christians Union, the supreme standard by which all human conduct, creeds and opinions will be tried.
- 3. We believe that man was created holy, under the law of his Maker, but from voluntary transgression fell from that holy state; in consequence of which all mankind is now deprived and unable of his own free will and ability to recover from the fallen state which he is in by nature.
- 4. We believe that God has not fixed the future state of mankind by an absolute and unconditional decree, but salvation is offered in the Gospel free to all and if sinners are lost forever, it will be their own fault.
 - 5. We believe that Christ by His death and suffering made an

atonement for the sins of mankind in general and every idnividual in particular who believes in Him can partake of the Divine benefit.

- 6. We believe that true faith cannot proceed from the exercise of our natural faculties and powers, or from the force and operation of our own free will, since man, in consequence of his natural correption is incapable of thinking or doing anything spiritually good.
- 7. We believe in the general application of the grace of God to falen men sufficiently to enable him morally and actually to obey the requirement of the law of liberty (James 1:5), this the Act-saving Faith (John 1:9). However, none but those who believe in Christ will be saved thereby (Acts 17:32; Romans 2:19; John 3:9).
- 8. We believe in the free moral agency of man, by the grace of God before an dafter conversion; that he is under no invincible necessity by his Creator to act in any given way; that, if he lives after the flesh he shall die, but if he, through the spirit do motify the deeds of the body, he shall live, and therefore man is always a proper subject of admonition and exhortation (Heb. 11:12-13). Romans 13:14; Mark 13:12; Ezekiel 18:24; Rev. 2nd and 8th chapters; Ezek. 33:13-28; I Tim. 4:1; Heb. 3:5; Cor. 1:12-24; I Peter 1:10).
- 9. We believe the visible Church of Christ is a congregation of believer, associated by covenant in the fellowship of the Gospel observing the ordinance of Christ, governed by His law and exercising the gifts, rights and privileges invested in them by His Word; that its only proper officers are bishops, pastors and deacons whose qualifications and duties are defined in the epistles of Timothy and Titus.
- 10. We believe that Christian baptism is immersion in water in the name of Father, Son and Holy Ghost, and that believers are the proper subjects.
- 11. We belive the Lord's Supper is a perpatual obligation by which members of the church are to commemorate together, in the form of bread and wine, the dying love of Christ, preceded always by solemn self-examination.
- 12. We believe in open and free commeunion, and the churches of our Body are authorized, through their pastors, to invite all Christians of orthodox churches, who are in good standing in their respective churches, to commune with us at the Lord's table.
- 13. We believe in the resurrection of the dead and the general judgement; that the joys of the righteous and the punishment of the wicked will be eternal, upon the principles of grace and justice.
- 14. Concerning the washing of the Saint's feet as a Gospel ordinance, each member shall have the right to participate in such ordinance as he can best answer his own conscience to God, without criticism on the part of anyone.

MINUTES OF THE SUNDAY SCHOOL CONVENTION

The West Alabama Sunday School Convention met with Union Chapel Church on May 31, 1942.

The Convention was called to order by E. W. Graves, the Moderator, after some singing and prayers, Bro. Harvey Yerby gave a splendid lecture on the Sunday School lesson, which deals with the betrayal and crusifiction of Christ.

The Moderator gave a short talk on the purpose of the meeting, after which Miss Bertie Mae Franks made a great lecture on the subject: (A Spiritual Sunday School). In this lecture she drew a beautiful picture of the requisites of a Sunday School teacher, also the method of teaching different ages of children.

The Kelly children sang a quartet after which Superintendent G. S. Smith gave a lecture on "The Moral side of Life." In this lecture Mr. Smith pointed out how important fire side training and Sunday School teaching were upon the child to produce a good moral character, and Christian life.
