CONSTITUTION.

- 1. This Association shall be known as the Water Valley Free Baptist Association of Mississippi, and shall be composed of delegates from the different churches forming the same, each church being entitled to three delegates and their ministers and deacons.
- 2. This body shall be an advisory council, but having no authority over the churcles.
- 3. Each church in this Association shall be an advisory body and shall control its own internal affairs.
- 4. The officers of this Association shall be a moderator, a clerk and a treasurer, who shall be chosen at each session by a majority of votes.
- 5. This Association shall meet annually at the time and place agreed upon by a previous annual session.
- 6. Churches wishing to become members of this Association must adopt the articles of faith and this Constitution and conform to its usages.
- 7. We agree, as churches of this Free Baptist Association, to use our best influence to promote the Cause of Christ.
- 8. The Minutes of this Association shall be its order of business.
- 9. The Moderator of this Association at each annual session shall read the Articles of Faith in these Minutes to this Association when convened.

ARTICLES OF FAITH.

THE BIRLE: The Scriptures of the Old and New Testament, were given by the inspiration of God, and are our infallible rule of faith and practice.

2. God: There is one living and true God, revealed in nature as the Creator, Preserver and Righteous Governor of the Universe, and in the Scriptures as Father, Son and Holy Spirit, and yet as one God, infinitely wise and good, whom all-

intelligent creatures are supremely to love; adore and obey.

- 3. Christ: Christ is God manifest in the flesh. In his divine nature, truly God; in his human nature, truly man; The mediator between God and man. Once crucified, he is now risen and glorified and is our ever present Savior and Lord.
- 4. THE HOLY SPIRIT: The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter Guide and Sanctitier of Men.
- 5. The Government of God: God exercises a wise and benevolent Providence over all beings and all things by maintaining the Constitution and Laws of Nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.
- 6. The Sinfulness of Man: Man was created innocent, but by disobedience fell into a state of sin and condemnation; his posterity, therefore, inherit a fallen nature of such tentencies that all who come to years of accountability sin and become guilty before God.
- 7. The Work of Christ: The Son of God, by his incarnation, life, sufferings, death and resurrection, effected for all a redemption from sin that is full and free and is the ground of salvation by faith.
- 8. The Terms of Salvation: The conditions of salvation are repentance, or sincere sorrow for sin, and hearty renunciation of it. Faith, or the unreserved committal of one's self to Christ as Savior and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sir, and becomes a child of God, continuing in faith and obedience until death.
- 9 Election: God determined from the beginning to save all who should comply with the conditions of salvation; hence by faith in Christ men become his elect.
 - 10. Freedom of the Will: The human will is free and

self-controlled, having power to yield to the influence of the truth and the spirit or to resist them and perish.

- 11 Salvation Free: God desires the salvation of all, the gospel invites all, the Holy Spirit strives with all, and whose-ever will may come and take of the water of life freely.
- 12. Perseverance: All believers in Christ who, through grace, persevere in holiness to the end of life, have promise of salvation.
- 13. Gospel Ordinances: Baptism, or the immersion of believers in water, and the Lord's Supper are ordinances to be perpetuated under the gospel of universal obligation and to be administered to all true believers.
- 14. The Christian Sabbath: The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works and activities and for personal communion with God.
- 15. RESURRECTION AND FINAL RETRIBUTION: The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done ill unto the resurrection of judgment. The wicked will go away into eternal punishment, but the righteous into eternal life.

Annual Report of Pine Valley church to the Asssociation:

We have appointed J. W. Starns, Sister Jane Jackson and Sister Barna Jackson delegates to represent our church in your body. Elder J. H. Norwood is our pastor, J. W. Starnes our clerk; time of meeting the 4th Sunday in each month. We send for minutes, \$1.40; \$1.00 for clerk fees. In our body there is one ordained minister, M. J. Kisner, one licensed minister, H. Starnes; total members, 92. We report the death of Brother Hugh Elliott, Sister Ellen Jackson, Sister Vela Moore and Brother E. A. Grisham.

Hill church, that he was excluded from the church at Union Hill years ago, and inasmuch as he misrepresented the facts in the case to the church at Antioch, your Committee requests that said church rescind its action in receiving W. B. Tramble into the fellowship of said church. We find that W.B. Tramble was excluded from Union Hill church for scriptural reasons after scripturally complying with scriptural prerequisites. We request Brother Tramble to make scriptural acknowledgment to said church. We further find that Brother J. H. Norwood did introduce a proposition and present it to Union Hill church advising said church to drop all trouble that existed between said church and W.B. Tramble. We believe such action to be unscriptural, and request Bro. J. H. Norwood to make scriptural acknowledgment to this Association and to Union Hill church for such action.
