

Resolution

- 2. Be it resolved that this Association insert in the minutes of each Quarterly Meeting the names and addresses (including street number) of each church and a copy of the minutes be mailed to each minister in the Association.
- 3. Be it resolved that this Association shall not license nor ordain any Deacon nor Minister who does not believe and practise tithing. Their tithing being a part of the record to be submitted to the Board at the time of presentaion for examinaion for credentials.
- 4. Be it resolved that the address of the church where the meeting takes place be put in the program.
- 5. Be it resolved that our Articles of Faith be printed in our minutes with the Scriptures added to it.
- 6. Be it resolved that our Quarterly Conferences convene on Friday evening and run through Saturday.
- 7. Be it resolved that our Treasurer's Report be printed in full, that is, total receipts and disbursements, as in our 1952 minutes.
- 8. Be it resolved that every Pastor and Delegate take to his church a report about League work and the necessity of its support financially.

Article I

THE BIBLE

We believe the scriptures of the Old and New Testaments were given by the inspiration of God, and are our infallible rule of faith and practice.

Article II

GOD

We believe there are three persons in the God head. Father, Son and Holy Spirit, and that all things were created by them.

We believe that immersion is the Scriptural mode of baptism.

OPEN COMMUNION

We believe that the Lord's people are one in Him, therefore should be one at His table.

THE CHRISTIAN SABBATH

We believe that the Divine Law requires that one day in seven be set apart for the worship of God and that no work of worldly nature should be done on that day. Work of piety, mercy and necessity excepted.

- 10. Miscellaneous Business.

RULES OF ORDER

- 1. The Moderator or Assistant Moderator or, in their absence the oldest minister present, shall call the Association to conference.
- 2. Each session shall be opened and closed by prayer.
- 3. Five members from two or more churches shall constitute a quorum. A lesser number may adjourn until such time as a quorum is present.
- 4. Visiting brethren are invited to seat as advisory members.
- 5. Those who speak shall rise and address the Moderator. Personal reflection shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
- 7. Motions made and lost shall not be recorded.
- No one shall speak more than twice on the same subject without special leave of the Moderator.
- 9. The Moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the Moderator may be overruled by a twothirds majority of the membership voting.
- 11. No question from any church shall come under the consideration of the Association unless it has first been discussed at its own church.
- 12. At each Asociation arrangement shall be made to insure two or more sermons or their equivalent devotional services each day.
- 13. The West Coast Association shall have no power to fill vacancies in the delegation from any composite body.
