Proceedings of the Ninth Annual Session of the West Florida Free Will Baptist Association which met with Christian Home Free Will Baptist Church, McDavid, Florida, September 20 and 21, 1957.

#### Friday, 10:00 A. M.

Singing by the congregation; prayer by Rev. L. V. Pinson; welcome address by Rev. B. B. Champion; Devotion by Rev. H. L. Henderson, reading from the 12th chapter of Hebrews, followed by prayer by Rev. W. B. Hughes.

The Moderator read the Rules and Decorum of the Association to the body.

All visiting Brethern were invited to sit with us. Brother Wayne B. Cook, Bonifay, Brother W. E. George, South Bonifay, Brother W. Hicks, Panama City, Brother Will Eddins, Liberty No. 1, Brother A. B. Cook, Bonifay, Brother W. E. George, South Bonifay, Brother W. B. Hughes, Chipley, responded.

Body was called to order for business.

Moved and seconded to read church letters before the body carried.

Moved and seconded for the Moderator to appoint the various committees, carried.

Brother H. L. Henderson was elected moderator by majority vote.

Sister Ashcraft asked the body to re-elect an assistant clerk, as she did not desire to keep her office.

Nominations were opened to fill vacancy of Executive Board, nominations were Brother Donaldson, Brother Wildon Hall, Brother Champion. Brother Champion was elected by a majority vote to serve a seven year term.

Moderator called for Executive Board report, no report.

Moved and seconded for Rev. Mortons preacher report to be accepted by the clerk. Carried.

Committees were dismissed to gather reports.

Brother Hughes led the congregation in song and testimony service while committees were out.

Committees returned and the following reports were read:

Vacation Bible School report read and adopted as read.

Home Mission report read and adopted as read.

Temperance Committee read and adopted as read.

Credential Committee report read and adopted as read.

Suggestion Committee report read and adopted as read.

Obituary Committee report read and adopted as read.

Brother Henderson asked all to stand for a moment of silence in memory of those passed on.

Standing of Ministers report read and adopted as read.

Clerks report read and adopted as read.

Brother Floyd Coleman and Sister Ruby Amerson were nominated as Daily Vacation Bible School promoter. Brother Coleman was elected by majority vote.

Moved and seconded to change the association from Friday and Saturday before the 4th Sunday in September, to Friday and Saturday before the 3rd Sunday in August. Carried.

Time was given Rev. Hughes to speak on Home Missions and Youth Camp.

Moved and seconded that each church in our association send \$2.50 per month to the clerk of West Florida Association, for home mission, in Miami, Fla. Carried.

Moved and seconded to adjourn, business to meet back at 10:00 A. M., Saturday. Carried.

Closing prayer by Brother Cook.

Session opened with congregational singing, prayer by Rev.

Breedlove. Brother R. H. Reddick brought morning devotion, scripture reading, John, 14th chapter.

Moderator called body to order for business.

The following church letters were read:

Grace Church letter, adopted as read; Shiloh Church letter, adopted as read; Christian Home Church letter, adopted as read; Oakfield Church letter, adopted as read; First Church letter, adopted as read.

Brother R. H. Reddick asked why the First Church did not send in a request for his ordination for minister as he had served his year as a licensed minister.

Motion made and seconded that the Executive Board meet on this case within the next thirty days and present an answer to Brother Reddick as to why he was not recommended for ordination, after which he has the privilege of joining another church. This church would have the privilege to recommend him to the Ordaining Council for ordination, carried.

Pilgrim Rest Church letter read and adopted as read.

Meeting adjourned to meet back at 1:30 P. M. for business.

Sunday School Convention report read, adopted as read.

Ladies Auxiliary report, adopted as read.

League Convention report, adopted as read.

Quarterly Meeting report, adopted as read.

Motion made and seconded that a list of available pastors be kept by clerk, carried.

Moved and seconded for moderator to appoint delegates to the State Association, carried.

Above motion tabled until information on standing delegates was obtained.

A vote was taken in favor of a Promotional Secretary and Evangelist for West Florida, carried.

Rev. Turman was elected by a majority vote.

Nominations were opened to fill Brother Hughes place on ordaining Council. Nominated were: Brother Turman and Brother Breedlove. Brother Breedlove was elected by majority vote.

Brother Ashcraft made motion, and was seconded to remove Deacons from Ordaining Council and replace them with ordained minis-

ters. A vote was taken in favor of above motion, carried.

Rev. Pinson presented his resignation from Ordaining Council. Moved and seconded that he be relieved.

Rev. Parham and Rev. Turman were nominated and elected to fill vacancies of Rev. Pinson and Brother R. L. Williams on Ordaining Council.

Nominations were opened to fill vacancy of Brother Roy Parker on Board of Trustees. Nominated were Brother Donaldson, Brother Parham and Brother Gardner.

Brother Donaldson was elected by majority vote.

Moved and seconded that Moderator appoint the committees, carried.

Standing of Ministers Committee, Christian Home Church.

A motion was made and carried to limit the nominations of Committees to the churches present.

Nominations were opened for minister to preach association sermon for 1958. Nominated were: Rev. Bryant, Rev. Breedlove, and Rev. Turman. Rev. Turman was elected by a majority vote.

Moderator asked for a report from our Tabernacle Committee. Rev. Breedlove, Rev. Pinson and Rev. Champion reported. There is two acres of land and a building on it, which could be purchased for \$6,000, near Molino, Florida.

Rev. Turman being Promotional Secretary said he would work with the committee on this and find out about it. He would then meet with Pastors of the churches to discuss financial plans.

Rev. Champion resigned from the Tabernacle Committee, and was replaced by Brother Wilson.

Motion made and seconded that 10 per cent of our church treasury be sent to our clerk for the tabernacle, not carried.

Brother and Sister Amerson, Brother and Sister Cook, and Sister Williams were nominated and elected delegates to the State Association.

Sister Henderson, Sister Ashcraft, and Sister Ellis were nominated and elected as alternate delegates to the State Association.

A special offering was taken for the printing of the minutes. Amount received, \$25.18.

#### GOVERNMENT AND CONSTITUTION

Article 1. Each Church in this Association shall be entitled to one vote, and each Church having more than twenty-five members shall have one vote for the first twenty-five and one vote for each additional twenty-five members or fraction thereof. These votes shall be cast by one delegate from each of the various churches, and this delegate shall be duly elected by the Church to cast these votes. A roll call shall be made on important questions when it is desired.

Article 2. In the letter from each church shall be expressed the number received by experience, letter, recommendation, restoration: the number dismissed by letter, excluded, died since the last Association, and the total number enrolled. Also give name of present Pastor and one called for the ensuing year; the name and addresses of Sunday School Superintendent and Secretary, the enrollment of Sunday School, the amount collected since last Association; the amount paid out to Pastor, to missionary, to minutes, and to miscellaneous expenses, and the amount left in the treasury.

Article 3. All subordinate Churches shall be subject to the ruling of this Association.

Article 4. This Association when convened, shall be governed by a Regular and Proper Code of Rules which they are authorized to establish for themselves.

Article 5. They may elect a Moderator, Secretary and Treasurer from themselves and they may hold office until their successors are elected.

Article 6. Every motion made and seconded shall come under the consideration of the Association, except when withdrawn by consent.

Article 7. New Churches may be received into the Association who shall petition by letter or delegates if they have been regularly

organized upon a profession of faith in the Lord Jesus Christ and are walking according to the gospel order.

Article 8. This Association shall furnish each Church with minutes of their proceedings in proportion to the amount sent by each Church in order to enable the Association to print their Minutes. It is expected that each Church will send such sums of money as they think proper, and when the money is received, it shall be placed in the hands of a trustee appointed for that purpose, and may be disbursed by order of the Association.

Article 9. For the purpose of ordaining ministers of the gospel and Deacons who shall come with recommendations from their churches, and for trying all ordained members of unChristian conduct, there shall be a Presbytery, which shall convene at the opening of the Association and at any time during the Association year, if called by the Moderator or his assistants or any five members of the said Presbytery who deem it necessary to make such a call. The Presbytery shall consist of ordained members present, and they shall elect a Moderator and clerk from among themselves for the time being who shall hold their offices until their successors are elected. It shall be the duty of said Presbytery to examine all applicants for ordination sent with recommendations from their Churches composing this Association, and if found competent, to ordain and set them apart for the work by laying on of hands. The Presbytery shall have full power to try all ordained members for unChristian conduct and on testimony. Their decision shall be final.

Article 10. It shall be the duty of each Minister who shall organize a church to ordain Deacons for the same. It is his duty also to ordain deacons where a vacancy occurs within his charge. It shall be the duty of each pastor to encourage the organization and support of a Sunday School in the church or churches where he is pastor.

Article 11. No person shall be ordained to the ministry until he is qualified to meet the conditions stated in the third chapter of I Timothy and this shall be tested by the Presbytery. The Presbytery shall have full power to propound such spiritual questions as they consider necessary to determine his qualifications. All candidates for ordination shall be required to answer these questions satisfactorily.

Article 12. The Association may exclude from its body any minister who teaches heresy or any other church that countenances him in said teaching or that may be disloyal of the tenets of faith as held by this Association and expressed in our Articles of Faith.

Article 13. All questions coming before this Association shall be determined by a majority vote, except exclusion of churches which shall require two-thirds (2-3) majority.

Article 14. Representatives from five churches shall constitute a quorum for the transaction of business and no business shall be transacted without a quorum.

Article 15. The Minutes of this Association shall be read before the body, corrected if need be, and signed by the Moderator and Clerk. Article 16. This Association may adjourn to meet with any Church that is a regular member of it at any time it deems proper.

Article 17. Amendments may be made to this form of government at any time by a majority of the members present composing the Association, voting in behalf of the amendment.

Article 18. When this Association shall have convened, it is the privilege of all ordained members belonging to the West Florida Association of Free Will Baptists to sit in council with us and to propose resolutions coming before the body as though they were delegates from the Church.

Article 19. This Association having jurisdiction over all the churches within its bounds, shall discipline any Church which calls a minister for a pastor who has been excluded by the Presbytery.

#### BOARDS

All Standing Boards shall be composed of three members, except the executive board, which shall be composed of seven members. Standing Boards include the Executive Board, Foreign Mission Board, Home Mission Board, Board of Education, and Orphanage Board. The personnel of each of the foregoing, exclusive of the Executive Board, shall be elected as follows: The first named for a period of one year, the second named for a period of two years, and the third named for a period of three years. Succession to office thereafter shall be determined as order requires.

Section 2. Left out by order of Executive Committee. Elected from the floor.

Section 3. The Executive Board shall have the power to act in behalf of and for the West Florida Association from one regular session to another and shall have power to elect such officers as may be necessary for its own government and to carry out the plans and undertakings of the Association. It shall be the duty of the Executive Board to make written reports of all its work to each Annual Session of the Association.

Section 4. The duties of the various Standing Boards shall be to plan a program and supervise its operations in their respective fields. They shall organize themselves and regulate their work as may become necessarry, and as may be found in harmony with the principles and tenets of the Association.

#### RULES AND DECORUM

This Association shall be opened by singing and prayer. Only one person may speak at a time. All addresses made by members shall be made to the Moderator and the person thus speaking shall strictly confine himself to the subject in debate. No speaker shall cast any personal reflection toward any member of this body who has spoken previously.

No person shall be allowed to speak for more than three times on

any one subject without the permission of a majority of the Association.

The speaker shall not be interrupted during his speech by anyone except the Moderator unless he violates the Rules of Order.

No member shall absent himself without permission from the Association. Members shall use the word "Brother," or "Brethren" in all debates.

The names of the members of this body shall be enrolled by the Clerk and the Roll Call be taken as often as necessary, provided a call is made by a member of the Association.

No member shall speak longer than fifteen minutes at any time without permission from the Moderator.

Any member who shall willfully and knowingly violate any of these rules shall be reported by the Moderator and shall be subject to censure of the Association.

#### CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the Word of God as our Rule of Faith and Practice, we now give ourselves to one another by the will of God in this Solemn Covenant:

We promise by his Grace to love and obey Him in all things; to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world; from all sanction of the use and sale of intoxicating beverages; and to provide things honest in the sight of all men. We agree faithfully to discharge our obligations in reference to study of the Scripture, secret prayer, family devotions, and social worship, and by self-denial, faith and good works endeavor to grow in "grace and the knowledge of our Lord Jesus Christ." We will not forget the assembling of ourselves together for Church Conferences, Public Worship and the observance of the ordinances of the gospel, nor fail to pay according to our ability for the support of the Church, for its poor and all its benevolent works. We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to keep the unity of the Spirit in the bond of peace; to be careful for one another's happiness and reputation, and to seek to strengthen the weak, encourage the afflicted, admonish the erring and as far as we are able, promote the success of the Church and of the gospel.

We will everywhere hold Christian principles sacred and Christian obligations and enterprises "supreme." Counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come and that His Will may be done in earth as it is in heaven; to this end we agree to labor for the promotion of educational enterprises, the support of mission, the success of Sabbath schools and evangelistic efforts for the salvation of soul, and the conversion of the world; and may the God of Peace Sanctify us wholly; and preserve us blameless unto the Coming of Our Lord Jesus Christ.
