Moderator called meeting to order. The following reports given: Sunday School report read and accepted (See reports)

MSC to take from table motion, to change constitution Article 3 to add: Moderator, V. Moderator, Clerk & Treasurer to be elected annually. Motion carried.

MSC to take from table motion, to change constitution Article 6 to add paragraph 5; This association shall have a Mission Board consisting of five members elected by this association. This board shall have a constitution and by-laws approved by this association. (approved 6-14-69) Board members to be elected Saturday 9-13-69.

MSC to have next annual association meeting at New Home Church, Cantonment, Florida. September 11 & 12, 1970. Dismissed by Rev. Sammy Wilkinson.

Saturday 10:00 A.M.

Services opened with congregational singing, devotion by Rev. Herbert Waid reading from Romans 8:9 subject was soul-winning.

Business session called to order by Moderator. Oral report of state work given by Rev. W. Hansley, our State Promotional Secretary.

C.T.S. Report read & accepted. Moderator asked for volunteers to be delegates to State Association. the following volunteered: Sis. Ruby Amerson, Sis. Louise Owen, Sis. Thelma Bass, Sis. Ann Watford, Sis. Margaret Baker; Alternates: Sis. B. Carroll & Sis. Carrie Bell Carroll.

11:00 A.M.

Opened with congregational singing, prayer by Rev. Jack Parham. Received offering of \$27.91 to be divided between the three missionaries present. Morning message by Rev. Sammy Wilkinson reading from Luke 5: 1-10 subject "Fishers of Men". Dismissed with prayer.

1:15 P.M.

Opened service with singing, devotion by Rev. H. Waid reading from Rev. 3:20 & 7:9 also II Cor. 5 followed with prayer.

Session called to order by Moderator. Treasurer's report given and accepted. Associations Statistic Report given & accepted. Nominating Committee report given, recommending we retain same officers presently serving in the Association. MSC to retain same officers.

MSC for vote to be taken for Asst. Moderator. Vote taken for Rev. R.C. Wiggins & Rev. L. Bass. Rev. Bass was elected by majority.

Consent of body for Nominating Committee Chairman to be by alphabet of churches. This years chairman was from Bethel. 1970's chairman to be from Beulah Church.

The following men were elected for the Home Missions Board. Rev. Robert Owen (74), Rev. B. Mathews (73), Bro. H. Dockens (72), Rev. J. D. Parham (71), Rev. Elzie Carroll (70).

Bro. Freeman Dockens was elected to replace Rev. F. Coleman on Ordaining Council. Rev. Coleman has moved membership to Alabama. Mutual agreement between Sunday School & C.T.S. Officers to exchange meeting dates for 1970. If change proves to be satisfactory, then preparations to make change permanent would be handled by individual conventions involved.

Seconded by Bro. F. Dockens, carried by body of delegates. This committee to report back in June for Associations approval. Altar prayer by Bro. E. Carroll. Offering taken of \$15.76, Minutes read and accepted. Dismissed by Bro. Harlie Dockens.

Clerk read proposed amendments to Constitution: (1) to amend Article 3 to add; Moderator, V. Moderator, Clerk & Treasurer to be elected annually MSC to table til next meeting. (2) amend Article 6 to add Sect. IV. This Association shall have a Mission Board consisting of five members elected by this Association. This board shall have Constitution & Bylaws approved by this Association. MSC to table until next meeting. Clerk read proposed Constitution & Bylaws of Mission Board. MSC to accept. State Moderator, Rev. H. Henderson made remarks on state work.

Report of Statistics Committee given by Bro. H. Dockens, MSC to accept. Bro. Bass moved for Association to bring to attention to churches to receive offering to help on expenses of our State C.T.S. competition winners to National Assoc. MSC for pastors to receive offering in their churches by June 22, and send to Dist. C.T.S. Treasurer for above purpose (divided equally). Minutes read & accepted. Dismissed with prayer.

CONSTITUTION & BY-LAWS OF THE WEST FLORIDA HOME MISSION BOARD OF FREE WILL BAPTIST

CONSTITUTION

Article L NAME:

This board shall be known as The West Florida Home Mission Board of Free Will Baptists.

Article 2. PURPOSE:

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the West Florida Association.

Article 3. MEMBERSHIP:

This board shall be composed of members elected by the West Florida Association and shall serve terms established on a rotational basis; one member's term shall expire annually. The number of members of this board shall be determined by the constitution & by-laws of the West Florida Association.

Article 4. OFFICERS:

Officers of the board shall be; A Chairman, A Vice-Chairman and a Secretary-Treasurer. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. Members of the board shall elect the officers of the board.

Article 5. MEETINGS:

Meetings shall be held as the need arises. Necessary meetings may be called by the Chairman or the Secretary-Treasurer. Mileage for board members expenses shall be paid from the general fund limited to 10¢ per mile one way.

Article 6. REPORTS:

A complete report of the board meetings and activities and a complete financial report must be presented to the annual West Florida Associational Meeting.

Article 7. FINANCES

This board shall receive it's finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions.

Article 8. MISCELLANEOUS

Section I. Missions and churches receiving financial support from this board must be Free Will Baptists which prove themselves sound in doc-

trine and practices as Free Will Baptists.

Section II. Missions and churches receiving financial support from this board shall consider this board as an advisory body in such matters as the selection of a pastor and further financial obligations.

Section III. Any work receiving financial support must agree to support

the denominational cooperative program.

Section IV. Any work receiving financial support must accept such as a loan on terms and conditions agreed upon by them and the board as set forth in this constitution and such information shall be made available to them and fully understood by those receiving the support.

Section V. Proper security must be granted the board for loans received. First mortgage is desired but second mortgage may be accepted; however no loan shall be granted in excess of the appraised value of the property. Interest shall be paid at the rate of 6% per annum. Monthly payments shall be paid at the rate of \$10.00 per \$1,000.00 loaned.

Section VI. Missions or churches receiving financial support must be in good standing with the West Florida Association & must have a pastor who is in good standing with the West Florida Free Will Baptist Assoc. Section VII. An agreement must be understood between the borrower and the board that in the event financial obligations cannot be met, rights to the property must be relinquished, said rights shall be turned over to the Mission Board and the decision of the board in regards to the property shall be final.

Section VIII. Contracts shall be considered delinquent when three (3) successive payments have not been met. It shall be determined by the board if contracts may be held valid and open for a longer period of time Section IX. The board shall have the right by majority vote to purchase property in desirable locations when there is good potential for organizing a Free Will Baptist Church. This action shall of necessity be subject to the availability of funds. In such matters full title must be acquired and no investment shall exceed the appraised value of property. Organizational work under such conditions shall be under complete supervision of the Mission Board.

BY-LAWS

Article 1. DUTIES OF OFFICERS:

Officers of the Mission Board shall hold office according to the terms set forth in the constitution and shall carry out those duties peculiar to their respective offices. The secretary-treasurer shall maintain a permanent record of the board's activities and financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding secretary-treasurer.

Article 2. VOTING AND QUORUM:

A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of board members before it is considered final. All members not present in meeting shall be notified of decisions made by the board.

Article 3. DUTIES OF MEMBERS:

All members shall endeavor to support mission work through cooperative efforts of the board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the board, be replaced by the West Florida Association.

Article 4. AMENDMENTS:

This constitution and by-laws may be amended by a majority vote of the board members and final approval of the West Florida Association.

(This Constitution & By-laws were adopted at Quarterly Meeting 6-14-69 at Bethel Church)

CONSTITUTION AND BY-LAWS OF THE WEST FLORIDA ASSOCIATION OF FREE WILL BAPTIST

Article 1. NAME:

This Association shall be known as the West Florida Free Will Baptist Association.

Article 2. MEMBERSHIP:

Section I. This Association shall be composed of such regularly organized and well diciplined Free Will Baptist churches conveniently located, as may embody themselves under this constitution.

Section II. Any church regularly organized, may by petition by delegation become members of this Association provided they will adhere to Free Will Baptist Doctrine and fully support the benevolent and educational enterprises of the denomination.

Section III. Churches from other Free Will Baptist Associations desiring membership must present a letter of recommendation from the association of which they were previously a member.

Article 3. OFFICERS OF THE WEST FLORIDA FREE WILL BAPTIST ASSOCIATION: Officers shall be composed of Moderator, Vice Moderator, Clerk, Treasurer and Ordaining Council. Moderator, Vice Moderator, Clerk, and Treasurer to be elected annually.

Article 4. REPRESENTATION:

Section I. Each church of this Association shall be entitled to one vote & one vote for each additional twenty-five members or fraction thereof.

Section II. All churches of this Association to be represented at the regularly scheduled meetings by delegates and letter, to conduct the business of the Association affecting the churches and the Association. Section III. All ordained ministers and deacons in good standing with the Association and West Florida Associational Officers shall serve as standing delegates.

Article 5. ORDAINING COUNCIL (Presbytery)

Section I. This Council shall be composed of five members, elected by the Association to serve a period of two years each. The Moderator is also automatically a member of the Council and the Vice-Moderator is authorized to sit on Council when it convenes if the Moderator is absent.

Section II The purpose of the Council is to license and ordain candidates after due examination as to their qualifications and to try all ordained members for un-christian conduct or the teaching of doctrine contrary to the Free Will Baptist faith. This Council to convene upon request of any church of this Association.

Article 6.BOARDS AND COMMITTEES

Section I. All standing boards shall be composed of three members, except the Executive Board which shall be composed to one (1) member from each church. The personnel of each of the foregoing, exclusive of the Executive Board, shall be elected as follows: the first named for a period of one year, the second named for a period of two years, and the third for a period of three years. Succession to office thereafter shall be determined as order requires.

BOARDS (Con't)

Section II The Moderator and Asst. Moderator will have the privilege to set on Executive Board Meetings or to moderate the meeting. Section III. The Executive Board shall have the power to act in behalf of and for the West Florida Association from one regular session to another, and shall have the power to elect such officers, except the Moderator, as may be necessary for its own government and to carry out the plans and undertakings of the Association. It shall be the duty of the Executive Board to make written reports of all its work to each annual session of the Association.

Section IV The duties of the various standing boards shall be to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their work as may become necessary and as may be found in harmony with the principles and tenets of the Association.

Section V. This Association shall have a Mission Board consisting of five members elected by West Florida Association. This board shall have a constitution and by-laws approved by this Association.

Article 7. MEETINGS (Scheduled)

Section I. Scheduled Associational meetings will be as follows: The yearly Associational Meeting will be held the second Friday and Saturday of the month of September each year. The Quarterly meetings of the Association will be held on the first Saturday in December, the first Saturday in March, and the second Saturday in June of each year at the places designated by the body.

Section II. Ministers and deacons of the Association shall hold an

annual conference each year in the month of April.

Section III. Minutes of the meetings shall be read, and corrected if need be at the end of each business session.

Article 8. FINANCES

Section I. Each church of the Association shall be responsible for sharing the financial obligations of the Association by paying into the treasury, the tithe (10%) of their income.

Section II. An additional fee of \$5.00 at each Quarterly Meeting will be assessed and a \$20.00 fee for churches with membership over 50, or a \$15.00 fee for churches of membership under 50, at the yearly meeting. Section III. Not less than 10% of the total income of the Association shall be retained in the Associational treasury for local home mission work.

Section IV. A sum of \$25.00 shall be paid annually to the moderator, clerk and treasurer to cover expense incurred in the line of duty to the Association during the year. In event expenses exceed this figure or any other member or officer of the Association is appointed a duty in which expenses are incurred, the body may take a vote to reimburse them.

Article 9. DISCIPLINE

Section I. This Association shall have power to discipline churches of which it is composed and to exclude them for disorderly walk if they practice doctrine contrary to bible principles and standards and those of the Free Will Baptist Treatise.

Section II. This Association shall not have the right to reverse the decision of the individual church nor to interfere with its internal

regulations.

Section III. All churches of this Association shall call as their pastors only duly licensed or ordained Free Will Baptist ministers.

DISCIPLINE (CON'T)

Section IV. All ministers entering this Association from another denomination or seeking ordination shall walk before this Association one year before being fully and officially accepted or ordained into the Associational ministry. All ministers coming into the Association from another Free Will Baptist Association shall be re-examined by the Ordaining Council and shall be required to bring a letter of recommendation from the Association in which they served.

Article 10. BY-LAWS:

This Association shall have power to adopt any regulations or by-laws not inconsistent with this Constitution, which may be deemed essential to the further regulations of its session.

Article 11 AMENDMENTS

This constitution may be altered or amended by the vote of the Association at any regular session; notice of such intended alterations of amendments having been given in writing and recorded at the previous session.

Article 12.QUORUM

Representatives from two (2) member churches shall constitute a quorum for transaction of business of the Association, at scheduled meeting. No business shall be transacted without a quorum.

This Revised Constitution was approved at the Yearly Associational Meeting held at Ensley Free Will Baptist Church, Sept. 12 & 13, 1969.
