CONSTITUTION & BY-LAWS OF THE WEST FLORIDA ASSOCIATION OF FREE WILL BAPTIST

Article 1. NAME:

This Association shall be known as the West Florida Free Will Baptist Association.

Article 2. MEMBERSHIP:

Section 1. This Association shall be composed of such regularly organized and well diciplined Free Will Baptist churches conveniently located, as may embody themselves under this constitution.

Section II. Any church regularly organized, may by petition by delegation become members of this Association provided they will adhere to Free Will Baptist Doctrine and fully support the benevolent and educational enterprises of the denomination.

Section III. Churches from other Free Will Baptist Associations desiring membership must present a letter of recommendation from the association of which they were previously a member.

Article 3. OFFICERS OF THE WEST FLORIDA FREE WILL BAPTIST ASSOCIATION: Officers shall be composed of Moderator, Vice Moderator, Clerk Treasurer and Ordaining Council. Moderator, Vice Moderator, Clerk and Treasurer to be elected annually.

Article 4. REPRESENTATION:

Section 1. Each church of this Association shall be entitled to one vote and one vote for each additional twenty-five members or fraction thereof.

Section II. All churches of this Association to be represented at the regularly scheduled meetings by delegates and letter, to conduct the business of the Association affecting the churches and the Association. Section III. All ordained ministers and deacons in good standing with the Association and West Florida Associational officers shall serve as standing delegates.

Article 5. ORDAINING COUNCIL (Presbytery)
Section I. This Council shall be composed of five members, elected by the Association to serve a period of two years each. The Moderator is also automatically a member of the Council and the Vice-Moderator is authorized to sit on Council when it convenes if the Moderator is absent. Section II. The purpose of the Council is to license and ordain candidates after due examination as to their qualifications and to try all ordained members for un-christian conduct or the teaching of doctrine contrary to the Free Will Baptist faith. This council to convene upon request of any church of this Association.

Article 6. BOARDS AND COMMITTEES
Section 1. All standing boards shall be composed of three members
except the Executive Board which shall be composed of one (1) member from each church. The personnel of each of the foregoing, exclusive of the Executive Board, shall be elected as follows: the first
names for a period of one year, the second named for a period of two
years, and the third for a period of three years. Succession to
office thereafter shall be determined as order requires.

Boards (cont'd)
Section II. The Moderator and Asst. Moderator will have the privilege to set on Executive Board Meetings or to moderate the meeting.
Section III. The Executive Board shall have the power to act in behalf of and for the West Florida Association from one regular session to another, and shall have the power to elect such officers, except the moderator, as may be necessary for it's own government and to carry out the plans and undertakings of the Association. It shall be the duty of the Executive Board to make written reports of all its wor to each annual session of the Association.

Section IV. The duties of the various standing boards shall be to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their work as may become necessary and as may be found in harmony with the principles and tenet

Section V. This Association shall have a Mission Board consisting of five members elected by West Florida Association. This board shall have a constitution and by-laws approved by this Association.

Article 7 MEETINGS: (Scheduled)
Section I. Scheduled Associational meetings will be as follows:
The Associational Yearly Meeting will be held the second Saturday in September, The Associational Mid-Yearly Meeting will be held the first Saturday in February, at places designated by the body.

Article 8. FINANCES: Section 1. Each church of the Association shall be responsible for sharing the financial obligations of the Association by paying into the treasury, the tithe (10%) of their income.

Section II. An additional fee of \$5.00 at each Quarterly Meeting will be assessed and a \$20.00 fee for churches with membership over 50, or a \$15.00 fee for churches of membership under 50, at the yearly meeting Section III. Not less than 10% of the total income of the Association shall be retained in the Associational treasury for local home mission work.

Section IV. A sum of \$25.00 shall be paid annually to the moderator, clerk and treasurer to cover expense incurred in the line of duty to the Association during the year. In event expense exceed this figure or any other member or officer of the Association is appointed a duty in which expenses are incurred, the body may take a vote to reimbures them.

Article 9. DISCIPLINE:

Section I. This Association shall have power to discipline churches of which it is composed and to exclude them for disorderly walk if they practice doctrine contrary to bible principles and standards and those of the Free Will Baptist Treatise.

Section II. This Association shall not have the right to reverse the decision of the individual church nor to interfere with its internal regulations.

Section III. All churches of this Association shall call as their pastors only duly licensed or ordained Free Will Baptist ministers. Section IV. All ministers entering this Association from another denomination or seeking ordination shall walk before this Association one year before being fully and officially accepted or ordained into the Associational ministry. All ministers coming coming into the Association from another Free Will Baptist Association shall be re-examined by the Ordaining Council and shall be required to bring a letter of recommendation from the Association in which they served.

Article 10. BY-LAWS:

This Association shall have power to adopt any regulations or by-laws not inconsistent with this Constitution, which may be deemed essential to the further regulations of its session.

Article II. AMMENDMENTS:

This constitution may be altered or amended by the vote of the Association at any regular session; notice of such intended alterations of amendments having been given in writing and recorded at the previous session.

Article 12. QUORUM:

Representatives from two (2) member churches shall constitute a quorum for transaction of business of the Association, at scheduled meeting.
