

#### Fifty-Fourth Annual Session held at Beulah Free Will Baptist Church February 1, 2002

The 54th Annual session of the West Florida Free Will Baptist Association Meeting opened with congregational singing led by Bro. Danny Conn.

Moderator, Bro. Kevin Flannagin, called the meeting to order and seated the standing delegates. MSC to seat the church delegates. Bro. Kevin Flannagin thanked everyone for all they do for the association.

**State Executive Secretary**, Bro. David Williford, came and gave the following information:

**State Meeting** – Jacksonville, May 8-11, 2002 - Marriott Rooms will be \$75.00 with reservation closing on April 15. Dr. David Gibbs will be addressing the body on Wednesday night and Thursday morning and evening. He encouraged everyone to attend and hear him speak, he will have tips on how you can protect yourself, your church and your testimony in your

community.

**Encouraged** us to take good care of our pastors, by offering insurance and retirement packages.

Special music was presented by Angela Wooton. The message was brought by Bro. Grant Webb. He encouraged us with Psalm 106 - "Praise ye the Lord, Because HE is Good".

Committees were appointed. We were then dismissed for committees to meet and a time of food and fellowship.

Following this time business resumed.

Secretary's Report was accepted as read.

**Treasurer's Report** was given, with a balance as of December 31, 2001 of \$2,981.46. MSC

All committee Reports were given and MSC to accept.

**The Children's Home Report:** Presently have 25 children. The 4th cottage will be completed in March, and dedicated on April 27, 2002. The new building will allow the home to add an additional 14 children. Future plans include redoing the 1st cottage. And praise the Lord everything is paid for.

**CTS Report:** District competition will be March 16, at 10:00am with coaches/judges meeting at 9:30am. Sis. Amy Holland was pleased to announce that all 5 churches will be having competitors this year. 2003 competition will be at Beulah.

**Camp Mt. Pleasant Report:** Plans are in the works to add a 2000sq. foot addition to the main building. The additional space will server as a sanctuary, offices and bathrooms. Encourage your youth to go to camp - the purpose is two fold; to win souls, and enrich those who are saved. Teen Camp -June 9-14; Primary Camp - June 20 - 22; Junior Camp - June 23- 28.

WAC Report: District Meeting - March 1, 2002 at Soul's Harbor, and the ladies will again be having the silent basket auction. Last year the ladies sent money to several projects, and hope to be able to do the same this year. Everyone enjoyed the ladies retreat and were touched by Lea Edgmon's testimony.  MSC to pay from the District Enrichment fund: (1) Registration fees of those attending the Christian Workers Retreat in Oct 2002.

(2) Registration fees for those attending the Ladies Retreat in Jan 2003.

(3) \$1,600.00 to Beulah - cost of one person going on Missions trip to Spain this summer.

(4) \$500.00 to the Bill George Foundation

- MSC to pay the following from the District Enrichment Fund for CTS competitors:
  - (1) State \$90.00 for the first competitor / \$50.00 for any siblings competing.
  - (2) National \$225.00 for the first competitor / \$150.00 for any sibling competing.
- MSC to increase district Missions shares from 20 shares to 25 shares.

Home Missions: Don Walker is starting a new mission work in Gainesville, be sure to keep him in your prayers.

**MSC to give Kelli Flannagin** \$300.00 from the Youth Fund towards her summer mission trip with the Academy of Arts Drama Team. MSC to adjourn.

#### **Bi-Annual Meeting**

September 7, 2001 Soul's Harbor Free Will Baptist Church

Bro. Kevin Flannagin presiding.

Churches reporting: Beulah \$25.00 Shiloh \$25.00 Christian Home \$25.00 Soul's Harbor \$25.00 First Church \$25.00 TOTAL \$125.00

Bro. Tim Vincent led the congregation in singing, "Jesus Saves". Bro. Danny Conn extended a welcome to everyone from the Soul's Harbor church and we then sang together, "To God Be The Glory".

Bro. Kevin seated standing delegates and MSC to seat church delegates. The Secretary's report was read and accepted. The Treasurer's report was read and accepted. The general fund balance as of August 27, 2001, was \$2,040.11. The treasurer also expressed her appreciation to the local church treasurers for sending their Co-op monies in early.

MSC to carry out the Executive Board's recommendations as follows:

- Pay registration fee for members of our association who attend the Christian Worker's Conference on September 21-22, 2001, from the District Enrichment Fund.
- Pay registration fee for ladies of our association who attend the District WAC Ladies Retreat from the District Enrichment Fund.
- Pay registration fee for teens of our association who attend the Teen Camp Retreat in October from the Youth Fund.
- Pay up to \$500.00 on a student's summer tuition to Free Will Baptist Bible College who is from our association.

The delegates addressed these recommendations from the Ordaining Council;

MSC to license Bro. Gene Wooton to the Gospel ministry.

MSC to ordain Bro. Chris Hawkins to the Gospel ministry.

The report from the Home Missions Board stated that they had made a loan to Shiloh Free Will Baptist church in the amount of \$43,000.00, for their building program.

Bro. Jack Cowart was present at the meeting and shared with the congregation news of his ministry in a new mission church in Lynn Haven, Florida, called Berean Baptist Church. The church started with twenty-three, and at present, have forty people attending. They are supported as a tentmaker ministry (part-time). He requested prayer for their church and stated his willingness to contact anyone in his area if people would give him the new name. Bro. Cowart also serves as chairman of the Camp Mt. Pleasant Board. He shared that the board wanted to begin a "Promotional Council" which would include anyone from any of our churches who wanted to be involved in different areas of our camp. He also encouraged everyone to participate in the "Friends of the Camp" giving which is designated monthly giving or a one-time annual gift to the camp.

Bro. Kevin gave a Mission Shares Program update. He stated that the Lunsford's support is at 50%. A new full-time pastor for the Gainesville work has also been accepted. He encouraged everyone's continued support. Shares are at \$20.00 a month.

The Children's Home report was also given by Bro. Kevin. The old school building has been torn down. They are about to

begin construction on the fourth cottage.

We began our worship service with the congregation singing, "Have Faith in God". An offering was taken and a MSC to designate the offering for the "Friends of the Camp" fund. Before the message, a trio from Soul's Harbor church blessed our hearts with the song, "He Whispers Sweet Peace to Me". Bro. R.C. Wiggins preached from Jeremiah 3:22 and pointed out ways we can recognize that we are backsliding and rebelling against God: 1) We don't enjoy serving God, 2) We're not producing fruit, 3) We're always looking for something to fit <u>our</u> nature not God's will. God pleads with His people to repent. After prayer together, we were then adjourned.

#### CONSTITUTION AND BY-LAWS OF THE WEST FLORIDA ASSOCIATION OF FREE WILL BAPTIST

#### ARTICLE 1. Name:

This association shall be known as the West Florida Free Will Baptists Association

#### <u>ARTICLE 2.</u> Membership:

**Section I.** This association shall be composed of such regularly organized and well disciplined Free Will Baptist Churches conveniently located as may embody themselves under this constitution.

**Section II.** Any church regularly organized may by petition by delegation become members of this association provided they will adhere to Free Will Baptist Doctrine and fully support the benevolent and educational enterprises of the denomination.

**Section III.** Churches from other Free Will Baptist Association desiring membership must present a letter of recommendation from the association of which they were previously a member.

#### ARTICLE 3. Officers:

Officers shall be composed of Moderator, Vice-Moderator, Clerk, Assistant Clerk, Treasurer and Ordaining Council. Moderator, Vice-Moderator, Clerk, Assistant Clerk and Treasurer to be elected annually.

#### <u>ARTICLE 4.</u> Representation:

**Section I.** Each church of this association shall be entitled to one vote and one vote for each additional twenty-five (25) members or fraction thereof.

**Section II.** All churches of this association to be represented at the regularly scheduled meetings by delegates and letter, to conduct the business of the association affecting the churches and the association.

**Section III.** All ordained ministers and deacons in good standing with the association and the West Florida Associational officers shall serve as standing delegates.

#### ARTICLE 5. Ordaining Council (Presbytery):

**Section I.** This council shall be composed of five members, elected by the association to serve a period of two years each. The moderator is also automatically a member of the council and the vice-moderator is authorized to sit on the council when it convenes if the moderator is absent.

**Section II.** The purpose of the Council is to license and ordain ministers after due examination as to their qualifications and to try all ordained members for unchristian conduct or the teaching of doctrine contrary of the Free Will Baptist faith. This council to convene upon the request of any church of this association.

#### ARTICLE 6. Boards and Committees:

**Section I.** The Executive Board shall be composed of one member from each church to be elected by the church to serve at the churches discretion. The members of all standing boards exclusive of this Executive Board; shall be elected as follows: the first named for a period of one year, the second named for a period of two years, and the third named for a period of three years. Succession of office thereafter shall be determined as order requires.

The Moderator and Assistant Moderator will have the Section II. privilege to set on Executive Board Meetings and to moderate the meeting. The clerk and treasurer shall be present as nonvoting members. **Section III.** The Executive Board shall have the power to act in behalf of and for the Association from one regular session to another, and shall have the power to elect such officers, except the moderator, as may be necessary for it's own government and to carry out the plans and undertakings of the Association. It shall be the duty of the Executive Board to make written reports of all its work to each annual session of the Association. The duties of the various standing boards shall be to Section IV. plan a program and regulate their work as may become necessary and as may be found in harmony with the principals and tenets of the Association.

#### <u>ARTICLE 7.</u> Meetings:

Scheduled Associational Meetings will be as follows: The Association Annual Meeting will be held the first Friday night in February. Report period January 1 - December 32. The Bi-Annual Meeting will be held the first Friday night in September.

Finances: ARTICLE 8.

Section I. Each Church of the Association shall be responsible for sharing the financial obligation of the Association by paying into the treasury the tithe (10%) of their income.

Section II. A \$25.00 fee per church will be assessed at the annual meeting and the bi-annual meeting.

**Section III.** Total cooperative income of the West Florida Association will be disbursed by a finance committee and approval by the body. The Finance Committee shall consist of the Executive Board Moderator, Clerk, and Treasurer to be present at Executive Board Meetings concerning Finances.

**Section IV.** A Love Offering of \$100.00 shall be given from the General Fund to the Moderator and Clerk at the Annual Association meeting. The Assistant Moderator and Assistant Clerk shall be given a \$50.00 Love Offering. The Treasurer will be paid monthly an amount to be determined by the Association from the General Fund. Expense incurred to fulfill the duties of the offices shall be paid from the General Fund. Expenses incurred carrying out the duties to the Association by others appointed a duty, will be paid, after approval of the Moderator, Assistant Moderator, Clerk, Assistant Clerk and Treasurer, from the General Fund.

Moderator, Assistant Moderator, Clerk and Assistant Section V. Clerk will compose Audit Committee for purposes of auditing the Treasurer's books each year.

#### ARTICLE 9. Discipline:

Section I. This association shall have power to discipline churches of which it is composed and to exclude them for disorderly walk if they practice doctrine contrary to Bible principles and standards to those of the Free Will Baptists Treatise.

**Section II.** This association shall not have the right to reverse the decision of the individual church nor to interfere with its internal regulations.

**Section III.** All churches of this association shall call as their pastors only duly licensed or ordained Free Will Baptists ministers.

**Section IV.** All ministers entering this association from another denomination or seeking ordination shall walk before this association one year before being fully and officially accepted or ordained into the associational ministry. All ministers coming into the association from another Free Will Baptist Association shall be re-examined by the Ordaining Council and shall be required to bring a letter of recommendation from the association in which they served.

#### ARTICLE 10. By-Laws:

This association shall have power to adopt any regulations or by-laws, not inconsistent with this association, which may be deemed essential to the further regulations of its session.

#### **ARTICLE 11.** Amendments:

This constitution may be altered or amended by the vote at the association at any regular session; notice of such intended alterations of amendments having been given in writing and recorded the previous session.

#### ARTICLE 12. Quorum:

Representatives from two (2) member churches shall constitute a quorum for transaction of business of the association at scheduled meeting.

#### CONSTITUTION & BY-LAWS FOR THE WEST FLORIDA ASSOCIATION OF FREE WILL BAPTIST HOME MISSION BOARD

#### **CONSTITUTION**



Name:

This board shall be known as the West Florida Home Mission Board of Free Will Baptists.

#### ARTICLE 2. Purpose:

The purpose of this board shall be that of promoting mission work among Free Will Baptists in the West Florida Association

#### ARTICLE 3. Membership:

This board shall be composed of members elected by the West Florida Association and shall serve terms established on a rotational basis; one member's term shall expire annually. The number of members of this board shall be determined by the constitution and by-laws of the West Florida Association

#### <u>ARTICLE 4.</u> Officers:

Officers of the board shall be: a chairman, a vice-chairman, and a secretary. These officers shall hold office for one (1) year and may be elected to serve succeeding terms. Members of the board shall elect the officer of the board.

#### <u>ARTICLE 5.</u> Meetings:

Meetings shall be held as the need arises. Necessary meetings may be called by the Moderator of the Association. Mileage for board members expense shall be paid from the general fund limited to \$.10 per mile one way.

#### ARTICLE 6. Reports:

A complete report of the board meetings and activities and a complete financial report must be presented to the annual West Florida Associational Meeting.

## ARTICLE 7. Finances:

This board shall receive it's finances from churches and individuals making special contributions, cooperative program allocations, interest on loans, and special offerings received through promoting missions.

#### <u>ARTICLE 8.</u> Miscellaneous:

**Section I.** Missions and churches receiving financial support from this board must be Free Will Baptists which prove themselves sound in doctrine and practices as Free Will Baptists.

Missions and churches receiving financial support Section II. from this board shall consider this board as an advisory body in such matters as the selection of a pastor and further financial obligation. **Section III.** Any work receiving financial support must agree to support the denominational cooperative program **Section IV.** Any work receiving financial support must accept such as a loan on terms and conditions agreed upon by them and the board as set forth in the constitution and such information shall be made available to them and fully understood by those receiving the support. Section V. Proper security must be granted the board for loans received. First Mortgage is desired but second mortgage may be accepted; however, no loan shall be granted in excess of the appraised value of the property. Interest shall be paid at the rate of 6% per annum. Monthly payments shall be paid at the rate of \$10.00 per \$1,000.00 loaned. **Section VI.** Missions or churches receiving financial support must. be in good standing with the West Florida Association and must have a pastor in good standing with the West Florida Free Will Baptist Association.

**Section VII.** An agreement must be understood between the borrower and the beard that in the event financial obligations cannot

be met, rights to the property must be relinquished, said rights shall be turned over to the Mission Board and the decision of the Board in regards to the property shall be final.

**Section VIII.** Contracts shall be considered delinquent when three (3) successive payments have not been met. It shall be determined by the board if contracts maybe held valid and open for a longer period of time.

**Section IX.** The board shall have the right by majority vote to purchase property in desirable locations when there is good potential for organizing a Free Will Baptist church. This action shall of necessity be subject to the availability of funds. In such matters full title property.

Organizational work under such conditions shall be under complete supervision of the Mission Board.

#### **BY-LAWS**

#### ARTICLE 1. Duties of Officers:

Officers of the Mission Board shall hold office according to the terms set forth in the constitution and shall carry out those duties peculiar to their respective offices. The secretary shall maintain a permanent record of the board's activities and financial transactions. All records and property mortgages and titles shall be surrendered to the succeeding secretary.

#### ARTICLE 2. Voting Quorum:

A majority membership shall constitute a quorum and be duly authorized to transact business. All items of business must receive a majority vote of board members before it is considered final. All members not present in meeting shall be notified of decisions made by the board.

#### ARTICLE 3. Duties of Members:

All members shall endeavor to support mission work through cooperative efforts of the board. Any member that fails to cooperate with the board for a period of one year may, upon recommendation of the board, be replaced by the West Florida Association.

#### **ARTICLE 4.** Amendments:

This constitution and by-laws may be amended by a majority vote of the board members and final approval of the West Florida Association.
