Suggestions: We, your committee on suggestions beg leave to submit the following report: We recommend that this association have

an ordaining board of three ministers, to administer the ordination of ministers desiring to be ordained in this association, and we further recommend that said board examine each candidate as to his qualifications for this office. That our members subscribe for the Freewill Baptist Witness, published in Ayden, N. C. That each member pay each year into the treasury of his church for home missions not less than one dollar. That any church which is received with a petitionary letter in our union meeting shall be received in good standing at our association without a petitionary letter. That this association have one hundred corresponding letter blanks printed for use in our churches, also that we have one hundred copies of our church decorum and articles of faith printed.

Reports of Ministers

Revs. M. L. Hall Thoꝛ. Lemmieux and J. H. Chesnut gave short statements of their ministerial work for 1922.

Rev. A. L. Pate's report: Pastoral work extends into 3 counties, also into 3 associations. Received at Christian Home church seventeen members, and \$54.00; at Spring Hill, \$15.00; at St. Paul, two members, \$20.00; First Freewill Baptist Church at Blountstown 7 members, received \$120.00. Three sermons at Abe Springs, nine members and \$12.50. Held some burial services. Total members 35 money \$221.50.

Rev Hubbard Yates made a short but interesting statement of his work in the ministry. Bro. W. A. Elmore was released from the executive committee and Bro. J. L. Anderson was elected in his stead.

Rev. C. I. Wells gives a statement of his work in the ministry for the year 1922. Additional members 164; Sermons preached 314; compensation received \$151.67; conducted six funeral services, married seven couples.

Report of Rev. A. B. Nelson: Serving churches Poplar Head, Liberty, Beulah, Tharp's Mill and Noma. Preached 103 sermons, received 45 members and \$50.75.
