#### **MINUTES**

### Union Meeting Held With Beulah Church, Graceville, Fla., August 10, 1951

The meeting was called to order at 11:00 o'clock by Moderator protem, Rev. Rufus Hyman. After a short devotion, Rev. A. B. Cook brought the Message. Text: St. Luke 13:23-29.

#### Saturday Afternoon

Devotion by Moderator pro tem, Rev. Rufus Hyman. Text: St. John 15:16-27. Call was made for letters from sister churches and delegates seated as follows:

St. John — Bros. Bill George, N. E. Chestnut.

Poplar Head — Bros. A. J. Pitts, A. F. Squires, Sister Effie Squires.

Piney Grove — Bros. I. T. Baxter, Bernard Owens, Sisters Grace Huckaby and Thelma Owens.

Beulah — Bros. W. O. Skinner, E. A. Hatcher, B. B. Hatcher.

Pleasant Hill — Sister Roland Yates.

#### Election of Officers

Moderator — Rev. A. H. Retherford.

Clerk — Mrs. Oma Owen

Moderator suggested that the Union Meeting be changed to Saturday before 5th Sunday. Motion made and carried that the Union Meeting meet quarterly, on Saturday before each 5th Sunday.

Talk on Youth camp by two young people who attended the Youth camp in Georgia. Olive Jean Owens and Johnnie Huckaby.

Offering was taken to be applied on our Youth Camp. Amt., \$15.00.

Suggestion was made that each church take an offering during year, for the camp, or set aside an amount of church offering for camp.

Motion made to adjourn. Song, "Amazing Grace." Prayer.

#### CHURCH DECORUM

- 1. The church may choose a pastor annually at the last conference in Association year, or if they prefer, it may choose a pastor for an indefinite length of time to continue from year to year, as long as he may deem it proper to keep up the connection.
- 2. When it becomes necessary, a pastor may be chosen at any given time, but if the choice be made at a special conference the time must be appointed at a monthly meeting of the church.
  - 3. The pastor shall be moderator of the church, but when the mod-

erator is absent or does not sit, a suitable brother shall be appointed in his place.

- 4 There shall be two or more deacons in the church whose duty it shall be to superintend the collection and distribution of all contributions made by the church for the pastor, etc., and to distribute the bread and wine in administration of the Lord's Supper.
- 5. The deacons shall take notice of such members as refuse or neglect to partake of the Lord's Supper and endeavor to ascertain the cause that the same may be laid before the church in conference if necessary.
- 6. Some suitable member shall be appointed clerk and it shall be his duty to do all the recordings and writing pertaining to the business of the church and to preserve a file of the minutes of Association.
- 7. When a clerk is appointed, all of the books, minutes, etc., belonging to the clerk, shall be immediately delivered to him by his predecestor.
- 8. When it becomes necessary, a committee of not less than three male members, well acquainted with business, shall be appointed, whose duty it shall be to give advice to brethren who apply to them relative to cases of dealing, etc., with the church.
- 9. The church holds a two days' meeting embracing Saturday and the Lord's Day following, the first of which shall be the regular time of the conference.
- 10. It shall be the duty of every church member, male or female, to attend each conference meeting, if they can, for on that day the pastor is expected to instruct the church in a certain manner by giving plain and pointed lessons on doctrine, discipline, and the rules of Holy living.
- 11. Any male member who shall fail to attend three successive conferences and any member who may be generally remiss in attending meetings of the church according to covenant (Article 10), shall be cited to appear in conference and answer for his conduct, but the church may exempt members from this if necessary.
- 12. Conferences shall be opened and conducted as follows: (1) Prayer, unless divine service has just been concluded, and generally then. (2) Invite visiting brethren to seats. (3) Open the door for reception of members. (4) Call of absentees. (4) For acknowledgements. (6) For reference of deferred business. (7) For matters of dealing which are in order to come before the church. (8) For miscellaneous business.
- 13. Visiting brethren called in as help from sister churches shall be allowed to vote.
- 14. Any ordinary member of the Baptist Church who does not hold this church in fellowship may be received into the church without a letter when it is made apparent that his Christian character is irreproachable and that he has applied for a letter and could not obtain it because he desires to join this or some sister church. All other persons must join by letter or baptism.
- 15. We receive members by experience of baptism; or confession of faith, by letter or restoration.
- 16. When the moderator calls for absentees the clerk shall inform the church what male members have been absent from three successive conferences and the moderator shall appoint some brother or brethren to cite each of them to the next conference.
- 17. No member shall be expelled unless he has been cited verbally or in writing to attend his trial provided his residence be known to the church.
- 18. When a witness, not a member of the church, is introduced he shall not be examined until the question has been put to the church: "Will you hear the testimony of the witness?"
- 19. The evidence in every case of dealing and acknowledgement shall be recorded in the church book.

20. Members dismissed from the church by letter who become disorderly or continue to hold their letters without good reason shall be cited to conference to answer their conduct. 21. Expelled members may be restored to fellowship on their petition if their walk since expulsion has convinced the church that they have sincerely repented for their former evil. 22. A vote shall not be taken upon question without a move and a second and on all important questions the vote shall be taken by rising to the feet. 23. No motion shall be made while a move and second is before the conference. 24. It shall be considered disorderly for any member to absent himself from conference when an important question is to be decided but a member, upon request, may be exempted by the church from voting on either side in peculiar cases. 25. No member shall leave the house during conference without a sufficient cause, nor engage in conversation or whispering without being subject to be called to order by the moderator. 26. All discussions in conference must be conducted with calmness

and good feeling. Those who speak must rise to their feet, and keep to the point in debate.

27. No one shall speak more than three times on the same subject without permission from the moderator, nor shall the remarks of anyone be unreasonably long.

28. When the moderator speaks he must nominate some other brother as moderator to act in his stead.

29. No one shall be interrupted while speaking unless it be necessary to call him to order.

30. We believe it to be the duty of the church to communicate, wash saints' feet as often as the church sees fit, the expense to be paid by the church.

31. Members not in good standing should not commune, but the administration should not be deferred on account of any ordinary matter of dealing.

#### ARTICLES OF FAITH

1. We believe in one true and living God; the Father, the Son and Holy Ghost. — 1st John 5:7.

2. We believe that there is one Lord Jesus Christ by whom are all things, and by whom our salvation is made secure. — Heb. 2-9; St. John 3:16; 1st John 2:2.

3. We believe that in the beginning God made man upright and placed him in a state of glory, without the least mixture of misery, from which he voluntarily, by transgression, fell, and by this means brought on himself a miserable and mortal state, subject to death. —Romans 5:15 Genesis 2:17; 3-19.

4. We believe that no man is excepted from the graces of God made possible through Christ; but that all may believe unto salvation, or disbelieve unto eternal perdition. —John 3:16; Romans 1:16; 1st Timothy 2:4.

5. We believe that the holy scriptures are the word of God and that they are the only rule of faith and practice. —John 5:10; 2nd Tim. 3:16.

6. We believe that sinners are drawn to God, the Father, by the Holy Ghost. —Rev. 22:17.

7. We believe that good works are the fruits of faith and faith

without work is dead. —Mark 1:15; James 2:17,22.

- 8. We believe that the blessings of salvation are made free and attainable to all mankind.—Matthew 11:28,29,30; Titus 2:11,12; St. John 12:32.
- 9. We believe commemoration and feet washing are ordinances of Christ and immersion only is baptism. —St. John 13:1-17; St. John 3:5; 1st Corinthians 11:23-32.
- 10. We believe that all Christians should unite in performing the sacred ordinances. —St. John 6:53-54; St. John 13:8.
- 11. We believe that the end of the world is approaching when Christ will descend from Heaven and raise the dead from their graves to equal retribution; that a solemn separation will then take place, the righteous being adjusted to everlasting happiness and the wicked to endless punishment and this judgment will fix forever the final state of man in Heaven or hell, on principles of righteousness. —Rev. 22:12; St. John 14:2-3.

### DECORUM OF LIBERTY ASSOCIATION

Article 1. This Association shall be composed of delegates from churches in good standing only, and shall be called together by the Moderator of last session if present. If absent, by his assistant, or someone elected by the body.

Article 2. This Association shall be opened and closed with prayer.

Article 3. The Moderator and Clerk of the last session shall officiate until the body is organized and new officers are elected by ballot.

Article 4. The Moderator shall call the body to order and see that order is preserved. Submit all actions to the body. He shall have the same right of speceh as any other member, but appoint some other brother as chairman while speaking. He shall not have the right to vote unless it be in the case of a tie, then he may cast the deciding vote.

Article 5. The delegates shall be enrolled by the Clerk as they are seated in the body. And the roll shall be called each morning and all not answering to their names marked absent.

Article 6. That no delegate or minister shall be allowed to absent himself from the body during any session without permission from the Moderator.

Article 7. That each minister shall make a report of how many churches he is serving, if any, and what each church has paid him for his services.

Article 8. That no minister shall be considered in good standing that officiates in the rites of matrimony where either party has been divorced except it be for fornication.

Article 9. That no church shall be considered in this body that retains a minister or deacon that has more than one living wife or drinks intoxicating beverages.

Article 10. All business shall be brought before the body by move and second and shall be disposed of according to good usage. But no move shall be submitted to the body when there is a move before the house, unless the first one be withdrawn by the person who made such move, and no person shall be allowed to speak more than three (3) times on the same subject, and not more than ten (10) minutes each time without a move and second from the body.

Article 11. No person shall be disturbed while speaking so long as he keeps to the point in debate, only by the Moderator, and then only to call him to order. Only one person shall be allowed to speak at a time and he must rise to his feet and address the Moderator, and he must not use abusive language or personal reflection upon anyone.

Article 12. This Association shall have a Treasurer and Executive Committee to be elected annually. And no church shall be considered in this body who shall, or have retained a minister that has stepped aside from his obligations in any form (as in 1st Tim., 3rd Chapter) unless said minister has shown by his action that he has repented of the former evil.

Article 13. That any minister who will voluntarily step aside shall immediately turn his credentials over to the executive committee and said executive committee shall visit various churches to see if they are in good standing or not and help them to retain good order.

Article 14. That no church shall retain a minister or deacon who does not rule his own house well.

Article 15. That no church shall be recognized in this body who does not commune and wash feet at least twice (2) a year and who does not have conference quarterly and each church shall state in its associational letter as to whether this ordinance has been kept or not. And also state how much it has paid its pastor. All ministers serving churches shall preach at least one sermon a year on doctrine and rules of holy living.

Article 16. Any preacher belonging to this body who sends an appointment or serving churches who fails to meet at the appointed hour, shall be due acknowledgements to congregation or church.

Article 17. No preacher shall preach in our churches that cannot bring a clear record from his home church.

Article 18. No preacher shall pastor a church unless he on his first trip produces his credentials.
