

FIRST QUARTERLY MEETING January 16, 1965, St. Johns Church

We recessed with prayer.



On August 6, 1965 we organized into a Free Will Baptist Mission. This organization took place after several nights of revival services under a tent in the Wright section of Fort Walton Beach. At this meeting we accepted the Doctrine of Free Will Baptist as our Rules of Faith and Practice.

We used the tent for the remaining part of the month of August as our place of worship. During this time we carried on regular Sunday School, Sunday Worship Services and a Mid-Week Prayer Service. 
Meeting of Presbytery was announced.

We were dismissed with prayer for lunch.

Friday Afternoon

The meeting opened after lunch with singing led by Bro. John M. Rich, Bro. Ernest Owen led group in prayer. Devotion was given by Bro. Fred Warner, visiting evangelist.



The Moderator welcomed those who come in late, Bro. H.D. Shumake and Bro. Fred Warner.

The meeting was declared in business session and received report of Examining Council concerning Bro. Don Pettis being ordained as a deacon in the Association and to serve Wright F.W.B. Church. M.S.C. that he be accepted and ordained.

An Ordaining Service was held. The Charge was delivered by Bro. Milton Gann and a Prayer of Consecration was led by Bro. John M. Rich.

The Credentials Committee gave their report. M.S.C. that it be accepted.

The Finance Committee gave a partial report stating that \$700.34 had been received up to this time. M.S.C. that it be accepted.

The Resolutions Committee gave its report. There was talk and discussion about writing the Federal Communications Commission petitioning a clean-up of T.V. shows. M.S.C. that the report be accepted. No action was taken on the discussion to petition the Federal Communications Commission.

In further business, Bro. Earl Cook made a motion to add the Cooperative Plan Breakdown and a record of Communion and Feet Washing Services held in the Minutes. M.S.C. that this be done.

Bro. John Edwards announced that the Alabama State Association would convene in Dothan, November 10-12. A Welcome was extended.

An announcement was made concerning Mission Board Service for that night.

Business opened with the roll call of delegates.

Digest Committee did not have their report complete at this time.

Stewardship Report was given. M.S.C. that it be accepted.

Registration Committee gave their report. M.S.C. that it be accepted.

Education and Missions Reports to be given in afternoon.

Digest Committee gave their report which was accepted. This report was also to be compared with the Treasurer's Report.

Treasurer gave his report which was M.S.C. that it be accepted.



Obituary Committee gave report and asked for a period of silent prayer followed by Bro. Millard Sasser praying aloud. M.S.C. that it be accepted.

Request was made that Finance Committee give complete report, including funds taken in this session. M.S.C. that it be accepted. M.S.C. to appoint a Committee to study revision of disbursement of Cooperative Money in order to give more to Childrens Home. The following were appointed to serve on this committee; Bro. Ernest Owen, Bro. Leon Owens, and Bro. Bill George.

We recessed with prayer by Bro. Frank Willis.

Recess ended with singing of "Stand Up, Stand Up for Jesus" led by Bro. Wendell Walley. Bro. Milton Gann led in prayer. Bro. John Pettis brought the morning message. "Just As I Am" was sung following the message. We were dismissed for lunch with prayer by Bro. Wallace Peterson.

Saturday Afternoon

The afternoon service opened with congregational singing. Mrs. Bertie Baxter gave the devotional.

Education Board gave report. M.S.C. that it be accepted.

Mission Board gave report. Moved and seconded that report be accepted and taken item by item.

- 1. M.S.C. that Bro. Homer Willis be our missions conference speaker.
- 2. M.S.C. that gifts of \$100.00 each be given to the Niceville and the Wright Churches.

Committee on Childrens Home fund report given. M.S.C. that it be accepted. The proposals are as follows: M.S.C. that we as an Association recommend to the State Association that the percentage of money be increased to at least 30% instead of 25%. M.S.C. that 5% of Cooperative money from our Association go to the Childrens Home.

M.S.C. that we accept Bro. Wendell Walley as Pastor in our Association after having been examined by Committee from Presbytery. Bro. Walley and his wife were given Hand of Fellowship, while "Leaning On Everlasting Arms" was sung.



Talked about placing Bro. John Pettis on list of Ministers and Deacons in Minutes. Agreed without motion to do this as he is a member of our Association.

Brother Burns gave a comparison of last years giving in comparison to this years giving. An increase was seen in areas of Foreign Missions, Cooperative Giving, and Childrens Home, but was behind last years in areas of Home Missions, Bible College, General Fund. Total money handled was greater this year.

Final Finance Committee report was given stating that \$922.17 was the total amount of money received. M.S.C. that it be accepted.

A motion was made to take from the table the report of Committee on Revision of Constitution. M.S.C. that it be as follows:

The Revision Committee composed of Rev. Leon Owens, Rev. Bill George, and Rev. Luther Burns met on December 3, 1963 to study the Constitution, Association Decorum, Church Decorum, and to check Articles of Faith for any missprint or error involved in wording.

We make the following recommendations:

- 1. Article VI, Section 2 (page 15) The word "Whose"
 to replace the word "who" (typographical error)
- 2. Article X (page 16) Amendments-

To read as follows:

"This Constitution may be altered or amended by a vote of the Association at any regular session provided notice of such intended alteration has been given in writing and recorded at the previous session."

Associational Decorum

- 1. Paragraph #9- To read as follows: "No minister shall be considered in good standing that officiates in the rites of matrimony where either party has a living mate."
- 2. Paragraph #12- To read as follows: "Any minister belonging to this body who has an appointment or is serving churches and fails to meet the appointed hours, shall render proper acknowledgements to the congregation or church. M.S.C. that the revisions be put into the minutes.



The report of Nominations Committee was given by the Piney Grove Church. The report is broken down as follows: The Committee assigned to the various churches was accepted as read, the quarterly meetings and the yearly meeting as outlined in the report was accepted as read. M.S.C. that proposal to combine Sunday School and C.T.S. Convention be placed in hands of President Aaron Burch, Sunday School and Milton Gann, C.T.S. The Committee also recommended that the Woman's Auxiliary Convention, the Master's Men Convention and the District Youth Rally be allowed to choose their own meeting times. The annual District Missions Conference to be held at a time to be announced by Missions Board with the understanding that it be as close to usual time, First of February.

The Liberty Association to hold next Annual Conference with Panama City Church. M.S.C. that all be accepted as per report.

Bro. Ernest Owen was nominated for the Mission Board and was elected. The Nominating Committee submitted the fol-

lowing names for officers: Moderator, Bro. Bill George; Vice Moderator, Bro. Millard Sasser; Clerk, Bro. Luther Burns. All were elected.

The names of Bro. Leslie Roberts and Bro. Lonnie Squires were submitted to serve on Executive Committee. M.S.C. to accept them.


Bro. Wendell Walley was nominated from floor to serve as Vice Clerk-Treasurer and was elected.

We recommend that space be provided in our Minutes to show if a church has a Sunday School, Church Training Service, Woman's Auxiliary, Master's Men, Vacation School.



MISSION BOARD REPORT

We your Mission Board make the following report with recommendations:

Our Annual Missionary Conference started January 27 and closed Sunday afternoon, January 31st. and was a success. Bro. Sammy Wilkinson, Missionary on leave from Brazil was our guest speaker. The services were held in the following churches: Piney Grove (Wednesday), Bonifay (Thursday), Damascus (Friday), Liberty (Saturday), with the Rally at Chipley on Sunday afternoon. The offering totaled \$230.28 with the pledges being about \$1100.00.

There were other missionary services in our area this year that the Mission Board helped to sponsor and conduct. Miss Patsy Tyson and Miss Ella Rae Jones, missionary nurses to Ecuador were in Youth Camp with us and while in the area conducted services at Liberty, Piney Grove, Pleasant Hill and at an Associational Youth Rally held at Chipley.

Bro. Herman Brooks, Home Missionary to Canadawas in our area for nine services from August 26th, through September 3rd. Three services were held in the Salem Association during this time. Services were conducted in the following churches: Faith, Damascus, and Traveler's Rest (Salem), Liberty, Pleasant Hill, Poplar Head, Bonifay, Chipley and Piney Grove. The offerings totaled \$139.34 monthly pledges amounting to \$30.00.

The following recommendations were offered and approved

- 1. We recommend that emphasis be placed on Home Missions in our next Missionary Conference.
- 2. We recommend a gift offering of \$100.00 each be given to the niceville and Wright Churches.



CONSTITUTION

ARTICLE I. Name. This Association shall be known as the WEST FLORIDA LIBERTY FREE WILL BAPTIST ASSOCIATION.

ARTICLE II. Composition. This Association shall be composed of such regularly organized and well-disciplined Free Will Baptist Churches conveniently located, as may embody themselves under this constitution.

ARTICLE III. Representation. The Conference of this Association shall consist of delegates from the several Churches of which it is composed, each Church being entitled to two (2) delegates for the first twenty-five (25) members or fraction thereof, and one (1) delegate for each subsequent twenty-five (25) members or fraction thereof.

Section 2. All ordained ministers and deacons who are in good standing with the Association shall be standing delegates.

ARTICLE IV. Section 1. Officers, Boards and Committees. The officers of this Association shall be a Clerk-Treasurer, Moderator, Vice Moderator, Board of Trustees, and a Presbytery, which shall be responsible to God and to the Association for ordination of ministers and deacons, and for their doctrine and moral character, who shall be chosen at every session of the Association, with assistants as may be deemed necessary.

Section 2. The Standing Committees of this Association shall be Executive, Finance, Obituary, Temperance, Stewardship, Auxiliaries, Resolutions, and Nominations. Other committees shall be appointed as the need may arise. The Executive Committee shall be composed of seven members of which the Moderator of the Association who shall be Chairman of the Committee, and Clerk shall be standing members. The other five members shall be elected for two year terms as follows: two one year and three the next year.

Section 3. The Board of Missions consisting of three (3) members shall be elected as follows: one member shall be elected each year.

ARTICLE V. Membership. Any well-organized and well-regulated Free Will Baptist Church which conforms to the practices, and adopts the doctrines of the Free Will Baptist denomination, as published in the treatise of their faith, and in the Minutes of the National Association, and is in favor of all the benevolent enterprises of the denomination, may at any time, on application, by vote of this body, become a member thereof.

Section 2. Churches from other Associations wishing to become members of this Association must present a letter of recommendation from the Association of which they were previously a member.

ARTICLE VI. Meetings. The sessions of this Association shall be held on Friday and Saturday before the third Sunday in October at which time it shall be the duty of the churches of which this Association is composed to represent themselves by letter and delegates, and report their standing, prospects, and statistics. At this time the Association shall act upon such questions and topics as may be referred to it by its respective Quarterly Meeting or Churches, and transact such other business not repugnant to this Constitution, nor to the practices of the denomination, as in its judgment may promote the cause of Christ and the interest of the Churches within the limits of this Association.

Section 2. This Association shall sponsor a Quarterly Meeting to be held on Saturday before the first-third Sunday in each Quarter whose representation shall be the same as that of the Association.

Section 3. This Association shall sponsor a student loan fund which shall make loans to worthy students within this Association en-



rolled in Free Will Baptist Bible College. This loan fund shall be established by a representation fee of \$5.00 from each church in the Association payable at each quarterly meeting and annual association and supplemented by gifts. Those being eligible: (1) Shall be a member in good standing of a Free Will Baptist Church in this Association. (2) Shall give to the Trustees of this Association a promissory note payable six months after leaving school with 2 per cent interest to begin when note is due. (3) Note to be endorsed by two competent business men.

ARTICLE VII. Finances. The general expense of the Association shall be provided by each Church according to its ability. The moderator and Clerk shall receive twenty-five dollars (\$25.00) each per year, and the remainder of the money shall be used for Minutes, postage and any other expense that may occur.

Section 2. Each Church shall send at least 10% of its income to the Treasurer of the Quarterly Meetings and the Association for the different phases of the denominational work.

ARTICLE VIII. Discipline. This Association shall have power to discipline the Churches of which it is composed, and to exclude them for disorderly walk, if the labor proves unsuccessful, but in no case to reverse their decisions, nor to interfere with any of their internal regulations.

ARTICLE IX. By-Laws. This Association shall have power to adopt any regulation or by-laws, not inconsistent with this Constitution, which may be deemed essential to the further regulations of its sessions.

ARTICLE X. Amendments. This Constitution may be altered or amended by a vote of the Association at any regular session, notice of such intended alteration having been given in writing, and recorded at the previous session.

ASSOCIATION DECORUM

1. This Association shall be called to order by the Moderator elected at the last session if present. If absent, by the Vice Moderator, or someone elected by the body.

2. The Moderator shall see that order is preserved and submit all actions to the body. He shall have the same right of speech as any other member, but appoint some other brother as chairman while speaking. He shall not have the right to vote unless it be in the case of a tie, then he may cast the deciding vote.

3. The Vice Moderator shall assume the duties, rights and privileges of the Moderator in his absence.

4. The delegates shall be enrolled by the clerk as they are seated in the body. The roll shall be called each morning, and all not answering to their names marked absent.

5. No delegate or minister shall be allowed to absent himself from the body during any session without permission from the Moderator.

6. All business shall be brought before the body by move and second and shall be disposed of according to ROBERT'S RULES OF ORDER. No person shall be allowed to speak more than three times on the same subject, and not more than ten minutes each time without a move and second from the body.

7. Only one person shall be allowed to speak at a time and he must rise to his feet and address the Moderator. No person shall be disturbed while speaking so long as he keeps to the point in debate, except by the Moderator, and then only to call him to order. The speaker must not use abusive language or personal reflections upon anyone.

8. Each minister shall make a report of how many churches he is serving, if any, and what each church has paid him for his services.



9. No minister shall be considered in good standing that officiates in the rites of matrimony where either party has a living mate.

10. No minister or deacon shall be considered in good standing with this body that has more than one living wife, drinks intoxicating beverages or fails to pay or make proper satisfaction of his just and honest debts.

11. All ministers serving churches shall preach at least one sermon a year on doctrine and rules of holy living.

12. Any minister belonging to this body who has an appointment or is serving churches and who fails to meet the appointed hours, shall render due acknowledgements to the congregation or church.

13. No minister shall preach in our churches that cannot bring a clear record from his home church.

14. Any minister who will voluntarily step aside shall immediately turn his credentials over to the Executive Committee of the Association.

15. No church shall be recognized in this body who does not commune and wash feet at least twice a year and who does not have conference quarterly. The pastor's salary, number of conferences and the number of communion and feet washing services shall be contained in the associational letter.

16. No church shall be considered in this body that holds fellowship with a minister or deacon that does not conform to Article 10 of this Decorum.

CHURCH DECORUM

1. The church may choose a pastor annually at the last conference in the associational year; or if they prefer, it may choose a pastor for an indefinite length of time to continue from year to year, as long as they may deem it proper to keep up the connection.

2. When it becomes necessary, a pastor may be chosen at any given time, but if the choice be made at a special conference, the time for the conference must be appointed by the church in conference at least thirty (30) days in advance.

3. When a pastor wishes to resign a church he shall give the church a sixty (60) day notice; or when the church wishes to call a pastor it shall give the present pastor a sixty (60) day notice.

4. The pastor shall be Moderator of the church, but when the Moderator is absent or does not sit, a suitable brother shall be appointed in his place.


5. There shall be two or more deacons in the church whose duty it shall be to superintend the collection and distribution of all contributions, and to assist the pastor in administration of the Lord's Supper and washing the Saints' Feet.

6. The deacons shall take notice of such members as refuse or neglect to partake of the Lord's Supper and endeavor to ascertain the cause that the same may be laid before the church in conference if necessary.

7. Some suitable member shall be appointed clerk and it shall be his duty to do all the recording and writing pertaining to the business of the church and to preserve a file of the Minutes of the Association.

8. When a clerk is appointed, all of the books, Minutes, etc., belonging to the clerk shall be delivered to him by his predecessor.

9. Some suitable member shall be elected treasurer whose duty shall be to distribute all funds as directed by the church.



10. It shall be the rule of the church to attend to the administration of the Lord's Supper and washing of the Saints' Feet as often as the church sees fit. Members not in good standing should not commune, but the administration should not be deferred on account of any orderly matter of dealing.

11. Conferences shall be opened and conducted as follows: (1) Prayer unless divine service has just been concluded, and generally then, (2) Invite visiting brethren to seats, (3) Open the door for reception of members, (4) Call for absentees, (5) Call for acknowledgement, (6) for reference of deferred business, (7) for matters of dealing which are in order to come before the church, and (8) for miscellaneous business.

12. It shall be the duty of every church member, male or female, to attend each conference meeting, if they can, for on that day the pastor is expected to instruct the church in a certain manner by giving plain and pointed lessons on doctrine, discipline, and rules of holy living.

13. Any male member who shall fail to attend three successive conferences and any member who may be generally remiss in attending meetings of the church shall be cited to appear in conference and answer for his conduct; but the church may exempt members from this if necessary.

15. A vote shall not be taken upon a question without a move and second and on all important questions the vote shall be taken by rising to the feet.

14. When the Moderator calls for absentees the clerk shall inform the church what male members have been absent from three succesive conferences, and the Moderator shall appoint some brethren to cite each of them to the next conference.

16. Visiting brethren called in as help from sister churches shall be allowed to speak and make motions or seconds, but not allowed to vote.

17. No main motion shall be made while a move and second is before the conference.

18. It shall be considered disorderly for any member to absent himself from conference when an important question is to be decided; but a member, upon request, may be exempted by the church from voting on either side in peculiar cases.

19. No member shall leave the house during conferences without a sufficient cause, nor engage in conversation or whispering without being subject to be called to order by the Moderator.

20. All discussions in conference must be conducted with calmness and good feeling. Those who speak must rise to their feet, and keep to the point in debate.

21. No one shall speak more than three times on the same subject without permission from the Moderator, nor shall the remarks of anyone be unreasonably long.

22. When the Moderator speaks he must nominate some brother as Moderator to act in his stead.

23. No one shall be interrupted while speaking unless it be necessary to call him to order.

24. No member shall be expelled unless he has been cited verbally or in writing to attend his trial provided his residence be known to the church.

25. Expelled members may be restored to fellowship on their petition if their walk since expulsion has convinced the church that they have sincerely repented for their former evil.

26. When a witness, not a member of the church, is introduced



he shall not be examined until the question has been put to the church: "Will you hear the testimony of the witness?"

27. The evidence in every case of dealing and acknowledgement shall be recorded in the church.

28. Members dismissed from the church by letter who become disorderly or continue to hold their letter without good reason shall be cited to the conference to answer for their conduct.

29. Any ordinary member of the Baptist Church who does not hold this church in fellowship may be received into the church without a letter when it is made apparent that his Christian character is irreproachable and that he has applied for a letter and could not obtain it because he desires to join this or some sister church. All other persons must join by letter, baptism, statement, or restoration.

ARTICLES OF FAITH

1. THE BIBLE. The Scripture of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.

2. GOD. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe; and in the Scriptures as Father, Son, and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.

3. CHRIST. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The Mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Saviour and Lord.

4. THE HOLY SPIRIT. The Scriptures assign to the Holy Spirit all the attributes of God.

5. THE GOVERNMENT OF GOD. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for, as the highest welfare of men requires.

6. THE SINFULNESS OF MAN. Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity therefore, inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

7. THE WORK OF CHRIST. The Son of God by His incarnation, life, sufferings, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. THE TERMS OF SALVATION. The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved commital of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

9. ELECTION. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect.

10. FREEDOM OF THE WILL. The human will is free and selfcontrolled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.

11. SALVATION FREE. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all and whosoever will may come and take of the water of life freely.



12. PERSEVERANCE. All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal sal-vation.

13. GOSPEL ORDINANCES. Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel; Feet Washing, an ordinance teaching humility, of universal obligation, and to be ministered to all true believers.

14. TITHING. God commanded tithes and offerings in the old Testament; Jesus Christ endorsed it in the Gospel (Matt. 23:23), and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God hath prospered him."—(1 Cor. 16:2).

15. THE CHRISTIAN SABBATH. The divine law requires that one day in seven be set apart from secular employment and amusements, for rest, worship, holy work and activities, and for personal communion with God.

16. RESURRECTION, JUDGMENT, AND FINAL RETRIBU-TION. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."




