**CONSTITUTION
OF THE WEST MICHIGAN ASSOCIATION
OF
FREE WILL BAPTISTS**

1. The Association, when properly convened, shall consist of a Moderator, an Assistant Moderator, Clerk, and Treasurer, who shall be to keep the Association in order, state questions fairly and take the vote thereon; to have no vote unless the Association be equally divided, in which case he shall have the deciding vote.

The duty of the Clerk and Treasurer shall be to keep a fair record of the proceedings and monies of the Association. The Assistant to the Moderator is to assist, or occupy the respective seat when vacant, or otherwise necessary. The Clerk and Treasurer are to assist one another, or occupy the respective seat when vacant, or otherwise necessary.

2. This Association shall be composed of ordained Ministers and their wives who are standing delegates along with the West Michigan Association Clerk, together with delegates duly chosen by the church of their membership in our Association.

Said Ministers shall be men of good report, within and without, of honest integrity and full of the Holy Ghost, meeting the qualifications to that of I Timothy 3. Coming under the hands, or approval of the Ordaining Council.

3. No question shall be received by this Association from any church until it has been acted upon by said church and referred to the Association. In which case the Association shall take up the matter, acting as advisory counsel to promote peace and harmony according to true discipline of Divine grace.

4. Every church in this Association shall be entitled to a representation of five elected delegates from the body; together with Ordained Ministers and their wives along with the West Michigan Association Clerk.

5. This Association shall maintain a Presbytery Board selected from the ordained Ministers; three in number, also an Executive Board consisting of five, selected from the body, whose tenure of office shall be ranging from one to five years. The Association shall select, annually, to supply the vacancies as they occur.

6. Every motion, when in order and properly sustained, shall be acted upon unless withdrawn by the mover; that is to say, to present matters for discussion, trying the merits of the same, and, if found worth and orthodox, to adopt it.

7. This association shall not exercise power so as to lord it over God's heritage so as to infringe on the internal rights of any. Maintaining the rights and privileges, and relationships to each church to that of individual members; that is to say, if a church trespass against a sister church, the church injured shall try to reclaim them by Gospel steps; whereupon, if a reconciliation cannot be effected, the said church in default shall be dropped from our counsel.

8. We agree to do all regular business by a majority of members present.

9. Any church may be admitted into this Association by a petitionary letter and delegates, if however, said church is found to be orthodox and orderly. Such admission shall be manifested by the Moderator extending the right hand of fellowship to said delegates.

10. This Association shall sit as an advisory council, to advise, if prudent, in all matters of difficulty; to ascertain the cause of nonrepresentation, to select from this body such committees deemed necessary to the functioning of the body; to exclude, or disannul any member not conforming to the Rules of Decorum, and shall report his, or their, conduct to the church of which they hold membership.

11. This Association shall not, at any time, engage in what may seem to be of a commercial nature. However, it shall be the duty of each church to provide the means for defraying current expenses of the Association.

12. This Association shall advise, or recommend the support of denominational enterprises according to the ability, or means otherwise provided, and under the jurisdiction of the local church.

13. This constitution shall not be changed, or amended, only by a three-fourths majority of Ministers, and their wives, and likewise the duly elected delegates at the regular annual setting of the Association.

RULES OF DECORUM

1. The Association when convened shall be opened and closed by singing and prayer.
2. Only one person shall speak at a time who shall arise to his feet and address the moderator and not proceed until recognized by the moderator.
3. Each person thus speaking shall not be interrupted in speech except by the moderator, until he gets through, nor shall the moderator interrupt him unless he breaks order.
4. The person speaking shall adhere to the question and shall in no wise cast reflection on any person who may have spoken before him.
5. No person shall speak more than three times on the same subject without leave of the Association.
6. No person shall laugh or whisper in time of public speech.
7. Members shall address each other by the appellation of Brother or Brethern, or Sister.
8. No member of this Association shall absent himself when the Association is sitting in conference without leave of the moderator.
9. The name of the members of this Association shall be enrolled and called over as often as the Association think necessary.
10. No member shall speak longer than fifteen minutes at any time without leave of the moderator.

MINUTES FOR MAY 11, 1985

THE SOUTHWEST ASSOCIATION OF FREE WILL BAPTISTS

The West Michigan Association of Free Will Baptists met for their first organizational meeting on Saturday, May 11, 1985, at the South Haven Free Will Baptist Church.

We were welcomed by Pastor J.D. Tolbert and led in congregational singing. Brother Ballard then led in prayer. Brother Tolbert introduced Charles Cooper as the Moderator of Organization.

Brother Cooper read from Exodus chapter 18 as his introduction and then officially called the meeting to order.

Brother Cooper called for the letters of membership from the joining churches. The Benton Harbor and South Haven Churches presented letters to Sister Tolbert who was acting as clerk. Faith Free Will Baptist and First Free Will Baptist of Kalamazoo presented Sister Tolbert with the names of their delegates in lieu of letters. At this time all of the delegates came forward to receive the right hand of fellowship. A prayer of blessing was offered by Brother Raymond Riggs.

Brother Cooper read the Constitution and By-laws for approval. A motion was made by Brother John Vick to accept the Constitution and By-laws as read. A second was made by Brother Tolbert. The motion was passed by a voice vote.

Brother Cooper read the treaties of the Free Will Baptist and a motion was made by Brother Tolbert to accept as read. The motion was seconded by Brother Presley. The motion was carried by a voice vote.

Nominations were opened for the position of moderator by Brother Cooper. Brother John Vick was nominated and elected unanimously by voice vote. Brother Vick then took over duties of moderator of the association.

Brother Vick took nominations for the position of assistant moderator. J. D. Tolbert was nominated and elected unanimously by a voice vote. Nominations were then accepted by Brother Vick for the position of clerk. Brother Tom Roberts was nominated and elected unanimously by a voice vote.

Nominations were then taken for the position of treasurer. Brother Ike Livingston was nominated and elected unanimously by a show of hands.

Brother Vick took nominations for Home Missions Board Representative and Brother Presley was nominated. He was elected unanimously by a voice vote.

A motion was made by Brother Presley and seconded by Brother Tolbert to present a letter to the state association at their next meeting presenting ourselves as a new association by the name of The West Michigan Association of Free Will Baptists consisting of charter members: The South Haven Free Will Baptist Church, The Benton Harbor Free Will Baptist Church, Faith Free Will Baptist of Watervliet, and First Free Will Baptist of Kalamazoo. The motion was carried by a voice vote.

Brother Vick opened nominations for the Presbytery Board. Nominated were Brother Glisson for a term of one year, Brother Presley for a term of two years and Brother Tolbert for a term of three years. All were elected by a standing vote.

Nominations were then accepted by Brother Vick for the Executive Board. Nominated for a term of one year was Brother Alvis Cagle, for a term of two years - Brother Jim Koss, for a term of four years - Brother Don Stallings, and for a term of five years - Brother Harold Griffin. All were elected by a standing vote.

It was unanimously decided the next meeting of our association would be August 10th at 9:30 a.m. at Faith Free Will Baptist in Watervliet.

Brother Ike Livingston was nominated to serve as Representative to the State Association meeting. He was elected by a voice vote.

We were then officially welcomed and invited to the Women's Auxiliary Meeting at the National Convention in Nashville by Sister Riggs.

At this time we adjourned for a fifteen minute break.

When we reconvened we were led in congregational singing by Brother Livingston and in prayer by Brother Chuck Rogers. Brother and Sister Riggs then performed two songs as special singing.

Brother Vick introduced Brother Raymond Riggs as our guest speaker. Brother Riggs brought our dedicatory message from Matthew chapter sixteen. We were then adjourned in a benediction and blessing on the dinner by Brother Presley.

MINUTES FOR AUGUST 10, 1985
THE WEST MICHIGAN ASSOCIATION OF FREE WILL BAPTISTS

The West Michigan Association of Free Will Baptists met for their first quarterly meeting at Faith Free Will Baptist Church of Watervliet on August 10, 1985, at 9:30 a.m.

We were welcomed by Brother John Vick to begin the meeting. Brother Darron Glisson led the congregation in singing "Victory In Jesus." Brother J. D. Tolbert then led us in prayer.

Brother Vick introduced the pastor of Faith Free Will Baptist, Brother Darron Glisson, to lead in the morning devotion. Brother Glisson took his text from Psalms Chapter 12.

Upon finishing the morning devotion, Brother Vick read and explained the rules of decorum. Brother Vick received into recognition the standing delegates. Brother Tolbert made a motion that we receive the elected delegates for seating. Brother Allen Presley led in a prayer of consecration.

The clerk, Brother Tom Roberts, called the roll of churches. All churches in the Association was represented and quarterly conference letters received.

Brother Roberts read the minutes from the organizational meeting of May 11, 1985. Brother Ike Livingston made a motion to accept the report as read. The motion was carried.

Brother Roberts read the minutes of the United Board meeting of June 18, 1985, to become part of the record. At this time we were recessed for a short break.

Assistant Moderator J.D. Tolbert reconvened the conference at 11 a.m. Brother Livingston led the congregation in "Blessed Assurance" and Brother Roberts led in prayer. Brother Livingston led in another congregation song and Brother Carl Loomis prayed the offeratory prayer. A motion was made by Brother Roberts that the Business Committee decide during their session the purpose of distribution of each conference offering. The motion was carried. It was noted that the United Boards would next meet on October 4th in Kalamazoo at 7 p.m. The next quarterly meeting would be held November 9th at Benton Harbor at 9:30 a.m.

The Presbytery Board, with Brother Tolbert reporting, recommended that Brother Darron Glisson be ordained as a pastor. The recommendation was made into a motion and the motion unanimously was carried.

Brother Vick recognized visitors from Indiana and several announcements were made at this time.

Brother Eugene Glisson made a motion that we adjourn. The motion was carried.

At this time the service was turned over to the host church. We were greatly blessed by singing and words of this clerk and can not express the blessings and moving of the Spirit during the ordination service of Brother Glisson.

- (5) Recommend that the offering be given to the host church. The host pastor, Brother Allan Presley, requested that the offering be given to the foreign mission in the name of the association. Brother Charles Rogers made a motion on the amendment of the offering. Motion was carried.
- (6) Recommend that \$100.00 per year be given to the moderator and \$100.00 per year to the clerk-treasurer to offset expenses. Motion was made by Brother Glisson, motion carried.

It was noted that the next United Executive Board meeting is on January 14, 1985, at 7 p.m. at the First Free Will Baptist Church of South Haven.

Brother Vick asked that a standing of appreciation be given to the United Executive Board. Brother Charles Rogers made a motion that a standing of appreciation be given to the Host church for a fine meal and hospitality motion was carried.

Brother J.D. Tolbert made a motion to adjourn, motion was carried.

A motion was made by Brother Charles Rogers to accept this recommendation. The motion was carried. (5) It was recommended that a vote of appreciation be given to the host church. A motion was made by Brother Harold Griffin to accept this recommendation. The motion was carried. The next meeting of the Executive Board will be held on April 10, 1986, at 7:00 p.m. at the Faith Free Will Baptist Church of Watervliet. Brother Vick then called for any old business, there was none. Brother Livingston then gave the Digest report. A motion was made by Brother Andy Campbell to accept the report as read. The motion was carried. Brother J.D. Tolbert then gave the Presbytery report. A motion was made by Brother Tolbert to accept the report as read. The motion was carried.

The moderator then called for the Women's Auxiliary report. Sister Krajecki reported that on January 18, 1986, we organized the District Auxiliary of the West Michigan Association of Free Will Baptists with 22 ladies present. We elected officers as follows: President, Sister Trudy Krajecki; Vice President, Sister Helen Byers; Secretary, Sister Wanda Glisson; Assistant Secretary-Treasurer, Sister Norma Rogers; Mission Prayer Sister, Delores Stultz; Mission Study Sister, Sharon Bowlin.
