REPORT OF BUSINESS COMMITTEE

The report which was read and accepted by motion is as follows:

1. We, your Business Committee, recommend that, since it is necessary to give good-standing cards to the ministers of the Logan Q. M., we also give good-standing cards to all other bodies requesting them for their ministers. This is not to interfere with the present custom of issuing cards by district bodies. Accepted by motion.

2. Recommended that bills be paid in the amount of \$49.40 for

postage, letter forms, by-laws, programs, etc. Accepted.

3. Recommended that a bill of \$5.75 for printing minister's cards be paid. Accepted.

4. Recommended that we purchase a seal for the W. Va. State Meeting. Clerk to be authorized to do this. Accepted.

We resolve that each church belonging to a Q. M. or District Association which is a member of the State Meeting, pay \$1.00 and each minister pay 50c per quarter to the Home Mission Board. Rejected.

2. Resolve that the Home Mission Board pay the State Secretary \$100 per mo. Accepted and tabled until later in this session.

- 3. Resolved that all ministers and delegates be registered and a registration fee of \$1.00 be received each session. Accepted with an explanation that the above amount would go to the host church to help bear the expense of the session.
- 4. Resolve that we take a standing vote of thanks to the Sophia Church for its hospitality. Accepted and concurred in.
