### REPORT OF BUSINESS COMMITTEE

- Item 1: Motion and carried that we pay Rev. W. C. Combs the sum of \$9.00 for the printing of programs and postage. Carried.
- Item 2: Motion and second that we abolish the office of State Secretary. Rejected.
- Item 3: Motion and second that a board be appointed to raise funds to finance the State Secretary. Also, moderator appointed Home Mission Board, Rev. Brooks Spurlock, Rev. Oliver Privett, and Rev. E. N. Withrow.
- Item 4: Motion that the Southern Association be granted good standing cards, when an approved list of their ministers are received properly signed by the moderator and clerk. Carried.
- Item 5: We recommend that each district association, quarterly meeting, or yearly meeting have a certified list of ministers from same to be eligible for state meeting cards. Carried.
- Item 6: We recommend that the clerk's fee paid, and that same have minutes printed and draw an order on treasury for the amount. Carried.
- Item 7: That a delegation be sent to the National Meeting, and sufficient funds for each district and quarterly meeting be sent as required by the National Association.

Item 8: We recommend that all district associations, yearly meetings, and quarterly meetings discontinue the licensing and ordaining of women to preach the gospel. Carried 25 to 1.

Rev. D. E. Bias notifies the State Meeting of the appeal of the above action to the National Association.

Rev. Jesse Blankenship nominated as three year man on Home Mission Board. Elected.

Rev. Hoarce Carey was elected to fill the two year unexpired term of Bro. Napier.

Motion and second that we receive report of Home Mission Board. Carried.

Each district association, yearly meeting, or quarterly meeting is requested to raise \$1.00 per year, per member for Home Mission work. 25 per cent to be retained in the quarterly meeting, 25 per cent to the district association or yearly meeting, 50 per cent to be forwarded to the State Home Mission Treasury.

Motion and second that we stand one minute in silent prayer for the deceased of our number.

Motion and second that the chair appoint an Obituary Committee. Rev. Brooks Spurlock, Rev. Rice Browning, and Rev. J. M. Henson.

Next session of the W. Va. State Meeting to convene with the Green Shoals F. W. B. Church at Fry, W. Va., if they can't handle it Logan Quarterly Meeting Executive Board meet, decide, and notify the cltrk as to the change so it could be put in the minutes. The State Meeting will convene Friday and Saturday before the second Sunday in June, 1950.

Motion we give a rising vote of thanks to the community for their hospitality while in their midst. Carried.
