SANCTIFICATION

Since the subject of sanctification is one concerning which there is so much difference in opinion, it is especially vise when studying the subject, to gather all relating scriptures and through a prayerful study of each, be led by the Spirit into a line of thinking coinciding with the scriptures as a whole.

In defining the word, it is generally accepted that it means, the act of purging, cleansing, purifying, setting apart, etc.

There are several agents of Sanctification mentioned in the Word.

- 1. The Blood. Heb. 9:13-14; 10:29; 13:12.
- 2. The Word if Truth. St. John 17:17-19; Eph. 5:26.
- 3. The Holy Ghost. Rom. 15:16.
- 4. God. I. Thes. 5:23; Jude 1.

There are many other places in the Word which are too numerous to mention here, yet they all conform the same general line of Truth, that is, that sanctification not only embraces the conversion but the whole pathway of the Christian life.

For a moment let us consider the purpose of Sanctification. Man, who was created in the image and likeness of God, and who enjoyed the fellowship and communion with God, fell so low into depravity, sin, corruption, ungodliness, and death, and so far from the lofty, holy, pure and heavenly estate of God, that before he could again come into the presence of God, there must be a "process" of preparation, lest he should be consumed. Heb. 12:29.

There are three biblical pictures, which, when taken in their entirety, and compared with the other, give us a very thorough and sound insight into this sanctifying process.

- 1. In the Mosaical Law we have the pattern.
- 2. In the New Testament a spiritual confirmation in reality of the pattern.
- 3. Finally, by the Word in Revelation, we see that in Heaven itself, and after this life is over, the process of sanctification shall have been completed.

In giving to Moses the pattern, God, not only told him by Word of mouth, but He bowed the Heavens low and came down letting Moses look on the things he was instructed to, "Make them according to the pattern shewed to thee in the mount." Psalms 18:9-10; Heb. 9:23; Heb. 8:5.

The people were instructed to sanctify themselves, that is, through cleanliness and sanitation, doing those things that they themselves could do. God would then come to them afar off in a cloud of smoke and fire.

In the pattern, God commanded Moses to make a holy annointing oil after the art of the Apothecary, to be used only for the special purpose for which it was made. (The incense was made likewise). This oil, a type of the Holy Ghost, was to be used to anoint the priesthood and the vessels of the ministry, setting them apart for the work of God from the very start, just as the Holy Ghost entering the new convert does the same.

Let us give a brief study to the work of the high priest, preparatory to, and, while entering into the presence of God in the Holy of Holies in the tabernacle. In this we shall make an illustrative comparison with the actual process of sanctification, accomplished in the individual from it's beginning at conversion unto it's completion at the end of the "pathway."

Bear in mind the fact that in the arrangement of the Tabernacle, the entrance to the Outer Court, the Holy Place, and the Holy of Holies, each faced east, or were in line one with the other. In this straight line, or suppose we call it "Pathway," were: 1. The Brazen Altar of burnt offering, and the Laver containing water for washing. Ex. 40:30-32, these both in the Outer Court.

2. The Table of Shewbread on the right, the Candlestick on the left, and the Golden Altar of Incense in the "Pathway," these in the Holy Place. 3. Finally, through the vail into the Holy of Holies was the Ark of the Covenant where God promised to dwell, between the cherubim over the Mercy Seat. God was at the end of the "Pathway."

Let us consider diligently the "Process of Preparation" undergone before the High Priest actually came into the presence of God. He came to the door of the tabernacle by way of the Brazen Altar, the sacrificial animal having been slain and the blood applied to the lobes of the ears, the thumbs and the great toes. Blood was also sprinkled around about and upon the Brazen Altar where the flesh was burnt. Just so the penitent sinner begins his sanctification or "Process of Preparation" by faith in the Blood of Christ. Heb. 9:13 14; 10:19-22. He next came to the Layer

and washed upon the arrival at the door of the Tabernacle, already mentioned. Just so the regenerated soul while traveling the Christian Pathway is refined to a higher state of purity by the "Washing of Water by the Word." Eph. 5:25-27. Exodus 29 also places the anointing with the oil as being at the door of the Tabernacle.

Next, he entered the Holy Place by way of the Shewbread, comparable to the bread (Christ) that came down from Heaven. St. John 6:48-51; the candlestick or type of the Spirit, then at the Golden Altar of incense he got a censer of fire to carry with him into the Holy of Holies.

As he entered through the vail into the Holy of Holies he sprinkled incense (prayers, Rev. 8:3-4) on the censer of fire producing a cloud of smoke (Comparable to the glory of the consecrated and separated Christian) which served as a protective covering from the consuming power of God. Heb. 12:29.

Two of Aarons sons coming into the presence of God, contrary to the plan of preparation and bringing strange fire which God did not kindle, were consumed.

Solomon summed up the process of Sanctification in a few words by saying, "The Path of the just is as the shin ing light, that shineth more and more unto the perfect day. Prov. 4:18; I. Cor. 13:9-12; Phil. 3:13.

By way of conclusion let us say that Sanctification is a process of purification or preparation begun in the life of the individual at regeneration and continuing toward the whole or perfect state. I. Thes. 5:23.

Brethren, while we are going through the fires of pruification (Malachi 3:2-3) here, let us be comforted with the picture portrayed in Rev. 15:2-3, where the victorious saints (no longer needing the washing by the Word, or yet in the Laver, nor even in Solomon's brazen sea) who stand on a sea of glass containing fire rather than water, sing the song of victory, praise His name forever. We close with "For the marriage of the Lamb is come, and his wife hath made herself ready." Rev. 19:7.

Item No. 3.—Motion made that we table Item Number 3 of business committee until tomorrow for change of article 6 of Constitution to read as follows: "The Executive Board shall be composed of the following members: the Mderator, the Secretary, the Treasurer of the State Meeting, and one representative from each quarterly meeting to be elected from the floor of the State Meeting."

Item No. 4.—We, the Business Committee, recommend that this body grant the Beckley Conference it's appeal as the W. Va. Yearly Meeting over-rode its by-laws. (a) The decision of the State meeting is that the Beckley Quarterly Meeting was right and that the Yearly Meeting over-rode their own by-laws. Carried.

—The Yearly Meeting shall have power to discipline the quarterly meetings of which it is composed, and to exclude them for disorderly work, if labor proves unsuccessful; but in no case to reverse their decision, nor to interfere with any of their internal regulations.

Item No. 5.—We, the Business Committee, recommend that this body receive all letters from various conferences, but omiting the remarks of the McDowell letter. Carried.

Item No. 6—We, the Business Committee, recommend to this body that it send a committee of 5 men to meet with the Greenville, Tennessee orphanage board, to consider building a W. Va. Cottage. Carried.

Item No. 7.—We, the Business Committee, recommend to this body that the Christian Worker's Institute be held with the Kilsyth, W. Va. Free Will Baptist Church. Carried

Item No. 8.—We, the Business Committee, recommend to this body that it raise the fee from \$5.00 to \$25.00 per Conference to be used for the various phases of the work. Carried.

Moton we give time alloted to sister Ruby Dunlap to Bro. I. L. Stanley from the Orphanage for a report on Education and Free Will Baptist Orphanage work in Greenville, Tennessee. His talk was very much appreciated and he answered several questions pertaining to the work. Carried.

Rev. D. E. Bias gave his report on Education. He was elected on the Board of Education for 3 years. Motion was made that we take from table items of business pertaining to Article 6 of Constitution. Motion carried. Adjournment for preaching. Song by congregation "There Is A Fountain."

Motion we accept the report of Rev. D. W. French, the treasurer of Free Will Baptist Orphanage Fund to the amount of \$1,954.76 in Treasury. (Carried.)

Motion to accept report of Publication Committee, with \$8.00 due on last issue of state paper. (Carried.)

While pausing for a few minutes the \$8.00 was collected.

Motion that we give state paper back to Sunday School Convention. Lost 27—6.

Motion that five men be elected to serve as Committee, and that Sunday School Convenion be requested to do same to work together to keep the paper going. (Carried.)

Gave chair permission to appoint them as follows: (Carried.) Rev's. E. F. Bias, Rufus Johnson, Nathan Conn, James Herrold and Bro. R. W. Henson.

Motion that we stand in silent prayer for those of our number who have passed to their reward. (Carried.)

Motion that we correspond with letter and delegates to the National Association. (Carried.) Bro. J. T. Ross of War, W. Va., volunteered to go. Motion we send funds for same. Carried.

Motion that the sermon of Rev. W. C. Combs on "Sanctification" be printed in minutes. (Carried.)

The special board meeting will be held at "Warrior Mines" W. Va., to revise by-laws and make up program. Jan. 13, 1951.

Motion to draw an order for Treasurer to pay for printing of minutes and postage, etc.
