## CONSTITUTION OF STATE ASSOCIATION

### ARTICLE NO. 1

This Association shall be known as the West Virginia State Association of Free Will Baptists.

### ARTICLE NO. 2

The object of this organization shall be to more thoroughly unify the work of the Free Will Baptists of the state of West Virginia and to advise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in connection with the various Quarterly or Yearly Meetings comprising this state association.

### ARTICLE NO. 3

The membership of this State Association shall consist of the Quarterly Meetings and district association or yearly meetings from time to time upon approval shall become members of this body.

### ARTICLE NO. 4 — Discipline

The State Association shall have the right to settle any questions of discipline, doctrine or usage that may properly come before it from time to time, from any quarterly meetings or yearly meetings composing the said State Association, or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association making the appeal, then forwarded by mail or in person to State Association and Quarterly Meeting.

### ARTICLE NO. 5 — Officers

The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Promotional Secretary. Each of whom shall be nominated from the floor and elected by a standing vote from the floor, at each regular session, except the Treasurer shall be elected for a Three Year period, beginning with the 23rd Session, providing however that the Moderator shall not be elected two years in succession from the same Quarterly Meeting or Yearly Meeting, except in case of necessity.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

### ARTICLE NO. 6 — Executive Board

The Executive Board shall be composed of the following: The Moderator, the Clerk, the Treasurer of the State Association, and four (4) elected members, and not more than one (1) from any one Conference.

### ARTICLE NO. 7 — Boards and Committees

All Standing Boards shall be composed of three (3) members to be elected as follows: the first named for the term of three years; the second for a term of two years; the third for a term of one year, in order that, once the Board is set up, there will be one vacancy each year to fill, for a term of three years. Standing Boards include Foreign Mission, Home Mission, Board of Education, Orphanage Board, Christian Training Service (C. T. S.), Woman's Auxiliary Board and Sunday School Board.

Section 2—The duties of the various boards shall be to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their work as may become necessary, and may be found in harmony with the principles and tenets of the State Association.

Section 3—This State Association shall have as many committees as it is necessary to carry out the program that it may determine to promote.

#### **ARTICLE NO. 8 — Dues**

Annual dues shall be Fifteen dollars (\$15.00) per each Quarterly Meeting that is presented to the State Association, plus Three dollars (\$3.00) for each church belonging to the Quarterly Meeting or Yearly Meeting composing this body.

#### **ARTICLE NO. 9**

Section 1—All ordained ministers, deacons, and delegates shall voice and vote that are represented by their Quarterly Meeting or Yearly Meeting to this body.

Section 2—Each Quarterly Meeting shall have one delegate for each church belonging to it.

#### **ARTICLE NO. 10 — Meetings**

This State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place fixed by the regular session and made known before adjournment. Special meetings may be called by the Executive Board when extreme necessity demands, provided that the clerks of each Quarterly Meeting or Yearly Meeting have been properly notified fifteen days before the date of the meeting. Twenty-five legal representatives shall constitute a quorum for any special or regular meeting of this organization.

#### **ARTICLE NO. 11 — Trustees**

This State Association shall have a Board of Trustees, consisting of five members, each of whom shall be nominated from the floor, elected by a standing vote. Two-thirds of all voting members shall be final. This board shall receive property only at the order of the State Association. It shall be a permanent Board unless body sees fit to discontinue.

#### **ARTICLE NO. 12 — Duties of Officers**

It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and the By-Laws are obeyed and respected, and to exercise all the rights of any other member except the right to vote. The right to vote shall only be given the Moderator in case of a tie. He shall be allowed to speak on any subject provided the Assistant is in the chair. He shall not speak at any other time except in way of explanation. It shall be the duty of the Assistant Moderator to assist the Moderaor in any way that he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed by same rule as affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings, to publish same in book form, minuted and distributed to the various Quarterly Meetings or Yearly Meetings composing this

State Association. All expenses of such records and printing to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession.

#### **I. PROMOTIONAL DIRECTOR**

It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into the membership of the West Virginia Association. Also to promote the work of Free Will Baptists in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Department.

#### **II. THE EXECUTIVE BOARD**

It shall be the duty of the Executive Board to prepare the Program of the State Association. The Program shall be prepared by the Executive Board at a time designated by the Clerk and Moderator. The Executive Board shall act as an arbitration committee when called.

This committee shall be composed of not less than five (5) members of the Executive Board and they shall not be from the same conference, when the clerk and moderator requests.

#### **III. FOREIGN MISSION BOARD**

It shall be the duty of this board to cooperate with the Foreign Mission Board of the National Association of Free Will Baptist and to endeavor to raise funds for the Foreign Mission work of our denomination. This board shall organize within itself with a Chairman and a Secretary-Treasurer. All money for Foreign Missions shall be sent to the Chairman of the Foreign Missions Board. This board shall arrange for missionary conferences throughout the State work as it feels necessary.

#### **IV. HOME MISSION BOARD**

This board shall organize within itself and elect a chairman and a secretary-treasurer. It shall be the duty of the Home Mission Board to promote the establishing of new churches and conferences through the State of West Virginia where we do not have established Free Will Baptist work. Sixty per cent of all money raised by the Home Mission Board shall be used in the promotional work of our own state and forty per cent shall be channeled to the National Home Mission Board.

#### **V. ORPHANAGE BOARD**

This Board shall maintain a relationship with the Free Will Baptist Home of Children at Greenville, Tennessee, and help provide for its support. One member of this board shall be a trustee of the Board of Trustees of the Free Will Baptist Home for Children at Greenville, Tennessee. Expenses of this trustee shall be provided for each official visit to the Home, not to exceed Twenty dollars (\$20.00). This board shall raise money for and relate its work with a Treasurer, Soliciting Member and Director and a Trustee.

#### **VI. BOARD OF CHRISTIAN EDUCATION**

This board shall organize within itself with a Chairman, Secretary and soliciting member. The duties of this board shall consist of: The

enlightment of the Free Will Baptist of West Virginia to the cause of the denomination and to publish tracts and help in the financial support of the students at Free Will Bible College; also help in the support of the Bible College itself. This board shall endeavor to meet the quota set for the Bible College for our state.

All funds raised for this work shall be divided — 40 per cent to the Bible College and 40 per cent to the students that attend the Bible College at Nashville, Tennessee and 20 per cent for operating expenses.

This board shall provide funds only as they are available to the support of students. Any student willing to receive support from this board must be a Free Will Baptist and be in good standing in some church within the bounds of the State Association. They must also be recommended by their Church and Pastor.

#### **VII. AUXILIARY BOARD**

It shall be the duty of this board to promote the work of the Woman's Auxiliary in our state. This board may be composed of three women interested in this work.

#### **VII. CHRISTIAN TRAINING SERVICE**

This board shall organize within itself with Chairman and Secretary-Treasurer. This board shall promote the Free Will Baptist C. T. S. in our state and endeavor to get District and State C. T. S. into their proper place in our churches and conferences.

#### **IX. SUNDAY SCHOOL BOARD**

This board shall organize within itself and have a chairman and Secretary-Treasurer. This board shall endeavor to co-ordinate the Sunday School work in West Virginia and try to bring our Sunday Schools up to National Standard for Sunday Schools. The board shall endeavor to establish a Workers' Conference in our Sunday Schools and to work for the improvement of Sunday School literature and to help in establishing Teachers' Training Courses in our schools. These schools shall be taught by those who have Evangelical Teachers' Training Association Certificates or are otherwise qualified. This board shall seek to establish a Sunday School Board in each Conference and shall be responsible for the over-all planning of Sunday School work in the State Association.

#### **ARTICLE 13 — Licensing And Ordaining**

Section 1—No man, having been divorced and remarried or having married a divorced woman, shall be licensed or ordained to preach or for deacons.

Section 2—No woman shall be ordained or licensed to preach or usurp authority over men.

#### **ARTICLE 14 — Amendments**

This Constitution may be amended at any regular session of the State Association by a two-thirds vote of all members present provided the changes are recommended in writing at least one day before the vote is taken.

#### **BY-LAWS**

1—A portion of the Scripture shall be read and prayer shall be offered at the beginning of each morning and afternoon sessions of the State Association and prayer shall be offered at the close of each session.

2—The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the Program Committee. When neither Moderator or Assistant is present the Executive Board shall elect a Moderator pro tem who shall call the meeting to order.

3—It shall be the duty of the Clerk to enroll the names of delegates, ministers and deacons at the beginning of each session and assess them one dollar (\$1.00) each; who shall present themselves with proper evidence of their rights to seat therein and those enrolled by the Clerk shall compose the State Association.

4—It shall be the duty of the Quarterly Meeting or Yearly Meeting or Associations so composing this Organization to send a letter to it giving as accurately as possible the information requested by the National Association.

5—Not over one deacon shall be appointed on any one committee.

6—Only ordained ministers shall be allowed to moderate this meeting.

7—All Sunday Schools and Young Peoples' C. T. S. and Woman's Auxiliaries shall work in their bodies and report to State Association.

8—In case of any controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.

9—All business except routine shall be brought before this body by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be presented by any member of the body, but cannot be discussed unless by vote of this body.

10—No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

11—That each conference having their letter and finance sent to the State Association Clerk one week before the State Association convenes.

12—Any member of this body can appeal from the decision of the Moderator to the body and by a two-thirds majority vote of all members present, thereon. This decision shall be sustained or rejected.

13—No one shall leave the body without the consent of the Moderator.

14—Anyone desiring to speak shall arise and say Brother Moderator, but shall not speak further until he or she is recognized by the Moderator.

15—The Moderator shall stop all discussion when not carried on in a Christian Spirit, or when he thinks it will lead to discord or division.

16—This State Association shall correspond by messenger or otherwise to other religious bodies.

17—The same person or group of persons shall not serve on more than one standing board or committee as long as it can be supplied otherwise.

18—Not less than three Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

19—No person shall be elected to any office without being present.

20—These By-Laws may be revised or changed at any regular session of the State Association provided that they be plainly written and stated one day before the vote is taken.

21—The Moderator shall be elected at the close of each session on

Saturday, who shall serve until his successor be elected at the same time the following year.

Minutes of the 24th Session of the West Virginia State Association of Free Will Baptist, write in session with the Wintred Free Will Baptist Church at Winfred, W. Va., June 6 & 7th, 1969.

9:00 A. M. — Devotional by Rev. Arlue Persinger.

Song and Scripture Lesson. Philippians 3rd chapter, verse 10. Thoughts on the lesson, Know Him Personal, In Life, In Fellowship. Song and altar of prayer lead by Rev. John Snodgrass.

Address of welcome by the host Pastor Rev. Samms.

Response by Rev. Snodgrass.

The Moderator Rev. F. A. Giles called the association to order.

The Program was approved and the Moderator was allowed to make any change needed.

Recognizing Rev. and Mrs. Robert Bryan Missionary to South America. Rev. Bryan gave a talk on the work there.

Credential Committee was asked to give their report. The Clerk Rev. T. C. Morgan reporting that 18 conferences were reporting by letter and delegates. Report by Rev. Vallance on Item No. 9 of last session regarding the possibility of getting the National Association in W. Va., he said there was a possibility of getting it in 1972. A motion was made by Rev. Vance and seconded by Rev. Samms to receive this information and extend an invitation to the National Association for them, and that Rev. Vallance and Rev. Halbrook and Rev. Samms be retained as the committee.

Had a report by Sister Alberts for the Obituary Committee, all stood in a moment of silent prayer for those deceased. Closed by Rev. John Henson.

Partial report was given by Sister Alberts of the work of the (Ladies) Auxiliary.

Brother Billy Smith gave report on the Home Mission work of the state. He made a request that all persons sending money to Home Mission should send it to the State Board. So that they could get their share of 60 per cent of this fund. So they could have money in their treasure for to work with. Reported was received last year \$236.63 and that they paid out \$117.00, leaving a balance in their treasure of \$4423.64, if we continue to send our money direct to the National Board there would be no need for a State Board as we would not have any money in our own state treasurer, because when it goes direct to the National they do not return to us the 60 per cent we should have from our state giving, and so we will never be able to help our own state Home Mission wise. So please give this item your close attention.

Promotional Director Rev. Wm. Samms gave his report as follows: traveled 10,684 miles, held some revivals, organized some churches, organized one Quartley Meeting and helped organize one Q. M. Total money received \$743.00 paid out \$605.00 for expenses. Rev. Samms was reelected to this office.

9:00 A. M. Devotional Leader by the Pastor Rev. Samms, prayer by Rev. McGraw. Song and Scripture Lesson 1 John 3rd Chapter 1-3 verses.

9:05 A. M. the Moderator Rev. Giles called the meeting to order for business. Rev. Norwood Webb gave report for the Foreign Mission Board, requested that each church should give 5 or 10 per cent of their offering each month to this cause. Our quota for last year was \$16,250.00 and we only paid \$9,970.06 of this amount and so far this year have received \$3,183.74, report was received by M&S.

Rev. Harrison of the National Sunday School Board gave report on the work being done throughout the states and by the National Board, said that our new Sunday School Literature was a great success and requested that all of our Sunday Schools that was not using this literature should do so.

Rev. Robert Shockey gave report on the work of the National Home Mission Board and requested that all of our Free Will Baptist should give greater in the coming year as the work was growing and the need was greater.

Rev. Robert Kessinger gave the report for the State Sunday School Board.

Elected the following delegates to the National Association: James Vallance, Earl Green, John George, Raymond Halbrook.

The Business Committee submitted seven items of business for consideration and these were dealt with and are recorded with the rest of business.

11:00 A. M. Devotional service leader Joe Braggs. Song and prayer, Scripture Lesson Psalms 47 chapter, song, While Lifting Offering For The Children Home. Amount received \$62.48.

Rev. Parimore from the Bible College at Nashville, Tenn., was the morning messenger, reading from Matt. 28: 19-20 verses and 2 Timothy 2nd chapter for his lesson using the following points for his message. Go Preach — Baptize — Teach, and a very inspiring message that should of stirred all present to have a greater zeal for the work of the Lord. Prayer of Benediction and grace for the food.

1:00 P. M. Devotional leader Rev. Ellis the director of the Children's Home at Greenville, Tenn., after Scripture and prayer, he gave the following report on the work at the home, said they had built a new Administration building this past year, cost of building \$45,000.00 and that they were doing quite a bit of farming, reported that W. Va. had gave \$7,000.00 last year for the work, of which he was very thankful for, also said that they were getting some black Angus cattle for the farm. Report was received by M&S.

Rev. Kenneth Skeens from Virginia gave a report.

The election of members to fill the boards of the association were elected through Friday and Saturday in there proper order and will be listed under Officers, Boards and Committees. Business Committee gave their final report, and it was dealt with in order and will be listed with other business items.

A motion was made at 3:00 P. M. for adjournment and was complied with, Rev. Caudel Adkins praying the closing prayer.

#### POST SCRIPT TO MINUTES

The Rev. Carl Vallance was asked by the association to give the hand of Fellowship to the Christian Fellowship Conference, into the State Association.

Placement Committee, Mrs. Ruby Albert, John George, Bob Cook, made the announcement that no one had asked for the next session of the association, Rev. Carl Vallance of the Brotherhood, asked that it come to Thomas Memorial Church at Huntington, and Mingo No. 1 asked for it, Wyoming asked for it. W. Va. conference asked for it, the Placement Committee met again and accepted the invitation of Rev. Carl Vallance, to have it at Huntington, W. Va. at the Thomas Memorial Church, 525 Buffington Street, Huntington, West Virginia.

#### BUSINESS COMMITTEE REPORT

ITEM NO. 1 We the business committee recommend that the executive board get together with this conference in question, namely the W. Va. F. W. Baptist conference and work out their situation, received by M&S, and complied with.

ITEM NO. 2 We move that we accept the Christian Fellowship Conference into the fellowship of the W. Va. State Association and seat their delegates and Ordained Ministers and Deacons, and return their Credentials, received by M&S and complied with.

ITEM NO. 3 We recommend that we seat the Elk River and the Greenbrier Conference, received by M&S and complied with.

ITEM NO. 4 We the business committee recommend that we elect from the floor two more members on the publishing board of the Free Will Baptist Paper, making it a 5 member board, including the Editor, received by M&S and complied with.

ITEM NO. 5 We the business committee recommend that a special committee be selected to rewrite the Constitution and By-Laws of the Association, to bring them up to meet the needs of the present day, received by M&S. and complied with.

ITEM NO. 6 We the business committee recommend that the state association give \$125.00 to our general board member for transportation to the National Association, received by M&S, and complied with.

ITEM NO. 7 We recommend that the state association have 1,000 minutes printed, received by M&S.
