#### Constitution Of State Association

#### Article No. 1

This Association shall be known as the West Virginia State Association of Free Will Baptists.

The object of this organization shall be to more thoroughly unify the work of the Free Will Baptists of the State of West Virginia and to advise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in connection with the various Quarterly or Yearly Meetings comprising this state association.

The membership of this State Association shall consist of the quarterly meetings and district association or yearly meetings from time to time upon approval shall become members of this body.

#### Article No. 2 - Discipline

Section 1. The State Association shall have the right to settle any questions of discipline, doctrine or usage that may properly come before it from time to time, from any quarterly meetings or yearly meetings composing the said State Association, or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association making the appeal then forwarded by mail or in person to State Association and Quarterly meeting.

Section 2. No quarterly meeting shall license or ordain to preach or to serve as deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained for deacon in this State Association.

Section 3. No Quarterly Meeting shall license or ordain a woman to preach.

Section 4. No Quarterly Meetings shall be accepted or retained as a member that licenses or ordains deacons or ministers with two living wives or that licenses or ordains women to preach.

Section 5. The Executive Board shall investigate any charges made. The person or organization making charges shall pay expenses of executive board members.

#### Article No. 3

The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Promotional Secretary and Parliamentarian. Each of whom shall be nominated from the floor and elected by a standing vote from the floor, at each regular session, except the Treasurer, who shall be elected for a three year period, beginning with the 23rd session, providing however that the Moderator shall not be elected two years in succession from the same Quarterly Meeting or Yearly Meeting, except in case of necessity.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors

are elected and installed.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and the By-Laws are obeyed and respected, and to exercise all the rights of any member except the right to vote. The right to vote shall be given the Modrator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. He shall not speak at any other time except in way of explanation. It shall be the duty of the Assistant Moderator to assist the Moderator in any way that he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed by the same rule as that affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings, to publish in book form, minuted and distributed to the various Quarterly Meeting or Yearly Meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and risburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

I. Promotional Director — It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into the membership of the West Virginia State Association. Also to promote the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Department.

II. The Executive Board — It shall be the duty of the Executive Board to prepare the program of the State Association. The Executive Board shall act as an arbitration committee when called as such. That a committee be elected on Saturday morning, two ministers, one deacon and four delegates, to make out program, and placement committee. To report to the Association by 2:00 p.m.

III. Foreign Mission Board — It shall be the duty of this board to cooperate with the Foreign Mission Board of the National Association of Free Will Baptist and to endeavor to raise funds for the Foreign Mission work of our denomination. This board shall arrange for missionary conferences throughout the state work as it feels necessary.

IV. Home Mission Board — It shall be the duty of the Home Mission Board to promote the establishing of new churches and conferences through the State of West Virginia where we do not have established Free Will Baptists work. Sixty per cent of all money raised by the Home Mission Board shall be used in the promotional

work of our state and forty per cent shall be channeled to the National Home Mission Board.

V. Orphanage Board — This board shall maintain a relationship with the Free Will Baptist Home of children at Greenville, Tennessee, and help provide for its support. The member of this board shall be a trustee of the Board of Trustees of the Free Will Baptist Home for children at Greenville, Tennessee. Expenses of this trustee shall be provided for each official visit to the Home, not to exceed Twenty Dollars (\$20.00). This board shall raise money for and relate its work with a Treasurer, Soliciting Member and Director, and a Trustee.

VI. Christian Training Service — This board shall promote the Free Will Baptist C.T.S. in our State and endeavor to get District and State C.T.S. into their proper place in our churches and conferences.

The enlightment of the Free Will Baptists of West Virginia to the cause of the denomination and the publishing of tracts to help in the financial support of the students at Free Will Bible College; and also to help in the support of the Bible College itself. This board shall endeavor to meet the quota set for the Bible College for our State.

All funds raised for this work shall be divided — 40 per cent to the Bible College and 40 per cent to the students that attend the Bible College at Nashville, Tennessee and 20 per cent for operating expenses.

This board shall provide funds only as they are available to the support of students. Any student willing to receive support from this board must be a Free Will Baptist and be in good standing in some church within the bounds of the State Association. They must also be recommended by their church and pastor.

VII. Sunday School Board — This board shall organize within itself and have a chairman and Secretary-Treasurer. This board shall endeavor to co-ordinate the Sunday School work in West Virginia and try to bring our Sunday Schools up to the National Standard for Sunday Schools. The board shall endeavor to establish a workers' conference in our Sunday Schools and to work for the improvement of Sunday School literature and to help in establishing Teachers' Training Courses in our schools.

These Schools shall be taught by those who have Evangelical Teachers' Training Association Certificates or are otherwise qualified. This board shall seek to establish a Sunday School Board in each Conference and shall be responsible for the over-all planning of Sunday School work in the State Association.

#### Article No. 4 - Executive Board

The Executive Board shall be composed of one (1) representative from each Quarterly Conference that is in good standing with the State Association. This board shall organize within themselves as to Chairman and Secretary. 60 per cent must be present to constitute a quorum.

#### Article No. 5 - Boards and Committees

The standing boards shall be the following: Foreign Mission, Home Mission, Orphanage Board, C.T.S. Board, Sunday School Board,

(NOTE: The Christian Education Board duties are combined with C.T.S. Board. Also the Women's Auxiliary Board is to be eliminated because there is no further need for it at this time. Should there be a need later it could be reorganized by vote or state association).

#### Article No. 6

Annual dues shall be Fifteen Dollars (\$15.00) per each Quarterly Meeting that is presented to the State Association, plus Three Dollars (\$3.00) for each church belonging to the Quarterly Meeting or Yearly Meeting composing this body.

Section 2. All ministers, deacons and delegates shall pay Two Dollars (\$2.00) registration fee. One dollar to go to the State Treasury and one dollar to go to the church and have a roll call of names of delegates.

Section 3. All ordained ministers, deacons and delegates shall have a voice and vote that are represented by their Quarterly Meeting or Yearly Meeting to this body.

Section 4. Each Quarterly Meeting shall have one delegate for each church belonging to it.

#### Article No. 7

The State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment. Special meetings may be called by the Executive Board when extreme necessity demands, provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting. Twenty-five legal representatives shall constitute a quorum for any special or regular meeting of this organization.

Section 2. Any Quarterly Meeting or Church desiring the State Association meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

#### Article No. 8 - Trustees

This State Association shall have a Board of Trustees consisting of five members, each of whom shall be nominated from the floor and elected by a standing vote. Two-thirds of all voting members shall be final. This board shall receive property only at the order of the State Association. It shall be a permanent board unless body sees fit to discontinue.

#### Article No. 9

This Constitution may be amended at any regular session of the State Association by a two-thirds vote of all members present provided the changes are recommended in writing at least one day before the vote was taken.

# By-Laws

- 1. A portion of the Scripture shall be read and prayer shall be offered at the beginning of each morning and afternoon sessions of the State Association and prayer shall be offered at the close of each session.
- 2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the Program Committee. When neither Moderator nor Assistant is present the Executive Board shall elect a Moderator pro-tem who shall call the meeting to order.
- 3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this Organization to send a letter to it giving as accurately as possible the information requested by the National Association.
  - 4. Not over one deacon shall be appointed on any one committee.
- 5. Only ordained ministers shall be allowed to moderate this meeting.
- 6. All Sunday Schools and Young Peoples' C.T.S. and Women's Auxiliaries shall work in their bodies and report to the State Association.
- 7. In case of any controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.
- 8. All business except routine shall be brought before this body by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be presented by any member of this body, but cannot be discussed unless by vote of this body.
- 9. No one shall speak for more than five minutes or more than twice on the same subset without the consent of the Moderator.
- 10. Each conference shall have its letter and finance report sent to the State Association Clerk one week before the State Association convenes.
- 11. Any member of this body can appeal from the decision of the Moderator to the body and by a two-thirds majority vote of all members present, thereon. This decision shall be substained or rejected.
- 12. No one shall leave the body without the consent of the Moderator. Anyone desiring to speak shall arise and say "Brother Modera-

tor," but shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or when he thinks it will lead to discord or division.

- 13. This State Association shall correspond by messenger or otherwise with other religious bodies.
- 14. The same person or group of persons shall not serve on more than one standing board or committee as long as it can be supplied otherwise.
- 15. Not less than three Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptist.
  - 16. No person shall be elected to any office without being present.
- 17. The Moderator shall be elected at the close of each session on Saturday, and shall serve until his successor is elected at the same time the following year.
- 18. These By-Laws may be revised or changed at any regular sesion of the State Association provided that they be plainly written and stated one day before the vote is taken.

Minutes of the 25th Session of the West Virginia State Association of Free Will Baptists while in session with the Thomas Memorial Free Will Baptist Church at Huntington, West Virginia, June 12 and 13, 1970.

9:00 a.m. - Devotional by Rev. Walter Raines.

Song - Amazing Grace.

Prayer - Rev. T. C. Morgan.

Scripture - 40th Psalms.

Address of welcome by Rev. Caudel Adkins.

Response by Rev. F. A. Giles.

The Program was approved and the Moderator was allowed to make any changes needed.

Report of Credentials Committee given by Rev. Jerry McGraw. M&S. Carried.

Election of Clerk for the coming year. Rev. Norwood Webb was elected.

Rev. John Henson was elected Assistant Moderator.

Business Committee elected, Rev. F. A. Giles, Rev. T. C. Morgan, Rev. Daniel Kelly, Rev. Walter Raines, and Rev. Billy Pistore. Elected by acclamation.

Treasurers Report was given by Rev. T. C. Morgan. We had \$227.20 in the bank, minus \$85.00 Clerk's fee for last year. Leaves balance of \$142.20.

Rev. Albert Halbrook resigned as Treasurer. Rev. Jerry McGraw was elected to fulfill Rev. Holbrook's term of office.

Special Committee Report by Rev. Jerry McGraw. That the Constitution and By-Laws be rewritten. The changes were read and tabled until tomorrow's session.

C.T.S. Report given by Deacon John George.

Recognizing of visitors. Brother Andrew Workman gave report of Ohio Conference.

Report of Boards. Deacon Robert Kessinger gave report on Sunday School Board. Also gave report on Dollars for Scholars. There were six members present who had attended the Bible College.

Sister Myrtle Samms gave the report on the Women's Auxiliaries of the State. Forty seven were present at their State Auxiliary Meeting. Rev. Jim Combs, one of our missionaries from Brazil, was there with his family. Brother Jim spoke at the Meetings. Sister Samms stirred the Auxiliary to reach a goal of \$1,000 by the next association.

Motion, and second, was made to suspend the election of officers on the Boards until tomorrow when the reading of the Constitution and By-Laws are read and voted on. Carried.

No report of Executive Board.

Brother N. R. Smith from the National Association gave a report on Sunday Schools. He spoke on new ways to teach.

Rev. Jim Combs talked about his Ministry in Brazil. He said about 95 per cent in Brazil are Roman Catholics, and some of these are being converted into Christians. Jim sang "When The Saviour Reached Down For Me."

Rev. Redford Wilson spoke on Foreign Missions. He stressed the need for us to support missions. He also spoke of the need for Missionaries in Panama.

Adjourned for the morning worship service.

Rev. Kermit Cunningham gave Obituary report. This report is submitted on separate page. M&S. Carried. Association stood for a moment of silent prayer; closed by Rev. Billy Samms.

Rev. Billy Samms gave Promotional Directors report. Rev. Samms has held nine Revivals and attended all Quarterly Meetings except one.

One trip to Nashville as Promotional Director, and has met three times with the Special Committee. He traveled approximately 12,000 miles. He has promoted all phases of work, Home Missions, Foreign Missions, Childrens Home and Sunday School. Received for Pro-

motional Director Work \$300.00 and paid out \$250.00. M&S. Carried.

Rev. Robert L. Shockey gave report of Home Mission Board. The following is a report of our gifts to National Home Missions.

1969 West Virginia Quota \$1,500 — gave \$1,941.05 — over \$441.05. 1970 West Virginia Quota \$2,500 — given through May \$604.31 — lack \$1,895.69.

Rev. Giles gave the report of the Business Committee.

#### Business Committee Report

Item No. 1. We the business committee recommend that the State Association elect an Assistant Treasurer. He shall act only in the absence or incapitation of the Treasurer. M&S, and complied with.

Item No. 2. We the business committee recommend that a program committee be elected on Saturday morning to prepare the program for the coming year. This committee shall act as a placement committee, and shall comply with the Constitution in making their choice for the church, where the State Association is to be held. This Committee shall consist of two ordained ministers, one deacon and four members of the duly seated delegates. This committee shall be prepared to report to the State Association by 1:45 P.M. on Saturday afternoon. M&S. Carried.

Item No. 3. We the Business Committee recommend that we give the Promotional Director \$100.00 for his service. M&S. Carried.

Item No. 4. We the Business Committee recommend that we report to the National Association of Free Will Baptist by letter, delegates and proper finance. M&S. Carried.

Item No. 5. We the Business Committee recommend that the program for the 1971 session have the complete date inserted in the heading. M&S. Carried.

Item No. 6. We the Business Committee recommend that the Clerk of the State Association send each department of the National Association an up to date mailing list of our Churches, clerks and ministers each year. M&S. Carried.

Item No. 7. We the Business Committee recommend that the West Virginia State Association accept the new revised Treatise of the National Association. As recommended by the National Association of Free Will Baptist, and adopted in St. Louis, Missouri, 1969. M&S. Carried.

Item No. 8. We the Business Committee recommend to pay the outgoing Treasurer \$22.50 for nine months. 3/4 Fee to Rev. Albert Halbrook. M&S. Complied with.

Item No. 9. We the Business Committee recommend to give General Board Members \$150.00 for expenses to National Association. M&S. Carried.

Item No. 10. We the Business Committee recommend all Quarterly Meetings to request all ministers and deacons to make a contribution of one dollar at their next Quarterly Meeting, and send same

to Treasurer of State Association as soon as possible. M&S. Carried. M&S to elect Rev. John Henson as General Board Member. Carried. M&S to elect Rev. T. C. Morgan as Assistant Treasurer. Carried. M&S to adjourn this session of business until tomorrow at 9:00 a.m. Carried.

Saturday, June 13th - Conference called to order.

Devotional by Rev. Billy Smith.

Scripture — 66 Chapter of Isiah. A few Testimonies were given. The Moderator, Rev. Henry Damron took charge of the service.

Rev. Norwood Webb gave the Foreign Mission report for the State of West Virginia. We have given through May, 1970, \$4,355.21 of our \$16,250.00 quota, leaving a balance of \$11,894.79 yet to raise. We of the Foreign Mission Board pray that all pastors will see the need to support the Foreign Mission Program of our State. Huff Creek gave \$25.00; Fayette gave \$25.00; Tug River gave \$10.00 and Kanawha gave \$100.00. The Kanawha youth gave a donation of \$50.00. All of these donations were applied to the Jim Combs account. M&S. Carried.

Rev. Wade Webb gave the report of the Children's Home. He said that some of the children there became Christians. M&S. Carried.

M&S were made to remove the item of business concerning the Constitution and By-Laws from the table. Carried.

M&S to act upon these item by item. Carried.

M&S amendment to add to section number two of Article number two of the Constitution. That no Quarterly meeting shall license or ordain to preach or for a deacon, any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained for deacon in this State Association. Carried.

Recognizing of visitors. Rev. Redford Wilson and Brother N. R. Smith from the National Association were present. We also had visitors from the Lawrence County Conference and from the Franklin County Conference.

The Rohr Family singers from Carter County, Kentucky, sang for us.

Brother Tunage from the National, representing the Laymens or Master's Men, read scripture from Ezekial, chapter 22:30 and 13:5, and gave a wonderful talk on his program.

Devotional by Rev. Billy Samms. Scripture, Phil. 2:5.

Song — Sister Ruth Hess from the Winifrede Free Will Baptist Church at Winifrede, sang I've Been To Calvary.

Rev. Daniel Kelly sang He Touched Me.

Congregation sang Showers Of Blessings.

Prayer led by Rev. Wade Webb.

M&S to elect three men on the Business Committee to replace

three that were not there. Rev. Don Ellis, Rev. Brooks Spurlock, and Rev. B. W. Belvin were elected. Carried. Complied with.

Songs by the Rohr Family Singers.

Rev. Robert L. Shockey brought message from 11 Timothy 1:3, 2:2, 2:15 and 4th chapter 4:2, 3. His message was on exortation.

Invitation was given to ministers, deacons, sunday school teachers, laymen and all. There was a great response of people rededicating their lives.

M&S to adjourn for lunch. Complied with. Rev. Carl Cooper dismissed us and asked blessing on food by prayer.

1:30 p.m. Conference called back to order by Rev. Jerry McGraw. Song — Power In The Blood. Brother Tunage led the singing. Prayer by Rev. Billy Samms.

Moderator took charge. Power was given the Moderator to pick Placement Committee. The Placement Committee is Rev. Jerry McGraw, Rev. Lowell Webb, Robert Kessinger, Brother Parsons, Taylor Adams, Nel H. May and Sister Hughes.

M&S to accept Article number 4 with changes and amendments. Carried.

M&S to accept Article number 5. Carried. And that instead of being a one man Board, we stay with the three man board. M&S, Carried, Complied with.

M&S to accept Article No. 6. Carried.

M&S to accept Article No. 7 with amendment to insert date. Carried, and complied with.

M&S to accept Article No. 8. Carried.

M&S to accept Article No. 9. Carried.

M&S that 13-14-15 of the By-Laws be combined together and become B-Law No. 12. Carried, and complied with.

M&S that the last two By-Laws be reversed, so that the one concerning the revisions or changes shall be read last. Carried, and complied with.

M&S that the Executive Board be composed of one ordained minister from each Conference. Carried. Names to be listed with other board members.

Rev. John Henson resigned as General Board Member. M&S was made to accept Rev. Henson's resignation. Carried.

M&S to elect Rev. Billy Samms as General Board Member and vote by acclamation. Carried.

Rev. Norwood Webb resigned as Foreign Mission Member to accept the Clerk position. M&S. Carried, and complied with.

Nominations were made for the board members. All boards were filled.

Rev. John Henson was elected as Promotional Director for the coming year.

Moderator and Assistant Moderator were elected for the coming

year. Moderator — Rev. Caudel Adkins. Assistant Moderator — Rev. T. C. Morgan.

Rev. Billy Samms was elected as Parliamentarian for the coming year.

M&S that we give the Thomas Memorial Church a rising vote of thanks for the way they prepared for the State Association. Complied with.

M&S that we give our Clerk and Promotional Director a vote of thanks for their work this past year. Carried.

M&S that the Orphanage Board notify the Clerk who their Executive Board Member will be that he may notify the National Association. Carried.

Elected as delegates to the National Association were John George and Sandra Kessinegr.

M&S to adjourn until next session. Carried and complied with.
