# **Constitution of the State Association**

## **Article No. 1**

This Association shall be known as the West Virginia State Association of Free Will Baptists.

The object of this organization shall be to more thoroughly unify the work of the Free Will Baptists of the State of West Virginia and to advise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in connection with the various Quarterly or Yearly Meetings comprising this state association.

The membership of the State Association shall consist of the quarterly meetings and district association or yearly meetings from time to time upon approval shall become members of this body.

Section 2. Any minister voting in State Association must be a member of a Church in Quarterly Meeting representing him to the State Association.

## **Article No. 2 — Discipline**

Section 1. The State Association shall have the right to settle any questions of discipline, doctrine or usage that may properly come before it from time to time, from any quarterly meetings or yearly meetings composing the said State Association, or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association making the appeal then forwarded by mail or in person to State Association and Quarterly Meeting.

Section 2. No quarterly meeting shall license or ordain to preach or to serve as deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained for deacon in this State Association.

Section 3. No Quarterly Meeting shall license or ordain a woman to preach.

Section 4. No Quarterly Meeting shall be accepted or retained as a member that licenses or ordains deacons or ministers with two living wives or that licenses or ordains women to preach.

Section 5. The Executive Board shall investigate any charges made. The person or organization making charges shall pay expenses of executive board members.

## **Article No. 3**

The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Promotional Secretary and Parliamentarian. Each of whom shall be nominated from the floor, and elected by a standing vote from the floor, at each regular session, except the Treasurer, who shall be elected for a three-year period, beginning with the 23rd session, providing however that the Moderator shall not be elected two years in succession from the same Quarterly Meeting or Yearly Meeting, except in case of necessity.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and the By-Laws are obeyed and respected, and to exercise all the rights of any member except the right to vote.

The right to vote shall be given the Moderator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. It shall be the duty of the Assistant Moderator to assist the Moderator in any way that he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed by the same rule as that affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings, to publish in book form, minuted and distributed to various Quarterly Meeting or Yearly Meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

I. Promotional Director — It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into membership of the West Virginia State Association. Also to promote the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Department.

II. The Executive Board — The Executive Board shall act as an arbitration committee when called as such.

III. That a program committee be elected on Saturday morning to prepare the program for the coming year. This committee shall act as a placement committee and shall comply with the Constitution in making their choice for the church, where the State Association is to be held. This committee shall consist of two ordained ministers, one deacon, and four members of duly seated delegates. This committee shall be prepared to report to the State Association by 1:45 P.M. on Saturday afternoon.

IV. Foreign Mission Board — It shall be the duty of this board to cooperate with the Foreign Mission Board of the National Association of Free Will Baptist and to endeavor to raise funds for the Foreign Mission work of our denomination. This board shall arrange for missionary conferences throughout the state work as it feels necessary.

V. Home Mission Board — It shall be the duty of the Home Mission Board to promote the establishing of new churches and conferences



through the State of West Virginia where we do not have established Free Will Baptists work. Sixty percent of all money raised by the Home Mission Board shall be used in the promotional work of our state and forty percent shall be channeled to the National Home Mission Board.

VI. Children's Home Board — This board shall maintain a relationship with the Free Will Baptist Home of Children at Greenville, Tennessee, and help provide for its support. The member of this board shall be a trustee of the Board of Trustees of the Free Will Baptist Home for Children at Greenville, Tennessee. Expenses of this trustee shall be provided for each official visit to the Home, not to exceed Twenty Dollars (\$20.00). This board shall raise money for and relate its work with a Treasurer, Soliciting Members and Director, and a Trustee.

VII. Christian Training Service — This board shall promote the Free Will Baptist C.T.S. in our State and endeavor to get District and State C.T.S. into their proper place in our churches and conferences.

The enlightenment of the Free Will Baptists of West Virginia to the causes of the denomination and the publishing of tracts to help in the financial support of the students at Free Will Baptist Bible College; and also to help in the support of the Bible College itself. This board shall endeavor to meet the quota set for the Bible College for our State.

All funds raised for this work shall be divided 40 percent to the Bible College at Nashville, Tennessee and 20 percent for operating expenses.

This board shall provide funds only as they are available to support of students. Any student willing to receive support from this board must be a Free Will Baptist and be in good standing in some church within the bounds of the State Association. They must also be recommended by their church and pastor.

VIII. Sunday School Board — This board shall organize within itself and have a chairman and Secretary-Treasurer. This board shall endeavor to co-ordinate the Sunday School work in West Virginia and try to bring our Sunday School up to the National Standard for Sunday Schools. This board shall endeavor to establish a worker conference in our Sunday Schools, and to work for the improvement of Sunday School literature and to help in establishing Teachers' Training Courses in our schools.

These Schools shall be taught by those who have Evangelical Teachers' Training Association Certificate or are otherwise qualified. This board shall seek to establish a Sunday School Board in each Conference and shall be responsible for the over-all planning of Sunday School work in the State Association.

#### **Article No. 4 — Executive Board**

The Executive Board shall be composed of one (1) representative from each Quarterly Conference that is in good standing with the State Association. This board shall organize within themselves as to chairman and Secretary. 60 percent must be present to constitute a quorum.

#### **Article No. 5 — Boards and Committees**

The standing boards shall be the following: Foreign Mission, Home



Mission, Children's Home Board, C.T.S. Board, Sunday School Board.

(NOTE: The Christian Education Board duties are combined with C.T.S. Board. Also the Women's Auxiliary Board is to be eliminated because there is no further need for it at this time. Should there be a need later it could be reorganized by vote or State Association.)

#### **Article No. 6**

Annual dues shall be Twenty Dollars (\$20.00) per each Quarterly Meeting that is presented to the State Association, plus Five Dollars (\$5.00) for each church belonging to the Quarterly Meeting composing this body.

Section 2. All ministers, deacons, and delegates shall pay Two Dollars (\$2.00) registration fee. One dollar to go to the State Association Treasury and one dollar to go to the church and have a roll call of names of delegates.

Section 3. All ordained ministers, deacons and delegates shall have a voice that are represented by their Quarterly Meeting or Yearly Meeting to this body.

Section 4. Each Quarterly Meeting shall have one delegate for each church belonging to it.

#### **Article No. 7**

The State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment. Special meetings may be called by the Executive Board when extreme necessity demands, provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting. Twenty-five legal representatives shall constitute a quorum for a special or regular meeting of this organization.

Section 2. Any Quarterly Meeting or Church desiring the State Association meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

#### **Article No. 8**

This State Association shall have a Board of Trustees consisting of five members, each of whom shall be nominated from the floor and elected by a standing vote. Two thirds of all voting members shall be final. This board shall receive property only at the order of the State Association. It shall be a permanent board unless body sees fit to discontinue.

## BY-LAWS

1. A portion of the Scripture shall be read and prayer shall be offered at the beginning of each morning and afternoon sessions of the State Association and prayer shall be offered at the close of each session.

2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the Program Committee. When neither Moderator nor Assistant is present the Executive Board shall elect a Moderator pro-tem who shall call the meeting to order.

3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this Organization to send a letter to it giving accurately as possible the information requested by the National Association.

4. Not over one deacon shall be appointed on any one committee.

5. Only ordained ministers shall be allowed to moderate this meeting.

6. All Sunday Schools and Young People's C.T.S. and Women's Auxiliaries shall work in their bodies and report to the State Association.

7. In case of any controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.

8. All business except routine shall be brought by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be presented by any member of this body, but cannot be discussed unless by vote of this body.

9. No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

10. Each conference shall have its letter and finance report sent to the State Association Clerk one week before the State Association convenes.

11. Any member of this body can appeal from the decision of the Moderator to the body and by two-thirds majority of all members present, thereon. This decision shall be sustained or rejected.

12. No one shall leave the body without the consent of the Moderator. Anyone desiring to speak shall arise and say "Brother Moderator," shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or he thinks it will lead to discord or division.

13. This state Association shall correspond by messenger or otherwise with other religious bodies.



14. The same person or group of persons shall not serve on more than one standing board or committee as long as it can be supplied otherwise.

15. Not less than three Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

16. No person shall be elected to any office without being present.

17. The Moderator shall be elected at the close of each session on Saturday, and shall serve until his successor is elected at the same time the following year.

18. These By-Laws may be revised or changed at any regular session of the State Association provided that they be plainly written and stated one day before the vote is taken.

Rev. Tommy Street was elected as three-year man on the Foreign Missions Board.

State Paper Report by James Vallance and Carl Sullivan. There were 4,160,000 copies of the State Paper mailed out last year. M&S to receive Report. Carried.

Report of the Executive Board. The Executive Board met March 22, 1975, with Rev. Harrison Starr and the Executive Board of the Christian Fellowship Conference. Rev. Harrison Starr was charged by the Christian Fellowship Conference of violating doctrine by instructing or teaching deacons to Baptize. After discussing the charges brought against Rev. Starr, the recommendation of the Executive Board of the State Association, was that the clerk of the West Virginia State Association write a letter to the Christian Fellowship Conference, asking them to reconsider reinstating Rev. Harrison Starr and give him a letter of good standing. Amendment to the motion that the Christian Fellowship Executive Board and Rev. Harrison Starr meet today (March 22, 1975) and see if they can resolve their problem. They met, problem not resolved.

The Executive Board of the Christian Fellowship Conference recommended that we follow through with the motion to send letter to Christian Fellowship Conference concerning the recommendation of the Executive Board of the State Association.

LaVerne Vallance was elected as three-year member on Obituary Committee.

No report of business committee at this time.

Promotional Directors Report by Rev. John Henson. During the 1974-1975 term which I have served, I have preached 63 sermons, had 6 confessions, held 4 revivals, had 1 baptism, performed 3 weddings and officiated at 2 funerals. I have received \$1,403.61. My expenses were \$553.45. I have traveled 8,435 miles. In October I made a trip into Pocahontas County exploring the possibility of establishing a Church in the Hillsboro area. No success.

March 29, 1975 I attended Tri-County Conference at Beech Grove Church, Home Creek, Virginia. They elected a committee to attend W. Va. State Association with authority to put their conference in if everything is in order.

I went to Upshur County May 21-23 to prospect the possibilities of a church near Gain. No success. M&S to receive report and to give a rising vote of thanks to Bro. John for his work the past year.

Carl Sullivan sang a song while free will offering was taken for Bro. John.

Children's Home Report by Rev. James Earl Raper, Superintendent of Children's Home. From January 1972 until April, 1975 the State of West

Virginia has given a total of \$52,651.50 to the Children's Home. M&S. Carried.

### **Business Committee Report**

Item No. 1 — We recommend that the State Association give the State Paper, for the next twelve (12) months \$25.00 per month or a gift of \$300.00 now. Next year this Item will be reviewed again. M&S. Carried.

Item No. 2 — We recommend that the State Association give \$200.00 to our Promotional Director for his service this past year. M&S. Carried.

Item No. 3 — We recommend a board of five members should review the Constitution and By-Laws of the State Association, paying particular attention to the Duties and Qualifications of all officers and Board members. We recommend that members should be taken from different Conferences and that laity be included in this board if so nominated by the body. M&S. Carried. The five members elected to act upon item No. 3 are named as follows: Chairman, Rev. John Henson. Other four members are Rev. Billy Samms, Rev. T. C. Morgan, Rev. Arlie Joe Ball and Rev. H. B. Hall.

Item No. 4 — We recommend that a nominating committee of three men be elected to recruit qualified individuals that are also aware of all responsibility connected with said job and are willing to do said job if nominated and elected by majority of body. M&S to table this item of business. Carried.

Item No. 5 — We recommend that two assistants be elected to assist the State Promotional man, with the understanding no financial support would be given by State Association. This item of business failed.



Item No. 6 — We recommend that the State Association give \$150.00 to our General Board member for his expenses. M&S. Carried.

Item No. 7 — We recommend that the State Association hold up the publication of the State Minutes until the Conferences have met and made a review of their reports to the State Association, especially of their ministers. Moderator ruled item No. 7 out of order. Carried.

Item No. 8 — We recommend this item of business be referred to section VI, paragraph A, page 51 of F. W. B. Treatise. M&S that this item of business be tabled indefinitely. M&S. Carried.

Item No. 9 — We recommend that the Home Mission Board work with Brother Bob Shockey on a joint project Missionary. M&S. Carried.

Item No. 10 — We recommend that the State Association ask every Church in State Association if they would be willing to work with their Pastor and Conference in contributing \$1.50 per member per year, for the support of a promotional man in State of West Virginia. Money should be given to conference, which in turn is distributed to State. The money is to be used exclusively for Promotional work. M&S. Carried.

Item No. 11 — We recommend that the Promotional Director contribute as much time as possible in promoting item of business No. 10. M&S. Carried.

Item No. 12 — We recommend that each church be contacted by letter to make them aware of this recommendation. M&S. Carried.
