CONSTITUTION OF THE WEST VIRGINIA STATE ASSOCIATION  
OF FREE WILL BAPTISTS

Preamble

Having received salvation through faith in Jesus Christ, and having been baptized as an outward sign of our seperation from the world, and realizing the necessity of being identified with and sharing the fellowship of other believers, have joined ourselves to a local visible church, we do ordain this Constitution to unify the work of Free Will Baptists in the State of West Virginia, and to devise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in cooperation with the various quarterly or yearly meetings comprising this State Association. May God bless our labor.

Article No. 1

Section 1. All ordained ministers and deacons belonging to member quarterly meetings and district Associations shall make up the standing delegates to this State Association. Each quarterly meeting shall be permitted to send three lay delegates to the State Association plus one delegate from each Church composing that quarterly meeting.

Section 2. The membership of the State Association shall consist of the quarterly meetings and district Association or yearly meetings from time to time upon approval shall become members of this body.

Section 3. Any minister, deacon, or delegate voting in State Association, must be a member of a church in good standing with the quarterly meeting recommending them to the State Association.

Section 4. This State Association shall be affiliated with the National Association of Free Will Baptists of the United States of America, and recognize the Treatise of faith and practise as our guideline for denominal fellowship. As long as they remain an independant denomination.

Article No. 2 - Discipline

Section 1. The State Association shall have the right to settle any questions of discipline, doctrine or usage that may properly come before it from time to time, from any quarterly meetings or yearly meetings composing the said State Association or act upon any appeal that may be made by any of the bodies that belong to the State

Association. The said appeal shall have been written and signed by the Association making the appeal then forwarded by mail or in person to State Association and Quarterly Meeting.

Section 2. No quarterly meeting shall license or ordain to preach or to serve as deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained as deacon in this State Association.

Section 3. No quarterly meeting shall license or ordain a woman to preach.

Section 4. No quarterly meeting shall be accepted or retained as a member that license or ordains deacons or ministers with two living wives or that license or ordain women to preach.

Section 5. The Executive Board shall investigate any charges, after they have been properly presented to the quarterly meeting of which the grieved party or parties are a member. Any charges presented to this State Association Executive Board for consideration must be presented in writing and signed by the person or persons, making the charges.

Section 6. The Executive Board shall be paid the rate of fifteen cents (15¢) per mile from home to destination and return to home. When traveling on State Association official business.

### Article No. 3

The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Promotional Secretary and Parliamentarian. Each of whom shall be nominated from the floor, and elected by a standing vote from the floor, at each regular session, except the treasurer, who shall be elected for a three year period, beginning with the 23rd session, providing however that the Moderator shall not be elected two years in secession from the same Quarterly Meeting or Yearly Meeting, except in case of necessity.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and By-Laws are obeyed and respected, and to exercise all the right to vote.

The right to vote shall be given the Moderator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. It shall be the duty of the Assistant Moderator to assist the Moderator in any way that he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed to the same rule as that affecting the Moderator.



It shall be the duty of the Clerk to keep a complete record of all meetings to publish in book form, minuted and distributed to various quarterly meetings or yearly meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

I. Promotional Director - It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into membership of the West Virginia State Association. Also to promote the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Department.

II. The Executive Board - The Executive Board shall act as the State Association when State Association is not in session, action subject to approval by State Association.

III. That a program committee be elected on Friday Morning to prepare the program for the coming year. This committee shall act as a placement committee and shall comply with the Constitution in making their choice for the Church, where the State Association is to be held. This committee shall consist of two ordained ministers, one deacon, and four members of duly seated delegates. This committee shall be prepared to report to the State Association by 1:45 P.M. Saturday afternoon.

IV. Foreign Mission Board - It shall be the duty of this board to cooperate with the Foreign Mission Board of the National Association of Free Will Baptists, and to endeavor to raise funds for the Foreign Mission work of our denomination. This board shall arrange the missionary conferences throughout the state work as it feels necessary.

V. Home Mission Board - It shall be the duty of the Home Mission Board to promote the establishing of new churches and conferences through the State of West Virginia where we do not have established Free Will Baptists work. Sixty percent of all money raised by the Home Mission Board shall be used in the promotional work of our state and forty percent shall be channeled to the National Home Mission Board.

VI. Children's Home Board - This Board shall maintain a relationship with the Free Will Baptist Home for Children at Greenville, Tennessee, and help provide for its support. The member of this board shall be a trustee of the Board of Trustees of the Free Will Baptist Home for Children at Greenville, Tennessee.



Expenses of this trustee shall be provided for each official visit to the Home, not to exceed Twenty Dollars (\$20.00). This Board shall raise money for and relate its work with a Treasurer, Soliciting Members and Director, and a Trustee.

VII. Christian Training Service - This board shall promote the Free Will Baptist C.T.S. in our State and endeavor to get District and State C.T.S. into their proper place in our churches and conferences.

The enlightenment of Free Will Baptists of West Virginia to the causes of the denomination and the publishing of tracts to help in the financial support of the students at Free Will Baptist Bible College itself. This Board shall endeavor to meet the quota set for the Bible College for our State. All funds raised for this work shall be divided 40 percent to the Bible College at Nashville, Tennessee and 20 percent for operating expenses.

This board shall provide funds only as they are available to support of students. Any student willing to receive support from this board must be a Free Will Baptist and be in good standing in some church within the bounds of the State Association. They must also be recommended by their church and Pastor.

VIII. Sunday School Board - This board shall organize within itself and have a chairman and Secretary-Treasurer. This board shall endeavor to coordinate the Sunday School work in West Virginia and try to bring our Sunday School up to the National Standard for Sunday Schools. This board shall endeavor to establish a worker conference in our Sunday School literature and to help in establishing Teachers' Training Courses in our schools.

These Schools shall be taught by those who have Evangelical Teachers' Training Association Certificate or are otherwise qualified. This board shall seek to establish a Sunday School Board in each Conference and shall be responsible for the overall planning of Sunday School work in the State Association.

IX. Publication Board - The publication board shall consist of five (5) members, elected for a term of Five (5) years and elected so that one member is elected annually. It shall be organized with an Editor, Associate Editor-Treasurer and three Associate Editors. It shall be the duty of this board to publish a regular news publication concerning the various ministries of Free Will Baptists in West Virginia and in the world. This board shall be limited to new equipment purchases of \$300.00 per year without the approval of the Association or the Executive Board.

X. Trustee Board - The State Association shall have a Board of Trustees consisting of five members, each of whom shall be nominated from the floor and elected by a standing vote. Two thirds of all voting members shall be final. This board shall receive property only at the order of the State Association. It shall be a permanent board unless body sees fit to discontinue.

#### Article No. 4 - Executive Board

The Executive Board shall be composed of one ordained minister from each Quarterly Conference that is in good standing with the State Association. This board shall organize within themselves as to Chairman and Secretary.

Section 2. If any member of the Executive Board is unable to attend, he must send a proxy in his place.

#### Article No. 5 - Boards

The standing boards shall be the following: Foreign Mission, Home Mission, Children's Home Board, C.T.S. Board, Publication Board and the Board of Trustees.

#### Article No. 6

Annual dues shall be Thirty Five Dollars (\$35.00) per each Quarterly Meeting that is presented to the State Association, plus Five Dollars (\$5.00) for each church belonging to the Quarterly Meeting composing this body.

Section 2. All ministers, deacons, and delegates shall pay Three Dollars (\$3.00) registration fee. One dollar to go to the church, one dollar to the State Association and one dollar to help pay the annual dues to the National Association.

Section 3. Any minister receiving a good standing card must pay his three dollars (\$3.00) registration fee. Each quarterly meeting is requested to collect this fee and send to State Association with their letter.

Section 4. Each Quarterly Meeting shall have one delegate for each church belonging to it.

#### Article No. 7

The State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment. Special meetings may be called by the Executive Board when extreme necessity demands, provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting of this organization.

Section 2. Any Quarterly Meeting or Church desiring the State Association meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

#### Article No. 8

This Constitution may be revised or changed at any regular session of the West Virginia State Association provided the change is presented in writing and stated one day before vote is taken.



BY - LAWS

1. A portion of the Scripture shall be read and prayer shall be offered at the beginning of each morning and afternoon sessions of the State Association and prayer shall be offered at the close of each session.

2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the Program Committee. When Moderator nor Assistant is present the Clerk shall call the meeting to order and elect a Moderator protem.

3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this organization to send a letter to it giving accurately as possible the information requested by the National Association.

4. Not over one deacon shall be appointed on any one committee. Except in case of emergency.

5. Only ordained ministers shall be allowed to moderate this meeting.

6. All Sunday School Conventions and State Women's Auxiliary Convention report to the State Association, and their report be received as information.

7. In case of any controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.

8. All business except routine shall be brought by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be discussed unless by vote of this body.

9. No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

10. Each conference shall have its letter and finance report sent to the State Association Clerk one week before the State Association convenes.

11. Any member of this body can appeal from the decision of the Moderator to the body and by two-thirds majority of all members present, thereon. This decision shall be sustained or rejected.

12. No one shall leave the body without the consent of the Moderator. Anyone deciding to speak shall arise and say "Brother Moderator" shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or think it will lead to discord or division.

13. This State Association shall correspond by messenger or otherwise with other religious bodies.

14. The same person or group of persons shall not serve on more than one standing board or committee as long as it can be supplied otherwise.

15. Not less than three Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

16. No person shall be elected to any office without being present. Except the Executive Board. (The member is recommended by the Quarterly Conference.)

17. The Moderator shall be elected at the close of each session on Saturday, and shall serve until his successor is elected at the same time the following year.

18. No Ministers, Deacon or Delegate shall be permitted to vote, that is a known Homosexual, Bi-Sexual and Lesbian in this State Association. The State Association will not retain any person or persons known to be as such.

19. The Officers of the State Association shall receive an honoraria as follows: Moderator - \$15.00. Assistant Moderator - \$7.50. Clerk - \$85.00. Treasurer - \$30.00.

20. The member of the General Board of the National Association shall receive \$200.00 toward his expenses.

21. These By-Laws may be revised or changed at any regular session of the State Association provided that they be plainly written and stated one day before vote is taken.

ITEM NO. 1. We accept the letters from Beckley, Brotherhood, Christian - Fellowship, Coal River, Elk River, Fayette, Greenbrier-Nicholas, Guyan Valley, Huff Creek, Kanawha, Logan, McDowell, Mingo, Tug River, Wayne and Wyoming. LaPorte County Conference came in late. M&S. Carried.

ITEM NO. 2. The Guyan Valley Conference and the Huff Creek Conference, who wish to go on record protesting the three dollar registration fee for ministers, if they have any representatives present to get with the Executive Board, that is to be elected to discuss the matter and what course they may take. M&S. Carried.

ITEM NO. 3. That we receive the Upper Ohio Valley Conference of Free Will Baptists in fellowship with the State Association, upon report of the State Association Promotional Director. M&S. Carried.

ITEM NO. 4. That the Greenbrier County Conference letter is out of order, and by their request, we return their letter and money. M&S. Carried.

ITEM NO. 5. That the State Association keep the three dollar registration fee of Rev. John Walker and send him a letter requesting him to join a conference in good standing with the State Association so the State Association can give him a good standing card. If he decides not to join a conference in good standing, the State Association will refund his three dollars. M&S. Carried.

ITEM NO. 6. That we refund the thirty none dollars back to the Huff Creek Conference that they overpaid. M&S. Carried.

Business Committee elected - Chairman: Rev. Daniel Kelly. Other members are: Rev. Ottie Burke, Rev. Curtis Booth, Rev. Franklin Parsons and Rev. Mike Kidd.

Credential Committee for the coming year - Chairman: Rev. Edwin Hughes. Others are Rev. Noah Adams, Jr., Rev. Walter Lambert, Rev. Robert Koontz, Jr., Rev. F. A. Giles, Rev. W. P. Vance and Rev. Ottie Burke.

Program and Placement Committee elected as follows: Chairman: Rev. Charles Donaldson. Others were Rev. Bernard Thrash, Carl Parsley, Ed Dempsey, Eddie Holstein, Edwin Freeman and Chester Tingler.

Election of clerk for coming year - Rev. Norwood Webb.

Motion and second was made for moderator to choose an Assistant Moderator pro-tem. Carried. Rev. Kermit Cunningham was chosen.

Motion and second was made to appoint a committee for the Obituary report. Carried. Those appointed were: Beulah Morgan, Mary Eden and Margie Cunningham.

Rev. Kermit Cunningham gave a report on Home Missions. Rev. H. B. Hall spoke on behalf of his Home Missions work in Wheeling, M&S to receive these reports. Carried.

Foreign Mission Report - Rev. Robert Koontz, Jr. We missed our quota of \$50,000.00 by \$7,201.07. Our quota for 1978 is \$60,000.00.

Rev. W. P. Vance was elected as three year member to the Foreign Mission Board.

Rev. Robert Crawford gave a report on the Bible College at Nashville, Tenn.

Executive Board Report - by clerk. The Executive Board met with the Executive Board of the Beckley Conference, the Bible College Committee and the Promotional Director of the State Association on April 26, 1978, to discuss the proposed Bible College and to make plans for their report to the State Association when it meets in June of this year. Rev. Russell Wright, member of the

Bible College Committee, gave his report to the Beckley Executive Board. Rev. Wright made recommendation that the State Association, or the Bible College Committee bring in someone as promotional director for the Bible College. M&S was made to recommend this item of business to the State Association. Carried.

This item of business was recommended to the State Association. It was M&S and passed.

The moderator of the Executive Board requested that the clerk of the State Association write Rev. Bill Jones, president of Hillsdale F.W.B. Bible College in Oklahoma, to let him know, that if the State Association accepts the Bible College Committee's proposal, and the Executive Board report, we may be calling on them for their offer of assistance in the near future. M&S was made to have this item placed on record. Carried.

The Executive Board makes the following recommendation that if the State Association accepts the proposal of the Bible College Committee, that an item of business be drawn up and state whether or not they will accept the Beckley Conferences' offer and when the State Association will start the legal work on the transition and that it be started by July 1, 1978. M&S. Carried.

This item of business was recommended to the State Association. It was M&S and passed.

The Executive Board met again on May 20, 1978, with Rev. Robert Belcher and Deacon Harlan Hall of the Christian-Fellowship Conference to discuss a problem they had. Rev. Belcher stated that he had been pastor at Calvary Church for four years making many improvements before confusion and jealousy arose of which he was not aware. He stated that the Christian - Fellowship Conference Executive Board was called as a Board of Arbitration. The board showed up only to meet with a few in a Sunday School room and not the complaining body. Several minutes of business meetings were read stating that many members were discharged by the new pastor which took over after much confusion came up in the first business meeting and Rev. Belcher was voted out as pastor.

A certified letter was read by Bro. Vallance which had been sent to Deacon Harlan Hall by the local conference asking for the return of his papers.

The confusion began over two preachers which were ac-



cused of preaching false doctrine on divorce. They informed the Executive Board that they were meeting in a garage until such time they could get their building back or start a new program. Bro. Vallance advised that they start a new work and organize a new church.

The moderator asked that the State Executive Board be dismissed for private discussion on this matter. A unanimous decision was reached by the board and the following recommendation was made. We recommend that the State Association Executive Board meet with the Christian-Fellowship Conference Executive Board and this church, as we feel they have been done an injustice according to their report. We further recommend that they continue to meet in the name of their church (The Calvary F W B Church). This item of business was M&S and passed at the State Association.

Rev. Russell Wright made his report of the Bible College Committee. M&S was made to table until tomorrow's session. Carried.

Partial Business Committee report:

ITEM NO. 1. That the State Association report to the National Association with proper finance and delegates. M&S. Carried.

ITEM NO. 2. That we pay the Executive Board members for their trip and meetings with the Bible College Committee. M&S. Carried.

Delegates to the National Association were: Clifford Lester, Garland Lemon, Margie Cunningham, Charlene Batten and Shirley Giles.

Rev. James E. Raper gave a report on the Children's Home. Offering for Children's Home was \$135.11.

Rev. Ulysess Holstein was elected as three year member to the Children's Home Board.

Carl Parsley gave a report on the CTS Department. M&S was made that we give Kilsyth FWB Church \$100.00 To pay on the finances to the National. Carried.

Rev. Michael Kidd was elected as three year member to the CTS Board.

Motion and second was made to adjourn from business until tomorrow's session. Carried.

Beulah Morgan gave the Obituary Report. M&S to stand in silent prayer. Closed by Rev. John Henson.

Annilee Hughes was elected as three year member to the Obituary Committee.

Bill Foster gave a report on the National Sunday School Department. M&S to receive the report. Carried.

Rev. Roy Thomas gave a report on National Home Missions. M&S to receive report as information. Carried.

Carl Sullivan gave a report on the State Sunday School Convention. The Sunday School Convention will convene at the Winifrede FWB Church on September 23, 1978 at 9:30 a.m. M&S to receive report. Carried.

Rev. Bernard Thrash was elected as three year member to the Sunday School Board.

ITEM NO. 3. That we delete Article No 6, Section 4 from the Constitution because it conflicts with Article No. 1 Section 1. M&S to table until next year. Carried.
