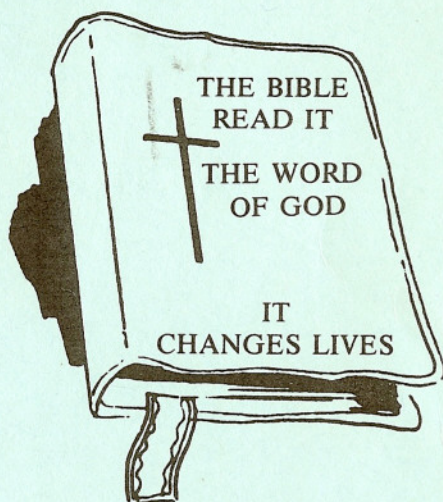

CONSTITUTION OF THE
WEST VIRGINIA STATE ASSOCIATION OF
FREE WILL BAPTISTS
PREAMBLE

Having received salvation through faith in Jesus Christ, and having been baptized as an outward sign of our separation from the world, and realizing the necessity of being identified with and sharing the fellowship of other believers, have joined ourselves to a local visible church, we do ordain this Constitution to unify the work of Free Will Baptists in the State of West Virginia, and to devise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in cooperation with the various quarterly or yearly meetings comprising this State Association. May God bless our labor.

Article No. 1

Section 1. All ordained ministers and deacons belonging to member quarterly meetings and district Associations shall make up the standing delegates to this State Association. Each quarterly meeting shall be permitted to send three lay delegates to the State Association plus one delegate from each Church composing that quarterly meeting.

Section 2. The membership of the State Association shall consist of the quarterly meetings and district Association or yearly meetings from time to time upon approval shall become members of this body.

Section 3. Any minister, deacon or delegate voting in State Association, must be a member of a church in good standing with the quarterly meeting recommending them from the State Association.

Section 4. This State Association shall be affiliated with the National Association of Free Will Baptists of the United States of America, and recognize the Treatise of faith and practice as our guideline for denominial fellowship, as long as they remain an independent denomination.

Article No. 2 - Discipline

Section 1. The State Association shall have the right to settle any questions of discipline, doctrine or usage that may properly come before it from time to time from any quarterly meetings or yearly meetings composing the said State Association or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association

making the appeal then forwarded by mail or in person to State Association and Quarterly Meeting.

Section 2. No quarterly meeting shall license or ordain to preach or to serve as deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained as a deacon in this State Association.

Section 3. No quarterly meeting shall license or ordain a woman to preach.

Section 4. No quarterly meeting shall be accepted or retained as a member that license or ordain women to preach.

Section 5. The Executive Board shall investigate any charges, after they have been properly presented to the quarterly meeting of which the grieved party or parties are a member. Any charges presented to this State Association Executive Board for consideration must be presented in writing and signed by the person or persons, making the charges.

Section 6. The Executive Board shall be paid the rate of fifteen cents (15¢) per mile from home to destination and return to home when traveling on State Association official business. The party or parties requesting the Executive Board to meet with them, shall be responsible to pay their expenses.

Article 3

The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Parliamentarian. Each of whom shall be nominated from the floor, at each regular session, except the treasurer, who shall be elected for a three-year period, beginning with the 23rd session, and the Moderator, who will be elected for two year terms, and he can serve two terms for a period of four years, beginning with the 38th session.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

The Promotional Director shall be employed by the Executive Board subject to approval by the State Association when in session.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and By Laws are obeyed and respected, and to exercise all the right to vote.

The right to vote shall be given the Moderator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. It shall be the duty of the Assistant Moderator to assist the Moderator in any way he can in the discharge of his duty. This duty shall

not be construed to abridge his right to vote when in the chair, in which he shall be governed to the same rule as that affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings to publish in book form, minutes and distributed to various quarterly meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

I. Promotional Director - It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into membership of the West Virginia State Association. Also to promote the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Board or Department.

II. The Executive Committee - The Executive Board shall act as the State Association when State Association is not in session, action subject to approval by State Association.

III. Program Committee - That a program committee be elected on Friday morning to prepare the program for the coming year. This committee shall act as a placement committee and shall comply with the Constitution in making their choice for the Church, where the State Association is to be held. This committee shall consist of two ordained ministers, one deacon, and four members of duly seated delegates. This committee shall prepare to report to the State Association by 1:45 P.M. Saturday afternoon.

IV. The Missions Board - This board is to be a six member board, and shall work to promote Foreign and Home Missions work throughout the State of West Virginia. This board shall cooperate with the Missions board of the National Association, and endeavor to raise funds for the Missions board of our denomination. This board shall arrange missionary conferences throughout the state work as it feels necessary. Also to promote new churches and conferences through the State of West Virginia where we do not have established Free Will Baptist work.

V. Children's Home Board - This Board shall maintain a relationship with the Free Will Baptist Home for Children at Greenville, Tennessee, and help provide for its support. The member of this board shall be a trustee of the Board of Trustees of the Free Will Baptist Home for

Children at Greenville, Tennessee. Expenses of this trustee shall be provided for each official visit to the Home. He shall be paid one Hundred Dollars (\$100.00) per trip, not to exceed three trips a year. This Board shall raise money for and relate its work with a Treasurer, Soliciting Members and Director, and Trustee.

VI. Christian Education Board - This board shall consist of five (5) members elected for a term of five (5) years and elected as so that one member be elected annually. It shall organize within itself a chairman, secretary and treasurer. It shall be the duty of this Board to generally oversee the educational efforts of this Association. This would include but not be limited to (A) organize and conduct a State Bible Institute; (B) Establish Sunday Schools; (C) Promote Church Training Service (CTS) and generally oversee competitive events on the state and district levels.

VII. Publication Board - The Publication Board shall consist of Five (5) members, elected for a term of five (5) years and elected so that one member is elected annually. It shall be organized with an Editor, Associate Editor Treasurer and three Associate Editors. It shall be the duty of this board to publish a regular news publication concerning the various ministries of Free Will Baptist in West Virginia and in the world. This board shall be limited to new purchases of \$300.00 per year without approval of the Association or the Executive Board.

Article No. 4 - Executive Board

The Executive Board shall be composed of one ordained minister from each Quarterly Conference that is in good standing with the State Association.

Section 2. If any member of the Executive Board is unable to attend, he must send a proxy in his place.

Section 3. At a regular scheduled session, the Saturday before the state meeting, this board shall hear the reports of all standing boards and officers. It shall serve as a budget committee and make recommendations as deemed pertinent to State Association.

Article No. 5 - Boards

The standing boards shall be the following, Foreign Mission, Home Mission, Children's Home Board, C.T.S. Board, Publication Board and the Board of Trustees.

Article No. 6

Annual dues shall be Fifty Dollars (\$50.00) per each Quarterly Meeting that is presented to the State Association, plus Fifteen Dollars (\$15.00) for each church belonging to the Quarterly Meeting composing this body.

Section 2. All ministers, deacons and delegates shall pay Three Dollars (\$3.00) registration fee, with the exception of those ministers who are Sixty-Five years old, and older or disabled. One Dollar (\$1.00) to go to the Church, one dollar to go to the State Association, and one dollar to help pay the annual dues to the National Association.

Section 3. Any minister receiving a good standing card must pay his Three Dollar (\$3.00) registration fee. Each quarterly meeting is requested to collect this fee and send to State Association with their letter.

Article No. 7

The State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment.

Special meetings may be called by the Executive Board when extreme necessity demands provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting of this organization.

Section 2. Any Quarterly Meeting or Church desiring the State Association meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

Article No. 8

This Constitution may be revised or changed at any regular session of the West Virginia State Association provided the change is presented in writing and stated one day before vote is taken.

BY - LAWS

1. A portion of the Scripture shall be read and prayer be offered at the beginning of each morning and afternoon session of the State Association and prayer shall be offered at the close of each session.

2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the Program Committee. When Moderator nor assistant is present, the Clerk shall call the meeting to order and elect a Moderator-protem.

3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this organization to send a letter to it giving accurately as possible the information requested by the National Association.

4. Not over one deacon shall be appointed on any one committee. Except in case of emergency.

5. Only ordained ministers shall be allowed to moderate this meeting.

6. All Sunday School Conventions and State Women's Auxiliary Convention report to the State Association, and their report be received as information.

7. In case of any controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.

8. All business except routine shall be brought by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be discussed unless by vote of this body.

9. No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

10. Each conference shall have its letter and finance report sent to the State Association Clerk one week before the State Association convenes.

11. Any member of this body can appeal from the decision of the Moderator to the body and by two thirds majority of all members present, thereon. This decision shall be sustained or rejected.

12. No one shall leave the body without the consent of the Moderator. Anyone deciding to speak shall arise and say "Brother Moderator" shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or think it will lead to discord or division.

13. This State Association shall correspond by messenger or otherwise with other religious bodies.

14. The same person or group of persons shall not serve on more than one standing board or committee as long as it can be supplied otherwise.

15. Not less than three (3) Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

16. No person shall be elected to any office without being present, except the Executive Board. (The member is recommended by the Quarterly Conference.)

17. The Moderator shall be elected at the close of each two year session on Saturday, and shall serve until his successor is elected at the same time the following two years.

18. No Ministers, Deacons or Delegates shall be permitted to vote that is a known Homosexual, Bi-Sexual or Lesbian in this State Association. The State Association will not retain any person or persons known to be as such.

19. The Officers of the State Association shall receive and honoraria as follows: Moderator - \$35.00. Assistant Moderator - \$15.00. Clerk - \$100.00. Treasurer - \$30.00.

20. The member of the General Board of the National Association shall receive \$250.00 when the National Association convenes East of the Mississippi River and \$350.00 West of the Mississippi River.

21. These By-Laws may be revised or changed at any regular session of the State Association provided that they be plainly written and stated one day before vote is taken.

MINUTES

Minutes of the 39th Annual Session of the West Virginia State Association of Free Will Baptists, held at the Cedar Grove Free Will Baptist Church, June 8, 9, 1984, Parkersburg, W. Va

THEME - Stand fast in one Spirit, with one Mind. Phil. 1:27.

9:30 A.M. - Devotional by Rev. Tom Blake

Scripture was read and prayer was offered by Rev. Carl Vallance

Address of Welcome - Rev. Billy Samms

Response - Larry Evans

Moderator - Rev. George Smith took charge.

Motion and second was made to accept program with any necessary changes to be made by the Moderator. Carried.

Rev. W.C. Combs and Rev. Ronnie Scott were elected to fill nominating committee for members not present.

Credential Committee Report - The Credential Committee made the following recommendations;

Item No. 1. That we accept the letters from Beckley, Brotherhood, Christian Fellowship, Coal River, Elk River, Fayette, Greenbrier County, Greenbrier Nicholas, Guyan Valley, Huff Creek, Kanawha, Liberty, Logan, McDowell, Mingo, Trinity, Tug River, Upper Ohio Valley, Wayne, Wyoming, which were presented to this body by proper finance and delegates. The ministers, deacons and delegates to be seated to conduct the business of the West Virginia State Association. (Note) Point of information that only ministers with good standing cards are allowed to vote in business today. Ministers from several conferences were in question.

Item No. 2. That the ministers from the conferences which were in question meet with the Executive Committee. This they did during the lunch break.

Item No. 3. That the letter from the Unity Association be turned over to the Business Committee.

All three items were motioned, second and passed.

Report of Audit Committee - The Audit Committee reports that all money in treasury is correct according to audit.

Business Committee Elected - Rev. Joseph Osborne, Rev. Clyde Wood, Dr. Lewis Hall, Jr., Rev. Carl Vallance and Rev. Carl Cooper.

Credential Committee elected for the coming year are as follows: Rev. Kit Meade, Rev. Don Ellis, Rev. Henry Damron, Rev. Edwin Hughes and Carl Sullivan.

Election of Program and Placement Committee - Rev. Jesse Blankenship, Rev. Earl Burdges, Larry Evans, Rick Holstein, Garland Lemon, Eddie Freeman and Tom Myers.

Nominating Committee for the coming year are as follows: Rev. Roy McVey, Rev. Billy Samms and Rev. Tom Blake.

Rev. James Varney was nominated and elected as Assistant Moderator for this session.

Recognized and welcomed all visitors.

Rev. John Hockenberry was nominated and elected by acclamation to serve as Executive Board Member from the Brotherhood Conference.

Executive Board Members from each Conference names were read and accepted by this State Association.

Glenna Murphy, President of the Women's Auxiliary gave their report and it was accepted as such.

Report of Master's Men - Jim Vallance. This year we have five chapters in West Virginia and one individual membership. In my first 40 weeks here, 38 new chapters were added. We ended the year with 252 chapters. That is better than any year for which we have records. Financially, 1983 was a good year, we were able to retire several of our outstanding debts. In 1983 West Virginia gave \$765.76 to Master's Men Department. There were 2,568 men involved in the work. Last year, Master's Men received \$24,362.06 from Co-op. Our Theme is "Sharing the Load."

Home Missionary Report - Rev. Russell Wright, Lincoln Nebraska, in a little over two years we are averaging about sixty, and hopes to be self-supporting very soon.

Prayer was offered for the reports by Rev. James E. Raper.

M&S was made to adjourn for morning worship service. Carried.

Devotional - Rev. Harold Blankenship had song and prayer by all, service turned over to Minister for message.

FRIDAY AFTERNOON SESSION

Rev. James Varney opened afternoon session with prayer by Rev. John Hockenberry and song by Deliah Scott

Bible College Nashville, Tenn. report. Ron Creech. West Virginia gifts to Bible College, 1979-1980, \$9,191.95 - 1980-1981, \$8,962.58 - 1981-1982, \$8,319.80 --- 1982-1983, \$10,476.87 --- 1983-1984, \$5,993.40. West Virginia is being asked for \$12,000 during the college year, June, 1984 thru May, 1985. Rev. Kit Meade offered prayer for Bible Colleges.

Partial Business Committee Report - We the business committee make the following recommendation to this State Association;

Item No. 1. That the Unity Association be accepted into the fellowship of the State Association. M&S. Carried.

Item No.2. That the State Executive Board make a proposal to the State Association in regard to the hiring of a Promotional Director, bringing our Constitution and By-Laws in line for such a full time Promotional work. M&S to lay on table until tomorrows session. Carried.

Item No. 3. That we prepare a letter with proper finance and delegates to the National Association. M&S. Carried

Delegates to National Association are; Carl Sullivan, Jody Sullivan, Norma Combs, Garland Lemon and Dorman Sargent.

The Unity Association was welcomed and given the right hand of fellowship into this State Association.

State Paper Report - by Rev. W. C. Combs. June 1, 1984 Bank Balance of \$140.56. 49,464 copies were mailed out at a cost of less than 12.35 cents per copy. We will probably be able to continue with a budget of \$6500.00 for the coming year.

Executive Board Report by Clerk. The Executive Board met Sept. 10, 1983 at the Buffalo Creek Church, with the Buffalo Creek Church and the Guyan Valley Conference, to discuss the Guyan Valley Conference withdrawing the right hand of fellowship from the Buffalo Creek Church, over the doctrine of speaking in Tongues.

Charges brought by the Guyan Valley Conference were, that the Buffalo Creek Church went away from the Treatise of Faith, for practicing tongues in Church, and was dismissed on these grounds.

The Buffalo Creek was asking for an apology from the Guyan Valley Conference, and a letter of recommendation from the Conference.

The State Executive Board met and discussed this situation and this is their recommendation; We the Executive Board support the Guyan Valley Conference stand against speaking in tongues, and do believe it is not in the best interest of our denomination, and are not beneficial, and that it only adds to confusion, or leads to confusion. We cannot support a letter of recommendation from the Conference to the Buffalo Creek Church. We support the Guyan Valley Conference decision not to give letter of recommendation.

If the Buffalo Creek Church and members in question feel the charges were improperly drawn up, then rewrite and request that charges be restated by the Guyan Valley Conference to you, the Buffalo Creek and the parties involved.

The Executive Board met again the same day at Greenbranch Church to discuss the National Association coming to our State in 1991 at the Civic Center. The Clerk was asked to write Rev. Melvin Worthington, requesting

the National Association to meet at the Civic Center, in Charleston, W.Va. July 21st thru 25th, 1991. The cost of meeting would be \$10,430.00.

The Executive Board elected Bro. Dave Lucas to finish the term left vacant on the Mission Board by Virgil Merritt.

The Executive Board met again June 2, 1984 to propose budget and prepare for State Meeting on June 8, 1984. The Proposed budget which was read and accepted as a whole will follow the Treasury report.

Promotional Director's Report - by Rev. Billy Sanims. I have met seven times with the Mission Board, five times with the Christian Education Board, visited sixteen quarterly meetings, some as many as three times. Traveled about eight thousand miles the past year, organized one quarterly meeting, preached five revivals, received from general fund \$900.00, assigned gifts \$706.77. I have promoted all phases of work of State and Foreign Missions, Bible Colleges, Children's Home, C.E.D. Board and Cooperative plan of giving. Organized the Unity Association of Free Will Baptist which was accepted into this State Association. Organized this Unity Conference Jan. 9, 1984.

Children's Home Report - by Rev. James E. Raper. He asked for the Children's Home to be placed in Wills. Offering for Children's Home \$181.03. Bro. Raper said for 82,500 soup labels and \$35.00 postage they purchased three typewriters worth about \$400.00 each.

Report of Christian Education Board - Rev. William Smith. Bro. William said if anyone desired to have a Bible Institute get in touch with one of the members on the Board.

Sunday School Department Report - Harold Harrison.

Rev. Kit Meade received plaque for about \$2700.00 giving to Home Mission.

Missions reports were given by R. Eugene Waddell, Associate Director, Foreign Missions. Rev. Connie Cariker Home Mission and a letter from Sis. Alice Smith was read by Rev. F.A. Giles.

Obituary Report by Shirley Giles. Moment of silent prayer ended by Rev. George Smith.

M&S was made to adjourn until Saturday session. Carried.

Ottis Hensley was nominated and elected as the three year member on the audit committee.

Rev. Carl Lilly and Rev. Lewis Hall were nominated and elected to serve as the three year members on the Missions Board.

Roger Smith was nominated and elected to serve as the five year member on the C.E.D. Board.

Larine Tolliver was nominated and elected to serve as the five year member on the Publication Board.

Rev. Rex Thompson was nominated and elected to serve as the three year member on the Children's Home Board.

Beulah Morgan was nominated and elected to serve as three year member on the Obituary Committee.

Rev. Carl Vallance was nominated and elected to serve as General Board member to the National Association.

Rev. George Smith was nominated and elected to serve on the Board of Trustees of the State Association.

Rev. F. A. Giles was nominated and elected to serve as assistant moderator for the coming year.

Add to section 1, article No. 3, The Promotional Director shall be employed by the Executive Board, subject to approval by the Association when in session. M&S to delete and accept proposal. Carried.

Item No. 7. That we give a rising vote of thanks to the Host Church for its splendid preparation and care of this meeting. M&S. Carried.

Report of Program and Placement Committee. The program was read by Rick Holstein and the 1986 session would be held at the Prince of Peace Church, Huntington, WV. M&S to accept as read. Carried.

Rev. A.C. Cox was nominated and elected to serve as Executive Board member from the Huff Creek Conference to the State Association, since there was none present from Huff Creek.

Rev. Carl Vallance gave report of the work of the General Board Member elected to the National Association.

Rev. Ronnie Scott Home Missionary from Wheeling project gave report and hopes to be self supporting by September, or at least fifty percent.

M&S to adjourn for preaching. Carried.
