**CONSTITUTION OF THE  
WEST VIRGINIA STATE ASSOCIATION OF  
FREE WILL BAPTISTS**

**PREAMBLE**

Having received salvation through faith in Jesus Christ, and having been baptized as an outward sign of our separation from the world, and realizing the necessity of being identified with and sharing the fellowship of other believers, have joined ourselves to a local visible church, we do ordain this Constitution to unify the work of Free Will Baptists in the State of West Virginia, and to devise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in cooperation with the various quarterly or yearly meetings comprising this State Association. May God bless our labor.

**Article No. 1**

Section 1. All ordained ministers and deacons belonging to member quarterly meetings and district Associations shall make up the standing delegates to this State Association. Each quarterly meeting shall be permitted to send three lay delegates to the State Association plus one delegate from each Church composing that quarterly meeting.

Section 2. The membership of the State Association shall consist of the quarterly meetings and district Association or yearly meetings from time to time upon approval shall become members of this body.

Section 3. Any minister, deacon or delegate voting in State Association, must be a member of a church in good standing with the quarterly meeting recommending them from the State Association.

Section 4. This State Association shall be affiliated with the National Association of Free Will Baptists of the United States of America, and recognize the Treatise of faith and practice as our guidelines for denominational fellowship, as long as they remain an independent denomination.

**Article No. 2 - Discipline**

Section 1. The State Association shall have the right to settle questions of discipline, doctrine or usage that may properly come before it from time to time from any quarterly meetings or yearly meetings composing the said State Association or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association making the appeal then forwarded by mail or in person to State Association and Quarterly Meeting.

Section 2. No quarterly meeting shall license or ordain to preach or to serve as a deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained as a deacon in this State Association.

Section 3. No quarterly meeting shall license or ordain a woman to preach.

Section 4. No quarterly meeting shall be accepted or retained as a member that license or ordain women to preach.

Section 5. The Executive Board shall investigate any charges, after they have been properly presented to the quarterly meeting of which the grieved party or parties are a member. Any charges presented to this State Association Executive Board for consideration must be presented in writing and signed by the person or persons, making the charges.

Section 6. The Executive Board shall be paid the rate of fifteen cents (15¢) per mile from home to destination and return to home when traveling on State Association official business. The party or parties requesting the Executive Board to meet with them, shall be responsible to pay their expenses.

### **Article No. 3**

The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Parliamentarian. Each of whom shall be nominated from the floor, at each regular session, except the treasurer, who shall be elected for a three-year period, beginning with the 23rd session, and the Moderator, who will be elected for two year terms, and he can serve two terms for a period of four years, beginning with the 38th session.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

The Promotional Director shall be employed by the Executive Board subject to approval by the State Association when in session.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and By-Laws are obeyed and respected, and to exercise all the right to vote.

The right to vote shall be given the Moderator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. It shall be the duty of the Assistant Moderator to assist the Moderator in any way he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed to the same rule as that affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings to publish in book form, minutes and distributed to various quarterly meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

I. Promotional Director - It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into membership of the West Virginia State Association. Also to promote the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Board or Department.

II. The Executive Committee - The Executive Board shall act as the State Association when State Association is not in session, action subject to approval by State Association.

III. Program Committee - That a program committee be elected on Friday morning to prepare the program for the coming year. This committee shall act as a placement committee and shall comply with the Constitution in making their choice for the Church, where the State Association is to be held. This committee shall consist of two ordained ministers, one deacon, and four members of duly seated delegates. This committee shall prepare to report to the State Association by 1:45 P.M. Saturday afternoon.

IV. The Mission Board - This board is to be a six member board, and shall work to promote Foreign and Home Missions work throughout the State of West Virginia. This board shall cooperate with the Missions board of the National Association, and endeavor to raise funds for the Missions board of our denomination. This board shall arrange missionary conferences throughout the state work as it feels necessary. Also to promote new churches and conferences through the State of West Virginia where we do not have established Free Will Baptist work.

V. Children's Home Board - This board shall maintain a relationship with the Free Will Baptist Home for Children at Greenville, Tennessee, and help provide for its support. The member of this board shall be a trustee of the Board of Trustees of the Free Will Baptist Home for Children at Greenville, Tennessee. Expenses of this trustee shall be

provided for each official visit to the Home. He shall be paid one Hundred Dollars (100.00) per trip, not to exceed three trips a year. This Board shall raise money for and relate its work with a Treasurer, Soliciting Members and Director, and Trustee.

VI. Christian Education Board - This board shall consist of five (5) members elected for a term of five (5) years and elected as so that one member be elected annually. It shall organize within itself a chairman, secretary and treasurer. It shall be the duty of this Board to generally oversee the educational efforts of this Association. This would include but not be limited to (A) organize and conduct a State Bible Institute; (B) Establish Sunday Schools; (C) Promote Church Training Services (CTS) and generally oversee competitive events on the state and district levels.

VII. Publication Board - The Publication Board shall consist of five (5) members elected for a term of five (5) years and elected so that one member is elected annually. It shall be organized with an Editor, Associate Editor, Treasurer and three Associate Editors. It shall be the duty of this board to publish a regular news publication concerning the various ministries of Free Will Baptist in West Virginia and in the world. This board shall be limited to new purchases of \$300.00 per year without approval of the Association or the Executive Board.

VIII. Trustee Board - The duties of this board shall be to hold titles to all real property belonging to this body; the maintenance and upkeep of all such properties; the planning and supervision of all future developments; and the expansion of these properties as directed by the West Virginia State Association.

It is agreed, in this connection, that the Board of Trustees shall at no time sell or encumber these properties by mortgage, lein, or otherwise without the express consent of this body given in regular or called session of this association.

The Board of Trustees is hereby authorized to receive, in behalf of and for the West Virginia State Association of Free Will Baptists, gifts, grants, monies, real estate, or other valuable assets.

The Board of Trustees shall act for and in behalf of the West Virginia State Association of Free Will Baptists in any and all transactions involving any of it's properties, but shall do so strictly in accordance with instructions given by said State Association in regular or called session.

In as much as the work of the Publication Board may require an occassional replacement of certain mechanical items, costing more than the present set limit, it shall be the duty of the Board of Trustees to determine the validity of such a need, approve and implement or disapprove the requested purchase at their discretion.

#### **Article No. 4 - Executive Board**

The Executive Board shall be composed of one ordained minister from each Quarterly Conference that is in good standing with the State Association.

Section 2. If any member of the Executive Board is unable to attend, he must send a proxy in his place.

Section 3. At a regular scheduled session, the Saturday before the State Meeting, this board shall hear the reports of all standing boards and officers. It shall serve as a budget committee and make recommendations as deemed pertinent to State Association.

#### **Article No. 5 - Boards**

The standing boards shall be the following, Foreign Mission, Home Mission, Children's Home Board, Christian Education Board, Publication Board and the Board of Trustees.

#### **Article No. 6**

Annual dues shall be Twenty Five (\$25.00) per each church belonging to Quarterly Meeting that is presented to the State Association.

Section 2. All ministers, deacons and delegates shall pay Five Dollars (\$5.00) registration fee, with the exception of those ministers who are Sixty-Five years old, and older or disabled. One Dollar (\$1.00) to go to the church, Three Dollars (\$3.00) to go to the State Association, and One Dollar (\$1.00) to help pay the annual dues to the National Association.

Section 3. Any minister receiving a good standing card must pay his Five Dollar (\$5.00) registration fee. Each quarterly meeting is requested to collect this fee and send to State Association with their letter.

#### **Article No. 7**

The State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment.

Special meetings may be called by the Executive Board when extreme necessity demands provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting of this organization.

Section 2. Any Quarterly Meeting or Church desiring the State Association meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

#### **Article No. 8**

This Constitution may be revised or changed at any regular session of the West Virginia State Association provided the change is presented in writing and stated one day before vote it taken.

## BY-LAWS

1. A portion of the scripture shall be read and prayer be offered at the beginning of each morning and afternoon session of the State Association and prayer shall be offered at the close of each session.

2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the program committee. When Moderator nor Assistant is present, the Clerk shall call the meeting to order and elect a Moderator-protem.

3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this organization to send a letter to it giving accurately as possible the information requested by the National Association.

4. Not over one deacon shall be appointed on any one committee. Except in case of emergency.

5. Only ordained ministers shall be allowed to moderate this meeting.

6. All Sunday School Conventions and State Women's Auxiliaries Convention report to the State Association, and their report be received as information.

7. In case of controversy regarding parliamentary procedure, Robert's Rules of order shall be considered as final authority.

8. All business except routine shall be brought by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be discussed unless by vote of this body.

9. No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

10. Each conference shall have its letter and finance report sent to the State Association Clerk one week before the State Association convenes.

11. Any member of this body can appeal from the decision of the Moderator to the body and by a two thirds majority of all members present, thereon. This decision shall be sustained or rejected.

12. No one shall leave the body without the consent of the Moderator. Anyone deciding to speak shall arise and say "Brother Moderator" shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or think it will lead to discord or division.

13. This State Association shall correspond by messenger or otherwise with other religious bodies.

14. The same person or group of persons shall not serve on more than one standing board or committee as long as it can be supplied otherwise.

15. Not less than three (3) Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

Minutes of the 41st Annual Session of the West Virginia State Association of Free Will Baptist, held at the Prince of Peace Church, June 6, 7, 1986, at Huntington, W. Va.

### FRIDAY MORNING

9:30 A.M. - Welcome by Rev. Ron Scott

Motion and second was made to accept program with any necessary changes to be made by the Moderator. Carried.

Credential Committee Report - The Credential Committee made the following recommendations;

Item No. 1. That we accept the letters from Beckley, Brotherhood, Coal River, Elk River, Fayette, Greenbrier County, Greenbrier Nicholas, Guyan Valley, Huff Creek, Kanawha, Liberty, Logan, McDowell, Mingo, Trinity, Tug River, Upper Ohio Valley, Wayne and Wyoming which were presented to this body by proper finance and delegates. The ministers, deacons and delegates be seated to conduct the business of the West Virginia State Association. M&S. Carried.

Report of Treasurer - Rev. Roger Tolliver. Treasury Report will be on page following the minutes.

Report of Audit Committee - The treasurers books were audited when Bro. William Smith resigned and Rev. Roger Tolliver became the treasurer, and the books were in order.

Business Committee Elected - Rev. Edwin Hughes, Rev. Arthur Frye, Rev. Carl Cooper, Rev. Luther Morgan and Rev. Clyde Wood.

Election of Program and Placement Committee - Rev. Jerry Castelle, Rev. Randall Brogan, Russell May, J.R. Persinger, Mary Eden, Alice Smith and Mary Jo Corbin.

Recognizing of all visitors - Gene Waddell, Foreign Mission Department, James E. Raper, Children's Home, Jim Cox, Joe Haas, Bible College, Melvin Worthington, Executive Department, and Jerry Dudley, Hillsdale Bible College.

Reports were given by Glenna Murphy for Women's Auxiliary and the report was received as information.

Director of Foreign Mission Report - Rev. E. Gene Waddell. \$51,000.00 was given last year from West Virginia and more than 800 people made profession through Missions. There is 110 Missionaries on the field and three more going out this summer.

Alice Smith, Foreign Missionary from Ivory Coast, Africa spoke about her work there and she is now in on furlow.

Bobby Jude, Home Missionary in the Chapmanville area spoke about his work there.

Jim Vallance, National Master's men said that more money was needed for support of the Master's Men. Bro. Jim stated that the Prince of Peace church has the largest Master's Men in the Nation.

We did not issue a paper during the months of August and January. We mailed out 44,278 copies at a cost of \$5408.20, 12.2¢ per copy. There have been three postage changes since January, .06 to 8.5¢, the permit has gone from \$40.00 to \$50.00. I herewith submit my resignation as editor. W. C. Combs.

Report of Executive Board - by Norwood Webb Clerk. The Executive Board of the West Virginia State Association met four times during the past year. The Executive Board met October 5, 1985 at the Beckley HQ. building in Beckley, W. Va., with the Memorial Free Will Baptist Church and the Beckley conference Executive Board, by request of the Memorial church to hear a grievance against the Beckley conference for dismissing them from their conference.

Recommendation of the State Executive Board. That the Beckley Conference, reconsider their action against the Memorial church and take them back into fellowship of the conference. This item of business was sent to the Beckley conference Executive Board, but due to a misunderstanding this item of business was not presented when the conference met in session.

Other items of business presented at this meeting are listed;

The State Executive Board gave Rev. William Smith, treasurer of State Association, permission to transfer the contingent account into the Board of Retirements, until the State meeting in June, if they wish to change it.

Letters were sent out to the Executive Board for Rev. Roy Adkins to have permission to start a Bible Book Store. Permission was granted by letters returned by Executive Board members to clerk.

The Executive Board gave permission the Editor of State paper to print ads in the paper, with an offering for certain ads to be printed.

Discussion was held about buying a Video Camera/Recorder for Jim Combs. The cost about \$1500.00. It was suggested that the Executive Board members take this back to their conference and churches, to try and raise finances for this project.

The Executive Board met February 15, 1986, at the Western Steer Steak House at the Kanawha Mall, Kanawha City. Reports are listed as follows;

**Promotional Director** - Rev. Billy Samms said he visited all conferences and has promoted all phases of the work. Traveled 30,000 miles, received \$4800.00.

**Missions Report** - by J. L. Varney. Topics discussed were, The Advance campaign, looking for state chairmans, the Moderator will serve as advance chairman, until someone else takes the position. The Madison-Danville work by Rev. Bobby Jude, Missionary to these areas was discussed. Discussing was held about our missionaries on the field, both foreign and home, and for the continual support of these missionaries. The raising of \$1,000,000.00 was discussed and of our state trying to raise \$20,000.00 per year. Russell Wright, home missionary to Lincoln, Nebraska, has found some land to build a church for \$18,000.00 and has put \$9,000.00 down payment. It was stated that many of the missionaries accounts were in need of finances.

**Christian Education Board** - Steve Parsons reminded us of the May 3, 1986 youth competition to be held at the Charleston Civic Center at 10:00 a.m. Also referred back to previous minutes where the Sunday School Board and the C.T.S. Board merged, to be called the Christian Education Board.

**Report of State Treasurer** - Rev. Roger Tolliver said the state treasury was low, and that there seemed to be a decline in giving, and that there was a lack of interest in the co-op plan of giving.

**Children's Home Report** - Rev. Joe Thomas said that offerings for the children's home the past several months has been good.

**Report of State Women's Auxiliary** - Glenna Murphy said that the auxiliary is trying to help Sister Alice Smith get clothing to take back with her when she comes home on furlow.

**Report of State Paper** - Rev. W. C. Combs said he had no January paper due to lack of funds and material. June 85 through February 86, the paper mailed out 26,659 copies, at a cost of \$2942.60, at about 11 cents per copy. Income for the paper has dropped in the last few years.

At this meeting suggestion was made to take money out of the state master's men account to purchase off-set printing press and folder, with money going to state paper account.

The Executive Board met again April 26, 1986 at the Beckley HQ. building with the Memorial Free Will Baptist Church, and the Beckley conference Executive Board, to try and resolve the grievance for the Beckley conference dismissing them for non-compliance with the conference by-laws. The state Executive Board made this recommendation to the Memorial church, that they write a letter of petition to the Beckley conference, asking them to reconsider the matter and take them back into the conference.

The Executive Board met again May 31, 1986 to hear the reports of all standing Boards and Officers. Boards and Officers reporting are as follows: The Christian Education Board, The Mission Board, The Publication Board, The Trustee Board, and The General Board member to the National Association. Officers reporting were The Promotional Director and the Treasurer. Their reports will be heard during Friday and Saturday of the state meeting.

Other items of business presented at this meeting and the Executive Boards recommendations follows;

Item No. 1. That we donate the printing press and folder, that is now at the Central Church, to the National office of our Master's Men Department in Nashville, TN. That the money in the Master's Men account for 1985-86 be transferred to the account of the state paper. Item of business turned over to business committee at state meeting.

Item No. 2. That we appoint a committee, made up of the Moderator, Promotional Director and members selected by these two men, to investigate and procure a group insurance policy for our pastors and full time christian workers in our state association. This item of business was turned over to the business committee at state meeting.

Item No. 3. That we accept the 1979 minutes book item combining the Sunday School Board and the C.T.S. Board and calling them the Christian Education Board. M&S to table. Carried.

Item No. 4. The Executive Board selected a five member board to make preparations for the National Association to be held at the Civic Center in Charleston, in 1991. The five men elected were: Rev. Ron Scott, Chairman; Rev. Billy Samms, Rev. George Smith, Rev. Carl Vallance and Rev. J. L. Varney.

Item No. 5. The Executive Board is submitting Rev. Billy Samms name to the Nominating Committee to serve as Promotional Director for the year 1986-1987.

Item No. 6. The Executive Board recommends that proposed budget for 1986-1987.

This item of budget was turned over to the business committee at state meeting.

Report of Christian Education Board - Steve Parsons. The Christian Education Board met five times during the year. Discussed at these meetings was a variety of topics which included the possible purchase of a duplicating tape machine, Sunday School promotion, a radio Ministry, statewide C.T.S. program and a State Youth Rally.

The C.T.S. program has been our most successful endeavor. We have had several new churches ask about this program and we would urge all of our churches to use this as a youth building program.

Our C.T.S. competition was held on May 3, 1986 at the Charleston Civic Center. We feel it was the most successful competition, not only in number but also the facilities that seemed to be enjoyed by all. We were honored to have with us in this years competition our National Youth Director, Brother Jim Lauthern. Next years competition will be April 4, 1987 at the Charleston Civic Center. There will be facilities to seat 750 people. We know that West Virginia Free Will Baptist can fill these seats, and are looking forward to continued growth in our C.T.S. program. Continue to pray for the Christian Education Board and the youth in our state.

Brother James Mounts resigned from this board and Brother Larry Cooper replaced him.

Missions Board Report - Rev. F. A. Giles. The Mission Board has accomplished this year the following: established a mission church in the Madison-Danville area, with Rev. Bobby Jude as pastor. The church is continuing to grow. The Wheeling church where Rev. John McCormick is pastor is doing well. I preached at two of these services and they were well attended with 74 in Sunday School and 97 for the preaching service. This church has offered \$7000.00 for about three acres of ground near the church. The Foreign Missionaries whom this board feels responsible for, are promoting their work throughout the state. Dave Franks, Jim Sturgill, Jim Combs, Alice Smith and others are receiving support through co-op and designated giving. Our plea is, however you are supporting the

missions continue to do so, and if you are not supporting them in any way, please try and find a way which will best be for your church. Most of the accounts are in fair condition except the Jim Sturgill account, please try and help these accounts.

West Virginia gave about \$51,000.00 to Foreign Missions in the 1985-1986 year. The Mission Board met seven times during the year and voted to adopt and cooperate with the National Advance Program, subsidize the Wheeling Mission for two years from June 1985. Appointed Brother John McCormick as pastor for Wheeling Mission. Started a new work in the Madison-Danville area, hired Rev. Bobby Jude as the Missionary for this work as a joint effort with the National Home Mission Department. Inform and enlighten our churches to progress and needs through all means of promotion especially in visitation of our smaller churches.

Brother John Gibbs gave report of National Home Mission. Eight new missionaries were sent to the field in 1985. At present, we have 55 missionary families planting Free Will Baptist churches throughout North America and the islands belonging to the United States. We have nine National pastors in Mexico, eight of whom are starting a new work. Our National Association has adopted "Target 90" to reach 50,000 new members and plant 100 new churches by 1990.
