

# CONSTITUTION OF THE WEST VIRGINIA STATE ASSOCIATION OF FREEWILL BAPTISTS

## PREAMBLE

Having received salvation through faith in Jesus Christ, and having been baptized as an outward sign of our separation from the world, and realizing the necessity of being identified with and sharing the fellowship of other believers, have joined ourselves to a local visible church, we do ordain this Constitution to unify the work of Free Will Baptist in the State of West Virginia, and to devise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in cooperation with the various quarterly or yearly meetings comprising this State Association. May God bless our labor.

### Article No. 1

Section 1. All ordained ministers and deacons belonging to member quarterly meetings and district Associations shall make up the standing delegates to this State Association. Each quarterly meeting shall be permitted to send three lay delegates to the State Association plus one delegate from each Church composing that quarterly meeting.

Section 2. The membership of the State Association shall consist of the quarterly meetings and district Association of yearly meetings from time to time upon approval shall become members of this body.

Section 3. Any minister, deacon or delegate voting in State Association, must be a member of a church in good standing with the quarterly meeting recommending from the State Association.

Section 4. This State Association shall be affiliated with the National Association of Free Will Baptists of the United States of America, and recognize the Treatise of faith and practice as our guidelines for denominational fellowship, as long as they remain an independent denomination.

### Article No. 2 - Discipline

Section 1. The State Association shall have the right to settle questions of discipline, doctrine or usage that may properly come before it from time to time from any quarterly meetings or yearly meetings composing the said State Association or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association making the appeal then forwarded by mail or in person to State Association and Quarterly Meeting.

Section 2. No quarterly meeting shall license or ordain to preach or to serve as a deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained as a deacon in this State Association.

Section 3. No quarterly meeting shall license or ordain a woman to preach.

Section 4. No quarterly meeting shall be accepted or retained as a member that license or ordain women to preach.

Section 5. The Executive Board shall investigate any charges, after they have been properly presented to the quarterly meeting of which the grieved party or parties are a member. Any charges presented to this State Association Executive Board for consideration must be presented in writing and signed by the person or persons, making the charges.

Section 6. The Executive Board shall be paid the rate of fifteen cents (15 c) per mile from home to destination and return to home when traveling on State Association official business. The party or parties requesting the Executive Board to meet with them, shall be responsible to pay their expenses.

### Article No. 3

Section 1. The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Parliamentarian. Each of whom shall be nominated from the floor, at each regular session, except the treasurer, who shall be elected for a three-year period, beginning with the 23rd session, and the Moderator, who will be elected for two year terms, and he can serve two terms for a period of four years, beginning with the 38th session.

Election shall be determined by a majority vote, Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

The Promotional Director shall be employed by the Executive Board subject to approval by the State Association when in session.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and By-Laws are obeyed and respected, and to exercise all the right to vote.

The right to vote shall be given the Moderator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. It shall be the duty of the Assistant Moderator to assist the Moderator in any way he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed to the same rule as that affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings to publish in book form, minutes and distributed to various quarterly meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

1. Promotional Director - It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into membership of the West Virginia State Association. Also to promote the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Board or Department.

II. The Executive Committee - The Executive Board shall act as the State Association when State Association is not in session, action subject to approval by State Association.

III. Program Committee - That a program committee be elected on Friday morning to prepare the program for the coming year. This committee shall act as a placement committee and shall comply with the Constitution in making their choice for the Church, where the State Association is to be held. This committee shall consist of two ordained ministers, one deacon, and four members on duly seated delegates. This committee shall prepare to report to the State Association by 1:45P.M. Saturday afternoon.

IV. The Mission Board - This board is to be a six member board, and shall work to promote Foreign and Home Missions work throughout the State of West Virginia. This board shall cooperate with the Missions board of the National Association, and endeavor to raise funds for the Missions board and our denomination. This board shall arrange missionary conferences throughout the state work as it feels necessary. Also to promote new churches and conferences through the State of West Virginia where we do not have established Free Will Baptist Work.

V. Children's Home Board - This board shall maintain a relationship with the Free Will Baptist Home for Children at Greenville, Tennessee, and help provide for its support. The member of this board shall be a trustee of the Board of Trustees of the Free Will Baptist Home for Children at Greenville, Tennessee. Expenses of this trustee shall be provided for each official visit to the Home. He shall be paid one Hundred Dollars (\$100.00) per trip, not to exceed three trips a year. This board shall raise money for and relate its work with a Treasurer, Soliciting Members and Director, and Trustee.

VI. Christian Education Board - This board shall consist of five (5) members elected for a term of five (5) years and elected as so that one member be elected annually. It shall organize within itself a chairman, secretary and treasurer. It shall be the duty of this board to generally oversee the educational efforts of this Association. This would include but not be limited to (A) organize and conduct a State Bible Institute; (B) Establish Sunday Schools; (C) Promote Church Training Services (CTS) and generally oversee competitive events on the state and district levels.

VII. Publication Board - The Publication Board shall consist of five (5) members elected for a term of five (5) years and elected so that one member is elected annually. It shall be organized with an Editor, Associate Editor, Treasurer and three Associate Editors. It shall be the duty of this board to publish a regular news publication concerning the various ministries of Free Will Baptist in West Virginia and in the world. This board shall be limited to new purchases of \$300.00 per year without approval of the Association or the Executive Board.

VIII. Trustee Board - The duties of this board shall be to hold titles to all real property belonging to this body; the maintenance and upkeep of all such properties; the planning and supervision of all developments; and the expansion of these properties as directed by the West Virginia State Association.

It is agreed, in this connection, that the Board of Trustees shall at no time sell or encumber these properties by mortgage, lein, or otherwise without the express consent of this body given in regular session of this association.

The Board of Trustees is hereby authorized to receive, in behalf of and for the West Virginia State Association of Free Will Baptists, gifts, grants, monies, real estate, or other valuable assets.

The Board of Trustees shall act for and in behalf of the West Virginia State Association of Free Will Baptists in any and all transactions involving any of its properties, but shall do so strictly in accordance with instructions given by said State Association in regular or called session.

In as much as the work of the Publication Board may require an occasional replacement of certain mechanical items, costing more than the present set limit, it shall be the duty of the Board of Trustees to determine the validity of such a need, approve and implement or disapprove the requested purchase at their discretion.

#### Article No. 4 - Executive Board

The Executive Board shall be composed of one ordained minister from each Quarterly Conference that is in good standing with the State Association.

Section 2. If any member of the Executive Board is unable to attend, he must send a proxy in his place.

Section 3. At a regular scheduled session, the Saturday before the State Meeting, this board shall hear the reports of all standing boards and officers. It shall serve as a budget committee and make recommendations as deemed pertinent to State Association.

#### Article No 5 - Boards

The standing boards shall be the following, Foreign Mission, Home Mission, Children's Home Board, Christian Education Board, Publication Board and the Board of Trustees.

#### Article No. 6

Annual dues shall be Twenty Five Dollars (\$25.00) per each church belonging to Quarterly Meeting that is presented to the State Association.

Section 2. All ministers, deacons, and delegates shall pay Five Dollars (\$5.00) registration fee, with the exception of those ministers who are Sixty-Five years old, and older or disabled. One Dollar (\$1.00) to go to the church, Three Dollars (\$3.00) to go to the State Association, and One Dollar (\$1.00) to help pay the annual dues to the National Association.

Section 3. Any minister receiving a good standing card must pay his Five Dollars (\$5.00) registration fee. Each quarterly meeting is requested to collect this fee and send to State Association with their letter.

#### Article No. 7

The State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment.

Special meetings may be called by the Executive Board when extreme necessity demands provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting of this organization.

Section 2. Any Quarterly Meeting or church desiring the State Association meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

#### Article No. 8

This Constitution may be revised or changed at any regular session of the West Virginia State Association provided the change is presented in writing and stated one day before vote is taken..

## BY-LAWS

1. A portion of the scripture shall be read and prayer be offered at the beginning of each morning and afternoon session of the State Association and prayer shall be offered at the close of each session.

2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the program committee. When Moderator nor Assistant is present, the Clerk shall call the meeting to order and elect a Moderator-protem.

3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this organization to send a letter to it giving accurately as possible the information requested by the National Association.

4. Not over one deacon shall be appointed on any one committee. Except in case of emergency.

5. Only ordained ministers shall be allowed to moderate this meeting.

6. All Sunday School Conventions and State Women's Auxiliaries Convention report to the State Association and their report be received as information.

7. In case of controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.

8. All business except routine shall be brought by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be discussed unless by vote of this body.

9. No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

10. Each conference shall have its letter and finance report sent to the State Association Clerk one week before the State Association convenes.

11. Any member of body can appeal from the decision of the Moderator to the body and by a two thirds majority of all members present, thereon. This decision shall be sustained or rejected.

12. No one shall leave the body without the consent of the Moderator. Anyone deciding to speak shall arise and say "Brother Moderator" shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or think it will lead to discord or division.

13. This State Association shall correspond by messenger or otherwise with other religious bodies.

14. The same person or group of persons shall not serve on more than one standing board or committees as long as it can be supplied otherwise.

15. Not less than three (3) Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

16. No person shall be elected to any office without being present, except the Executive Board. (The member is recommended by the Quarterly Conference.)

17. The Moderator shall be elected at the close of each two year session on Saturday, and shall serve until his successor is elected at the same time the following two years.

18. No Ministers, Deacons or Delegates shall be permitted to vote that is a known Homosexual, Bi-Sexual or Lesbian in this State Association. The State Association will not retain any person or persons known to be as such.

19. The Officers of The State Association shall receive an honoraria as follows: Moderator - \$35.00. Assistant Moderator - \$15.00. Clerk - \$150.00.

20. The member of the General Board of The National Association shall receive \$250.00 when the National Association convenes East of the Mississippi River and \$350.00 West of the Mississippi River.

21. These By-Laws may be revised or changed as any regular session of the State Association provided that they be plainly written and stated one day before vote is taken.

## MINUTES

Minutes of the 42nd annual session of the West Virginia State Association of Free Will Baptists. held at the Bradley Free Will Baptist Church, Bradley, W.Va. June 12-13, 1987.

The session was opened Friday morning by the host pastor, Rev. Gerald Kelley, then turned over to Moderator, Rev. George Smith.

Report of Credential Committee, The Credential Committee recommend that the twenty one conferences reporting, by letter, proper finance and delegates, to be seated to conduct the business of this session.

That the Old Path Conference seeking admission into this State Association, be turned over to the Executive Board for further study, M&S. Carried.

Rev. Roger Tolliver gave report of state treasury and report will be on a separate page in the minute book.

Business Committee elected for the coming year are as follows; Rev. T.C. Morgan, Rev. F.A. Giles, Rev. Gerald Kelley, Rev. Jerry Castelle and Rev. Bill Blackshire.

Women's Auxiliary Report by Sisters Glenna Murphy and Alice Smith. Glenna Murphy made mention of her resignation as president of the Women's Auxiliary, and Myrtle Samms being elected as the new president. A rising vote of thanks was given to sister Glenna for her years of service as president of the Women's Auxiliary.

Rev. W.O. Tolliver, editor of state paper, reported that there was a balance in checking account of \$101.65 at the end of June 1, 1987. There were 39,158 copies of the paper mailed out this past year at a cost of \$3,328.45. The cost of printing papers \$2000.00. Cost of supplies \$137.94. bulk rate for stamps \$50.00. Received from state treasury \$5,442.00.

## FRIDAY AFTERNOON SESSION

Devotional - by Rev. Jerry Castelle

Moderator took charge of service and declared open for business.

These members were nominated and elected to serve on the program and placement committee. Rev. Arthur Frye, Rev. Randall Brogan, Deacon Rich Holstein, delates, J.R. Persinger, Dennis Cooper, Rick Moore and Bob Casto.

Rev. Carl Cooper the Promotional Director, reported that he had traveled a total of six thousand eight hundred and thirty three miles, including the march for missions. He has received \$5,169.39, paid out \$1,554.74 for milage and expenses. Leaving \$3,614.65 for wages.

Rev. John Richmond, Jr. reporting for the Christian Education Board, said that even though we had the deep snow during this past year competition, over 400 showed up at the Civic Center. The board is trying to set up a way to have the state competition every year the fourth weekend in April, at the Civic Center, in Charleston, W.Va.

Partial business committee report - by Rev. T.C. Morgan. We the business committee make the following recommendations to this State Association;

Item No. 1. That we prepare a letter with proper finance, and delegates to the National Association. M&S. Carried.

Item No. 2. That we accept the resignation of Rev. Joe Thomas, as a member of the Children's Home Board, M&S. Carried.

Item No. 3. That we accept the recommendation of the mission board, to extend support of the Wheeling work one year, until September of 1988. M&S. Carried.

Item No. 4. Item of business submitted that the moderator serve one year, and that he not be able to succeed himself. We recommend that the moderator stay as written in the Constitution. M&S to accept business committee recommendation. Carried.

Item No. 5. Item of business submitted that we bring to the floor, for discussion of making the promotional director a full time position. We the business committee recommend at the request of the Executive Board, that the position of Promotional Director be a part time one at this time. M&S was made to accept the business committees recommendation. Carried.

Executive Board Report by clerk Norwood Webb.

The Executive board met December 13, 1986, with the New Found Free Will Baptist Church, with pastor Rev. Tilden Blair and the Executive Board of the Guyan Valley conference, to discuss the removal of the New Found Church from the Guyan Valley conference, and the revoking of Rev. Tilden Blairs ordination paper.

Recommendations made by the state Executive Board at this meeting are as follows:

Item No. 1. That pastor and church try reconciliation with seven members by letter stating, time, place, and charges at this meeting.

Item No. 2. That moderator, clerk and a six man board from the Guyan Valley conference, investigate the charges of both parties.

Item No. 3. That the church and pastor be reinstated in conference before a letter can be given.

The Executive Board met again February 21, 1987, to hear reports of all standing boards and committees.

The clerk was asked by moderator to keep record of meeting and send copies to Executive Board members and the chairman of each board. Complied with.

Boards and Officers reporting at this meeting are as follows;

The Mission Board - Rev. Jim Varney, The Christian Education Board Rev. John Richmond, Jr., The Children's Home Board - Rev. Joe Thomas, The Women's Auxiliary President - Glenna Murphy, The Promotional Director - Rev. Carl Cooper, The Trustee Board - Rev. W.C. Combs and the State Paper - Rev. W.O. Tolliver.

Their reports will be given at the State Meeting in June.

The Executive Board met again June 6, 1987 at the Bradley church, to hear reports of all standing boards and officers, and to serve as a budget committee.

Report of state paper by editor, Rev. W.O. Tolliver, asking for an increase from 14% to 19% for the coming year.

Report of mission board by Rev. Jim Varney, the mission board is asking for a budget of 40% for the coming year.

Report of Children's Home Board by Rev. Joe Thomas, this board is asking an increase of from 2% to 5% for the coming year.

Report of Christian Education Board by Rev. John Richmond, Jr., this board did not make a budget request at this time.

Report of Promotional Director by Rev. Carl Cooper, the office of promotional director can use an increase in salary for the coming year.

Discussion. Discussion was held about having the Executive Board look into, paying the expenses of the moderator and the promotional director to the National Association.

(Note from the clerk) since this item was not discussed any further, perhaps, the Executive Board can consider it for next year.

Advance Report by Rev. George Smith, since there has not been much support for the state advance program, the Executive recommends that we discontinue this program. Rev. George Smith offered his resignation from this board, and said he would inform National of the same.

Others at this meeting were the General Board Member, The Trustee Board and the 1991 placement committee.

The Executive Board at this meeting proposed a budget and will submit it to the business committee at the state association for final consideration.

Items of business recommended for the approval of the West Virginia State Association.

Item No. 1. That we take the \$905.00 in the co-op promotion plan, and put it in the 1991 convention account. M&S. Passed.

Item No. 2. That since we dropped the 2% to co-op plan promotion, we add the 2% to the Christian Education Board. M&S to table until state association approves a budget, then will bring off table if necessary. Passed.

Item No. 3. Rev. Douglas Young offered a proposal for hiring a full time promotional director. M&S was made by the Executive Board to elect a three man committee to study this proposal, and report back to the Executive Board by 8:45 a.m. June 12, 1987. The three men elected were; Rev. Moss Craddock, Rev. Billy Samms and Rev. Martin L. Corbin. Passed.

Item No. 4. That the Executive Board submit a name for Promotional Director, Friday morning June 12, 1987. M&S. Passed.

Item No. 5. That since there is no real support or concern for the states advanced program, we discontinue the project and send what monies we have in our state treasury for this account, be forwarded on to National Advance Program. M&S. Passed.

The Executive Board met again June 12, 1987 at 8:45 a.m. to discuss the proposal of Rev. Douglas Young. The recommendation to hire a full time promotional director at this time was defeated. The Executive Board recommends that we accept the proposal to ask each church member to donate (Fifty Cents) per quarter, for the possibility of hiring a full time promotional man and also for the support of the 1991 National Convention in Charleston. M&S. Passed.

The Executive Board recommends that we stay with a part time promotional man until we are financially able to support a full time office. M&S. Passed.

Item No. 2. These three brethren names were submitted to the Executive Board, for consideration as Promotional Director, (Part Time) Rev. Billy Samms, Rev. Carl Cooper and Rev. Edwin Hughes. Rev. Billy Samms was nominated by the Executive Board and brought before the state association and elected as Promotional Director for the coming year.

(Note) A gift of \$500.00 was presented to Alice Smith by Rev. Jim Varney for her account on behalf of former Foreign Mission Director, Rolla Smith's wife who is deceased..

The Executive Board after further investigation of the Old Path Conference, seeking admission as a member of our state, recommend that we do not receive them into this State Association. M&S. Passed.

M&S was made to adjourn until tomorrows session. Passed

The Friday night service continued through a Camp Meeting Service, hosted by the Bradley Free Will Baptist Church. Singing by Squire Parsons and members of Bible College and the Bradley Church. (Note by clerk) It was one of the most rewarding services we have been in for sometime. Thank You.

## SATURDAY MORNING SESSION

9:00 a.m. Devotional by Don Bell

Moderator took service and declared state ready to conduct business.

Mission Board Report by Rev. Jim Varney. The Wheeling Mission project is being supported out of the co-op plan of giving. There were fourteen churches represented at the March for Mission, and fourteen souls were saved. The march for missions raised a little over \$3000.00. The Danville Mission Church is no longer there, Bro. Bobby Jude resigned, and the mission project had to be closed, due to lack of finance. The Lincoln Nebraska Mission has been a great success, it has become a self supporting church, with \$15,000.00 in their building fund, and is currently looking for a pastor. (Note) we have 458 ministers in our state association, is there anyone God is speaking to? Also if you have been supporting the mission work in Lincoln Nebraska, please don't quit giving, direct your support to another missionary of our state. Bro. Jim stated that there are 27 counties in our state without a Free Will Baptist Church. We need to thank God for these brethren who have labored in this mission project, and continue to pray for the brethren who will replace them.

Bro. Trymon Messer, National Home Mission, said the state of West Virginia gave \$48,000.00 to Home Missions this year.

Obituary Committee. Elected to serve for today only, were; Myrtle Samms, Mary Corbin and Rev. Dallas Adkins wife.

Sunday School Convention Report - by Assistant Vice President. The Sunday School Convention will be held September 26, 1987 at the Prince of Peace Church, Huntington, W.Va., where Rev. Ronn Scott is the pastor. The Theme this year is taken from Matt. 28:19, 20, Go, Teach and make disciples. Seminars to be held for Sunday School Superintendents, Sunday School Teachers, tools that teach and seminars for the youth.

Report of Nominating Committee - Rev. Luther Morgan. The nominating committee made the following recommendatin to this state association.

Nominated and elected to serve as the Credential committee for the coming year, are Rev. Ralph Dean, Rev. Carl Cooper, Rev. Daniel Kelly, Rev. W.C. Combs and Rev. Gerald Kelley.

Nominated and elected to serve as the Nominating Committee for the coming year, were, Rev. Billy Samms, Rev. Edwin Hughes and Rev. Roy Adkins.

Nominated and elected to serve as Audit Committee for the coming year, were,

Irvin Scarberry, Rev. Clyde Wood and Rev. Dallas Adkins.

Nominated and elected to serve on the Mission Board, were, three year members, Rev. George Smith and Dr. Lewis Hall.

Nominated and elected to serve the in the two year position left vacant by, Rev. Jim Varney was Rev. Roger E. Pauley.

Nominated and elected to fill the vacancies of Bro. Roger Perry and Bro. Harold Blankenship, were, Rev. Otis Hensley and Rev. Charles Donaldson, the one year members.

Nominated and elected to be the five year member of the Christian Education Board was, Rev. J..D. McCormick.

Nominated and elected to serve as five year member to the Publication Board, James Loggins.

Nominated and elected to serve as three year member to the Children's Home Board, Thomas Myers.

Nominated and elected to fulfill the one year vacancy, by Rev. Joe Thomas resignation, Rev. A.E. Persinger, and the Children's Home Board.

Nominated and elected to serve as three year member on the Obituary Committee, Glenna Murphy.

Nominated and elected to serve as Clerk for coming year, Norwood Webb.

Nominated and elected to serve as Parliamentarian for the coming year, Rev. Luther Morgan.

Nominated and elected to serve as Moderator next two years, Rev. Jim Varney.

Nominated and elected to serve as Assistant Moderator next two years, Rev. Arthur Frye.

The recommendations from the Conferences for their Executive Board member to the State Association were read and approved.
