CONSTITUTION OF THE WEST VIRGINIA STATE ASSOCIATION OF FREEWILL BAPTISTS

PREAMBLE

Having received salvation through faith in Jesus Christ, and having been baptized as an outward sign of our separation from the world, and realizing the necessity of being identified with and sharing the fellowship of other believers, have joined ourselves to a local visible church, we do ordain this Constitution to unify the work of Free Will Baptist in the State of West Virginia, and to devise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in cooperation with the various quarterly or yearly meetings comprising this State Association. May God bless our labor.

Article No. 1

Section 1. All ordained ministers and deacons belonging to member quarterly meetings and district Associations shall make up the standing delegates to this State Association. Each quarterly meeting shall be permitted to send three lay delegates to the State Association plus one delegate from each Church composing that quarterly meeting.

Section 2. The membership of the State Association shall consist of the quarterly meetings and district Association of yearly meetings from time to time upon approval shall become members of this body.

Section 3. Any minister, deacon or delegate voting in State Association, must be a member of a church in good standing with the quarterly meeting recommending from the State Association.

Section 4. This State Association shall be affiliated with the National Association of Free Will Baptists of the United States of America, and recognize the Treatise of faith and practice as our guidelines for denominational fellowship, as long as they remain an independent denomination.

Article No. 2 - Discipline

Section 1. The State Association shall have the right to settle questions of discipline, doctrine or usage that may properly come before it from time to time from any quarterly meetings or yearly meetings composing the said State Association or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association making the appeal then forwarded by mail or in person to State Association and Quarterly Meeting.

Section 2. No quarterly meeting shall license or ordain to preach or to serve as a deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained as a deacon in this State Association.

Section 3. No quarterly meeting shall license or ordain a woman to preach.

Section 4. No quarterly meeting shall be accepted or retained as a member that license or ordain women to preach.

Section 5. The Executive Board shall investigate any charges, after they have been properly presented to the quarterly meeting of which the grieved party or parties are a member. Any charges presented to this State Association Executive Board for consideration must be presented in writing and signed by the person or persons, making the charges.

Section 6. The Executive Board shall be paid the rate of fifteen cents (15 c) per mile from home to destination and return to home when traveling on State Association official business. The party or parties requesting the Executive Board to meet with them, shall be responsible to pay their expenses.

Article No. 3

Section 1. The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Parliamentarian. Each of whom shall be nominated from the floor, at each regular session, except the treasurer, who shall be elected for a three-year period, beginning with the 23rd session, and the Moderator, who will be elected for two year terms, and he can serve two terms for a period of four years, beginning with the 38th session.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and By-Laws are obeyed and respected, and to exercise all the right to vote.

The right to vote shall be given the Moderator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. It shall be the duty of the Assistant Moderator to assist the Moderator in any way he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed to the same rule as that affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings to publish in book form, minutes and distributed to various quarterly meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

1. Promotional Director - It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into membership of the West Virginia State Association. Also to promote the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Board or Department.

II. The Executive Committee - The Executive Board shall act as the State Association when State Association is not in session, action subject to approval by State Association.

III. Program Committee - That a program committee be elected on Friday morning to prepare the program for the coming year. This committee shall act as a placement committee and shall comply with the Constitution in making their choice for the Church, where the State Association is to be held. This committee shall consist of two ordained ministers, one deacon, and four members on duly seated delegates. This committee shall prepare to report to the State Association by 1:45P.M. Saturday afternoon.

IV. The Mission Board - This board is to be a eight member board, with expiration to be two at four years, two at three years, two at two years, and two at one year terms. It shall be the duty of this board to work to promote Foreign and Home Missions work throughout the State of West Virginia. This board shall cooperate with the Missions board of the National Association, and endeavor to raise funds for the Missions board and our denomination. This board shall arrange missionary conferences throughout the state work as it feels necessary. Also to promote new churches and conferences through the State of West Virginia where we do not have established Free Will Baptist Work.

V. Children's Home Board - This board shall maintain a relationship with the Free Will Baptist Home for Children at Greenville, Tennessee, and help provide for its support. The member of this board shall be a trustee of the Board of Trustees of the Free Will Baptist Home for Children at Greenville, Tennessee. Expenses of this trustee shall be provided for each official visit to the Home. He shall be paid one Hundred Dollars (\$100.00) per trip, not to exceed three trips a year. This board shall raise money for and relate its work with a Treasurer, Soliciting Members and Director, and Trustee.

VI. Christian Education Board - This board shall consist of five (5) members elected for a term of five (5) years and elected as so that one member be elected annually. It shall organize within itself a chairman, secretary and treasurer. It shall be the duty of this board to generally oversee the educational efforts of this Association. This would include but not be limited to (A) organize and conduct a State Bible Institute; (B) Establish Sunday Schools; (C) Promote Church Training Services (CTS) and generally oversee competitive events on the state and district levels.

VII. Publication Board - The Publication Board shall consist of five (5) members elected for a term of five (5) years and elected so that one member is elected annually. It shall be organized with an Editor, Associate Editor, Treasurer and three Associate Editors. It shall be the duty of this board to publish a regular news publication concerning the various ministries of Free Will Baptist in West Virginia and in the world. This board shall be limited to new purchases of \$300.00 per year without approval of the Association or the Executive Board.

VIII. Trustee Board - The duties of this board shall be to hold titles to all real property belonging to this body; the maintenance and upkeep of all such properties; the planning and supervision of all developments; and the expansion of these properties as directed by the West Virginia State Association.

It is agreed, in this connection, that the Board of Trustees shall at no time sell or encumber these properties by mortgage, lein, or otherwise without the express consent of this body given in regular session of this association.

The Board of Trustees is hereby authorized to receive, in behalf of and for the West Virginia State Association of Free Will Baptists, gifts, grants, monies, real estate, or other valuable assets.

The Board of Trustees shall act for and in behalf of the West Virginia State Association of Free Will Baptists in any and all transactions involving any of its properties, but shall do so strictly in accordance with instructions given by said State Association in regular or called session.

In as much as the work of the Publication Board may require an occasional replacement of certain mechanical items, costing more than the present set limit, it shall be the duty of the Board of Trustees to determine the validity of such a need, approve and implement or disapprove the requested purchase at their discretion.

Article No. 4 - Executive Board

The Executive Board shall be composed of one ordained minister from each Quarterly Conference that is in good standing with the State Association.

Section 2. If any member of the Executive Board is unable to attend, he must send a proxy in his place.

Section 3. At a regular scheduled session, 10:00 a.m. the Saturday before the State Meeting, this board shall hear the reports of all standing boards and officers. It shall serve as a budget committee and make recommendations as deemed pertinent to State Association.

Article No 5 - Boards

The standing boards shall be the following, Foreign Mission, Home Mission, Children's Home Board, Christian Education Board, Publication Board and the Board of Trustees.

Article No. 6

Annual dues shall be Twenty Five Dollars (\$25.00) per each church belonging to Quarterly Meeting that is presented to the State Association.

Section 2. All ministers, deacons, and delegates shall pay Five Dollars (\$5.00) registration fee, with the exception of those ministers who are Sixty-Five years old, and older or disabled. One Dollar (\$1.00) to go to the church, Three Dollars (\$3.00) to go to the State Association, and One Dollar (\$1.00) to help pay the annual dues to the National Association.

Section 3. Any minister receiving a good standing card must pay his Five Dollars (\$5.00) registration fee. Each quarterly meeting is requested to collect this fee and send to State Association with their letter.

Article No. 7

The State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment.

Special meetings may be called by the Executive Board when extreme necessity demands provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting of this organization.

Section 2. Any Quarterly Meeting or church desiring the State Association meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

Article No. 8

This Constitution may be revised or changed at any regular session of the West Virginia State Association provided the change is presented in writing and stated one day before vote is taken..

BY-LAWS

1. A portion of the scripture shall be read and prayer be offered at the beginning of each morning and afternoon session of the State Association and prayer shall be offered at the close of each session.

2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the program committee. When Moderator nor Assistant is present, the Clerk shall call the meeting to order and elect a Moderator-protem.

3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this organization to send a letter to it giving accurately as possible the information requested by the National Association.

4. Not over one deacon shall be appointed on any one committee. Except in case of emergency.

5. Only ordained ministers shall be allowed to moderate this meeting.

6. All Sunday School Conventions and State Women's Auxiliaries Convention report to the State Association and their report be received as information.

7. In case of controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.

8. All business except routine shall be brought by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be discussed unless by vote of this body.

9. No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

10. Each conference shall have its letter and finance report sent to the State Association Clerk one week before the State Association convenes.

11. Any member of body can appeal from the decision of the Moderator to the body and by a two thirds majority of all members present, thereon. This decision shall be sustained or rejected.

12. No one shall leave the body without the consent of the Moderator. Anyone deciding to speak shall arise and say "Brother Moderator" shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or think it will lead to discord or division.

13. This State Association shall correspond by messenger or otherwise with other religious bodies.

14. The same person or group of persons shall not serve on more than one standing board or committees as long as it can be supplied otherwise.

15. Not less than three (3) Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

16. No person shall be elected to any office without being present, except the Executive Board. (The member is recommended by the Quarterly Conference.)

17. The Moderator shall be elected at the close of each two year session on Saturday, and shall serve until his successor is elected at the same time the following two years.

18. No Ministers, Deacons or Delegates shall be permitted to vote that is a known Homosexual, Bi-Sexual or Lesbian in this State Association. The State Association will not retain any person or persons known to be as such.

19. The Officers of The State Association shall receive an honoraria as follows: Moderator - \$35.00. Assistant Moderator - \$15.00. Clerk - \$150.00.

20. The member of the General Board of The National Association shall receive \$250.00 when the National Association convenes East of the Mississippi River and \$350.00 West of the Mississippi River.

21. These By-Laws may be revised or changed at any regular session of the State Association provided that they be plainly written and stated one day before vote is taken.

The Executive Board met June 4, 1988 to hear the reports of all Boards and committees. Also to act as a budget committee to make recommendation to State Meeting.

Rev. Dallas Adkins gave report on Tri State Soul Winning Conference to be held July 5, 1988 at the Beckley Conference HQ. Building.

Rev. W.O. Tolliver, editor of state paper, \$69.14 at the end of June 1, 1988. There were 26708 copies of the paper mailed out this past year at a cost of \$2,261.25. The cost of printing paper \$1,500.00 Miscellaneous expenses 301.46. Bulk rate \$50.00.

Report of Bible College, Nashville, Tenn. Rev. James Earl Raper, reporting, that the Pass The Torch, gifts as of May 3, 1988 were \$6616 and their goal by August this year is \$13,219.99, so we need to raise an additional \$6616.07 by August this year.

Rev. Billy Samms the State Promotional Director, reported that he had attended nineteen of our conferences, met with the Mission Board five times, had special meetings with two of our ministers groups, met twice with the Christian Education Board, went to Leadership Conference in Nashville, Tenn., attended the Youth Competition at the Civic Center in Charleston, WV., challenged our churches and conferences to support all phases of our work, encouraged the 50c per member from our churches for the support of the 1991 National Convention in Charleston, WV., ask for support of Rev. Roy Adkins Book Store for our Sunday School Literature or any other Literature we need. I have traveled about 7400 miles and received \$4800.00 for expenses.

Rev. John Richmond, Jr. reporting for the Christian Education Board, said that it cost about \$2500.00 to hold the Youth Competition at the Charleston Civic Center this year, but about \$1900.00 of that came in through registration. Bro. John, discussed the possibility of using our pastors and teachers who are qualified to teach in a Bible Institute.

Beulah Morgan, gave the obituary report, there were 110 deceased since last year, reported on letters. The State Association stood for moment of silent prayer, closed by Rev. Carl Vallance. Obituary report will be on another page.

Rev. Jim Sturgill, spoke for Foreign Missions, he said that many of our Foreign Missionaries are in the Red with their accounts, and about \$62,000.00 was given this year by West Virginia. Any account that goes past \$8,000.00 in the red, the missionaries are sent back home to raise finances for their accounts.

Rev. Roy Thomas, reporting for Home Missions, said that Lincoln Nebraska, has a full time pastor. The State of West Virginia gave \$29,102.81 this past year. This past year several new missionaries were sent to the field, and several became self supporting. At present we have 30 Free Will Baptist Churches located south of the border. We need churches who for \$225 per month can fully support a pastor in Mexico. The Department led 31 Evangelism Conferences this year, from California to North Carolina and from Massachusetts to Florida. More than one third of our pastors attended at least one of these conferences.

Partial business committee report - by Rev. F. A. Giles. We the business committee make the following recommendations to this State Association.

Item No. 1. That the Mission Board of the State Association, be increased from a six (6) member to an eight (8) member board, with expiration dates to be, two at four years, two at three years, two at two years and two at one year. M&S to table because of constitutional change. Passed.

Item No. 2. That the State Association prepare a letter with finance, and delegates to the National Association. M&S. Passed.

Item No. 3. That the Mission Board as a board, and not as individuals, sign for a loan not to exceed \$30,000.00 for the Wheeling Building fund. Dr. Lewis Hall has the approval of a \$30,000.00 note from the bank of Mingo, at 12% for 48 months, at \$754.97 per month. M&S to accept this item of business, 56 for, none opposed. Passed.

Item No. 4. That the State Association give our treasurer, permission to purchase a computer, capable of doing what is necessary to carry out his duties as treasurer. A down payment of \$1500.00 be paid with monthly installments to finish paying for the computer. M&S. Passed.

Item No. 5. That we delete the part of paragraph; (for the hiring of a full time Promotional Director), item no .5, page nine of 1987 minutes, and bring back to floor to read, The Executive Board recommends that we accept the proposal to ask each church member to donate (Fifty Cents) per quarter, for the support of the 1991 National Convention to be held in Charleston. M&S. Passed.

Item No. 6. That we add to Article No. 4. - Executive Board, section three, a set time to meet, the business committee recommends the time at 10:00 a.m. M&S. Passed. To table. Carried.

Item No. 7. That we take off table item No. 7, page 12 of 1987 minutes, that was laid on table last year. That we delete paragraph three of article three of Constitution, which states, the Promotional Director shall be employed by the Executive Board subject to approval by the State Association, when in session. M&S to delete, passed by a 31 to 9 vote.

Moderator asked Rev. F. A. Giles to offer prayer for the family of Bro. Creig Scott Erwin, his Father passed away.

M&S was made to adjourn from todays session and a prayer of dismissal to be offered. Passed.

Review bookkeeping procedures of the State Treasurer and make suggestions.

Review all vendor invoices for accuracy and payment.

File the completed audit of all checks, statements, stubs, bills paid, and general information in a permanent storage box for future references.

Review the check register ledger sheets for accuracy.

Submit a written report of the findings of this audit to the State Moderator and other State Officers.

Summary of audit covering the period from 7-1-82 through 12-31-85.
Rev. William Smith was treasurer at this time.

All deposits accounted for on bank statements.

All checks written appear to be for the legitimate expenditures of the State Association.

No unethical bookkeeping practices discovered.

Bank statements and cancelled checks for the period of 2-1-85 through 12-31-85 were not present for me to review. However, I checked stubs, check register, and previous audit marks during this period and feel that these records must have been misplaced. From what information I had for this period, I see no reason to suspect any intentional withholding of these records. If these records are found in the near future, I will be glad to review them.

I suggest that in many instances the State Treasurer failed to place on checks or check stubs sufficient information needed to verify expenses of State Officer's travel.

A closer review by the State Treasure of Phone charges.

Payment of Vendor's invoices on time to avoid interest penalty.

The auditor comments that he felt William Smith did a commendable job as our State Treasurer during his term of office.
