# **CONSTITUTION OF THE WEST VIRGINIA STATE ASSOCIATION OF FREEWILL BAPTISTS PREAMBLE**

Having received salvation through faith in Jesus Christ, and having been baptized as an outward sign of our separation from the world, and realizing the necessity of being identified with and sharing the fellowship of other believers, have joined ourselves to a local visible church, we do ordain this Constitution to unify the work of Free Will Baptist in the State of West Virginia, and to devise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in cooperation with the various quarterly or yearly meetings comprising this State Association. May God bless our labor.

## **Article No. 1**

Section 1. All ordained ministers and deacons belonging to member quarterly meetings and district Associations shall make up the standing delegates to this State Association. Each quarterly meeting shall be permitted to send three lay delegates to the State Association plus one delegate from each Church composing that quarterly meeting.

Section 2. The membership of the State Association shall consist of the quarterly meetings and district Association of yearly meetings from time to time upon approval shall become members of this body.

Section 3. Any minister, deacon or delegate voting in State Association, must be a member of a church in good standing with the quarterly meeting recommending from the State Association.

Section 4. This State Association shall be affiliated with the National Association of Free Will Baptists of the United States of America, and recognize the Treatise of faith and practice as our guidelines for denominational fellowship, as long as they remain an independent denomination.

## **Article No. 2 - Discipline**

Section 1. The State Association shall have the right to settle questions of discipline, doctrine or usage that may properly come before it from time to time from any quarterly meetings or yearly meetings composing the said State Association or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association making the appeal then forwarded by mail or in person to State Association and Quarterly Meeting.

Section 2. No quarterly meeting shall license or ordain to preach or to serve as a deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, or ordained as a deacon in this State Association.

Section 3. No quarterly meeting shall license or ordain a woman to preach.



## Constitution Continued

Section 4. No quarterly meeting shall be accepted or retained as a member that license or ordain women to preach.

Section 5. The Executive Board shall investigate any charges, after they have been properly presented to the quarterly meeting of which the grieved party or parties are a member. Any charges presented to this State Association Executive Board for consideration must be presented in writing and signed by the person or persons, making the charges.

Section 6. The Executive Board shall be paid the rate of fifteen cents (15 c) per mile from home to destination and return to home when traveling on State Association official business. The party or parties requesting the Executive Board to meet with them, shall be responsible to pay their expenses.

## Article No. 3

Section 1. The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Parliamentarian. Each of whom shall be nominated from the floor, at each regular session, except the treasurer, who shall be elected for a three-year period, beginning with the 23rd session, and the Moderator, who will be elected for two year terms, and he can serve two terms for a period of four years, beginning with the 38th session.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see to it that all the Constitution and By-Laws are obeyed and respected, and to exercise all the right to vote.

The right to vote shall be given the Moderator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. It shall be the duty of the Assistant Moderator to assist the Moderator in any way he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed to the same rule as that affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings to publish in book form, minutes and distributed to various quarterly meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

1. Promotional Director - It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into membership of the West Virginia State Association. Also to promote the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. This office shall be supported by the Executive Board or Department.



## Constitution Continued

### Article No. 7

The State Association shall hold its regular meetings annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment.

Special meetings may be called by the Executive Board when extreme necessity demands provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting of this organization.

Section 2. Any Quarterly Meeting or church desiring the State Association meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

### Article No. 8

This Constitution may be revised or changed at any regular session of the West Virginia State Association provided the change is presented in writing and stated one day before vote is taken..

## BY-LAWS

1. A portion of the scripture shall be read and prayer be offered at the beginning of each morning and afternoon session of the State Association and prayer shall be offered at the close of each session.

2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the program committee. When Moderator nor Assistant is present, the Clerk shall call the meeting to order and elect a Moderator-protem.

3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this organization to send a letter to it giving accurately as possible the information requested by the National Association.

4. Not over one deacon shall be appointed on any one committee. Except in case of emergency.

5. Only ordained ministers shall be allowed to moderate this meeting.

6. All Sunday School Conventions and State Women's Auxiliaries Convention report to the State Association and their report be received as information.

7. In case of controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.

8. All business except routine shall be brought by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business may be discussed unless by vote of this body.

9. No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

10. Each conference shall have its letter and finance report sent to the State Association Clerk one week before the State Association convenes.

11. Any member of body can appeal from the decision of the Moderator to the body and by a two thirds majority of all members present, thereon. This decision shall be sustained or rejected.

12. No one shall leave the body without the consent of the Moderator. Anyone deciding to speak shall arise and say "Brother Moderator" shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or think it will lead to discord or division.

13. This State Association shall correspond by messenger or otherwise with other religious bodies.

14. The same person or group of persons shall not serve on more than one standing board or committees as long as it can be supplied otherwise.



### By-Laws Continued

15. Not less than three (3) Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

16. No person shall be elected to any office without being present, except the Executive Board. (The member is recommended by the Quarterly Conference.)

17. The Moderator shall be elected at the close of each two year session on Saturday, and shall serve until his successor is elected at the same time the following two years.

18. No Ministers, Deacons or Delegates shall be permitted to vote that is a known Homosexual, Bi-Sexual or Lesbian in this State Association. The State Association will not retain any person or persons known to be as such.

19. The Officers of The State Association shall receive an honoraria as follows: Moderator - \$35.00. Assistant Moderator - \$15.00. Clerk - \$150.00.

20. The member of the General Board of The National Association, the Moderator or Assistant Moderator of the State Association shall receive \$250.00 when the National Association convenes East of the Mississippi River and \$350.00 West of the Mississippi River.

21. These By-Laws may be revised or changed at any regular session of the State Association provided that they be plainly written and stated one day before vote is taken.

## MINUTES

Minutes of the 44th annual session of the West Virginia State Association of Free Will Baptists. Held at the Ward Road Free Will Baptist Church, at Canvas, WV (Greenbrier Nicholas Conference) June 9-10, 1989.

The session was opened Friday morning by the host pastor, Rev. Charles Donaldson with song, scripture the 23rd Psalm and prayer, led by Rev. A. E. Persinger, then turned over to Moderator, Rev. Jim Varney.

The Moderator read scripture from Revelation 3:7,13 and challenged congregation to fall in line

Report of Credential Committee: We the credential committee recommend, that we accept the twenty conferences reporting by letter, proper finance and delegates, and the Christian Fellowship conference letter not yet in, pending their letter, to be seated by the Moderator to conduct the business of the day. M&S. Carried.

Rev. Roger Tolliver gave treasury report and said he bought a print out computer for the State Treasurers office. He also recommends the churches continue to give through the Co op plan of giving. The 1991 National Convention money is coming in good and we were up \$12,000 in our giving this year over 1987. The financial report will be on or listed in separate pages.

Report of State Association Audit Committee: The audit committee met to audit the Treasurer's books on 5/11/89. We generally feel the accounts to be in order. One check (#1341) was not entered into the General ledger but was properly issued and cleared the bank. Another check (#1444) had a discrepancy of \$1.95 from the check and ledger entry. M&S was made to accept the report of audit committee. Carried.

The Moderator was given the right to make any needful changes in the program.

Business Committee elected for this session are as follows; Rev. Larry Cooper, Rev. A. E. Persinger, Rev. Roger Pauley, Rev. Tom Cox and Rev. Ottis Hensley.

Program and Placement Committee elected for this session are as follows; Rev. G.W. Mounts, Rev. Floyd Dove, Deacon Marvin Holly, Delegates, Bob Casto Arlene Riffe, Lady Marcum and Candy Holstein.

Recognition of visitors by moderator; A. L. Looper, Free Will Baptist Home for children, Jim Vallance, National Master's Men Department, Dave Franks, our foreign missionary from Brazil, Jim and Vicki Sturgill, Foreign Missionaries, Don Sexton, Foreign Missions Department, Bill Fulchner, Southeastern Bible College, Roy and Pat Thomas, Home Mission Department, Guy Owens, Southeastern Bible College and Bob Shockey, Nashville Bible College, and last, the wives who travel with these brethren.



Women's Auxiliary Report was given by Rev. Gerald Kelley on behalf of Sister Susie, who was unable to attend today's meeting. Their theme, Do it again Lord, "Through me." About 140 young ladies attended the Mt Tabor retreat. Their goal for the 1991 project is \$15,000. Myrtle Samms was given thanks and appreciation as the outgoing president.

M&S was made from floor to take item No. 10 of business that was tabled in last year's session, that reads, we insert in By-Laws no. 20, after General Board, the Moderator or the Assistant Moderator receive the same as the General board member, off table and act upon it today. Taken from table, acted on and passed.

Jim Vallance reporting for Master's Men; The Master's Men Conference, gathered for the 10th year at Camp Linden, in Tennessee to explore the theme "Continue in the Faith." Through the Master's Hands Projects, the Master's Men help construct at least 20 churches, with a result in savings of nearly \$400,000. Lifemembership increased to 274 laymen, pastors and missionaries with 25 Lifefriends among our women. 36 additional men are making monthly payments to attain the \$100 deposit fee. The Endowment Trust Fund held by the Free Will Baptists Foundation now totals over \$30,000. Special memorial gifts, wills, paid up insurance policies, real estate, stocks and bonds may be given to this Endowment Fund. For more information, call or write Jim Vallance, Nashville Tennessee.

## FRIDAY AFTERNOON SESSION

Singing by Rev. J. D. McCormick and the Disciples Quartet

Moderator Rev. Jim Varney called session back to order to continue business.

State Paper Report by Rev. W.O. Tolliver. Editor of State paper was chosen for roll call sunday report to National. We had 16.000 this year in Roll Call Sunday. The paper purchased and typed 5000 new address cards, updated mailing list, improved mailing rates, support increased, mailed out 26.692 copies, paid out \$4,077,59 with balance in treasury of \$4,963,55. Good harmony on the board. Rev. W.O. Tolliver offered his resignation from the State Paper as Editor. M&S was made to accept his resignation. Carried

Executive Board Report by clerk: The Executive Board met for the information meeting in February 1989. There was no business by the Executive Board, and the boards and officers reports will be given at the State Meeting in June.

The Executive board met again on June 3, 1989 at a scheduled meeting, to hear the reports of all boards and officers and to serve as a budget committee. Reports were given by Rev. Carl Vallance, General Board Member, Rev. Billy Samms, State Promotional Director, Treasurer, audit committee, missions board, christian education board and state paper.

There were two budgets proposed to the Executive Board and this is the one from the treasurer we will recommend to the business committee at the State Meeting.

Promotional Director's Report by Rev. Billy Samms. Visited seven conferences before I became ill, four after surgery, held two revivals in conferences, taught one seminar, met with the mission board several times, visited the Wheeling church, met with C.T.S. Board and attended the C.T.S. competition. Traveled 7000 miles. Bro. Billy's report was accepted with a rising vote of thanks.

Children's Home Report by A.L.Looper. The Children's Home celebrated their Golden Anniversary in child care May 13, 1989. At present time there are eighteen children at the home. Have cared for seventy since June 1988. In 1987 West Virginia gave 14,718,00 and in 1988 \$11,484,00 to the children's home. Paid insurance on \$6,000,000,00 worth of buildings.

Report of Christian Education Board by Rev. John Richmond, Jr. The C.E.D. had a great Sunday School Convention and Bible, music and arts festival, held at the Bradley Free Will Baptists Church. The movement back to the church is because the civic center would not guarantee the Little Theater. I thank you for your support both prayers and finance the past several years. I thank you for the confidence you placed in me to the work for the Christian Education Board.

With regret I offer my resignation from the Christioan Education Board, I'll be leaving for North Carolina looking for a job. M&S to accept his resignation. Passed.

The next Sunday School Convention will be held September 23rd, 1989 at the Central Free Will Baptists Church, Huntington, WV. I request that the C.E.B. budget remain at 15%.



Randall House Publication - Delbert Wood. In the winter quarter of 1989 we will be making several curriculum changes. New materials will be added to our four children's levels. The Nursery, Preschool, Primary and Junior levels will receive additions to their visual aids and teacher's quarterlies.

The Teen and High Teen quarterlies will be changed completely. They will be placed on their own six year cycle. The Teen quarterly will become Turning point. The High Teen quarterly will become Horizon.

The young adult and adult quarterlies will be placed on a new nine-year cycle of Bible study. The young adult quarterly will receive a new name, The Bible Challenge.
