CONSTITUTION OF THE WEST VIRGINIA STATE ASSOCIATION OF FREE WILL BAPTISTS PREAMBLE

Having received salvation through faith in Christ Jesus, and having been baptized as an outward sign of our separation from the world, and realizing the necessity of being identified with and sharing the fellowship of other believers, have joined ourselves to a local visible church, we do ordain this Constitution to unify the work of Free Will Baptist in the State of West Virginia, and to devise and execute measures for the extension of the Kingdom of Christ and for the salvation of souls in cooperation with various quarterly or yearly meetings comprising this State Association. May God bless our labor.

Article No. 1

Section 1. All ordained ministers and deacons belonging to member quarterly meetings and district Associations shall make up the standing delegates to this State Association. Each quarterly meeting shall be permitted to send three lay delegates to the State Association plus one delegate from each church composing that quarterly meeting.

Section 2. The membership of the State Association shall consist of the quarterly meetings and district Association of yearly meetings from time to time upon approval shall become members of this body.

Section 3. Any minister, deacon or delegate voting in State Association must be a member of a church in good standing with the quarterly meeting recommending them to the State Association.

Section 4. This State Association shall be affiliated with the National Association of Free Will Baptists of the United States of America, and recognize the Treatise of faith and practice as our guidelines for denominational fellowship, as long as they remain an independent denomination.

Article No. 2 - Discipline

Section 1. The State Association shall have the right to settle questions of discipline, doctrine or usage that may properly come before it from time to time from any quarterly meetings or yearly meetings composing the said State Association or act upon any appeal that may be made by any of the bodies that belong to the State Association. The said appeal shall have been written and signed by the Association making the appeal then forwarded by mail or in person to State Association and Quarterly Meeting.

Section 2. No quarterly meeting shall license or ordain to preach or serve as a deacon any man having two living wives. No man having married a divorced woman shall be licensed or ordained to preach, ordained as a deacon in this State Association.

Section 3. No quarterly meeting shall license or ordain a woman to preach.

Section 4. No quarterly meeting shall be accepted or retained as a member that license or ordain women to preach.

Section 5. The Executive Board shall investigate any charges, after they have been properly presented to the quarterly meeting of which the grieved party or parties are a member. Any charges presented to this State Association Executive Board for consideration must be presented in writing and signed by the person or persons, making the charges.

Section 6. The Executive Board shall be paid the rate of fifteen cents (15¢) per mile from home to destination and return to home when traveling on State Association official business. The party or parties requesting the Executive Board to meet with them, shall be responsible to pay their expenses.

Article No. 3

Section 1. The officers of the State Association shall be a Moderator and Assistant Moderator, Clerk, Treasurer and Parliamentary. Each of whom shall be nominated from the floor, at each regular session, except the treasurer, who shall be elected for a three year period, beginning with the 23rd session, and the Moderator, who will be elected for two year terms, and he can serve two terms for a period of four years, beginning with the 38th session.

Election shall be determined by a majority vote. Those persons and officers thus elected shall hold their offices until their successors are elected and installed.

Section 2. It shall be the duty of the Moderator to preside at all meetings to see that all the Constitution and By-Laws are obeyed and respected, and to exercise all the right to vote.

The right to vote shall be given the Moderator only in case of a tie. He shall be allowed to speak on any subject provided the assistant is in the chair. It shall be the duty of the Assistant Moderator to assist the Moderator in any way he can in the discharge of his duty. This duty shall not be construed to abridge his right to vote when in the chair, in which he shall be governed to the same rule as that affecting the Moderator.

It shall be the duty of the Clerk to keep a complete record of all meetings to publish in book form, minutes and distributed to various quarterly meetings composing this State Association. All expenses of such records and printing are to be defrayed by the treasury.

It shall be the duty of the Treasurer to hold and keep all such money as may come into the State Association and disburse it only at the direction of proper authorities. He shall make a bond of not less than all funds coming into his possession. An Assistant Treasurer will be elected to act in any absence of the Treasurer, or act of emergency.

I. Promotional Director - It shall be the duty of the Promotional Director to strive for the enlistment of new conferences and associations into membership of the West Virginia State Association. To promote the works of this State Association first and the work of Free Will Baptist in new fields. The office of Promotional Director shall not be used to settle disputes between brethren and conferences. The office of Promotional Director shall be filled, supported and governed by the Executive Committee of the State Association.

II. The Executive Board - The Executive Board shall act as the State Association when State Association is not in session, action subject to approval by State Association.

III. Program Committee - That a program committee be elected on Friday morning to prepare the program for the coming year. This committee shall act as a placement committee and shall comply with the Constitution in making their choice for the Church, where the State Association is to be held. This committee shall consist of two ordained ministers, one deacon, and four members on duly seated delegates. This committee shall prepare to report to the State Association by 1:45 P.M. Saturday afternoon.

IV. The Mission Board - This board is to be a eight member board, with expiration to be two at four years, two at three years, two at two years, and two at one year terms. It shall be the duty of this board to work to promote Foreign and Home Missions work throughout the State of West Virginia. This missions board shall cooperate with the National Association, and endeavor to raise funds for the Missions board and our denomination. This board shall arrange missionary conferences throughout the state work as it feels necessary. Also to promote new churches and conferences through the State of West Virginia where we do not have established Free Will Baptist Work.

V. Christian Education Board - This board shall consist of five (5) members elected for a term of five (5) years and elected as so that one member be elected annually. It shall organize within itself a chairman, secretary and treasurer. It shall be the duty of this board to generally oversee the educational efforts of this Association. This would include but not be limited to (A) organize and conduct a State Bible Institute; (B) Establish Sunday Schools; (C) Promote Church Training Services (CTS) and generally oversee competitive events on the state and district levels.

VI. Publication Board - The Publication Board shall consist of five (5) members elected for a term of five (5) years and elected so that one member is elected annually. It shall be organized with an Editor, Associate Editor, Treasurer and three Associate Editors. It shall be the duty of this board to publish a regular news publication concerning the various ministries of Free Will Baptist in West Virginia and in the world. Also that the news publication include a News Letter Format. This board shall be limited to new purchases of \$300.00 per year without approval of the Association or the Executive Board.

VII. Trustee Board - The duties of this board shall be to hold titles to all real property belonging to this body; the maintenance and upkeep of all such properties; the planning and supervision of all developments; and the expansion of these properties as directed by the West Virginia State Association.

It is agreed, in this connection, that the Board of Trustees shall at no time sell or encumber these properties by mortgage, lein, or otherwise without the express consent of this body given in regular session of this Association.

The Board of Trustees is hereby authorized to receive, in behalf of and for the West Virginia State Association of Free Will Baptists, gifts, grants, monies, real estate, or other valuable assets.

The Board of Trustees shall act for and in behalf of the West Virginia State Association of Free Will Baptists in any and all transactions involving any of it's properties, but shall do so strictly in accordance with instructions given by said State Association in regular or called session.

In as much as the Publication Board may require an ocaasional replacement of certain mechanical items, costing more than the present set limit, it shall be the duty of the Board of Trustees to determine the validity of such a need, approve and implement or disapprove the requested purchase at their discretion.

VIII. Executive Committee - This committee would be made up of the Moderator, Treasurer, Chairman of Missions Board, Christian Education Board and Publication Board. The duties of this board would be Executive and Promotional.

Article No. 4 - Executive Board

The Executive Board shall be composed of one ordained minister from each Quarterly Conference that is in good standing with the State Association.

Section 2. If any member of the Executive Board is unable to attend, he must send a proxy in his place.

Section 3. At a regular scheduled session, 10:00 a.m. the Saturday before the State Meeting, this board shall hear the reports of all standing boards and officers. It shall serve as a budget committee and make recommendations as deemed pertinent to State Association.

Article No 5 - Boards

The standing boards shall be the following, Foreign Mission, Home Mission, Christian Education Board, Publication Board and the Board of Trustees.

Article No. 6

Annual dues shall be Twenty Five Dollars (\$25.00) per each church belonging to Quarterly Meeting that is presented to the State Association.

Section 2. All ministers, deacons, and delegates shall pay Five Dollars (\$5.00) registration fee, with the exception of those ministers who are Sixty-Five years old, and older or disabled. One Dollar (\$1.00) to go to the church, Three Dollars (\$3.00) to go to the State Association, and One Dollar (\$1.00) to help pay the annual dues to the National Association.

Section 3. Any minister receiving a good standing card must pay his Five Dollars (\$5.00) registration fee. Each quarterly meeting is requested to collect this fee and send to State Association with their letter.

Article No. 7

The State Association shall hold its regular meeting annually on Friday and Saturday before the second Sunday in June at a place and date fixed by the regular session and made known before adjournment.

Special meetings may be called by the Executive Board when extreme necessity demands provided that the clerk of each Quarterly Meeting or Yearly Meeting has been properly notified fifteen days before the date of the meeting of this organization.

Section 2. Any Quarterly Meeting or church desiring the State Association to meet with the body shall present in writing the seating capacity, the facilities for feeding, sleeping and parking.

Article No. 8

This Constitution may be revised or changed at any regular session of the West Virginia State Association provided the change is presented in writing and stated one day before vote is taken.

BY-LAWS

1. A portion of the scripture shall be read and prayer be offered at the beginning of each morning and afternoon session of the State Association and prayer shall be offered at the close of each session.

2. The Moderator or Assistant Moderator shall call the meeting to order at the hour designated by the program committee. When Moderator nor Assistant is present, the Clerk shall call the meeting to order and elect a Moderator-protem.

3. It shall be the duty of the Quarterly Meeting or Yearly Meeting or Association so composing this organization to send a letter to it giving accurately as possible the information requested by the National Association.

4. Not over one deacon shall be appointed on any one committee. Except in case of emergency.

5. Only ordained ministers shall be allowed to moderate this meeting.

6. All Sunday School Conventions and State Women's Auxiliaries Convention report to the State Association and their report be received as information.

7. In case of controversy regarding parliamentary procedure, Robert's Rules of Order shall be considered as final authority.

8. All business except routine shall be brought by committee but should the committee refuse or fail to present to this body any business given it by any member of this State Association, then such business cannot be discussed unless by vote of this body.

9. No one shall speak for more than five minutes or more than twice on the same subject without the consent of the Moderator.

10. Each conference shall have its letter and finance report sent to the State Association Clerk on or before May 24th, that the Executive Board may examine them the week prior to the State Meeting.

11. Any member of this body can appeal from the decision of the Moderator to the body and by a two thirds majority of all members present, thereon. This decision shall be sustained or rejected.

12. No one shall leave the body without the consent of the Moderator. Anyone deciding to speak shall arise and say "Brother Moderator" shall not speak further until he or she is recognized by the Moderator. The Moderator shall stop all discussion when not carried on in a Christian Spirit, or think it will lead to discord or division.

13. This State Association shall correspond by messenger or otherwise with other religious bodies.

14. The same person or group of persons shall not serve on more than one standing board or committee as long as it can be supplied otherwise.

15. Not less than three (3) Gospel Sermons shall be preached at any one session of the West Virginia State Association of Free Will Baptists.

16. No person shall be elected to any office without being present, except the Executive Board. (The member is recommended by the Quarterly Conference.)

17. The Moderator shall be elected at the close of each two year session on Saturday, and shall serve until his successor is elected at the same time the following two years.

18. No Ministers, Deacons or Delegates shall be permitted to vote that is a known Homosexual, Bi-Sexual or Lesbian in this State Association. The State Association will not retain any persons known to be as such.

19. The Officers of The State Association shall receive an honoraria as follows: Moderator - \$50.00. Assistant Moderator - \$25.00. Clerk - \$200.00.

20. The member of the General Board of the National Association, the Moderator or the Assistant Moderator of the State Association shall receive \$250.00 when the National Association convenes East of the Mississippi River and \$350.00 West of the Mississippi River.

21. These By-Laws may be changed or revised at any regular session of the State Association provided that they be plainly written and stated one day before vote is taken.

We praise the Lord for the work of the Free Will Baptist in West Virginia, with the accomplishments in the past year. It does not seem like a year has past since we met at Parsley Bottom and you gave us your approval on what we had planned to do.

You approved The Key 90 Program to be a legacy to Co-Op, and also the purchase of the property in Eastern Panhandle. Our aim was to have a missionary on the field for the State meeting here at Bradley in 1991. That has been accomplished, and Rev. Russell Wright is already well on his way to starting that work and winning many souls for Christ.

The March for Missions Revival was a tremendous success with 12,000 dollars in money raised, and 14 souls saved, with 5 rededications, all to the Praise of God.

The Beckley area had a Fall Festival in October, 1990 to raise money for Missions projects and followed that up with a Miracle in the Making Project in February, with these joint works over 5,000 dollars was raised. Thanks to all of those involved.

As you know, our goal last year was to build 3 Churches in the Eastern Panhandle and establish a conference for quarterly meetings for that area. That goal is more in sight than ever before.

Foreign Missions

On the foreign field, there are some tremendous needs, as well as some great news. First of all the WV quota was 5% behind after the first quarter of this year, with 85,000 dollars goal, our total giving to foreign missions was close to 20,000 dollars or as stated before 5% off.

Also the missionary's to Uruguay, Paul and Amy Robinson have had a terrible amount of medical bills, and their account is now a total of 25,000 dollars in the red. Sis. Amy has had 2 pacemakers put in and Bro. Paul fell and broke his ankle, medical bills total 17,000 dollars.

Ron and Linda Calloway's account is 10,000 dollars in the Red. And the Dave Franks need 95,000 dollars to pay for land, with 50,000 dollars already pledged. So as you see we have a great need.

Now for some good news::: The property in the Eastern Panhandle is paid off:: I SAID PAID OFF::: Contrary to what the devil said at the last State meeting, YOU DID IT:::

Again some Great News::: There is news of a Jewish Convert in Montevideo, Uruguay:: God is still in the business of saving souls.

PUBLICATION BOARD REPORT

1991 PUBLICATION BOARD REPORT TO EXECUTIVE BOARD MEETING IN BRADLEY JUNE 1, 1991 AND OUR STATE ASSOCIATION MEETING JUNE 7-8, 1991 AT BRADLEY FWBC

You are aware that we the Publication Board during the year proceeded to purge the mailing list of the State Paper. At the beginning of the period we were mailing out approximately 4,450 copies of the paper at the present time we are mailing out 2,000 copies, and have mailed over 18,000 this year.

The paper is now a MONTHLY Publication as requested by the State Moderator and the cost has changed during the year. Before the format change and reduction in the mailing list the cost was running on the average of \$606.00 every other month for a yearly average of \$3640.00. With the situation as it is now our costs is averageing \$700.00 per month with a yearly average of \$8400.00 for a difference of approximately \$4760.00 yearly.

At the present monthly income into the Publication Board Account of an average of \$300.00 per month from Co-Op -- Key 90 this board is running a deficit of approximately \$400.00 per month or \$4800.00 yearly. This is the present situation and our cost should remain steady at this level through the coming year.

We the board would like to present an order of business appealing the the State Association for a reinstatement of enough finances to be restored back to our budget allocation for the coming year so that we may continue to publish our State Paper in a timely manner.

The State Association voted to allow this board to purchase a Laser Jet Printer at the 1990 Association Meeting; however we have not proceeded in this matter as yet due to the change in our financial situation.

Also a matter for the consideration of our State is the fact that in the past 9 months this board has only received 47 contributing articles to use in the paper this is only an average of 5 articles per month and to be efficient we need at least 20 articles.

Please I encourage you to send articles that would be of interest to all our state readers and readers in other states and several Missionaries in foreign countries.
