7. Ministers Transferring/Exchanging Credentials with the Western Conference:

Rev. Scott Broadway from The Eastern Conference (before surrendering his credentials)

Rev. Todd Sutton (from the Central Conference)

8. License Period:

There is a one-year term on the license to preach the gospel with a five-year maximum on the amount of time allowed to preach under license in preparation for ordination. If at any time the *licensed minister allows the license to lapse*, the entire licensing process must be restarted beginning with the recommendation of the local church to the Board of Ordination.

9. Requirements for Ordination:

We commend to our member churches and to all of our licensed ministers the attached *Requirements for Ordination*. This document will serve as a checklist for our licensed ministers as they move toward ordination. This document will also aid our churches in answering initial questions that a candidate might have in regards to the requirements for ordination.

10. Conference Attendance:

A. Any minister (licensed or ordained) holding membership in the Western Conference, who fails to attend the annual session of the Conference for two

consecutive years or fails to send a letter showing reasonable excuse for nonattendance, is subject to censure and/or the revocation of his credentials of ordination.

B. All ministers (licensed or ordained) serving in the Western Conference in any pastoral position are **required to register and attend the annual session of the Western Conference**. Pastoral positions include but are not limited to pastors, associate pastors, and youth ministers. Failure to attend two consecutive years or failure to send a letter showing reasonable cause for non-attendance will subject the minister to censure and/or the revocation of credentials.

11. Annual Convention Attendance:

Any minister (licensed and ordained) holding membership in the Western Conference is required to register and attend at least one day of our annual OFWB Convention which meets Wednesday and Thursday following the second Sunday of May on the Mount Olive College Campus. A letter stating reasonable cause will also be accepted in lieu of this requirement. It may be sent to either the Clerk of the Board of Ordination or the Clerk of the Conference (not to the Convention office or the President of the Convention).

12. Ministers Transferring into the Western Conference:

A. From Sister Conferences: These ministers must be cleared with the Western Conference Board of Ordination *prior to assuming* the pastorate to which they are called. This is the responsibility of the church calling the minister; however, the minister should be sure it has been done *prior to* beginning the prospective work. This is a simple procedure designed to protect our churches from harm. Our churches are not independent of the Conference as is true in some other denominations and groups.

B. From other Denominations: For this information you are referred to page 89 of our *Articles of Faith & Principles of Church Government*.

13. The Christian Flag Service for Ministers:

The Board of Ordination will serve as the Conference Christian Flag Committee. Any minister serving in the Western Conference at the time of his death will be given the Christian Flag Service if the minister has so requested or the family so desires. The flag will be purchased by the Conference.

14. Items for Praise:

1. Our newly licensed and ordained ministers

2. Our new members by baptism or transfer into the member churches of the Western Conference.

15. Things a Licensed Minister Can and Cannot Do:

- 1. A licensed minister *cannot* be called or hired as pastor (or associate) of any church (we need the cooperation of both our churches and our ministers on this item).
- 2. A licensed minister *can* serve a church on an interim or supply basis under the supervision of his Board of Ordination Advisor or another ordained minister as directed by the Board of Ordination. This service is to be limited to six months in any one church. If the church wishes an extension on the services of the licensed minister, the church must appeal to the Board of Ordination.
- 3. A licensed minister *cannot* administer the ordinances of the Gospel.
- 4. A licensed minister *cannot* perform wedding ceremohies.
- 5. A licensed minister *can* conduct worship services, preach, and teach as the opportunities are afforded to the licensed minister.
- 6. A licensed minister can officiate in a funeral service.
- 7. A Licensed minister *can* be elected to serve as temporary chairman of a business meeting with the exceptions as outlined on pg. 74, paragraph 2 of *The Articles of Faith and Principles of Church Government*.
- 8. A licensed minister *can* vote at the annual conference.

16. Recommendations to the Conference:

- 1. The ministers joining our conference by transfer of credentials be welcomed into the Conference with the Right Hand of Fellowship by the Moderator and their names be added to the list of duly ordained ministers of the Western Conference by the Conference Clerk.
- 2. Newly licensed minister, be added to the list of licensed ministers by the Conference Clerk.
- 3. That all our ministers, both ordained and licensed, continue to abide by our current *Ministerial Code of Ethics*.
- 4. That our churches <u>not call</u> ordained or licensed ministers from other denominations to serve as interim or to do supply work. Our churches be reminded of the statement from page 68 of *The Articles of Faith and Principles*

of Church Government for Original Free Will Baptists (Of the English General Baptist Heritage): "The Church shall call its own pastor from among the duly ordained Original Free Will Baptist ministers who are approved by the Conference of which the church is a member, upon such terms as shall be mutually agreeable."

- 5. We request that our ministers inform the board of ordination when they resign from their church. This is so that we can assist our churches in the search process and interim period.
- 6. The Board of Ordination recommends that the Conference strongly encourage all current and future licensed ministers to attend annual workshops conducted by the Western Conference Ordaining Council or in conjunction with workshops of other Ordaining Councils, or other groups within our denomination.
- 7. The Board of Ordination RECOMMENDS that our licensed and ordained ministers get vaccinated for COVID-19.
- 8. That this report, in its entirety, be received by the Conference and these recommendations be accepted by the Conference as submitted.

The Reverend Harold Jones reported on behalf of the Board of Foreign Missions. Reverend Ronnie Taylor reported on behalf of the Retirement Homes Ministry. The Reverend Dr. De Wayne Eakes reported on behalf of the Free Will Baptist Ministers Program. The Reverend Dr. Brad Williamson reported on behalf of the Board of Home Missions, Director of Christian Education Gail Heath reported. Rev. Howard Scott reported on behalf of the University of Mount Olive. Reverend Will Kelly reported on behalf of Carolina Bible Institute and Seminary.

A break was enjoyed and the conference reconvened with a beautiful piano prelude, prayer and the receipt of the annual conference offering.

The Reverend Charles L. Renfrow introduced the Reverend Lewis Forsythe who brought a message from Acts 9: 10-20 entitled "Roadblocks."

The Moderator called for the Temporary Committee reports. The Nominating Committee Report was given by Rev. Ray Wells.

The Moderator called for the Resolutions Committee Report and the report was given Rev. De Wayne Eakes: A resolution was read as follows: *Whereas*, Piney Grove Original Free Will Baptist Church has invited this One Hundred and Thirty Fifth Session of the Western Conference of the Original Free Will Baptists to convene at this place on this the twenty first day of October, 2021; *and Whereas*, they have so graciously evidenced the gift of Christian hospitality in providing for the needs of this Conference during its session; *Therefore, be it resolved* that this conference extends to this congregation and to its pastor a rising vote of thanks and applause for so graciously hosting this session of the Western Conference of Original Free Will Baptists.

The Reverend Anderson Barnes gave the Credentials Committee Report. It was reported that 47 Ministers, 20 Delegates and 15 Visitors were registered, totaling 84. The Credentials Committee Report was received as information.

The Memorial Committee Report was given by Rev. Lloyd Hargis and Rev. George Futrell who gave honor to God for the life of The Reverend Donnie Massey.

The Moderator opened the floor for any final business to be brought before the conference. No final business.

A motion was made to adjourn, leaving all unfinished business in the hands of the Executive Committee. The motion was seconded and passed and the conference was adjourned.
